the Financial rules.

Sir,

I am directed to refer to your letter
No.EDN(Prv)H(4)4-19/2004, dated 25th August, 2004 and 4th
September, 2004, on the subject cited above and to convey the
sanction of the Governor of Himachal Pradesh for delegation of
powers in respect of Mid-day-Meal upto BPEOs level subject to
the following conditions:-

1. That specific Block-wise allocations of budget will be made by
the Director of Primary Education keeping in view requirements
of every block.
2. The delegations under specific Heads of Account will be
limited/restricted only for mid-day meal purpose and in any
case, it will not be utilized in other matters.
3. The delegations will be subject to availability of funds.
4. All other codal formalities and provisions of H.P.F.R. and
other relevant rules will be followed by the concerned officers.
