P R E F A C E

In every year, this office analyses State Government Budget through generating some meaningful tables under the guidance of National Accounts Division of Central Statistics Office, Govt. of India for State Income Accounting. This office brings out a report based on this budget analysis which must be of immense useful to the Policy Makers. This report furnishes all types of receipts and expenditure of Public Administration (PA) and Departmental Commercial Undertakings (DCU) on salaries and allowances, goods and services, maintenance, capital formation, loans and advances, transfers relating to different departments like Agriculture, Fishery, Forestry, Health, Education, Transport etc. So, this report depicts a clear idea about capital formation out of budgetary resources, Government consumption expenditure, savings of the Government and Government's contribution to the Gross State Domestic Product (GSDP).

This Publication includes the estimates of Gross Final Consumption Expenditure (GFCE), Revenue from Direct and Indirect Taxes and Gross Fixed Capital Formation (GFCF) of Government Sector based on the analysis of the State Government Budget for the year 2004-05 to 2012-13 (Actual), 2013-14 (Revised) and 2014-15 (Estimate). The estimates of Gross Fixed Capital Formation (GFCF) indicate the growth potential of the economy of Nation or a State. Higher the growth rate of Capital Formation, higher would be productive capacity of the economy. At the State level the estimate of Gross fixed Capital Formation are not readily available for the economy as a whole due to huge requirements of data from State Non-Departmental Commercial Undertakings (NDCUs), Urban & Rural Local bodies, Central Govt. Administrative Departments, Supra regional sectors, Autonomous Bodies, Cantonments, Private Corporate Sector and House hold Sector.

I am thankful to The National Accounts Division (NAD) of Central Statistics Office (CSO), Ministry of Statistics and Programme Implementation, Government of India for their valuable guidance of technical assistance.

I appreciate all staff of the Family Budget Unit for their sincere effort to prepare this report.

Any suggestion / valuable comments from the end of the users of the report will be highly appreciated.

STATE BUDGET ANALYSIS

1. INTRODUCTION :

The total economy consists of three institutional sectors viz., public, private and household. Public sector including General Government plays a key role in the economy. Its key contributions are evaluated and data of its performance is presented in this report.

Budgets are main Sources of information for economic transactions in terms of receipts, expenditure, loans, advances, capital formation etc., of Government Sector. Budget Analysis plays a crucial role to measure the level of economic development, the rate of economic growth, the change in consumption, saving, investment, debt and wealth for General Government Sector.

From Budget, we get Budget data of three years. In this publication the Budget Data of 2012-13 (Actual), 2013-14 (Revised) and 2014-15 (Estimate) have been used.

2. CONCEPT, SCOPE & COVERAGE :

A. The Budget of Government is analyzed in terms of Revenue and Capital account. Both accounts have been classified as Revenue & Capital receipt and expenditure. Receipts from sources such as taxation, dividend from companies owned by the government and user charges on public services are classified as Revenue receipt and receipt from sources such as borrowings and disinvestments of public sector companies are classified as Capital receipt. Expenditure has been categorized as Revenue & Capital expenditure. Capital expenditure is used to create assets e.g. building, roads, repaying a loan etc. Revenue expenditure is used on items such as salaries, interest payments and administrative expenses.

Again, in budget analysis according to the guidance of Central Statistics Office, the government expenditure can be classified according to

(i) the economic character of the expenditure like expenditure on salaries and allowances, goods & services, maintenance, capital formation, loans, advances, transfer etc. called "Economic Classification" and

(ii) the purpose it serves, such as, health, education, defence etc. called "Purpose Classification".

B. In Budget, the Govt. Sector(excluding public sector corporations) can be broadly divided into Administrative Department and Departmental Commercial Undertakings (DCUs). For Budget analysis, we are concerned with both of the followings :

i) State Govt. Departments or Offices engaged in Administration and Regulation of Public order come under the Administrative Department.

ii) The Undertakings, which are owned and controlled by the Government, producing Goods and services and selling at prices like any other commercial establishments come under the Departmental Commercial Undertakings (DCUs).

3. DATA ANALYSIS :

A: DATA COMPIRATION

The estimates of net product, consumption expenditure, capital formation, saving etc. are prepared by analyzing the data of receipts and expenditure as available in Budget Document i.e., (i) Financial Statement, (ii) Receipt Budget and (iii) Detailed demands for grants.

The Receipt budget and Demands for Grants give item wise (accounthead) receipts and expenditure data for different departments of the Government .Data on receipts and expenditure are available for three years from the Budget Publication, 2014-15, i.e., for the Year, 2012-13(Actual), 2013-14(Revised) and 2014-15(Budget Estimate).

By analyzing the Budget data, various accounts have been prepared as per guidelines and software provided by the Central Statistics Office (CSO), viz.,

Borrowing Account

Income and Outlay Account of Administrative Departments

Current expenditure of Departmental Commercial Undertakings

Capital Finance Account of Public Authorities

Net product from Public Administration and Defence

Domestic Product of Enterprises (DCU) by industry of origin and factor Incomes

Capital Formation (Administration) and

Capital Formation (Enterprises), only DCUs

B. GENERATION OF TABLES :

The above eight Accounts obtained from the State Budget Analysis are described in Table No. 1.1 to Table No. 8.3 along with Budget Purpose Classification (Table No.9). Broadly, through tables, sector wise total receipt and expenditure structure of the State are analysed. But, there is no scope to represent receipt and expenditure according to major heads as per software provided by CSO. So, Receipt & Expenditure of some major heads are given below for the years 2011-12(A), 2012-13(A), 2013-14(RE) & 2014-15(BE).

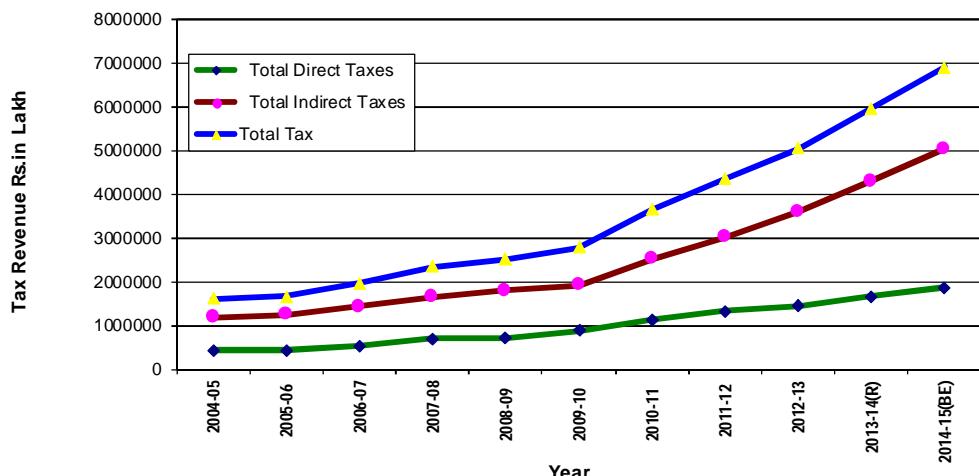

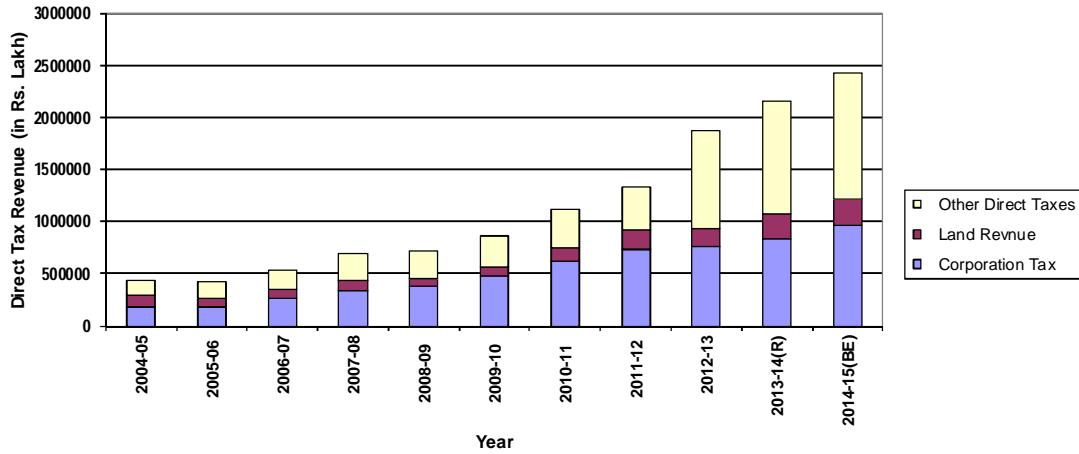
