The Government of India, Ministry of Human Resource Development, Department of Elementary Education & Literacy, Shastri Bhawan New Delhi-110001 has conveyed the allocation of foodgrains for Primary Stage (classes I - V) and Upper Primary Stage (classes VI - VIII) for the **3rd Quarter** (01-09-2012 to 31-12-2012) for the year 2012-13 vide their letter No. 5 (1) / 2012 – Desk (MDM) of dated 29th, August, 2012 which is being allocated to you on the basis of enrolment and working days keeping in view the balance stock lying in the wholesale godown of HPSCSC as on 30-6-2012 as per enclosed **ANNEXURE-1**.

In view of above, you are directed to further distribute 16436.40 quintals of rice for Primary stage & 16165.50 quintals foodgrains (Rice) for Upper Primary stage to the Blocks on the basis of targeted enrolment (as on 30.6.2012) as per norms i.e. 100 gms. per child per day in respect of Primary classes and 150 gms. per child per day for Upper Primary classes of your District.

It is also informed that, the balance of rice from the previous quarter may be kept in view while allocating rice to the Blocks for providing Mid Day Meal under MDM Scheme.

You are again directed to ensure the compliance of the instructions circulated vide this office letter of even No. dated 2.3.2012 and 19.3.2012 for the successful implementation in the state.
