NOTIFICATION

In supersession of this Department's Notification No. EDN-A-Ga(11)4/2000 dated 05<sup>th</sup> March, 2001 and EDN-A-Ga(10)1/2002 dated 28<sup>th</sup> December, 2002, the Governor, Himachal Pradesh is pleased to notify following guidelines for regulation/implementation of scholarship scheme of "Swami Vivekananda Utkrishi Chhatravriti Yojna" in the H.P. Education Department, in the public interest, with immediate effect:

1. This Scholarship will be given to top 2000 meritorious students of general category declared as such in the result of Matric Examination conducted by the H.P. Board of School Education Dharamshala strictly on merit basis for +1 and +2 classes in a recognized institution within or outside the state. The renewal in +2 class will be subject to satisfactory performance in 10+1 internal examination.
2. The Scholarship will also be given in case the eligible student takes admission in any professional/ technical course after matric, in a recognized institution within or outside the state, however it will be limited for maximum of two successive years after matric. The renewal in 2<sup>nd</sup> year of the course will be subject to satisfactory performance in 1<sup>st</sup> year of the course.
3. Under this Scholarship Scheme an amount of Rs. 10,000/- [Ten Thousand] only will be given to each eligible Student per year for two successive years after matric.
4. The eligible Students must belong to General Category.
5. In case of any dispute, the Director, [Hr. Education], H.P. will decide the matter/issues immediately. However, any person aggrieved with this decision may file an appeal before the Secretary [Education] to the Government of H.P. within 45 days of decision.
6. The eligible students will have to apply on the prescribed proforma along with Matric through their Heads of Institution. The Heads of Institution will then forward the duly filled up forms to their Deputy Director of Education. The concerned Deputy Director of Education will compile lists of entire District concerned and will submit the same to the Director of Higher before the date notified by him in the regard.

7. In case of non availability/absence of Head of the Office in any institution/ School, the eligible students may apply directly to the Deputy Director of Higher Education of the concerned District who will process the case further on confirmation from the office concerned. However, no eligible student will be deprived of his/her Scholarship on account of delay in submission or otherwise. It will be the foremost duty of the Head of each institution/school to get the form filled up from the eligible students of their respective institutions falling within their respective jurisdiction and will process the matter further in time bound manner.

Note: Since the H.P. Board of School Education have done away with 10-1 class examination w.e.f. March 2011; the re-renewal of this scholarship for 10+2 class for 2012-13 will be made on the basis of 10<sup>th</sup> Class H.P. Board of School Education's Examination Merit list of the previous session.
