- 4. Legal cases.
- 5. Specific GOs & service rules, amendment & modification required.

In pursuance of the decision taken in the District Educational Officer's conference a **"Working Group"** with the following officials and non-officials is hereby constituted to thoroughly study the issue of Specific GOs & service rules, amendment & modification required.

b) Issue in brief:

- ➤ The Government enacted AP Education Act 1 of 1982 and issued rules thereon in accordance with the provision of Act.
- ➤ Government of India enacted Right to Education Act 2009, for implementation of Free and compulsory Education upto 14 years.
- ➤ Some of the provisions of the Act 1 of 1982 and the Right to Education Act are overlapping on certain issues.
- Government have issued ad-hoc service rules for the teachers in G.O.Ms.No.9,10,11 & 12, and also issued amendments in G.O.Ms.No.4 Education dated 2012 and on several issues from time to time.
- > Due to the legal disputes on the service rules many of the inspecting officer posts / teaching posts in Training institutions are vacant

c) Terms of reference

- ✓ To study the provisions of the Act1/82, and RTE, 2009, rules, amendments issued from time to time and suggest the corrections to be made in the rules / act.
- ✓ To suggest filling up of all the teaching posts in training institutions like DIET's and CTE's and other administrative posts for effective functioning of the department.
- ✓ Comprehensive and compilation of rules.

d) Time frame

The working group shall examine and furnish report by 30.04.2015

The working group may take the services of any staff working in the O/o. Commissioner of School Education, Sarva Siksha Abhiyan, Rashtriya Madhyamik Siksha Abhiyan, Andhra Pradesh were ever required in preparation of suggestions/recommendations.

The Joint Director (Services), O/o Commissioner of School Education, to coordinate and provide all assistants to the working group.
