Governing Council Meeting Proceedings

The proceedings of the Governing Council of Sarva Shiksha Abhiyan Samithi – Karnataka held on Wednesday, 30.01.2002 at 4.00 p.m. at Committee Room No. 313, III Floor, Vidhana soudha, Bangalore.

- The meeting started with Hon'ble Minister for the Primary and Secondary Education., Govt. of Karnataka chairing the session. The list of the members and officers present in the meeting is enclosed. Sri. T.M. Vijaybhaskar, Commissioner for Public Instruction welcomed all the members and other officers.
- 2. Sri. G.L. Hegde, Director, Primary Education and the State Project Director, made a brief presentation on the Sarva Shiksha Abhiyan, its importance, objectives, target, achievement and the sanctions.

At the outset State I roject Director Sri. G.L. Hegde informed that Rs.241.51 lakhs have been released under the Sarva Shiksha Abhiyan in 2001-02 for the purpose of taking up pre-project activities. The grant is released to District Implementation Committees for the following activities.

- 1. Community mobilisation activities
- 2. House o House survey
- 3. Strengthening the District Office
- 4. Preparations for habitation plans
- 5. Baseline Assessment studies
- 6. Training.
- 7. School Display Board
- 8. Documentation

State Project Director, Sarva Shiksha Abhiyan informed further that the above activities at Sl.no. 1,2,5 and 7 have already been completed and the other activities are in progress.

- 3. Afterwards he presented the physical and financial sanctions for different activities from the Government of India under the Annual Work plan for the year 2001-2002.
- 4. In accordance with the sanction of Govt. of India vide letter No. F2-5/2001-DPEP-4, New Delhi dated 18.12.2001, the State Project Director informed

the members that Govt. of India has communicated its sanction for opening of 270 new primary schools, 22 BRC and 205 CRC buildings, drinking facilities for 1750 schools, toilet facilities for 1345 schools, repairs for 13995 schools, salaries for 905 teachers, training of teachers and SDMC members, purchase of teaching-learning materials, innovative activities, evaluation, integrated education for disabled children, supply of text books to 8th std., administrative expenses of BRCs, CRCs and dist level SSA office and other sanctions. He further informed that Govt. of India having agreed to release 85% of its share of Rs.5119.00 lakhs, has now released 50% of that being Rs.2559.00 lakhs. The members took note of guidelines for utilising the grants as per the action plan explained by State Project Director.

The Secretary to Govt. Primary and Higher Education informed that the State Govt. has agreed to release its share of Rs.903.30 lakhs and the same would be released shortly to Sarva Shiksha Abhiyana Samithi as approved for the year 2001-02.

5. a) While discussing the implementation of different activities as approved by Govt. of India for the year 2001-02, it was decided that District Implementation Committees have to identify the agencies at the district level for the construction of BRC, CRC and school buildings. The building specifications and blue prints will be supplied by State Office. The Hon'ble Minister for Primary and Secondary Education indicated that the BRC and CRCs as far as possible should be located in the premises of Higher Primary schools so that they could also be used as class rooms when not in use otherwise.

State Project Director informed the Hon'ble Minister for Primary and Secondary Education that the sites for BRCs/CRCs have already been identified on these lines.

b) It was resolved to release grant directly to the District Implementation Committees for enabling them to credit the same into the Bank account of respective School Development & Monitoring Committees for providing drinking water, construction of toilets, repairs of school buildings, purchase of equipments, school grant, teacher grant. It was decided that repairs of school buildings and purchase of equipment have to be done only through School Development and Monitoring Committees and similarly the other activities have to be implemented as per Govt. of India guidilines. It was also resolved to issue detail guidelines to district implementation committees while releasing grants and the Governing Council indicated to State Project Director to take action accordingly.

After detailed discussion the Governing Council approved the following changes in the composition of the District Implementation Committee and Block Implementation Committee of Sarva Shiksha Abhiyan Samithi.
