THE MADRAS UNIVERSITY (AMENDMENT) AC1, 1966.

Received the assent of the Governor on the 20th February 1966, first published in the Fort St. George Gazette, on the 23rd February 1966 (Phalguna 4, 1887).]

An Act further to amend the Madras University Act, 1923.

Be it enacted by the Legislature of the 3[State of Tamil Nadu] in the Seventcenth Year of the Republic of India as follows:—

- 1. (1) This Act may be called the Madras University Short title and (Amandment) Act, 1966.
- (2) It shall come into force on such date as the State Government may, by notification, appoint.
- 2-32. [The amendments made by these sections have already been incorporated in the principal Act, namely, the Madras University Act, 1923 (Tamil Nadu Act VII of 1923).]

- (2) All colleges which immediately before the date of the commencement of this Act continue to be recognised by the University of Madras as—
- (a) Oriental colleges providing courses of study for admission to the examinations of the University of Madras for titles and diplomas: and
- (b) Colleges providing courses of study for admission to the Pre-University examination of the University of Madras,

shall be deemed to be colleges approved by the University of Madras under the principal Act as amended by this Act and the provisions of the principal Act as amended by this Act shall, as far as may be, apply accordingly.

Continuance in University of Madras.

34. Notwithstanding anything contained in the members of the principal Act or in this Act, all persons holding office as members of the Senate, the Syndicate Academic Council on the date of the commencement of this Act shall continue to hold office up to such date as the State Government may, by notifica ion, fix in this behalf, or where no such date is fixed, up to the date on which their term of office would have expired if this Act had not come in o force.

Continuance in ... office of the of the University of Madras.

35. The Vice-Chancellor of the University of Madras Vice-Chancellor holding office on the date of the commencement of this Act shall be deemed to be the Vice-Chancellor appointed under the principal Act as amended by this Act and shall continue to hold office up to the date on which his term of office would have expired if this Act had not come into force.

36. Nothing contained in the principal Act as Act not to apply to certain amended by this Act, shall apply to colleges and institucolleges and tions situate in the area comprising the revenue districts institutions. of Madurai, Ramanathapuram, Tirunelveli and Kanyakumari.
