

GUIDELINES FOR PART-TIME RESEARCH ASSOCIATESHIP FOR WOMEN REVISED FOR THE IXTH PLAN PERIOD

OBJECTIVES

The Research Associateships are intended to provide opportunities to take up research work in Humanities including Languages, Social Sciences, Sciences, Engineering and Technology independently and on project basis to those women candidates who have shown talent and competence for independent research.

ELIGIBILITY

Ph.D. degree is an essential qualification for being considered for Research Associateship. The age should not be more than 50 years as on 1st July of the year of award. (Preference would be given to those researchers/teachers who have independently published research work).

NUMBER OF ASSOCIATESHIPS

Number of Associateships available every year will be decided on the position of the funds for the Scheme. Applications will be invited through Press advertisement/ circulation to the universities every year in the prescribed format.

EMOLUMENTS

For those who are teachers, the university/college will be compensated for a part time substitute. For others, the Research Associateship will be awarded in the following slabs: Rs. 4,000/- p.m. (Fixed)

Rs. 5,250/- p.m. (Fixed) (with five years research experience)

Associates have to devote at least 20 hours every week to work on research project.

CONTINGENCY

The contingency grant @ Rs. 5,000/- p.a. will be paid for meeting the expenditure on books, journals, travel and equipments to the Part-time Research Associates. The items so procured will be the property of the University/College/Institution.

DURATION

The duration of the Associateship is five years with no extension. They will have to reapply and compete with others if requesting continuance. Teacher Research Associates will have to get a no-objection certificate from the Vice-Chancellor/Principal.

ALLOWANCES & OTHER FACILITIES

House Rent Allowance

The Part-time Research Associates who are not teachers are not entitled to accommodation in the University or House Rent Allowance or Medical Facility of the University.

Reader's / Escort's Allowance

Reader's/Escort's Allowance at the rate of Rs. 1,000/- p.m. is admissible to Research Associates who are blind or physically handicapped.

Leave

- (1) The awardee shall be entitled to all leave as per the rules of the Institution.
- (2) In special cases, the Commission may allow leave without pay for a period not exceeding one year during the tenure of award on the recommendations of the supervisor and the Head of the Institution concerned. The period of leave without associateship will not count towards the tenure of associateship, if it is maternity, otherwise it will count towards the period of associateship.
- (3) Host Institution where Research Associates are placed would be given grant equal to 10 percent of the total associateship component for providing infrastructural facilities (stores, purchase, technical and clerical assistance, repairs and supply of electricity, water, gas etc)

CONDITIONS OF THE AWARD

- (a) The associateships are generally tenable at any University approved under the University Grants Commission Act, 1956. In special cases, the Commission may agree to Research Associate working in an Institution not covered by the UGC Act, if the Institution agrees to provide infrastructural facilities for research pursuits of the Research Associates and to meet all the expenses as per the rules set forth above.
- (b) She shall not accept or hold any appointment, paid or otherwise, or receive any emoluments, salary, stipend etc. from any other source during the tenure of the award.
- (c) She shall submit, through the senior faculty member with whom she is working and the Head of the Department/University, a half yearly report on the progress of hér research work. She shall submit a comprehensive report to the Commission before

the expiry of Associateship and a copy of her published work, if any, and abstract in about 500 words of the research work done during the tenure of Associateship.

- (d) If she wishes to leave the Associateship before the end of the tenure, it should be done with prior approval of the Commission. For appearing at any examinations conducted by any university or public body the prior approval of the Commission should be obtained.
- (e) The Commission, in consultation with the University/Institution concerned, may terminate an Associateship without assigning reasons at any time and the decision of the Commission in this regard shall be final.

PAYMENT

Payment of the Associateship amount and contingency grant will be made to the University/Institution for the financial year ending March for disbursement to the associate at the beginning of the quarter. The University/Institute must send Utilization Certificate of the expenditure incurred by 30th June of every year and progress of the wok done by the Associate.


REVIEW

The Research Associate should submit to the UGC every year a report of the research work done by her during the year which the Head of the Department and the Departmental Research Committee of the University/Institution will be examined by experts for recommendation with regard to the extension, or otherwise, of the tenure of the Research Associates. The Research Associate should submit to the UGC a report of the research work done by her at the end of second year, fourth year and fifth year through the Head of the department and the Departmental Research Committee of the University/Institution.
