Introduction

1.1 Prelude

As an outcome of the ideas contained in the National Policy on Education (NPE), 1986 and Programme of Action (POA), 1992, the National Assessment and Accreditation Council (NAAC) was established in 16th September 1994 as a creative idea to give positive thrust in the direction of quality enhancement of the Indian Higher Education Institutions (HEIs). It is highly motivating to know that NAAC has almost become synonymous with quality in higher education in India. NAAC has touched every stakeholder to higher education in one way or the other, either directly or indirectly. 'Quality' has become the buzzword on the academic campuses today and it is a matter of great satisfaction for those visionaries who made space for NAAC, worked day-in and day-out to realize the vision with which NAAC was brought into existence. It is not only the time for euphoria for all the people connected with NAAC in one way or the other but also time for introspection, innovation and improvement.

It is irrefutable that the pace of growth in the higher education sector in India is inimitable in terms of the number of Universities, Colleges, students, teachers, courses, aspirations of the stakeholders and the sheer volume of the 'unreached'. Further it is unassailable that the mere improvement in the numbers does not ensure the creation of the necessary 'resource pool' that is expected of the higher education system in India. It is a welcome feature that the system is evolving, expanding, fine-tuning, and attempts to 'perne in a gyre' to match the satisfaction of the stakeholders.

In a country where the landscape of higher education is extremely mosaic while it continuously tries to evolve and bring in complexities into the system, it is a dynamic world and every process that is developed either to make value addition to this system or to evaluate this system should be dynamic, relevant and customized. At a time when altogether unexpected and novel changes take place to cater to the stakeholder satisfaction in the Indian higher education system, it is imminent that highly dynamic systems have to be evolved for measuring quality.

It is highly important that quality assurance and sustenance activities need constant monitoring and motivation for the furtherance of the operations. As there are indications/reports that the academic is prone to inertia and indifference can creep in to the system (Harway & Williams, 2012), it is necessary that the processes are repeated and the in-house mechanisms are devised to keep the system ever awake. With this in mind, the NAAC conceptualized the concept of Internal Quality Assurance cells (IQAC) and it is mandatory for accredited HEIs.

During the post accreditation period, IQAC of an institution was envisioned with specific goals. It has to guide and monitor not only the sustenance but also enhancement of quality related process. The important objective of this is to internalize quality assurance process in all dimensions of the institution, both at the policy and implementation levels. The Re-accreditation needs to look at the process and practices that the institutions have developed for such monitoring and motivation, but the process of accreditation should not be merely repetitive or ritualistic.

It is exciting to know that NAAC enters and exhilarating phase as Higher Education Institutions come knocking at the doors of NAAC as they enter the third cycle of assessment and accreditation. Through its consistent and conscious efforts NAAC has assumed the role of a 'quality facilitator' in spite of extreme hardship. It is a reality that the stakeholders of higher education understand the importance of self-assessment and accept the peer evaluation by NAAC. Lot of thinking had to go in to developing the processes and told that would be acceptable, relevant and purpose serving.

As NAAC begins the third cycle of accreditation, the very process of accreditation and reaccreditation should be exciting both for the institution and the assessors. Accreditation status is no doubt necessary for value addition to the existence of an institution but it should also motivate the stakeholders to continuously improve the systems for quality enhancement. It is also true that the institutions have to really strive hard to sustain the accreditation status for many years to come. In a highly volatile system, where diversities and complexities dominate, it becomes inevitable that time-sensitive strategies are developed to attain, sustain and enhance quality in all the components of an academic institution.

Accreditation status should without question give rise to healthy competition among HEIs, and the innovations that these institutions make should become part of the national treasure and now any evaluation mechanism should focus on the abilities of an institution to demonstrate leadership in any self-defined area. During the third cycle of accreditation the HEIs that have achieved a benchmark should guide other non-accredited institutions to get the benefit of the practices and processes already experimented upon. They should give a proof of their social responsibility and the ability to share and care. The accredited institutions should be beacons of light.

NAAC has made a tremendous impact on Higher Education Institutions (HEIs) which is evident from the number of quality assurance seminars and workshops that have been conducted in the year 2010-2011 in order to achieve its objectives. Hitherto, the NAAC has conducted awareness programs in almost all States and this has triggered many regional level and district level activities.

The success of NAAC is measured by the number of Colleges 4371 and Universities 161 assessed and accredited.

The process of accreditation has created a tremendous momentum among the academia on issues pertaining to quality and this has largely been due to the partnership between NAAC and the State governments. As per the guidelines and suggestions of NAAC, all the 28 States, have established State Level Quality Assurance Cells (QACs) and State Level Quality Assurance Coordination Committees (SLQACCs) at the State Level. In case of National Capital Territory and 6 union Territories i.e., NCT of Delhi, Andaman and Nicobar Islands, Chandigarh, Dadra and Nagar Haveli, Daman and Diu, Lakshadweep and Pondicherry, the colleges are minimal, hence the Directorate/ Commissionerate of Higher Education of the respective UTs take care. NAAC has sponsored and participated in many seminars, conferences and workshops in order to achieve its mandate.

NAAC is the member of the International Quality Assurance Agencies in Higher Education (INQAAHE) and a founder-member of Asia-Pacific Quality Network (APQN).

1.2 NAAC: Objectives

The objectives of NAAC is to assess and accredit institutions of higher learning, universities and colleges or one or more of their units, i.e., departments, schools, institutions, programmes, etc.

The main objectives of assessment and accreditation are to:

- a) grade institutions of higher education and their programmes;
- b) stimulate the academic environment and quality of teaching and research in these institutions;
- c) help institutions realise their academic objectives;
- d) promote necessary changes, innovations and reforms in all aspects of the institutions working for the above purpose;
- e) encourage innovations, self evaluation and accountability in higher education.

In order to meet its mandate NAAC will:

- a) Review periodically and revise and update as and when considered necessary in the light of experience gained the techniques and modalities of assessment;
- b) Communicate the results of assessment and grading to the concerned institution in a form and manner appropriate for corrective action, rectification and self improvement;

- c) Help and encourage the institutions in developing their own procedures, techniques and modalities for self evaluation;
- d) Initiate research studies, in planning and evaluation of educational institutions, programmes etc.;
- e) Ensure an optimised use of resources and the achievement of the identified goals of institutions of higher learning;
- f) NAAC may collaborate with institutions, Indian and foreign, engaged in work of a similar nature and may also undertake on request assessment and accreditation of institutions of higher education, abroad.

1.3 Structure of NAAC

NAAC's working is governed by the General Council (GC) and the Executive Committee (EC) on which University Grants Commission (UGC), All India Council for Technical Education (AICTE), Ministry of Human Resource Development (MHRD), Association of Indian Universities (AIU), Universities, Colleges and other professional institutions are represented. Senior academics and educational administrators are nominated as members on these two bodies.

3 Academic Activities

3.1 Introduction

The prime agenda of NAAC is to assess and accredit Institutions of Higher Learning. During the year 2010-2011, NAAC has assessed and accredited 586 HEIs which include 277 Colleges for Accreditation; 293 Colleges for Re-Accreditation; 1 College for 3rd Cycle; and 2 Universities for Accreditation; 14 Universities for Re-Accreditation (kindly see annexure 7.4).

NAAC is in constant collaboration with the State Governments by establishing Quality Assurance Cell (QAC) and State Level Quality Assurance Coordination Committee (SLQACC) in each State. All 28 States have established QAC and NAAC is supporting this endeavor. This Cell not only focuses on the preparation of the Colleges to undergo the processes of assessment and accreditation, but also conducts many post accreditation quality sustenance and quality enhancement programmes. Many quality improvement, programmes have been organized jointly by NAAC and QAC of States for Colleges.

The vision, mission and core objectives of the NAAC as stated are Quality Assurance in Higher Education. Assessment and Accreditation is the tool in reaching these objectives. NAAC academic activities may be viewed at two levels one is the Awareness programmes on Assessment and Accreditation and the other is the Post Accreditation Programmes. The awareness / promotional programmes explains the policy, direction and guidelines of MHRD, UGC and NAAC for the process of Assessment and Accreditation. The post accreditation programmes on quality sustenance and quality enhancement are by means of sharing of Best Practices and preparing an Annual Quality Assurance Report (AQAR) by the functional Internal Quality Assurance Cell (IQAC) in each accredited College and University. From the XI plan onwards NAAC propagates creation and establishment of IQAC in all HEIs, especially for those HEIs who volunteers to the process of A&A for the first time through Institutional Eligibility for Quality Assessment (IEQA).

A programme or an activity may be a seminar, conference, workshop, symposium at the local, state, regional, national or international level. These activities are organized by NAAC in collaboration with the State Governments, QACs, UGC-Academic Staff Colleges, Universities, or Colleges. Some of the activities are conducted by NAAC at the Headquarters itself (kindly see section 3.2). In addition to this, NAAC also sponsor's many academic activities in the form of seminars, workshops, conferences, etc to

accredited Higher Education Institutions (HEIs). Either a NAAC staff or NAAC representative is present as a resource person in most of the programmes across the country. NAAC also constantly review its mechanisms, procedures and methodology. In addition to this, NAAC brings out quality publications in collaboration with International agencies, research projects funded external agencies and NAAC academic staff participate in these activities.

NAAC is regularly represented by its academic staff to International and National Quality Assurance Agencies for sharing and exchange of practices (kindly see section 3.7 and annexure 7.3).

A select brief of the academic activities across the country during the period 2010-2011 is given below in the chronological order region-wise (kindly see section 3.3 to 3.6).

3.2 Programmes at Headquarters

NAAC Campus Dedicated to the Service of Higher Education to the Country by Honourable Union Minister Shri Kapil Sibal, Minister for Human Resource Development, Government of India during his visit to NAAC on 1st May 2010.

- Excerpts of the speech

Chairman of UGC Prof. Thorat, Chairman of the Executive Committee, Prof Goverdhan Mehta, Secretary, Ministry of Human Resource Development Ms Viba Puri Das, Director, NAAC, Prof. Ranganath, distinguished Vice Chancellors present here, distinguished Members of the General Council, distinguished Members of the Academic Staff, distinguished Members of the Media, ladies and Gentleman.

As I entered this building I noticed the architecture of this building, I said to myself, that this is how Higher Education should be and the architecture of Higher Education should be. Open, Transparent, allowing the winds of change and achieving the level of excellence that is part of this great architectural structure, so congratulation for the campus, Thank you very much for giving us the architecture that we need to replicate in the education sector.

Accreditation is perhaps the most important element in achieving level of excellence. Without accreditation there are no benchmarks on the basis of which you can judge quality. Unfortunately we as a nation in the last 62 years have not embraced accreditation as a process through which we can achieve the level of excellence as we need to, as we move forward in the 21st century to compete in the globalised world.

We do not want that institutions of dubious quality start imparting education to our children, especially when we need to inform the world that, we are ready for the change, that we are committed to, that we are ready to compete with the rest of the world in higher education.

I don't hear the voice of academic community in any debate in India and I wish and wonder why? We are setting a frame work in the education sector to change the environment so that the academic community acquires local flexibility and the freedom that they need in order to build the excellence to compete with the rest of the world and yet I don't hear the voice of that academic community.

I am coming to a city which has a very high quality educational institution and very high quality private investment in the area of science and technology and whereas in the public sector this is in a sense,

knowledge Mecca of India. And if the Mecca and voice of the Mecca of knowledge is not heard, I don't think the debate will be rich enough to move forward. There are lots of challenges that we have to meet and one of the biggest challenge is that we have to meet and look forward in the number of universities that will have to be setup.

NAAC is the ideal institution which has now been able to, in a sense develop process or to determine is to what Quality Accreditation is all about, Assessment and Accreditation is all about, as we move forward in the government ratio moves from 12.4% to 30% which is what we intend to do in 2020, we will need not less that 800 universities, we will need not less than 35 to 40 thousand more colleges than the existing colleges which are 22 thousand in number. Who is going to regulate them? Who is going to address the issues of quality?

And we need to assess and accredit the wide variety of institution in which perhaps we don't have the necessary human resource that's available. How do you then give enormous diversity of institution that are going to come up in the near future? Do we have a relatively large quality human resource base which is viewed with the integrity to deal with that institutions. So Accreditation is at the heart of many of the trusts that is going to take place in the education sector as we a move forward. Therefore while we debate and discuss the constitution of the National Council for Higher Education and Research. We should be discussing the Variant issue in Education which today our page one and what ever pass the page one in 62 years, you have a great opportunity but you also have a great responsibility and therefore take on that challenge.

I am absolutely convinced, that whether we like it or not India is destined to be a leader in education to the rest of the world and we need to evolve our own methodology and systems of quality accreditation much unlike the systems that has been adopted by some agencies around the world which assess quality through out the world on basis precessions which has no relevance to the real world. Therefore NAAC should evolve Global Quality Certification Standards, which will determine on the objective base as to which are those institutions which should be part of those quality institutions in the world. And I am sure NAAC is up to the task and we wish in a very short time get that criteria in stake for us to ourselves.

Now with the National Accreditation Authority, this is compulsory. Every higher education will have to go through the accreditation process, even the new state universities that are going to be setup. But if the state itself setup mechanism internal and institutions that itself sets up mechanism internally, each institution which set up a quality Assurance mechanism, which then can be provided to the accreditation authority as an internal assessment of the institution in terms of quality.

The real wealth of the nation is acquisition of intangible assets, and intangible assets are assets of mind, assets of creativity, assets which cannot be touched and cannot be sensed. Those are the real assets of the nation. NAAC will provide a mechanism not to test those assets those non intangible assets that make up the wealth of the nation.

I congratulate NAAC for this beautiful architectural design. I congratulate NAAC for what ever is done in the past, Ithink since 1994, that is the time when it is started and it is 2010. And I think is a very short journey, 16 years is no journey in the life of any institution. But what I have seen and what NAAC has done in the last 16 years makes me believe, in fact I am convinced, if we Indians make up our minds, what others took 200 years to achieve, we shall do it within 20 years.

NAAC had invited 30 states for the meeting and representatives of 19 states namely Karnataka, Manipur, Andhra Pradesh, Assam, Nagaland, Arunachal Pradesh, Sikkim, Chhattisgarh, Tripura, Tamil Nadu, Kerala, Maharashtra, Jammu and Kashmir, Rajasthan, Uttar Pradesh, Himachal Pradesh, Uttarkhand, Punjab & Haryana attended the programme. Prof. H. A. Ranganath, Director, NAAC welcomed the participants and highlighted the support given by the NAAC for workshops, seminar, SQACs and the financial support extended to the accredited

institutions for conducting Workshops/ Seminars and Symposia for Quality Enhancement and Sustenance. Prof. S.P. Thyagarajan, former Vice-Chancellor, University of Madras, shared the study conducted by him on the quality gap of the accredited institutions and highlighted the gaps between the highly rated institutions and average institutions. The representatives for different states highlighted the priorities of the state Governments and elaborated on the steps taken up by the respective state Governments to give thrust to quality achievement, sustenance and enhancement. A few of them threw light on issues and concerns related to specific geographical locations and sought financial support from NAAC for setting up/improving QACs in their states. NAAC advisers shared their experiences and requested the State Quality Assurance Cells to be in touch with the regional coordinators. The QAC meet was coordinated by Dr. M. S. Shyamasundar, Deputy Adviser and Dr. Ganesh Hegde, Assistant Adviser.

Interaction with His Excellency, the Governor of Karnataka

Dr. Hans Raj Bharadwaj, His Excellency, the Governor of Karnataka, visited NAAC on 22 June 2010. Prof. Goverdhan Mehta, Chairman, EC, NAAC and Prof. H.A.Ranganath, Director, NAAC welcomed His Excellency, the Governor of Karnataka. The Director gave an overview of NAAC activities. His Excellency, the Governor of Karnataka delved at length on various issues concerning quality of education. He emphasized the need to reinforce the basic values like honesty and respect among the teachers. He applauded the vision of NAAC and advised NAAC to popularise the quality culture. Dr Jagannath Patil, Deputy Adviser, NAAC coordinated the activity. Academic staff of NAAC attended the meeting, which was followed by brief visit to the various facilities at the campus.

16th Foundation Day of NAAC

The NAAC had organised a one-day Discussion Meeting on "Quality Issues and Challenges for Accreditation" to mark the Foundation Day on 16 September, 2010. Prof. Goverdhan Mehta, Chairman, EC, NAAC in his inaugural address threw light on Issues of Quality in Higher Education, role and challenges of NAAC. The effectiveness of NAAC methodology depends on professionalism of assessors, he opined. Prof Mehta pointed out that Quality is an emerging issue and NAAC's role in management of quality assumes great significance in the days to come. Prof. H.A. Ranganath, Director, NAAC while welcoming the delegates made a presentation on "NAAC Journey so far". Shri Pawan Agarwal, IAS, made a presentation on "Quality Strategy for India Higher Education". He highlighted the accreditation strategies and challenges of higher education in different countries and lessons to be learnt. He also stressed that incentives may help to improve the quality of Indian Higher Education rather than coercion and penalties. Around fifty eminent educationists participated in the discussion. They also felt

that NAAC may develop region specific indexes as equity and access is also important. Eminent Academicians namely Prof Madhav Menon, Prof Anil K Bhatnagar, Prof. Deshpande, Prof Venkata Rao, Prof Veena R Mistry, Prof Mazumdar and a host of other academicians participated in the discussion meeting and threw light on a variety of topics related to quality. Mr. B. S. Madhukar, Deputy Adviser and Dr. Sujata Shanbhag, Assistant Adviser coordinated the meeting.

NAAC believes that the quality of the assessment depends on the quality of the Assessors. In view of this, NAAC has decided to empanel some of the best experts in the field for helping NAAC in Assessment and Accreditation exercise. As a prelude to empanelling assessors, the NAAC organised a series of Assessors' Interaction Meetings (AIM) at NAAC. The programmes were aimed at providing an insight to the experts on the NAACs philosophy, process of assessment and accreditation and evaluation framework. The programmes engaged the experts through simulation exercises, role plays and group work, thus making it interactive and educative. In all, around 200 assessors attended the meeting from across the country. The experts were drawn from various disciplines like Basic Science, Humanities, Law, Social Sciences, Medical, Nursing, Dental, Pharmacy, Ayurveda, Homeopathy, Physiotherapy, Allied and Paramedical, Teacher Education, Engineering, Languages, etc.

Engineering and Technology - AIM

Assessors Interaction Meeting for Engineering and Technology faculty was held on 4 and 5 October 2010 at NAAC Around 27 participants from fifteen states from across the country including premier institutions like IISc, IIT Delhi, Kharagpur, Mumbai, Roorkee, Banaras Hindu University and other reputed Universities in the Country participated in the programme. Prof. H. A. Ranganath, Director, NAAC welcomed the participants and elaborated on a wide range of quality issues with respect to the assessment of Engineering and Technology institutions. Dr. M. Anandakrishnan, former VC, Anna University, former Vice-Chairman, TANSCHE and presently Chairman-IIT Kanpur spoke on Quality Assurance in Higher Education: Accreditation as a Tool for Quality Improvement. Prof. A. Sridharan, Former Deputy Director & Adviser, IISc spoke on NAAC Methodology of Accreditation and Grading. Prof. B. S. Sonde, Former VC, Goa University and former professor at IISc, spoke on Report Writing and Grading; Challenges and Opportunities of an Assessor. All academic staff of NAAC were also resource persons for the AIM. Dr. Ganesh Hegde, Assistant Adviser, co-ordinated the programme.

UGC-ASCs AIM

Assessors Interaction Meeting of Academic Staff Colleges was held at NAAC on October 31, 2010. Prof. Ranganath, Director, NAAC welcomed the delegates and in his inaugural address informed the

delegates that the Ministry of Human Resource Development has entrusted NAAC with the responsibility of reviewing the performance of Academic Staff Colleges (ASC). The AIM was attended by about twenty six Vice Chancellors across the country. He further said that NAAC has initiated the process of developing the Methodology as the Chairman, NAAC has constituted the committee with the responsibility of preparing the manual and guidelines and the outcome of the committee's work has been circulated among the stakeholders for comments and suggestions. Dr. Ranganath intended to enlist the support of the ASCs in completing the process as there were 66 ASCs covering about 26 states. He further informed that 1,04,636 faculty have received the benefit of the Orientation Programme where as 2,57,301 teachers have attended the Refresher Course. Prof. Mariamma A. Varghese and Prof. S.P. Thyagarajan briefed the members on the reviewing process. The methodology, scoring pattern, report writing, selection of peers, and duration of the review were discussed and overall the manual, guidelines and other details were accepted during the interaction. Dr. Ganesh Hegde, Assistant Adviser coordinated the meeting.

Health Sciences - AIM

Assessors' Interaction Meeting (AIM) was organised during 3-4 November 2010 especially focussed on Health Science Institutions across the country. Health Science Institutions including AIMS-New Delhi, PGIMER-Chandigarh, IMSBHU-Varanasi, NIMS-Hyderabad, JIPMER- Pondicherry and NIMHANS Bangalore, etc, were among the invited experts. Chandrashekhar Shetty, former Vice Chancellor, Rajiv Gandhi University of Health Sciences and Prof. Bharat .c. Chapparwal, former Vice Chancellor, Devi Ahilya Vishwavidyalaya were invited as the external resource persons for the workshop. Prof. H. A. Ranganath, Director, NAAC, gave an overview of NAAC and conducted the proceedings of AIM. All academic staff of NAAC were also resource persons for the AIM. Dr. Jagannath Patil, Deputy Adviser coordinated the programme.

General - AIM

The Assessors' Interaction Meeting was held during November 23-24, 2010 at NAAC, Bangalore. Prof. H. A. Ranganath, Director, NAAC welcomed the participants. Prof. K. Sudha Rao, formerVC, KSOU; Prof. B. S. Sonde, former VC, Goa University and Prof. K. P. S. Unny, former Professor and Registrar, JNU were invited as Resource Persons for the programme. All academic staff of NAAC were also resource persons for the AIM. The programme was co-ordinated by Dr. M. S. Shyamasundar, Deputy Adviser. Prof. Goverdhan Mehta, Chairman, EC, NAAC had an interactive session with the delegates.

He called upon the assessors' to uphold highest standards of professionalism, ethics and Integrity in the course of their assessment and accreditation work. Prof Mehta called upon the delegates to give feedback on the current methodology process of NAAC and help modify and refine it so as to make it more accurate and objective. The 50 odd delegates comprising Vice Chancellors, Professors, Deans, Principals etc., from across the country shared their concerns and apprehensions with Prof Mehta and agreed to give constructive feedback to the NAAC processes.

NAAC-NCTE

The 3rd National Consultative Committee Meeting of NAAC and NCTE was held on 14 December 2010 at Board Room, NAAC. Prof. M. A. Siddiqui, Chairperson-NCTE, Prof. Chaudhary, Vice-Chairperson, NCTE, Prof. H. A. Ranganath, Director, NAAC and other members attended the meeting. Pressing issues regarding the assessment of Teacher training institutions were discussed during the meeting. Prof. Ranganath, Director, NAAC shared his concern regarding the convenient time for sending the peer team and logistics. It was further resolved that institutions which offer B.Ed., M.Ed. along with D.Ed., D.P.Ed., D.E.C.Ed. would be taken up for assessment by NAAC along with B.Ed., M.Ed. courses as single institution. It was also resolved that D.Ed., D.P.Ed. D.E.C.Ed. institutions would not be considered for assessment as they offer Diploma courses. During the meeting it was agreed upon that NAAC and NCTE would jointly organize awareness programmes on assessment and accreditation in different parts of the country. Director, NAAC suggested that NAAC may organise awareness programme in collaboration with regional offices of NCTE for Teacher Education institutions. It was further agreed upon funding that NAAC would provide assistance for the organization of workshops and awareness programmes. Dr. Ganesh Hegde co-ordinated the programme.

MCI-NAAC meeting

The Medical Council of India (MCI) had scheduled a meeting on March 16, 2011 by inviting experts from different organizations. The chairman of MCI requested the experts to develop Accreditation guidelines for Medical Colleges. During the meeting, the experts felt that NAAC's Manual for Health Science Institutions had been prepared by meticulously, which helped many HEI's in the country significantly. Accordingly various criteria for evaluating medical colleges had been identified and given to various experts for fine-tuning. Dr. M. S. Shyamasundar, Deputy Adviser attended the meeting.

3.8 Library and Information Services

The library continues to support the academic and research activities of NAAC through well resourced collection of books and subscription to scholarly journals-Indian as well as International. The library collection focuses on the core area of Quality, Assessment, and Accreditation in Higher Education. In addition to providing access to books and journals, the library also functions as repository of Self Study Reports. There are currently 5353 SSR's, RAR's archived in the library. Large number of people from different corners of India visits the library to consult the SSR's. During the year under review more than 684 academics from various colleges and Universities located across the country visited the library to consult these reports. Some of the international delegation visiting NAAC also visited the library.

All the In-house publications of NAAC are put on display at the library. Most of the visitors who come to NAAC have taken the opportunity to browse and buy many of these publications. Thus the library has been instrumental in showcasing the In-house scholarship of the NAAC and creating awareness about the academic/research work being carried out in NAAC.

During 2010-11 the library added 133 titles worth Rs.1,72/- lakhs for the benefit of the academics. The library subscribes to 62 International Journals. Besides subscribing to 62 print journals, Library also provides access to UGC-Infonet e-resources, which includes access to 4000 scholarly journals published all over the world. During the year under review the library renewed subscription to SCOPUS, the citation database from Elsevier. Elsevier provides access to 18,000 titles from more than 5.000 publishers all over the world. Academic Adviser extensively use Research productivity data from this source for assessment visits to Universities.

Future Plans for 2011-2012

The External Quality Assurance (EQA) Agency, NAAC has been continuously fine-tuning its assessment and accreditation methodologies along with local, regional and global changes in higher education scenario. This helps in reaching out to HEIs and wider acceptance of the methodology. The methodology of NAAC has stood the test of time for last 17 years, mainly because it has remained dynamic and responsive to the stakeholder feedback.

One of the major future plans is to review/relook/revise the existing methodology during the financial year 2011-2012, so that by XII plan period starting from 1^{st} April 2012 the revised methodology will be in operation.

NAAC continuously upgrades the existing ICT / e-infrastructure in the NAAC office in order to meet its mandate. NAAC extensively uses ICT in most of its academic, administrative and financial endeavor. As a step moving towards online assessment and accreditation process, NAAC has already introduced LOI and IEQA processes online. This online process has been continuously updated and upgraded.

In order to support the prime agenda of assessment and accreditation by NAAC, NAAC shall be looking into an high-end online enabled process of Assessment and Accreditation through the National Informatics Centre (NIC), Government of India (GOI) – for which the project is already ongoing. This is the second major future plan.

The third major initiative will be digitizing the existing the Self-Study Reports (SSRs), Peer Team Reports, etc for archiving, cross-referencing and retrieving purposes. The corollary will be submission of Reports also in digital format. This huge amount of data on higher education will help plethora of research activities at NAAC, which will result as inputs to policies.

With its prime agenda to assess and accredit institutions of higher learning in the country, the NAAC came into existence in the year 1994 as an autonomous institution of the UGC. Since then, the NAAC has been committed to the mission of upholding maintenance of standards and quality enhancement of higher education in the country.

Commitment and conviction on the part of the NAAC staff to motivate the people in the HEIs will be continued. This can be clearly seen by sheer of number of Universities and Colleges assessed and accredited by NAAC. It is an outstanding effort by NAAC to accredit 161 Universities and 4371 Colleges. NAAC will continue to reaching out to the HEIs in order to promote quality and quality culture among HEIs as a nation building exercise.

As stated in the previous year 16th Annual Report of NAAC 2009-2010 future plans for 2010-2011. NAAC has initiated the third cycle of assessment and accreditation. The projects on Programme Accreditation and NAAC Ranking of HEIs were continued.

A. Accounting Policies:

- The Accounts are prepared under the historical cost basis of accounting, on a going concern and on accrual basis.
- 2. The financial statements have been prepared in conformity with the generally accepted accounting principles.
- All significant accounting policies adopted in the preparation and presentation of this financial statement are mentioned hereunder:
 - (a) All Fixed Assets (including assets acquired out of UGC Grants) are stated at cost, which comprises of purchase price and attributable cost of bringing the assets to its working condition for its intended use. No depreciation is provided in respect of such assets.
 - (b) Assessment Fees, Appeal Fees for reassessment & accreditation and Interest on Fixed Deposits is recognized as it accrues. Other income such as sale of manuals etc., are recognized as and when collected/received.
 - (c) Revenue Grants received from UGC are recognised as income to the extent of the corresponding not expenditure of the period for which they are received.
 - (d) Interest on deposits with banks is treated as grants received from UGC.
 - (e) Liability in respect of leave encashment & Gratuity to employees is accounted at the time of payment.

B. NOTES TO ACCOUNTS:

1. NAAC is an autonomous body established under UGC Act with the objective of providing a forum that will encourage excellence in institutions of higher education, by providing a mechanism for the self-assessment in such institutions and assessment and accreditation by NAAC. For this purpose, UGC releases Grants to NAAC to meet the above objects in accordance with approved budgets relating to both Revenue and Capital.

- Depreciation has not been provided on assets as per University Grants commission (UGC) letter no. F.Misc./IA/2004-05 dated 27th Aug 2004.
- 3. Liability for payment of leave encashment & Gratuity to employees is not made in the books of accounts as the same is accounted at the time of payment. However, an amount of Rs.1,23,842/-, being leave salary received from IGNOU, New Delhi, on behalf of NAAC employees on deputation to be reimbursed to such employees on their resignation/retirement has been disclosed under the head "Current Liabilities".
- 4. NAAC maintains separate bank accounts & Books of Accounts in respect of employees & employer contribution to Provident Fund. The Balances as at the year end have been merged with NAAC's Accounts.
- All Balances pertaining to NAAC-Campus Project have been merged with NAAC's Accounts and previous year's figures have been regrouped accordingly wherever necessary.
- 6. The Fixed Assets, Refundable Deposits belonging to the NAAC- Quality Assurance cells which were hitherto treated as NAAC's Fixed Assets, Refundable Deposits have been charged off as part of Grants paid to the NAAC-Quality Assurance cells during the year.
- Previous Year and the Current Year figures have been regrouped wherever possible and have been rounded off to the nearest rupee.


