FOREWORD

The period under report saw the education sector preparing itself for the implementation of the New Education policy 2020 in true spirit and action. Indeed a historic move, NEP 2020 has also given an opportunity to align its objectives in the backdrop of COVID 19.

The board had to take tough calls during the Covid crisis surge, which led to indefinite closure of schools, disruption in on-going annual exams of class X and XII, postponement of other major professional exams, and most important of all, looking after mental well-being of students and teachers. It has finally proved to be a journey of grit, determination and resilience demonstrated by all stakeholders in the face of adversity.

Education is a great leveller and is the best tool for achieving economic and social mobility, inclusion, and equality and the broad vision of the New Education Policy 2020 provides for a quality education system for all students.

School education covers more than 15 lakh schools, 92 lakh teachers, and 25 crore children, out of these, CBSE has a fair share of approximately 26 thousand schools, 2 crore students and 9 lakh teachers. The impetus of the board remains on identifying newer ways and simplifying processes to ensure ease of doing business with the end goal of enhancing quality in every sphere of activity and creating global benchmarks.

The new pedagogical and curricular restructuring of 5+3+3+4 in NEP2020, covers ages 3-18. Schools must therefore ensure a caring, safe and stimulating environment. It expects a school to offer wide ranging learning experiences, good physical infrastructure and appropriate resources conducive to learning. The new Education Policy lays particular emphasis on the development of cognitive capacities - the 'foundational capacities 'of literacy and numeracy and 'higher-order' capacities, such as critical thinking and problem solving. CBSE on its part is in the process of preparing Structured Assessments for Analysing Learning (SAFAL), a framework for classes 3, 5 and 8. This competency-based system will test the foundational skills and learning outcomes with the intent to completely move away from rote memorization. The board has partnered with the Centre for Development of Advanced Computing (CDAC) to develop an online assessment tool.

Our schools have already adopted experiential learning, arts-and sports-integrated formats, as part of standard pedagogy, within each subject and among different subjects, to enhance essential learning and critical thinking. The new age subjects such as Artificial Intelligence, Design Thinking, Holistic Health, Organic Living, Environmental Education, Global Citizenship Education (GCED), have also been introduced at relevant stages to make education contemporary.

Looking at the uncertainties and unprecedented situation, the exams had to be cancelled midway. The Honourable Supreme Court of India took a view of the health and well-being of students and passed orders on 26.06.2020, approving the assessment scheme of CBSE for class X and XII to compute results on the basis of criteria, given in detail in the following pages of this report.

This brought to the fore the need for a standardised procedure of external and a systematic and transparent structure for internal assessment. The board has put an internal assessment system in place by dividing it into Pen and Paper Section, Multiple Assessment Activities such as Quizzes, Oral Tests, Projects, Portfolios, and Subject Enrichment Activities. This will reduce

stress generally associated with exams in students. The 2020 Board exam results also indicated increased pass percentage of students in maths as the Board started offering Mathematics at two levels Mathematics (Standard) and Mathematics (Basic) in Class-Likewise a new course on Applied Mathematics at class 11th and 12th has been introduced from the year 2020-21.

Talking of students, this year also board extended counselling facility to them but through an app which was named 'Dost for Life' as pandemic had disrupted regular tele-counselling. 83 volunteer principals and counsellors were part of this program out of which 17 were located at Saudi Arab, UAE, Nepal, Oman, Kuwait, Japan, Singapore and USA. Details of related activities are mentioned in the report.

The role of a teacher will remain most fundamental in bringing reforms and sustaining quality. Covid created a major learning crisis. CBSE confronted this challenge by increasing reliance on technology and innovations, making alternative arrangements for the training of teachers. More than 12 thousand online sessions of one hour duration were organised in the year 2020 in which more than 7 lakh teachers participated. The board also crowd sourced content from teachers to synergize schools and teachers from cities to the smallest villages with good quality e-content that can be used by them anytime, anywhere at no cost.

With a view to enhance the Ease of Doing Business, more than 150-200 compliances for affiliation to be followed earlier have been reduced and processing time has been drastically brought down with the help of a completely new automated and data driven affiliation system. An advanced version of the Online School Affiliation & Monitoring System (OSAMS) R-3.0 with end-to-end digitized system from submission of application for various categories of affiliation to the grant or rejection was also introduced alongside the "Virtual Inspection of School (VIOS)" system specially created during COVID restrictions.

To make the examination system more robust, a comprehensive one stop portal has been developed and implemented for all exam related activities. Results are being processed along with parallel collation of data to ascertain accuracy. A system for encryption, dissemination, decryption and printing of question papers for instant and secure delivery is in place to prevent any possible chance of leakage. The Confidential Material Tracking & Monitoring (CMTM) – Apps comes as an aid for electronic surveillance of highly confidential and sensitive materials, during board exams.

Technology was scaled up further for improving students' learning as well as for facilitation. At present, result data of X & XII examinees of seventeen years beginning 2004 to 2020 is available online for verification by employers and higher education institutions. Around 12 crore digital academic documents such as Mark Sheets, Migration Certificates and Pass Certificates are available at this repository called Parinam Manjusha. As an emergency response created in COVID situation to provide digital certificates to foreign students for their college admissions, Face Matching Technology has recently been added in Parinaam Manjusha as a second factor authentication.

CBSE in collaboration with Intel has prepared a self-paced learning program in Artificial Intelligence which is available in 11 different vernacular languages and compatible with various talkback applications used by visually impaired people. Further 11 skill modules of 12 hours duration for the students of classes VI-VIII, Coding for students of classes VI-VIII and Data Science for students of classes VIII-XII have also been introduced during this period.

CTET which was initially scheduled to be held on 5th July, 2020 had to be postponed due to widespread Corona Virus. It was finally conducted for 3058974 candidates on 31st January 2021 following all the safeguards. Examination centres were arranged in additional 23 cities for this purpose and the candidates were given the facility to change the city. The pass percentage of teachers in CTET has improved over last year; from 16.84% in July 2019 to 33.94% in January 2021. Further steps will be initiated to strengthen CTET as envisaged in NEP2020 with improved test items and mode of test.

NEP 2020 recommends that a sample based National Achievement Survey (NAS) of student learning levels will be carried out by the newly proposed National Assessment Centre, PARAKH with suitable cooperation with other governmental bodies-across government as well as private schools. The Steering Committee set up by Ministry of Education decided that the instrument development, testing, finalization of the test item, sampling will be done by NCERT while the actual administration of NAS in the sampled schools will be done by the CBSE. The survey could not be held in 2020 as per proposed schedule and was later conducted in 2021.

This year has been a litmus test for entire school fraternity as we grappled with the aftermath of pandemic, but our school system, teachers and students have braced through the challenge with resilience and hope. The board will make all out efforts to ensure uninterrupted and stress free learning and testing to best possible extent.

These changes have also been made possible with the help and inspiration of the Honourable Minister of Education, Minister of State (Education), Secretary (School Education & Literacy), all Heads of School Education Institutions, Members of Governing Body, members of all Committees, Principals, Teachers, Parents and media.

I would like to extend my thanks to all senior officers and officials of CBSE for the cooperation and support during these adverse times and withstanding challenges. I also appreciate Head Media & Public Relations and her team for this edition of the annual report.


26th National Annual Sahodaya Conference

"Building Competencies in Challenging Times"

The Bangalore Sahodaya School Complex hosted virtual conference on 11th and 12th December 2020 on the theme 'Building Competencies in Challenging Times'. The subthemes for this year's conference were: Technology as the substructure of all blended learning environments; Building on students' strengths and synergizing weaknesses as opportunities for improvement; Authentic and meaningful learning through integration of arts; Being mindfully Inclusive a step towards building bridges; Honing appropriate skills that build competencies for future readiness; Productive management of Mind and Heart with the Head; Research and inquiry as a powerful teacher driven tool to enact change in classrooms.

The conference saw the participation of 3800 members on the virtual platform, while more than 4000 members on YouTube and 5000 people on Facebook joined from schools across India and overseas.

The main recommendations of the conference were adoption of experiential learning pedagogies like integration of arts, sports, Lifeskills, craft, values, toys, stories, creation of an eco-system for ICT integrated teaching learning, implementation of recommendations of NEP 2020; redesigning curriculum, focus on inclusivity, designing of authentic assessment tools to offer constructive guidance for self-improvement.





Student Enrichment Activities

Expression Series

CBSE Expression Series on the theme 'Thinking Innovatively in Unprecedented Times like Covid 19' was held from 15th June to 21st July 2020 in CBSE schools. Participants could draw, paint, write a poem, essay or paragraph on the topics given for each category. In all 176667 students participated in this event.

Aryabhatta Ganit Challenge

To promote interest and proficiency among students through joyful assessment, Aryabhatta Ganit Challenge was conducted by CBSE. The Computer Based Test mainly focuses on the extent to which children are able to apply mathematics in their daily life. The feedback from the performance of the test helps the Board to handhold the schools and children in application of mathematics in daily life. This year's Aryabhatta Ganit Challenge started on November 12 and concluded on December 7, 2020. A total of 2.5 Lakhs students enrolled in this year's edition of Aryabhatta Ganit Challenge 1.8 lakhs out of these completed at least one module and 0.9 lakh participants completed 100% questions.

The CBSE Science Challenge 2020 through DIKSHA platform

As an initiative to generate curiosity, enquiry and higher order thinking amongst learners, the Board announced Science Challenge for students of classes 8th to 10th from 21st December 2020 to 11th January 2021. Students from class 8th to 10th from all Boards were eligible to participate in this challenge.

To access the challenge, students were required to join the 'CBSE Science Challenge 2020' course on the DIKSHA platform which helped the students to explore some aspects of science besides attempting the challenge itself. Participation certificates were issued online on DIKSHA platform upon completion of the course.

CBSE Heritage India Quiz

During the ongoing pandemic, CBSE modified the pattern of CBSE Heritage India Quiz and allowed the students to participate through an online portal. Ek Bharat Shreshth Bharat was included as one of the themes for this year's quiz scheduled for January 2020-21 and ecertificates were given to all the participants.

CBSE Expression Series on Art and Culture

In order to provide a platform to students to creatively express their ideas on Art and Culture CBSE conducted 2nd Expression Series for using pairing of States and Union Territories as per the Ek Bharat Shreshtha Bharat (EBSB) programme in January 2021. Each participant was given an online certificate of participation. Ten best entries in each category were selected at the regional level. 3 best entries under each category were selected and uploaded on the CBSE website.

Interaction Programme with Hon'ble Minister of Education

An Interaction Programme of the CBSE School Heads was organized with the Hon'ble Minister of Education Sh. Ramesh Pokhriyal 'Nishank' on 28th January 2021. The main aim of the programme was to sensitize the school heads about their role in the implementation of NEP 2020 at the grassroot level.

"New India Fit India"

Schools affiliated to CBSE are implementing two key initiatives Fit India School Certification System; and Fit India School Week involving students, teachers and parents. In Fit India School certification system, a total of 1,76,162 schools were awarded with the Fit India Flag. Further, a total of 33,083 and 11,745 schools applied for Fit India 3 Star and 5 Star School Certification respectively.

Fit India School Week was conceived with the imperative need of creating awareness about fitness not only for school going children but

also their parents, teachers and school staff. During present edition of Fit India School Week, various virtual activities like yoga, free hand exercises, painting, debates, symposiums, brain games like chess, Rubik's cube were organised among schools following the guidelines of COVID-19.

Khelo India Fitness Assessment

CBSE also adopted the Khelo India Fitness Assessment Program for School going children. 20,577 teachers from CBSE schools were trained to undertake Fitness Assessment in Schools and also train other schools.

Art Integrated Learning (AIL) to address stress issues related to school course/ syllabus/curriculum

Art Education and Art Integrated education has been made mandatory by the Board for all its affiliated schools. A document on the guidelines on Arts Integration-towards Experiential Learning was prepared containing details on the importance of Arts as a pedagogical tool for experiential and joyful learning, guidelines for Art-Integrated Learning for teachers and principals and a suggestive list of activities and projects for reference.

CBSE introduced mandatory Art-Integrated Project work for classes I to X to promote experiential learning. As part of this, at least one Art-Integrated Project in each subject shall be taken up by all students of classes IX and X from the academic session 2020-21, and students of classes I to VIII will also be encouraged to take at least one Art-Integrated Project (trans-disciplinary project) in a given academic year. More than 12.5 million students have submitted such projects.

Centre for Assessment

CBSE needs to build capacity to institutionalize systems required for implementing criterion-based assessment like PARAKH proposed in NEP2020 for which

Centre of Assessment has been set up at CBSE to set norms, standards and lay guidelines for assessment and evaluation in line with NCERT learning outcomes and monitor Learning Outcomes in the schools affiliated to CBSE. This Assessment Centre would be an initial step in the implementation of Competency Based Assessment. The Assessment Centre will also provide inputs for Key Stage Assessments in the backdrop of NEP-2020.

Improvement in Quality of Question Papers

Improvement in the quality of Question Papers was undertaken by increasing the proportion of higher order application oriented questions based on real life contexts. This has been done to reduce rote learning and shift focus on application of knowledge and skills.

Two Level Mathematics

The Board started offering Mathematics at two levels in Class-X and XII so that students who find mathematics challenging or daunting can have alternative easier option.

PISA 2022

The Ministry of Education (MoE) has signed an agreement with **Organization for Economic Co-operation and Development (OECD)** for India's Participation in Program for International Student Assessment - PISA 2022.

The schools run by Kendriya Vidyalaya Sangathan (KVS), Navodaya Vidyalaya Samiti (NVS) and schools in the UT of Chandigarh would be participating in PISA 2022. CBSE will be a part of the process and activities leading to the actual test for which the following initiatives were taken in 2020:

A. Creation of Resources for Teachers and Students

Practice Book on Mathematics was prepared.

- Teacher's Energized Resource Material (TERM) for Mathematics and Science for classes VI to X were released while the TERMs of English and Hindi was initiated.
- Teachers' Resource titled Achieving Learning Outcomes for classes I to X was released
- QR Coded PISA primers for parents detailing the key aspects of PISA were released.
- Competency-based questions for the CCT Weekly questions were created by CBSE, UT-Chandigarh, KVS and NVS. Education Initiatives (EI) contributed a pool of around 10,000 items for various classes.

B. Learners' Facilitation

- The Board organized the CBSE Science Challenge for students of classes 8th to 10th on DIKSHA in December 2020.
- CBSE Reading Challenge was organized for all CBSE affiliated schools in January 2021
- Creative and Critical Thinking (CCT) exercises were developed in English, Mathematics and Science.
- CBSE launched the CCT weekly practice for all CBSE schools under which 5 competency-based questions per week were uploaded on DIKSHA platform per student and teachers for practice.

C.Webinar on 'Enhancing Reading Comprehension Skills

A webinar for UT-Chandigarh teachers was conducted on 27th October 2020 and was streamed live on YouTube.

Three webinars were organized on 4th, 5th & 6th of September 2020 for parents of UT, Chandigarh to create awareness about PISA. 52,000 parents participated in these programmes over a period of three days.

D. Special Intervention for Identifying Learning Gaps

With the support of Pratham Education Foundation (PEF), CBSE initiated intervention for identifying learning gaps in students of UT, Chandigarh and tools for students in English and Hindi were piloted.

CBSE Survey

In a survey conducted by CBSE from July to October 2020, it was revealed that out of 13,527 schools responded:

- 10,799 schools (80%) had been conducting classes by using different modes like You tube, Zoom, WhatsApp, DIKSHA, offline mode.
- 9764 (71%) schools had ensured availability of textbooks for all their students.
- 11711 schools (87%) got their teachers trained online.
- 97 percent of teachers found distance education satisfactory.
- 88 percent of students found distance education satisfactory.
- 41 percent schools reported that their students were facing difficulty in learning Mathematics.
- 55 percent schools were sending Individualised Learning plans to children's home

In a second survey that began at the regional levels late October 2020, it came to light that

- 21,883 schools (around 90%) had successfully conducted internal survey for ascertaining learning gaps and reached out to their students in one way or the other.
- On an average around 15% of students reportedly showed some learning gaps
- Around 18% of students were not able to attend online classes.
- More than 90% schools in almost all the regions had taken measures to handhold students who were not attending online classes.

Regional Offices of the Board were involved in sensitizing the schools and monitoring of the efforts to reach out to students and address the learning gaps.

Major activities undertaken by schools to handhold students were:

- Personalized learning plans
- Regular contact with parents
- Learning through project work
- Sharing of learning content, sample papers and notes
- Personal home visits by teachers

- Sending recorded video lectures, worksheets and learning material
- Motivating students to attend school with the consent of parents to clear their doubts
- Sending letters to call parents if they were not responding telephonically
- Personal phone calls by teachers
- On demand one-to-one sessions with the students
- Continuous counselling sessions

To further sensitize schools after reopening, CBSE issued advisory to all schools to assess the learning gaps in a non-threatening formative way and accordingly prioritize remedial measures wherever needed. Schools were suggested to plan remedial sessions in blended mode to address the deficit in learning in a time bound manner as children and teachers were familiar and exposed to online methods.

Activities carried out to bridge the Learning Gaps in Students

(i) Learning Enhancement during COVID-19 Guidelines for continuous learning:

NCERT prepared guidelines on Learning Enhancement (LE) focusing on students without digital devices, with limited accessibility to digital devices and with digital devices. CBSE advised schools to adopt these guidelines for addressing the learning gaps in their students and optimise their learning achievement.

(ii) Special capacity building of teachers on how to conduct online classes where feasible

CBSE trained 5,50,000 teachers (from April till December 2020) on different areas including online pedagogy. Several bite-sized modules were also prepared and disseminated post training to augment the capacities of teachers. 403634 teachers were also trained under NISTHA program of the Government of India.

(iii) Alternative Academic Calendar The week-wise plan published by NCERT

consists of learning activities based on chapters in textbook mapped with learning outcomes to facilitate teachers to transact and assess the progress in students' learning. CBSE organised an online orientation programme on Alternative Academic Calendar on 17th July 2020 for its effective usage by the teachers. This programme was live streamed and viewed by around 2,55,000 teachers and principals.

(iv) Rationalisation of Syllabus

CBSE came out with reduction in syllabus only for the purpose of summative examinations as a temporary measure for this year only, to mitigate the effect of lockdown and in the context of closure of schools and reduction of face-to-face instructional hours. The Committee of Courses for each subject, considered the following while rationalizing the syllabus contents because of the necessity and observed:

- (a) All topics are important but in this extraordinary situation, certain topics which students have already studied or students will study in detail in higher classes may be omitted from summative assessments. Teachers can discuss these topics as required.
- (b) The topics/concepts which have minimum impact on future learning can be omitted for the purpose of Board Examination..
- (c) Appropriate changes in Practical components as per revision need to be done.
- (d) Teachers are expected to integrate those concepts which are not part of the revised syllabi in class in relation to previous and subsequent topics.

Special resources for teachers during COVID:

(v)Learning Outcomes mapped to Curriculum

CBSE took up the task of mapping each of the Learning Outcomes laid down by NCERT (for all subjects till class X) with the topics in the prescribed textbooks to facilitate teachers to further their understanding of competency-based education, and apply the same to their efforts during the pandemic. (vi) Teacher Energized Resource Material or TERM

Handbooks for two subjects – science and mathematics– covering entire syllabus of grades 6 to 10 were prepared to help teachers in aligning their classroom transaction to a competency framework. The concepts have been linked to the NCERT Learning Outcomes with a set of assessment items.

(vii) MOOCs modules on experiential learning and competency-based education

Activity-based and highly engaging modules were prepared on the pedagogies related to experiential learning and competency-based education and the need to integrate real-life situations into the teaching and learning process. https://bit.ly/cbse-explrn-wb https://bit.ly/CompetencybasedEducation

(viii) Vidyadaan:

VidyaDaan-2 was launched in April, 2020 as a national content contribution program that leverages the DIKSHA platform and tools to seek and allow contribution or donation of elearning resources for school education by educational bodies, private bodies, and individual experts. So far, CBSE has received 8592 pieces of content in English language as contribution.

(ix) PRAGYATA Guidelines on Digital Education

These guidelines were developed with a focus on online or blended, digital education for students who were at home due to the closure of schools. The guidelines recommend screen time for different categories of students. It also provides sufficient Do's and Don'ts regarding ergonomics and cyber safety. (x) Olabs

CBSE organised virtual training for the

Mathematics, Biology, Physics and Chemistry teachers of its affiliated schools on Olabs in which 22,000 teachers participated. Online Virtual Labs (OLabs) is a platform that teaches lab experiments using the internet. Content at Olabs is aligned to NCERT/CBSE and State Board Syllabus. https://olabs.edu.in.

(xi) Comic books for students on 21st century skills

To ensure that learners continue their learning through joyful means and acquire 21st century skills even during the pandemic, two comic books were released online for school going children by CBSE. These help the learner imbibe critical thinking and problem solving skills through the storyline. http://cbseacademic.nic.in/web material/ComicBooks/Cogito.pdf

(xii) Practise book on Mathematical Literacy

CBSE came out with a unique Workbook – **A Little Mathemagic** – a practise book for students for enhancing critical and creative thinking skills. This book is meant for elementary school children and takes the child through the world of mathematics through stories, adventure, fun and humour.

(xiii) Cyber Safety and Cyber Bullying

In order to orient students to safe internet use and sensitize about cyber bullying, a student-friendly Handbook on Cyber Safety – for students of secondary and senior secondary schools, has been prepared by CBSE. This handbook contains content in very engaging and simple formats, with econtent tagged to QR codes at several places to augment the understanding of the student further.

(xv) Social Empowerment through Work Education and Action (SEWA)

CBSE has introduced compulsory a component area of Social Empowerment through Work Education and Action (SEWA) under Health and Physical Education. It focuses on the mental, emotional and social health of the children by letting them do community service, learning environmental, civic responsibilities, democracy or health and fitness through related projects. All students of classes IX to XII (for XII, till end of the first semester/ term) participate in SEWA program round the year. Each year around 60 lakh students carry out these projects.

(xvi) Suggestions to make quarantine period more productive

CBSE also suggested a few activities related to annual planning, student enrichment and teacher enrichment for making quarantine period more productive like defining learning outcomes for different subjects and classes; preparation of annual curriculum plans for scholastic and co-scholastic activities; designing special activities for CWSN; developing e-content for DIKSHA; writing of blogs on best practices by teachers.

(xvii) Special interventions for inclusion

CBSE issued advisories for teachers on making lockdown productive, to plan and integrate activities considering the needs of CWSN. Schools were advised to ensure that all children with special needs and children whose parents were involved in essential services (health care professionals) continued to receive quality education as per their specific needs for accessible and adapted learning. Some of the suggestions for schools in this regard were:

- (a) Approach each special child and assess individual needs and discuss adjustments needed for learning.
- (b) Use alternatives to print, such as audio or other formats in instruction, pictures, captions, larger prints and sign-language options in all forms of the learning material (virtual, printed or broadcasted) depending upon the need of the students.
- (c) Use flexible scheduling and deadlines, assistive technology, simplified homework and formative assessments to alleviate the pressure on students and parents.
- (d) Guide and train teachers and provide them evidence-based resources on how to teach children with special needs in remote and online settings.
- (e) Support parents by offering expert advice of special educators and counsellors.
- (f) Follow the Pragyata guideline's section 3.4 for insights on supporting online learning of Children with Special Needs.

National Education Policy 2020

The Union Cabinet chaired by the Hon'ble Prime Minister paved way for transformational reforms in school and higher education systems in the country.

This is the first education policy of the 21st century and replaces the thirty-four year old National Policy on Education (NPE) 1986. The New Policy is built on the foundational pillars of Access, Equity, Quality,

Affordability and Accountability.

This policy is aligned to the 2030 Agenda for Sustainable Development and aims to transform India into a vibrant knowledge society and global knowledge superpower by making both school and college education more holistic, flexible, multidisciplinary, suited to 21st century needs and aimed at bringing out the unique capabilities of each student.







AI Integrated Multi-Disciplinary Pedagogy

CBSE has introduced Artificial Intelligence as a multi-disciplinary integrated pedagogical approach to further enhance teaching and learning. A handbook titled 'Artificial Intelligence Integration across Subjects' has also been prepared in this regard. A new set of 200+ multi-disciplinary AI integrated lesson plans have been compiled to enhance teaching and learning for each of the five core subjects — Hindi, English, Maths, Social studies and Science for classes VI - X.

These lesson plans have been released as handbooks for the use of schools and are available on the DIKSHA website (http://bit.ly/aiondiksha), as well as on the CBSE academic website (http://cbseacademic.nic.in/ai.html).

- 103 student projects (260+ students) were selected for mentoring by IBM AI experts as part of the hackathon and these projects were on boarded to the Hacker Earth mentorship platform. After intensive mentoring, the final of the hackathon was organized on 7th and 9th July where the students presented their project prototypes to a panel of judges from IBM.
- Top 3 projects were selected as winners of the Hackathon and the top 15 projects were selected to participate in the IBM EdTech Youth Challenge India 2020 providing them the opportunity to do a 2-week internship with IBM. The virtual internship was also provided to the selected students.



Virtual Professional Development Sessions "Canada series-Innovate and Inspire" July 20-24, 2020 were conducted for CBSE School Leaders and teachers.



The National Education Policy 2020 recommends a 'light but tight' regulatory framework to ensure integrity, transparency, and resource efficiency of the educational system through audit and public disclosure while encouraging innovation and out-of-the-box ideas through autonomy, good governance, empowerment.

Keeping this in view e-Affiliation system of the Board was restructured as SARAS and implemented from March 2021.

Business Processing Re-engineering (BPR) of affiliation system has been automated with least human intervention. It has the following features.


Integrated Payment System – IPS

One of the mandates for CBSE is to conduct public examinations. Besides Class-X and Class-XII examination, CBSE also conducts competitive exams such as JNVST, CTET and Recruitment Tests. Thousands of faculty members from various schools and institutions perform different examination related duties every year and paid honorarium and TA/DA.

In addition to this several principals and educational administrators inspect various CBSE Schools for affiliation or upgradation every year. They are also paid honorarium and TA/DA. Till 2020 the process of payment was manual and based on submission of various bills subject to various norms.

An Online Normative Payment System "(IPS) Integrated Payment System" has replaced the old practice after successful transfer for CTET January 2021 examination.

Online School Affiliation & Monitoring System R-3.0 (OSAMS)

The existing Online School Affiliation Management System (OSAMS) was also reengineered according to new requirements. This system caters to all types of applications for fresh affiliation, upgradation, extension of affiliation and additional subjects.

The application status is available on real time basis. New features such as algorithms and business rules-based shortlisting or scrutiny of applications, self-assessment by schools and points-based grading based on inspection reports have been added regularly.

Automatic IC Allocation System R-2.0 (AICA)

A system for automatic allocation of Inspection Committees based on pre-defined parameters and business rules. In case of refusal by member(s), school can change committee member(s) with a click of mouse.

School Area Measuring App (SAMA App) & Web Portal R-1.0

A mobile app and a web-based application to measure school area virtually as well as physically. The web application has been integrated with 'SARAS', however Mobile App is available for IC members going for physical inspection.

Virtual Inspection of Schools (VIOS)

Due to current COVID-19 pandemic, schools were closed and the Inspection Committees were not able to proceed for the inspection. Keeping this in view "Virtual Inspection of School (VIOS)" system was developed and implemented.

Online Affiliated School Information System R-3.0 (OASIS)

A portal for CBSE affiliated schools to submit or update online information against 500+ parameters annually. The information gathered through this portal is being used by CBSE in assessing schools for their potential usage for various activities. This is single source of truthful data for all applications pertaining to various domains across CBSE.

IT in Exam Processes

(e-परीक्षा): Examination Processing & Management System R - 3.0

Entire examination system of the Board has been digitalized. A comprehensive one stop portal has been developed and implemented for all exam related activities. Results are being processed simultaneously and parallel collation of data or results is being done to ascertain accuracy.

e-IG-Online Internal Grades Uploading and Validation System R-3.0

A portal for uploading of Class-XII Internal Assessment Grades data by the schools.

e-Prac R - 3.0

A portal for online submission of Class-XII Practical or Project Marks and geo-tagged lab images with students and examiners (both internal as well as external).

IAPX -R-3.0

A portal for online submission of practical, projects and internal assessment marks of Class-X by the schools.

e-Theory R-3.0

An online system for bag allocation to Chief Nodal Supervisor, distribution of blank award lists, question-wise theory marks uploading, evaluation monitoring and online generation of award lists.

TETrA: Theory Evaluation Trend Analysis R-2.0

A unique portal and Decision Support System based on Real Time Evaluation Monitoring. Evaluation trend can be visualised, analysed and monitored in this system. This also generates various statistical data and gives graphical representation in real time.

Exam Centre Locater App R-2.0 (ECL)

A mobile app to facilitate CBSE examinees of both Board as well competitive exams through which they can locate their examination centre by just entering exam and roll number This mobile app also guides them to reach the exam centre by giving shortest route based on real time traffic data.

Online Encrypted Question Paper Delivery System R-2.0 (OEQPD)

A system for just in time encryption, dissemination, decryption and printing of question paper for instant and secure delivery of QP to prevent any possible chance of leakage.

Online Exam Centre Management System R-3.0 (OECMS)

Comprehensive Decision Support System comprising of a portal and backend system to get real time information about centres and conduct of exams including feedback about the question paper(s), packing of answer books and dispatch, information about observers.

Re-Engineered Outlier System for Examination (ROSE) R-3.0

Unique Software to finely detect inconsistent marks cases at pre-result declaration stage for remedial action at RO level.

Modular Computerized Result Compilation system R-2.0 (MCRCS)

Digital Lockers in respect of all the students appearing for Board Exams are being opened in advance and their digital academic documents i.e. Marks Sheets, Migration Certificates and Pass Certificates are being pushed on the day of declaration of results. The credentials are being communicated on the registered mobile numbers of the students available with the Board. This is being done from last five years.

Face Matching Technology in Parinaam Manjusha

CBSE is authorized to provide digital mark sheets to its students after proper authentication as prescribed in the IT Act 2000. The facial matching technology has been created as one of the emergency responses in COVID situation to provide digital certificates to foreign students for their college admissions. CBSE is using facial recognition for multi-factor authentication before providing digital mark sheets to students. Face matching is performed with the already available photographs on CBSE admit card. The face match authentication has been added as a second authentication in the same system for foreign students where mobile OTPauthentication cannot be performed on foreign mobile numbers.

Development of unified dashboard a for all types of statistics.

Data sharing through API with various academic and admission bodies.

Online Verification of Evaluation & Revaluation System R-3.0 (OVERS)

A computerized system for post result marks verification, photocopy and re-evaluation of answer sheets.

Statistical Information System R-2.0 (SIS)

A system for compilation of variety of statistics pertaining to results. Due to implementation of this system, variety of statistics could be provided to media and other agencies immediately after declaration of results of Class X & XII.

e-**हरकारा** - Rapid Communication System for School

A portal for schools, through which they can communicate issues with the appropriate authority of the Board directly and can track the status of requests. The concerned authority can address the issue online directly. This initiative was taken during COVID lockdown.

e-Sandesh Portal

A Portal to send bulk SMS and E-mails to various stake holders such as Schools, Principals, Teachers and Students during COVID lockdown.

A Counselling App "DOST for Life" during Covid-19

CBSE launched a new app for psychosocial wellness of students of classes IX-XII during the pandemic. Making a departure from the existing practice of counselling through toll free number across the country, board designed this facility for the ease, convenience and utility of students and parents within the safe home environment.

CBSE New Website

The website was redesigned to make it more user friendly with easy navigation.

Art-Integrated Exemplar Portal

A portal for CBSE Affiliated schools to facilitate teachers and principals for implementing experiential and joyful learning in classroom. Through this portal, teachers can research, innovate, and create unique exemplars and showcase their skills of creativity and innovation.

The Portal aims to capture the pedagogical plan of a teacher's vision of the teaching learning process in classroom to action. It imbibes all thinking, preparation and steps of execution involved in making each stage of curriculum transaction meaningful and comprehensive for students.



CBSE declared Bronze partner for UMANG Initiative

On the occasion of the third anniversary of the Unified Mobile App for New-Age Governance (UMANG), an initiative of the Ministry of Electronics & Information Technology (MeitY), CBSE has been announced as a Bronze Partner for the year. The award was announced by the Hon'ble Minister of Communications, Electronics and Information Technology and Law & Justice Shri Ravi Shankar Prasad. CBSE has been collaborating with UMANG for the release of results and instructions for exams.





Examinations

The CBSE Board Examinations were scheduled to be conducted for Class X and XII from 15.02.2020 till the end of March 2020 however, due to the wide spread of Covid-19 pandemic, CBSE had to postpone examinations.

Looking at the uncertainties and unprecedented situation and keeping in mind the health and well-being of students, the Hon'ble Supreme Court of India passed orders on 26.06.2020, approving the assessment scheme of CBSE for class X and XII to compute results on the following criteria:

Assessment Scheme

- a) "For the students of both classes X and XII, who have completed all their examinations, their results will be declared based on their performance in the examinations.
- b) For students who have appeared in the examinations in more than 3 subjects, the average of the marks obtained in best three performing subjects will be awarded in the subjects whose examinations have not been conducted.
- c) For students who have appeared in the examinations in only 3 subjects, the average of the marks obtained in the best two performing subjects will be awarded in the subjects whose examinations have not been conducted."

One additional criteria was also approved by the Hon'ble Supreme Court of India for Class XII as mentioned below:

d) "There are very few students of class-XII, mainly from Delhi, who have appeared in the examinations in only 1 or 2 subjects. Their results will be declared based on performance in the appeared subjects and performance in internal, practical or projects assessment. These students will also be allowed to appear in the optional examinations conducted by CBSE to improve their performance, if they desire to do so. Result of these students will also be declared along with other students."

Chance for Optional Examination

Candidates whose results were declared based on the assessment scheme were allowed to appear in the optional examinations to improve their performance, if they wished so. Marks obtained by a candidate in these optional examinations were to be treated as final for those who had opted to take these examinations

Replacement of Term Fail by Essential Repeat

CBSE has replaced the term "Fail" by the term "Essential Repeat". Hence, in the result declared "Fail" was not mentioned in the documents issued to the candidates and the result hosted on the website.

Board Exam Result 2020:

The result was declared on the basis of assessment scheme. The result of Class XII was declared in record time on 13.07.2020 while the Class X was declared on 15.07.2020.

Certificates In Digilocker

Candidate's digital mark sheet, passing and migration certificates, skill certificates were available in Digilocker. The Digilocker account credentials were sent to students via SMS on their mobile number registered with CBSE.

The certificates could also be downloaded from the DigiLocker mobile app available at Google Play.


CBSE Post-Result Tele-Counselling





Region Wise Number of Registered Candidates - Class X 2020






Camparison of Pass% of candidates - Class X 2020





Genderwise Pass % of candidates - Class X (2019-2020)






Region Wise Number of Registered Candidates - Class XII 2020

14th Edition of Central Teacher Eligibility Test (CTET)

Initially scheduled to be held on 5th July 2020, the test had to be postponed due to widespread Corona Virus. It was finally conducted on 31st January 2021 following all the compliances and instructions issued by the Government of India at examination centers across the country. The Covid-19 guidelines were communicated to all the candidates.

To maintain social distancing and ensure other Covid-19 prevention measures, the Examination centers were arranged in additional 23 cities and the number of cities were accordingly increased from 112 to 135. In order to avoid inconvenience to the candidates, the board gave the facility to change the city and every effort was made to accommodate the candidates at exam centres of the cities opted by them.

CTET examination consists of two papers. Paper – 1 for teacher eligibility for class 1st to 5th while Paper – 2 is meant for ascertaining the eligibility for class 6th to 8th teachers. The candidates, fulfilling the prescribed qualification, may appear in either or both the papers and choose any two languages out of prescribed 20 languages.

Marksheets through Digi-locker

CBSE creates DigiLocker accounts of the all present candidates and the account credentials are conveyed to the candidates on their mobile numbers registered with CBSE. The candidates can download their digital mark sheets and eligibility certificates using the communicated credentials.

Advantages of Digi-locker

The mark sheets and eligibility certificates in such digital format, are convenient for everyone as they can be shared electronically anywhere, anytime.

To enhance security, the mark sheet and certificate contain an encrypted QR code, which can be scanned and verified using the DigiLocker mobile App.

The digitally signed mark sheets and eligibility certificates are legally valid as per the IT Act. Incorporation of technology in examination related activities is an empowering step of the Board towards environment protection. With these efforts, the board is committed to save huge amount of money and valuable resources like paper, trees, water and reduce carbon emissions.


15th CTET in CBT mode

Professional Examinations

National Achievement Survey - Preparatory Works



NEP 2020 under Para 8.10 states that "For a periodic 'health check-up' of the overall system, a sample-based National Achievement Survey (NAS) of student learning levels will be carried out by the proposed new National Assessment Centre, PARAKH with suitable cooperation with other governmental bodiessuch as the NCERT-that may assist in assessment procedures as well as data analysis.

The assessment will cover students across government as well as private schools. States will also be encouraged to conduct their own census-based State Assessment Survey (SAS), the results of which will be used only for developmental purposes, public disclosure by schools of their overall and anonymized student outcomes, and for continuous improvement of the school education system. Until the establishment of the proposed new National Assessment Centre, PARAKH, NCERT may continue to carry out NAS.

The Ministry of Education vide its OM F.No.19-4/2019-IS-8 dated 18th February 2020, constituted a Steering Committee and decided that the instrument development, testing, finalization of the test item, sampling will be done by NCERT while the actual administration of NAS in the sampled schools will be done by the CBSE. This has been done to ensure smooth, centralised conduct and quick compilation of result of the survey with high degree of reliability.

The NAS 2020 was earlier envisaged for conduct in the year 2020.

However, as the COVID pandemic struck, the preparatory work could not be initiated due to lockdown. Consequently, the NAS 2020 was deferred for the year 2021 and the date for conduct of NAS as 12th November, 2021 was notified to all the States / UTs by the Ministry of Education vide letter dated 28th October 2020.

The NAS-2021 is expected to cover around 733 Districts across the Country. More than 34 lakh children would be taking up this nation-wide survey which would be conducted on one single day on 12th November 2021 for all the target grades III, V, VIII and X.

Considering the enormity of the tasks, all preparatory works are underway. The PAB has approved the required fund allocation for both CBSE and the NCERT. The NCERT has been entrusted with the responsibility of developing assessment framework, instrument development, testing, finalization of the test items, sampling of the schools.


The sampling plan is being finalized by the NCERT and UNICEF in consultation with the DDG (Statistics).

The Professional Examination Unit of the CBSE is handling NAS administration part. It has already initiated required preparatory work such as identification of people to be engaged as District Level Coordinator, Observers and Custodians.

The Board is also coordinating with the NIC for necessary IT support for data management relating to NAS-2021. The Board would be conducting training programme for various functionaries. The training for Field Investigators would be conducted by the NCERT with the support of SLMT and others for which specific action plan will be developed in due course. The Field Investigators would be appointed by the state or UT machineries as per the modalities to be provided in due course.

Class IX Lateral Entry Test

CBSE also conducted Class IX Lateral Entry Test for admission in JNVs on 24th February 2021.



<u>Conduct of JNV Selection Test (JNVST-2020) Phase II (November 2020)</u>

The CBSE as part of its obligation under MoU entered with the NVS, conducts the selection test for admission in Class VI in JNVs across the country. In the year 2020, the JNVST was conducted in two phases.

The first phase exam (summer bound) was held on 11.01.2020. The 2nd phase (winter bound) was scheduled on 11.04.2020 and had to be deferred due to COVID pandemic. The test was rescheduled and conducted on 07.11.2020.

CBSE COVID-19 Response System

Committed and united: The CBSE COVID-19 Response Team

With the surge in cases during the second wave of COVID-19 in the country, CBSE had put in a system for helping the staff and their families.

- A COVID response team was formed at CBSE Headquarter consisting of representatives from each unit of the office.
- Daily health reports were collected from all CBSE employees, through their respective department groups. Positive cases were passed on to the CBSE Covid Response Team, for further medical assistance or hospitalization, when needed.
- Entire information was maintained in a format. One nodal person was deputed for 3-5 cases to monitor and report to the Covid Response Team twice daily.
- A facility was put in for tele medical consultation so that the affected staff could decide on the next course of action based on medical advice.
- The Covid Response Team made proactive efforts for finding a bed in hospitals and were able to do so in all the cases requiring hospitalisation.
- Administrative arrangements were made for COVID-19 management. CBSE management and senior officers took daily meetings to take the stock of situation. A high-level committee was empowered for quick decision making.
- CBSE staff also gave voluntary financial contribution for meeting expenditure on essential medical equipment.

- Separate WhatsApp groups were formed for COVID response Team, COVID affected people and COVID recovered people.
- These WhatsApp groups helped in live tracking of health of affected people and recovered people. Important instructions were shared on live basis in these groups.

No Shortage of Medical Equipment

- Essential medicines and equipments like oxygen cylinders, kits, concentrators, oxymeters and thermometers were procured in sufficient number for employees and family members.
- An ambulance fitted with Oxygen support was hired 24*7 for emergency use and a team of officials was trained.

Physical and Mental Health Care during and post Covid

- A panel of Physicians and Counsellors was formed and all requests of employees seeking consultation for themselves or immediate family members were sent for evaluation of medical reports or second opinion to the panel of Doctors.
- A team of Counsellors were arranged to counsel the people post recovery for staff and their family members with the purpose of normalizing the situation.



CBSE Counselling Program CBSE initially started this counselling programme 24 years ago in 1998, by offering telephonic counselling, which is now extended to different modes and verticals.

CBSE Counselling is an annual flagship program of the Board, which aims to facilitate different categories of secondary and senior secondary students and other stakeholders at national and international level through free of cost pre and post exam counselling.

Multi level psychological counselling for students and parents presentations is being provided by CBSE through live counselling sessions over phone, app, IVRS and Audio-Visual presentations.

Traditional and advance modes of communications and outreach have been adopted by CBSE to achieve this objective. In 1998, 24th years ago CBSE started initially this counselling programme by offering telephonic counselling, which is now extended to different modes and verticals:

During the report period (2020) online counselling was conducted through Centralized Call Centre in India where in 73 volunteer principals, counsellors, special educators in the country and 22 across other countries provided free of cost services to the students and parents.

Mental Health And Wellbeing Manual

The Mental Health and Wellbeing Manual was released by the Honorable Minister Education on 21.07.2020. The manual emphasizes on the importance of Mental Health and Well Being and encapsulates the role of school, family and community while covering other significant aspects related to health conditions, risk factors and challenges in adolescent period.





It has chapters on risk factors and challenges in adolescent period, special chapter on providing psychological support amidst COVID-19 effects while covering aspects of self care, positivity, dealing with fear and anxiety, dealing with stigma, importance of social support and staying connected with the help of available resources.

CBSE Dost For Life: A New Counselling App for psychosocial well-being of students

In another first CBSE launched a new app for psycho social wellness of students of classes IX-XII during the pandemic. In addition to the existing practice of tele counselling through toll free number across the country, this facility was designed for the ease, convenience and utility of students and parents within the safe home environment.

Counselling Sessions – The App simultaneously caters to students and parents from CBSE affiliated schools at different geographies across the world. The live counselling sessions were conducted free of cost, thrice a week on Monday, Wednesday & Friday by the trained Counsellors and Principals. This year there were 83 volunteers out of which 66 were in India and 17 located at Saudi Arab, UAE, Nepal, Oman, Kuwait, Japan, Singapore and USA.

The students and parents could choose any of the two time slots: 9.30 am - 1.30 pm or 1.30 pm - 5.30 pm and connect through a Chat Box as per their convenience.








Affiliation

One of the main functions of CBSE is to affiliate schools.

The Board has established its presence in 26 countries through 259 schools, 256 of these are private schools and 3 are Kendriya Vidyalayas.





The National Education Policy 2020 recommends a 'light but tight' regulatory framework to ensure integrity, transparency, and resource efficiency of the educational system through audit and public disclosure while encouraging innovation and out-of-the-box ideas through autonomy, good governance and empowerment (NEP 2020).

It further recommends that "The over emphasis on inputs, and the mechanistic nature of their specifications – physical and infrastructural - will be changed and requirements made more responsive to realities on the ground, e.g., regarding land areas and room sizes, practicalities of playgrounds in urban areas, etc. These mandates will be adjusted and loosened, leaving suitable flexibility for each school to make its own decisions based on local needs constraints, while ensuring safety, security, and a pleasant and productive learning space. Educational outcomes and the transparent disclosure of all financial, academic and operational matters will be given due importance and will be incorporated suitably in the assessment of schools. This will further improve India's progress towards achieving Sustainable Development Goal 4 (SDG4) of ensuring free, equitable, and quality primary and secondary education for all children. The aim of the public-school education system will be to impart the highest quality education so that it becomes the most attractive option for parents from all walks of life for educating their children (NEP, 2020)".

Re-structuring the CBSE Affiliation Systems

Beginning 1st March, 2021, the entire affiliation process was reengineered in consonance with NEP 2020. The new system is focussed to:

- Achieve the goal of minimum government maximum governance,
- Reduce compliances,
- Enable data driven decisions,
- Achieve transparency,
- Avoid data redundancy,
- Collection and analysis of data through single source and to
- Achieve quick and time-bound disposal of all application.

The timelines for applying under various categories of affiliation will be revised from 2021 onwards and applications are now being received from 01.03.2021 onwards and will continue throughout the year.

Facilities

Reliance on Self Certification

The application will be processed based on system generated self-certification submitted by the school.

Accountability of Inspection Committee

The accountability of the Inspection Committee will be fixed based on refusal to perform inspection, deliberate misrepresentation of facts, misconduct, non-conduct of inspection on fixed date(s), delay in submission of reports.

Minimalizing of Manual Interference

The processing of applications for affiliation will be end to end online with focus on minimalizing of manual interference.

Data Driven Scrutiny

The application will be securitized digitally based upon data, documents and information uploaded by the school to reduce manual intervention in processing of applications or reports.

Reduction of fee in certain categories

The existing application fees has been reduced by 25% of existing fees in certain categories.

Withdrawal of inspection for certain categories of Affiliation

The Board has withdrawn provision of inspection of school for certain categories. The school will get approval or permission automatically after submission of application with mandatory documents, data and information.

Period of Affiliation

The period of initial affiliation or upgradation granted to school has been increased from 3 years to 5 years.

Introduction of Virtual Inspection

Provision of Virtual Inspection has been introduced for certain categories of applications in respect of existing schools in order to reduce time lag for in decision making.

Period of receipt of application for Affiliation

The link for submission of applications for various categories shall be operational three times in a year instead of one time slot.

Online Affiliation School Information System (OASIS)

CBSE utilizes the information received in the Online Affiliation School Information System (OASIS) for various academic, examination and training purposes. Hence, it is mandatory for the affiliated schools to update the information about faculty, students, academic and infrastructure annually.

Virtual Inspection of Schools (VIOS)

As per provision under Clause 10.1.10 and 10.2 of Affiliation bye-laws, the Board appoints inspection committee for physical inspection of schools which apply for Upgradation of Affiliation.

In view of Covid-19 situation the schools were not fully functional and in cases where schools were already affiliated with the Board, Virtual Inspection of more than 300 schools was conducted.

Merit Scholarship Schemes In order to promote meritorious students from socially and economically weaker sections and girls, the Board has following scholarship schemes:

Central Sector Scheme of Scholarship for College & University Students (CSSS), sponsored by MOE

On behalf of Ministry of Education, CBSE invites, processes and upload applications on PFMS portal of Government of India (MoE) for award of 6854 Scholarships every year. This scheme is full sponsored by MoE, Government of India.

The scheme is aimed at extending a helping hand to meritorious students of economically weaker families for continuing their education at UG or PG level. The students whose parents' income is less than ₹ 8 lakh (Eight) per annum and have scored minimum cut off (80 percentile) in class XII are eligible for availing scholarship under the scheme. The scholarship is distributed in the ratio of 3:2:1 for Science, Commerce and Arts schemes. Eligible students are offered scholarship ₹10,000/- per annum at Graduation and ₹20,000/- per annum at Post Graduation level for 10 months in a year.

Single Girl Child Merit Scholarship Schemes

The Board has scholarship for Single Girl Child pursuing her education at class XI and XII who has passed class X from CBSE affiliated schools. This scheme is fully sponsored by CBSE. Girl students who are the only child of their parents and have scored 60% or more are eligible for the award, where school fee does not exceed ₹ 1500/-. A sum of ₹ 6,000/- per year is awarded to each scholar and there is no limit for numbers of scholarships.

Board Merit Scholarship Scheme for SC/ST students

The Board offers financial assistance of ₹250/- per month to 23 students of Class X and ₹500/- per month to 25 students of Class XII belongings to SC / ST community. The scheme is fully sponsored by CBSE.

Scholarship Scheme for the wards of employees of CBSE

To promote meritorious wards of the employees of the Board and provide scholarship to: Class VI-VIII ₹ 700/- per month, Class IX-XII ₹ 900/-per month.

(Late) Sh. Lakshman Singh Kothari Memorial Award

Sanjay Kothari Family Charitable Trust, New Delhi has instituted a running trophy, in the name of Late Sh. Lakshman Singh Kothari in association with CBSE with a cash reward of ₹10,000/- for the student, who secures maximum marks in five subjects taken together in Class XII Examination conducted by the CBSE. The award is given from the corpus fund provided by the trust. The felicitation function this year was held on 13.08.2020 at CBSE Headquarter and awards were given to Divyanshi Jain & Tushar Singh.

Propagation of Official Language

The Official Language Implementation Committee constituted in the Board, is headed by the Chairman, CBSE. The meeting of Official Language Implementation Committee is organized every quarter. The representatives of the Ministry of Education and the Regional Implementation Office of Department of Official Language are also invited in these quarterly meetings.

Annual Incentive Plan

In order to promote the use of Hindi an annual incentive scheme has been implemented for the officers/employees of the Board. Under this scheme, there is a provision to provide cash rewards to 10 officers/employees. The duration of this scheme for the period under report was from 1st April 2020 to 31st March 2021.


Hindi Day and Hindi Fortnight Celebrations

Structure of the Board

The Secretary (School Education and Literacy), Ministry of Education, Government of India is the Controlling Authority of the Board.

The Chairman is the Chief Executive of the Board and is assisted by fourteen Heads of Departments i.e. Secretary, Controller of Examinations, Director (Academics), Director (Training), Director (IT), Director (Misc. Examinations), Director (Edusat, Research & Development), Director (Skill Education), four Regional Directors, Director (Registered Office, Ajmer) and Director (Professional Examinations).

The Secretary, CBSE is the Chief Administrative Officer and responsible for the matters relating to Administration, Audit and Accounts, Public Relations, Legal and grant of affiliation to schools.

The Controller of Examinations is responsible for all matters concerning examinations and administration of examinations, the major areas being pre and post examination work, co-ordination with Regional Offices for conducting annual and compartmental Secondary and Senior School Certificate Examinations.

The Director (Academics) is responsible for developing the curriculum for all the subjects at the Secondary and Senior Secondary levels, development of new courses content and innovation in the field of education, to publish text books for Secondary and Senior Secondary classes and monitoring the academic projects.

The Director (Training) organizes teacher's training workshops, assessing training needs capacity building programmes.

The Director (IT) is responsible for all matters concerning On-line registration of class IX and XI pre-examination and post examination activities of all regions, all computer related activities, CTET and Proficiency Test etc., Online applications pertaining to Publication

Management System, Scholarship, Recruitment, Website-updation and maintenance and all new IT ventures and projects.

The Director (Misc. Examinations) is responsible for all matters concerning conduct of Central Teachers Eligibility Test (CTET) and Director (Professional Examinations) is responsible for all matters concerning conduct of Jawahar Navodaya Vidyalaya Selection Test (JNVST) and Kendriya Vidyalaya Selection Test.

The Director (Edusat, Research & Development) is responsible for all matters concerning Distance Education through Education Satellite launched by Indian Space Research Organisation (I.S.R.O.).

The Director (Skill Education) is responsible for all matters concerning designing of curriculum etc. for Skill Education subjects.






