# SCHEME OF MINORITY SCHOLARSHIP FOR STUDENTS BELONGING TO MINORITY <u>COMMUNITIES</u>

Applications are invited from students who are permanent residents in the state of Meghalaya studying within and outside the State for the year 2012-13.

1. Merit-Cum-Mean based Scholarship. Students pursuing Technical & Professional Courses at Under Graduate/Post Graduate level in an institution recognized by an appropriate authority are eligible for Merit Cum Mean based Scholarship for the year 2012-13 to be awarded by the Ministry of Minority Affairs, Govt. of India. Applications for Merit Cum Means Based Scholarship are to be submitted on-line to <a href="www.momascholarship.gov.in">www.momascholarship.gov.in</a>. Print out of duly filled-in application forms are also to be submitted to the office of the Director of Higher & Technical Education, Meghalaya, Shillong, alongwith all supporting documents through their respective institutions. Application form will be summarily rejected if the hard copy is not submitted to the office of the undersigned.

### Annual income of Parents - Not to exceed ₹. 2,50,000.00 per annum

2. **Post Matric Scholarship.** Students pursuing any course from class XI to Ph.D level in an institution recognized by an appropriate authority are eligible for Post Matric Scholarship for the year 2012-13 to be awarded by the Ministry Affairs, Govt. of India. Applications for Post Matric Scholarship are to be submitted on-line to <a href="https://www.momascholarship.gov.in">www.momascholarship.gov.in</a>. Print out of duly filled-in application forms are also to be submitted to the office of the Director of Higher & Technical Education, Meghalaya, Shillong alongwith all supporting documents through their respective institutions. Application form will be summarily rejected if the hard copy is not submitted to the office of the undersigned.

Annual income of Parents - Not to exceed ₹ 2,00,000.00 per annum.

3. **Pre-Matric Scholarship**. Students from Class I to Class X are eligible to apply for Pre-Matric Scholarship for the year 2012-13 to be awarded by the Ministry of Minority Affairs, Govt. of India. The application form for Pre-Matric Scholarship shall be obtained from the office of the District School Education Officer of their respective districts or Sub Divisional School Education Officer of their respective Sub-Division.

### Annual income of Parents - Not to exceed ₹ 1,00,000.00 per annum.

A Scholarship holder under this scheme will not avail of any other scholarship/stipends for pursuing the course. Moreover, students should not have less than 50% marks in the previous examination for both Fresh & Renewal at School/Higher Secondary/Graduation/Post Graduation/Vocational courses level. Selection of these students will be done strictly on Merit basis. Details of Bank Account of the students should also be filled in the application form as provided in the prescribed space.

The students should produce the Permanent Residential Certificate obtained from the Dy. Commissioner of the District in which a candidate is a Permanent Resident of Meghalaya along with all the Certificates / Mark sheets etc. and the student should also produce by way of affidavit on a nonjudicial stamp paper, a certificate showing that he/she belongs to the specified Minority Community i.e Christian/Sikh/Buddhist/Parsi/Muslim. Other details on eligibility and forms (both Fresh and Renewal) can be collected from the Scholarship Branch Room No. 206(B), Addl. Sectt. Building, Office of the undersigned, be downloaded from Education website or can http://megeducation.gov.in/dhte/scholarship/schforms.html. The last date for submission of Applications with all relevant documents is the 30<sup>th</sup> July 2012. No application will be entertained after the above specified date.
