# THE WEST BENGAL PRIMARY EDUCATION (AMENDMENT) ACT, 1988.

[Passed by the West Bengal Legislature.].

An Act to amend the West Bengal Primary Education Act, 1973.

WHEREAS it is expedient to amend the West Bengal West Ben. Primary Education Act, 1973, for the purposes and in the Act XLIII manner hereinafter appearing;

It is hereby enacted in the Thirty-ninth Year of the Republic of India, by the Legislature of West Bengal, as follows:--

Short title 1. (1) This Act may be called the West Bengal Primary and comm. Education (Amendment) Act, 1988.

(2) It shall come into force on such date as the State Government may, by notification in the Official Gazette, appoint.
