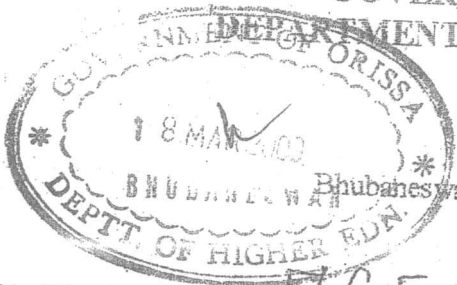

In exercise of the powers conferred by

sub-section (4) of section 7-C of the Orissa Education Act, 1969 (Orissa Act 15 of 1969), the State Government do hereby make the following Order to regulate the payment of grant-in-aid to private Educational Institutions imparting education in Sanskrit or for any post or any person employed in such institutions being Non-Government Shastri and Upashastri Colleges as specified hereunder, nameiy:-

1. Short title, application and commencement - (1) This Order may be called the Orissa (Non-Government Upashastri & Shastri Colleges) Grant-in-Aid Order, 2009.
 - (2) It shall apply to the Non-Government Upashastri and Shastri Colleges.
 - (3) This Order shall come into force on the date of its publication in the Orissa Gazette.

2. Definitions - (1) In this Order, unless the context otherwise requires, -
 - (a) "Act" means the Orissa Education Act, 1969;
 - (b) "Director" means the Director, Higher Education, Orissa and includes any officer not below the rank of Deputy Director who may be authorized by the Government in that behalf from time to time, by general or special order, to perform all or any of the functions and exercise all or any of the powers of the Director under this Order;
 - (c) "Block Grant" means a fixed sum of grant-in-aid payable in accordance with para 3 of this Order.
 - (d) "Government" means the Government of Orissa in the Department of Higher Education;

(e) "Governing Body" means a Governing Body constituted in accordance with the Act and the Orissa Education (Establishment, Recognition and Management of Private Colleges) Rules, 1991 or the Orissa Education (Establishment, Recognition and Management of Private Junior Colleges/ Higher Secondary Schools) Rules, 1991 as the case may be;

(f) "University" means Sri Jagannath Sanskrit University, Puri.

(2) The words and expressions used, but not defined herein, shall have the as meaning respectively assigned to them in the Act.

3. Admissibility of Grant-in-Aid – (1) Any private educational institution being a Non-Government Sanskrit College, imparting Upasastri Course and Shastri Course which has got permanent recognition by Government till the academic session 2005-06 shall be notified as Aided educational institution by the Government as required under clause (b) of section-3 of the Act and institutions so notified shall be entitled to receive Block Grant not exceeding 40% of the salary at initial level on the date of such notification.

Provided that Sanskrit institutions imparting Shastri and Upashastri course will be eligible for Block grant for its teaching and non-teaching posts admissible as per prescribed yardstick as Annexed to this Order.

Provided further that no Sanskrit institutions shall be notified to receive Block grant unless it satisfies the performance criteria as envisaged in Clause (ii) and (vi) of sub-section (1) of section 7-D of the Act.

(2) The Block grant shall be placed, through the Director, at the disposal of the Secretary of the Governing Body of the concerned educational institution proportionately either on quarterly or monthly basis.

(3) The Secretary of the Governing Body of each educational institution at whose disposal the Block grant is so placed shall utilize the grant in the manner and for the purpose as may be specified by the Director and furnish the utilization certificate thereof at such intervals as may be specified by the Director while releasing such grant.

(4) No claim on account of grant-in-aid under this order shall be made or entertained for any period prior to the date of notification as at sub-para (1).

4. Repeal and Saving - (1) The adhoc principle for payment of grant-in-aid to the Sanskrit Institutions in the State having Shastri and Upashastri course formulated in the erstwhile Education and Youth Services Department letter No.46010/EYS dated 25.10.1989 is hereby repealed.

(2) Notwithstanding any such repeal the private Sanskrit Institutions which are in receipt of grant-in-aid from Government under the order so repealed immediately before the date of commencement of this order, shall continue to receive such grant-in-aid as if the Government order No.46010/EYS dated 25.10.1989 had not been repealed.

Note - For ancillary and extra optional subjects work shall be managed by part time lecturers on remuneration basis.

2. In addition to the above posts in the teaching side each Upasastri and Sastri institution is to be given one Junior Clerk and one Peon.

3. Qualification of lecturers at Upasastri and Sastri stages shall be Acharya (new) or M.A. in relevant subject with 54% and above marks in the aggregate.
