1- REGULARITY IN SERVING MEAL	
District 1. Moradabad	(Sample size- 21 primary schools and 16 upper primary schools) Regularity in serving meal is in 20 (95.23%) PS & 16 (100%) UPS. The PS Imratpur MDM is irregular because raw material is not provided by Pradhan.
District 2 Bulandshahar	(Sample size- 21 primary schools and 16 upper primary schools) Regularity in serving meal is in 21(100%) PS & 16(100%) UPS.
District 3. Pilibhit	(Sample size- 22 primary schools and 16 upper primary schools) Regularity in serving meal is in 22 (100%) PS & 16 (100%) UPS.
District 4. Rampur	(Sample size- 19 primary schools and 19 upper primary schools) Regularity in serving meal is in 19 (100%) PS & 19 (100%) UPS.
2- TRENDS:	
District 1. Moradabad	(Sample size- 21 primary schools and 16 upper primary schools) Number of enrolled students: PS – 4589 (100%), UPS – 1342 (100%). On the day of visit food was prepared for 2006 (43.71%) students in PS and 693 (51.63%) students in UPS. Attendance was PS – 2235 (48.70%) & UPS – 686 (51.11%). According to MDM register PS – 1926 (40.96%) & UPS 679 (50.59%), But our count showed PS – 1909 (41.59%) & UPS – 659 (49.10%). One day previous the MDM register showed PS – 2491 (54.28%) & UPS – 714 (53.20%), which was much more than on the day of the visit.

On the day of visit food was prepared for 1600 (56.23%) students in PS and 806 (53.69%) students in UPS. Attendance was PS – 1680 (59.05%) & UPS – 811 (54.03%). According to MDM register PS –1480 (52.02%) & UPS 778 (51.83%), But our count showed PS – 1441 (50.65%) & UPS – 765(50.96%). One day previous the MDM register showed PS – 1651 (58.03%) & UPS – 879 (58.56%), which was much more than on the day of the visit.</p>
<p>District Pilibhit</p>	<p>3. (Sample size- 22 primary schools and 16 upper primary schools) Number of enrolled students: PS – 3325 (100%), UPS – 2023 (100%). On the day of visit food was prepared for 1781 (53.56%) students in PS and 1005 (49.67%) students in UPS. Attendance was PS – 1775 (53.38%) & UPS – 1021 (50.46%). According to MDM register PS –1781 (53.56%) & UPS 994 (49.13%), But our count showed PS – 1696 (51%) & UPS – 974 (48.14%). One day previous the MDM register showed PS – 1929 (58.01%) & UPS – 992 (49.03%), which was much more than on the day of the visit.</p>

According to MDM register PS –1534 (47.14%) & UPS 913 (41.18%), But our count showed PS – 1534 (47.14%) & UPS – 913 (41.18%). District Moradabad	1. (Sample size- 21 primary schools and 16 upper primary schools) There is one (4.76%) PS (Imratpur) where the food grain is not regularly supplied. There are PS-4 (19.04%) & UPS-5 (31.25%) where the food is supplied by the NGO. In 16 (76.19%) PS and 3 (18.75%) UPS the food stock for full month is available at the school and comes from pradhan house. In 1 (4.76%) PS & 8 (50%) UPS, the food stock of one month is not available at the schools As per norms the food grains are only available at PS 16 (76.19%) and UPS 9 (56.25%). Quality of the food grains are good at PS 16 (76.25%) and UPS 8 (50%).
District Bulandshahar	2 (Sample size- 21 primary schools and 16 upper primary schools) There is all (100%) PS & UPS food grain is regularly supplied. There are PS-6 (28.57%) & UPS-2 (12.5%) where the food is supplied by the NGO. In 9 (42.85%) PS and 10 (62.5%) UPS the food stock for full month is available at the school and comes from pradhan house. In 6 (28.57%) PS & 4 (25%) UPS, the food stock of one month is not available at the schools. As per norms the food grains are only available at PS 14 (66.66%) and UPS 13 (81.25%). Quality of the food grains are good at PS 15 (71.42%) and UPS 13 (81.25%).
District Pilibhit	3. (Sample size- 22 primary schools and 16 upper primary schools.) There is all (100%) PS & UPS food grain is regularly supplied. In 12 (54.54%) PS and 5 (31.25%) UPS the food stock for full month is available at the school and comes from pradhan house. In 10 (45.45%) PS & 11 (68.75%) UPS, the food stock of one month is not available at the schools. As per norms the food grains are only available at PS 21 (95.45%) and UPS 16 (100%). Quality of the food grains are good at PS 22 (100%) and UPS 16 (100%).

District Rampur	4.	(Sample size- 19 primary schools and 19 upper primary schools) There is all (100%) PS and UPS where the food grain is regularly supplied. There are PS-3 (15.78%) & UPS-1 (5.26%) where the food is supplied by the NGO. In 8 (42.10%) PS and 8 (42.10%) UPS the food stock for full month is available at the school and comes from pradhan house. In 8 (42.10%) PS & 10 (52.63%) UPS, the food stock of one month is not available at the schools. As per norms the food grains are only available at PS 15 (78.94%) and UPS 17 (89.74%). Quality of the food grains are good at PS 15 (78.94%) and UPS 18 (94.73%).

On the day of visit the food was supplied as per menu in PS-18 (85.71%) & UPS-13 (81.25%). In every day meal Rise/wheat/Green vegetables is included in only 17 (80.95%) PS & 8 (50%) UPS.
District Bulandshahar	2 (Sample size- 21 primary schools and 16 upper primary schools) In the all (100%) PS & UPS the menu is displayed. 2 (12.5%) UPS (Kanya Harishchand Nagar, Lal Bahadur Shastri) - the menu is not adhered. On the day of visit the food was supplied as per menu in PS-19 (90.47%) & UPS-16 (100%). In every day meal Rise/wheat/Green vegetables is included in only 18 (85.71%) PS & 11 (68.75%) UPS.
District Pilibhit	3. (Sample size- 22 primary schools and 16 upper primary schools.) In 1 (4.54%) PS (Gauhaniya) and 2 (12.5%) UPS (Lalpur & Police line) the menu is not displayed. In 1 (4.54%) (Gauhaniya) PS the menu is not adhered. The day of visit the food was supplied as per menu in PS-22 (100%) & UPS-15 (93.75%). In every day meal Rise/wheat/Green vegetables is included in only 21 (95.45%) PS & 12 (75%) UPS.
District Rampur	4 (Sample size- 19 primary schools and 19 upper primary schools) In 2 (10.52%) PS (Majara Tashka, Shighadiyana) and 1 (5.26%) UPS (Bageecha Amna) the menu is not displayed. In 1 PS (Majara Tashka) the menu is not adhered. On the day of visit the food was supplied as per menu in PS-18 (94.73%) & UPS-19 (100%). In every day meal Rise/wheat/Green vegetables is included in only 12 (63.15%) PS & 15 (78.94%) UPS.

6- QUALITY & QUANTITY OF MEAL	
1.District Moradabad	(Sample size- 21 primary schools and 16 upper primary schools) Students were satisfied by quantity in 19 (90.47%) PS & 16 (100%) UPS. Students were satisfied by quality in 19 (90.47%) PS & 14 (87.5%) UPS. The reason of dissatisfaction was that mainly rice was served in MDM and the food was not according to menu. The students of UPS informed that the quality of food supplied by NGO was not good.
2.District Bulandshahar	(Sample size- 21 primary schools and 16 upper primary schools) Students were satisfied by quantity in 20 (95.23%) PS & 15 (93.75%) UPS. Students were satisfied by quality in 19 (90.47%) PS & 14 (87.5%) UPS. The reason of dissatisfaction was that mainly rice was served in MDM and the food was not according to menu.
3.District Pilibhit	(Sample size- 22 primary schools and 16 upper primary schools.) Students were satisfied by quantity in all (100%) PS & UPS. Students were satisfied by quality in all 22 (100%) PS & 16 (100%) UPS.
4.District Rampur	(Sample size- 19 primary schools and 19 upper primary schools.) Students were satisfied by quantity in all (19%) (100%) PS & (19%) UPS. Students were satisfied by quality in all PS & UPS.

The cooked food is served in PS by schools cooks in 17 schools (80.95%), by teachers in 2 schools (9.52%) and by students in 2 schools (9.52%). The cooked food is served in upper primary schools by cooks in 11 schools (68.75%), by students in 2 schools (12.5%) and other in 3 (18.75%). The number of cooks is PS and UPS in as per norms. 17 schools of PS where the food is cooked in schools there is 1 (2.08%) male and 47 (97.91%) female , 11 schools of UPS where the food is cooked in schools there is 0 male and 25 (100%) female. The payment of cooks is Rs/-1000 only in PS and UPS and is given by cheque.
