MID DAY MEAL PROGRAMME <u>Annual Work Plan and Budget 2011-12</u>

1. INTRODUCTION:

1.1 Brief History:

- 1.1.1 Education plays a vital and important role in fulfilling the basic needs of a common man viz. food, shelter and clothing. The main aim of Education is to prepare and develop the child physically, mentally and spiritually to lead a quality life. Education is a process through which a child is made capable to attain the necessary competencies and skills to face the challenges in life to survive, and to make struggle for existence. Four important factors are identified for achieving the goal of Education for All. These are Access to Education, Enrolment of children, and Retention of the enrolled children and Achievement. Mid Day Meal scheme is an effort to achieve and facilitate all the four above said objectives.
- 1.1.2 Various schemes were implemented in the primary education sector by the Government to reach the disadvantaged population. Access to Primary Education was universalized through flagship programmes of Govt. like Sarva Shiksha Abhiyan, however, despite this; a few children are still deprived of Primary Education due to inability of their parents to send them to schools because of their poor economical status. For, these parents, sending their children to school means not only incurring extra financial burden but also depriving them of some money which their children would have earned otherwise by doing Labour. That being the attitude of these economically backward parents, one may, perhaps, to motivate the parents and children was to bring their children to school by providing food and nutritional needs.
- 1.1.3 Government of India, on Oct 2nd 1995, launched the scheme of National Programme of Nutritional Support to Primary Education also known as **Mid-Day-Meal Programme**. Under this scheme, students of Primary classes were to be provided wheat @ 3 kg per student per month (for 10 months in a year) subject to 80% attendance. Meanwhile, the apex court also intervened and vide its orders dated 28th November, 2001 the Supreme Court directed:-

- "1- We direct the State Government/Union Territories to implement the Mid-Day-Meal scheme by providing every child in every Government and Government Assisted primary schools with a prepared Mid-Day-Meal with minimum contents of 300 calories of energy and 8-12 grams of protein each day of school for a minimum of 200 days. Those Governments providing dry rations instead of cooked meals must within 3 months start providing cooked meals in all Government Aided primary schools in all half the districts of the state(in order of poverty) and must within a further period of 3 months extend the provisions of cooked meals to the remaining parts of the state.
- 2- We direct the Union of India and the FCI to ensure provision of fair average quality grain for the scheme on time. The State/Union Territories and the FCI are directed to do joint inspection of food grains. If the food grains are found, on joint inspection, not to be of fair average quality, it will be replaced by the FCI prior to lifting".
- known as Mid-Day-Meal (Modified Scheme) was launched in Haryana State on 15th August, 2004 as a Centrally Sponsored Scheme. National Programme of Nutritional Support to Primary Education, Commonly known as Mid-Day-Meal (Modified Scheme) is being implemented in all the Government, Local Bodies, Government Aided Primary Schools and all AIE centers started under SSA in the entire State in compliance of the above Hon'ble Apex Court's direction dated 20-04-2004. The School Children were being provided cooked food viz. Mitha Rice, Vegetable Pulao, Dalia, Paushtic Khichri and Bakli. These recipes were given to the children by rotation every day. Free foodgrains i.e. wheat and rice are provided by Government of India through F.C.I. Other ingredients like grams, pulses, Jeera, salt, pepper, cooking oil etc. were purchased by district committee under chairpersonship of Additional Deputy Commissioner of the district. Foodgrains were supplied by CONFED to all the Primary Schools. Vegetables are purchased locally as per need. The

average cost of conversion (excluding transportation and the foodgrains) was Rs. 1.43 per child per school day. Out of this Re. 1.00 was borne by Government of India and 0.43 paise by State Government. Govt. of India has decided to increase calorific value content from 300 to 450 k. calories and protein value from 8–12 gms to 12 gms from the year 2008-09. The Central Assistance had been increased from Re 1 to Rs. 1.50 and State Share from Rs. 0.43 to Rs. 0.57 i.e. total Rs. 2.07 per child per school day w.e.f January 2007.

During the year 2008-09, every child is to be given Mid-Day-Meal daily on all school days having 450 calories and 12 grams proteins (as compared to the earlier norm of 300 calories and 8-12 gms proteins). No additional quantity of food grains is to be provided and the extra calories and proteins are to be provided through addition of vegetables and/ or other ingredients. The cooking cost has been enhanced to Rs. 2.15 per child per school day during 2009-10 of which Rs. 1.58 paise is borne by Govt. of India and balance 57 paise is borne by State Govt. Out of this, 20 paise are as fuel charges and 40 paise as wages to the cook.

Mid-Day-Meal Programme was started in Middle schools of 36 Educationally Backward Blocks of the state from October, 2007. It has been extended in all Middle Schools from 1st April, 2008. The cooking cost for upper primary classes is Rs. 2.60 during 2009-10. Out of this Rs. 2.10 are born by Govt. of India and 50 paise by State Govt. Every child is to be daily given Mid-Day-Meal having 700 calories and 20 gms Proteins in upper primary classes.

According to revised norms the cooking cost and honorarium of cook-cum-helper have been modified by Govt. of India w.e.f. 1st April, 2010. The revised cooking cost has been enhanced from Rs. 2.50 to Rs. 2.69 for primary stage and from Rs.3.75 to Rs. 4.03 for upper primary stage. The cooking cost will be increased further by 7.5% from 1.4.2011 and as per GOI guidelines honorarium of cook-cum-helper is fixed Rs. 1000/- per cook per month.

1.1.5 **Objectives Of The Programme**

The main objectives of the Programme are:


- a) To increase enrolment, retention and to tone up the learning abilities of the beneficiaries, especially of children belonging to poor and down trodden sections of the society;
- b) To provide nutritious meal to the school going children to achieve the goal of Healthy mind in Healthy body;
- c) To promote friendship and feelings of common brotherhood among the children belonging to different caste, colour and creed by providing meals to them together and also to increase their retention in schools.

1.1.6 Demographic Profile Of The State

Haryana is a landlocked state in northern India. It is located between 27°37' to 30°35' N latitude and between 74°28' and 77°36' E longitude covering an area of 44,212 sq. km The altitude of Haryana varies between 700 to 3600 ft (200 metres to 1200 metres) above sea level. The city of chandigarh is the joint capital of Haryana and Punjab. As per census of 2001 the population of Haryana is 2,11,44,564 and literacy rate is 71.4%

1.1.7 Administrative Setup:

Haryana is divided into 21 administrative districts and 119 blocks.



1.2 Process Of Plan Formulation

A system has been developed to collect monthly, quarterly and yearly data regularly for smooth running of MDM Scheme. For formulation of plan, Block Education Office of every block collects the data from every school and after compiling it on block level, it is submitted to District Elementary Education Office at district level. District Elementary Education Office compiles it at district level and after that State plan is formulated. During compilation of plan at state level, monthly and quarterly reports of the districts are also taken for assessment of the data, submitted by the districts. Cooking Cost, cook labor, kitchen sheds cum store and kitchen devices amount is calculated on the basis of 75:25. 75% is borne by Centre Govt. and rest of 25% is borne by State Govt. Cooking Cost. Districts are being asked to calculate cooking cost and honorarium to cooks on the strength of enrolment of students studying in primary & Upper Primary Govt., Govt. aided and Local bodies Schools, no. of days and rate of cooking cost. Meetings are held at headquarter and at district level with district level functionaries regarding preparation of annual work plan.

2. Description and assessment of the Programme implemented in the current year (2010-11) and proposal for the next year (2011-12) with reference to:

Regularity and wholesomeness of Mid Day Meals served to children; reasons for Programme interruptions, if any

MDM is being provided by and large regularly the major reason for discontinuity or interruption is mainly due to non-availability of food grains due to interrupted lifting of food grains by CONFED from FCI godowns. However directions has been given that in case of interruption in supply of foodgrains due to some unavoidable circumstances for some days, the foodgrains are taken on loan locally which is returned after regular receipt of foodgrains. Even if there are any complaints regarding interruption in preparation of MDM, prompt action is taken at headquarter and district level. To sort out the problems with the lifting agency CONFED, the department has also constituted a core committee under the chairmanship of Joint Director, Elementary Education Haryana, Panchkula.

2.1 Food grains management, including adequacy of allocation, timeliness of lifting, transportation and distribution, and suitability of storage at different levels. Challenges faces and plan to overcome them.

Food grains were allocated adequately to the state Govt. During the year 2010-11, 16532.87 MTs of Rice and 14661.23 Mts of Wheat for Primary Stage and 11984.62 MTs of Rice and 10627.88 MTs. of Wheat for upper primary stage were allotted to the state. Accordingly foodgrains were allocated to each district. Foodgrains are stored at school level in the containers provided by the state Govt. CONFED, the nodal agency for lifting of food grains, lifts the food grains from FCI godowns and send it to the schools. Food grains allotted to all District Elementary Education Officers were adequate as there were no complaints in this respect.

2.2 System for release of funds provided under cooking costs (Central and State) Please indicate the dates when the fund was released to directorates /State Authority, District /Block/ Gram Panchayat and finally to the Cooking Agency / School.

The following system is adopted for releasing of cooking costs. Joint Bank Accounts in the name of Additional Deputy Commissioner & District Elementary Education Officer is opened at district level. A separate account for Mid-Day-Meal has been opened at school level also. The funds are released by the State to district level. After that it is transferred to school and the amount is withdrawn under the joint signature of Chairman of Self Help Group and Head of the School for the purchase of Ghee, Salt, Oil, Jeera, pulses, gram etc.

2.3 System for procuring cooking ingredients (pulses, vegetables including leafy ones, salt, condiments, oil and fuel etc.) Commodities, which are centrally purchased and supplied to schools or locally purchases at school level.

The purchasing at school level is done by Self Help Groups (SHGs) where SHGs has been formed. In schools where SHGs has not been formed a committee consisting School Head, Lady Punch or Municipal Councilor and One teacher is responsible for purchase. Fuel and Vegetables are purchased locally out of cooking cost amount placed at the disposal of Self Help Groups

and Head of the School. The rate of cooking cost per child per day is as per the norms fixed by Govt. of India which is as under.

2.5 System for cooking, serving and supervising Mid Day Meals in the school and measures to prevent any untoward happening.

The cooking and distribution of cooked meal has been assigned to Self Help Groups. Mothers of the children studying in that very School have been involved in the process of serving and supervising Mid day Meal in Schools. At school level Head teacher has been directed to taste the food before distributing it to the children. SHGs cook the food in the school premises and in front of the children. Members of School managing committees rotationally check the cooked meal and supervise distribution of Mid-Day-Meal.

ISCKON Food relief foundation has been engaged in Faridabad, Palwal and Thanesar, ladwa and Pehowa blocks of Kurukshetra to provide Mid Day Meal in Schools by establishing centralized kitchens.

2.6 Procedure for getting Kitchen shed constructed:-

Rs. 2435.09 lac were released by Govt. of India for construction of 4058 kitchen-cum-stores @ Rs. 60000/- per kitchen-cum-stores. However, this amount was insufficient for the construction of kitchen-cum-stores. The Govt. of Haryana has taken initiative to construct the kitchen-cum-stores and contributed Rs. 523.80 lac so that the incomplete work can be completed. During the year 2009-10 Rs. 7207.78 lac for construction of 4383 kitchen-cum-stores has been sanctioned on sharing basis of 75:25 (Central Share: State Share). The Kitchen-cum-store will be constructed as per Govt. of India norms with the help of Engineering Cell of Haryana Prathmik Shiksha Pariyojna Parishad, Chandigarh, A registered society which is also implementing Sarva Shiksha Abhiyan and Rashtriya Madhmik Shiksha Abhiyan in the state of Haryana. No funds from other sources have been arranged for this purpose.

2.7 Procedure of procurement of kitchen devices from (i) funds released under the Mid Day Mal Programme (ii) other sources.

(i) G.O.I have sanctioned Rs 155.89 lac during 2006-07, 176.35 Lac during 2007-08 and Rs. 143.10 lac for 2862 schools (Rs. 99.45 lac for 1989 primary and Rs. 43.65 for 873 upper primary schools) during 2008-09 for kitchen devices/ Gas connections. Rs. 5000/- each was placed at the disposal of schools for this purpose through District Elementary Education Officers for procuring kitchen devices/ Gas connections in 9507 schools out of 11483 schools immediately. Two gas cylinders and one chullah have been provided in each school. This amount has been fully utilized. During 2010-11, Rs. 98.80 lacs has been released to 1976 Govt. Middle Schools directly through bank drafts @ Rs. 5000/- for the purchase of Gas connection with two Gas Cylinders and Gas Stove.

2.8 Capacity building and training conducted for different categories of persons involved in the Mid Day Meal Programme.

The Department in Collaboration with Panchayati Raj Department, Haryana has organized Training Programme for members of SHGs at block level two times during this year. Objective of Mid Day Meal and how to prepare food was fully elaborated to them. Food and Nutritional Board, Ministry of Women & Child Development have conducted training/seminars of teachers involved in the Mid-Day-Meal. A module of Mid Day Meal addressing all the aspects of the scheme has also prepared and is an integral part of the Training Programme.

2.9 Management Information System at School, Village/Gram Panchayat, Block, District and State level.

Mid-Day-Meal Programme implementation is the overall responsibility of Committees constituted at school level. Teacher In charge of Mid-Day-Meal Programme maintains the day to day record of the Programme. There are only two registers to be maintained at school level. One register is for maintenance of funds (Cash Book) and second register is kept for foodgrains.

The Department has recently recruited Account Executives and Programme Executives at Block, district and headquarter level. They have been entrusted with responsibility to visit at least 30 Schools in a month and get telephonic

information of at least 10 Schools Daily. The basic qualification for Accounts Executive/Programme Executive is B.COM/BBA or BCA Degree with computer knowledge respectively. They are also trained by conducting 2 workshops of 3 days at headquarter level.

2.10 Systems to ensure transparency and openness in all aspects of programme implementation, including inter alia, food grain management, ingredients procurement, cooking and serving, appointment of cooking staff, construction of kitchen sheds, procurement of cooking devices.

Transparency and openness in all aspect of programmer implementation is been maintained at every level. The implementation of the scheme at the school level has been assigned to Self Help Groups. The account is being operated under the joint signature of Chairman of SHG and Head of the Institution. CONFED is responsible for the lifting of foodgrains from the Godowns of FCI. The foodgrains of fair average quality are transported by CONFED and delivered to the schools at their doorsteps. The schools maintain records containing the necessary information such as No. of children fed on each day, the type of food served.



SHG procured the ingredients locally as per their requirement. Cooking is done by cooks engaged by SHGs.

Kitchen shed cum stores has been allotted to all the Primary and Upper Primary schools. The amount received under this head immediately released to Haryana Prathmik Shiksha Pariyojna Parishad Chandigarh, a society for the implementation of Sarva Shiksha Abhiyan and Rashtriya madhmik Shiksha Abhiyan in Haryana. The society has been entrusted to construct kitchen shed in the schools, as the society has a well established civil works wing.

Procurement of cooking devices and utensils are made by a committee consisting of Chairman of School Management committee, Head of the institution and lady member of School Management committee.

2.11 Measures taken to rectify:

- a) Inter-district low and uneven utilization of food grains and cooking cost
- b) Intra-district mismatch in utilization of food grains and cooking cost
- c) Measures taken to rectify Delay in delivering cooking cost at school level.

Apparently there seems to be no inter district low and uneven utilization of food grains and cooking cost. However in some cases it is caused due to late release of cooking cost and delay in making of allocation of food grains. Some of the districts/schools manage the Programme at their own level while other schools wait for the Govt. Assistance, which cause the misled. the District Education Officers concerned have been asked to rectify and report correct utilization of food grains and cooking cost.

Utilization of cooking cost more or less corresponds to the utilization of food grains so perhaps does not need much explanation.

The department transfers the funds online to districts. Online transfer of funds by district even upto school level is being implemented to curtail delay in transfer of funds.

2.12 Details of Evaluation studies conducted and summary of its findings.

Evaluation studies have been conducted by Kurukshetra University, Society For Service To Voluntary Agencies (North) Haryana. The observations/ suggestions of Evaluation studies are as under:-

- (a) In all schools MDM was given regularly, on the day or Ml's visit 86.32% children in Panchkula, 84.21% children in Kaithal, 98.15% children in Fatehabad 83.16% children in Sirsa and 82.82% children in Gurgaon attended the school and availed MDM.
- (b) 48.38% visited schools of Fatehabad 60% visited schools Kaithal 89.65% visited schools in Gurgaon had one-month buffer stock of food grains.
- (c) No gender, caste and community discrimination was found by Ml in cooking, serving MDM and sitting arrangement.
- (d) All the schools had adequate numbers of cooks to meet the requirement.
- (e) There is a fixed weekly menu for MDM.
- (f) Children were happy with quality and quantity of meals.
- (g) Only iron tablets were given in 40% schools of Panchkula, 60% schools in Sirsa, and 34.48% in Kaithal.
- (h) Environment, safety and hygiene of cooking place was good. In all schools, children were encouraged to wash hands before and after eating MDM. The observations and the suggestions of the report have been sent to District Elementary Education Officers to plug the loopholes if any to run the scheme effectively.

2.13 Brief writ up on best practices followed in the State.

The Following best practices are followed in the schools:-

- 1. All students irrespective of their caste, creed and religion take the Mid Day Meal and thus spread a message of common brotherhood and also imbibe good traditions of the Indian society amongst the students.
- 2. Participations of the Govt. Particularly the cooks appointed by SHGs who are mostly the mothers of the children studying in that very school. Cooking and serving by them the Mid Day Meal is a very good practice. It has been enforced the accountability of Parents and teachers towards society to impart quality education to students.
- 3. In some of the places, the members of SHGs and students have been motivated to produce the vegetables by making use of available land in the

- schools effectively. This will not only make the school self sustainable but would also inculcate the habit of self reliance amongst the SHGs and students.
- 4. The Department for the first time has prepared draft of Rs. 2500/- for all the Schools the purchase of stain-less-steel plates for children out of MME grant. These drafts has been distributed by the officers of the Department personally to the head of the schools. This has been done to avoid any delay in reaching the grant to the beneficiaries and also to check involvement of any middle man.

2.14 Instances of unhygienic food served, children falling ill, substandard supplied, divesions/misuse of resources, social discrimination and safety measures adopted to avoid recurrences of such incidents.

No such unfortunate and avoidable incident has fortunately ever come to the notice though there are un-substantiated reports coming in the media once in a while. All these reports are monitored in the Head Office on regular basis and it has generally been found that the reports were either vague or there was some lack of communication.

2.15 Involvement of NGOs and Civic Body Organizations (CBOs) PRIs in the implementation and monitoring of the Scheme.

ISKCON food relief foundation, New Delhi has been involved in is supplying Mid Day Meal of Faridabad district and Palwal district and three block of Kurukshetra district namely, Thanesar, Ladwa and Pehowa. In remaining part of the state, the MDM is cooked as per instructions issued by GOI. Members of Gram Panchayats, V.E.C. and P.T.A have been given the task to check the cooked meal and supervise distribution of Mid-Day-Meal. Mothers are also being motivated for supervising and distributing the meal.

2.16 Status of School Health Programme with special focus on provision of micro-nutrients, Vitamin-A, De-worming medicine, Iron and Folic acid, Zinc and recording of height, weight etc.,

The health check up Programme is going on in the schools through Sarva Shiksha Abhiyan and the head department. Under this Programme students are checked up and De-worming medicines and tablets of Iron and Folic Acid have regularly been provided to the students by the Heath Department. Measurement of height and weight is done at the school level. However under MDM Scheme such separate Programme doesn't exist.

2.17 Steps taken of strengthen the monitoring mechanism in the village, Block, District and State Level and status of constitution of SMCs at these levels. Status of formation on Standing Committee at village/School. Cooking agency level.

The Govt. vide Notification No. 1/6-2005MDM(1) Dated 27-10-2005 have constituted three tier monitoring committee at state, district and block level under the Chairmanship of Chief Secretary, Deputy Commissioner and Sub divisional Officer(civil) respectively. The department has formed comprehensive micro level three tier monitoring system at State, District and block level by constituting Monitoring cells. All level monitoring cells have the telephone numbers of the Head of the schools where Mid Day Meal scheme is running. Monitoring cell randomly talk to the Head of the school and enquire about the running of the scheme. All the members of the cell are compulsorily directed to enquire 10 schools daily and send the report to the Head office.

2.18 Arrangements for official inspections of MDM centers and percentage of schools inspected and summary of finding and remedial measures.

The Programme is monitored regularly by State/Head Quarter Officers and District Elementary Education Officers as well as Block Education Officers. They have been directed to inspect at-least 25 schools in a month.

2.19 Feedback/Comments in respect of report of Monitoring Institutions designated for you State/UT to monitor implementation of MDM and action taken thereon.

The feed-back/comments in respect of monitoring institutions is at point No. 2.12 and suitable action has already been taken by the Department.

2.20 Overall assessment of the manner in which implementation of the programme is contributing to the programme objectives and an analysis of strengths and weaknesses of the programme implementation.


This Programme have been contributing positively in achieving its objectives such as increase in enrollment, retention and attendance of children in Primary schools and improving the nutritional level of Primary school children.






Utilisation of Foodgrains(Rice) Primary upto 31-12-2010




ALLOCATION OF WHEAT
