### ORDER

The 8th December 2008

No. 23611—IX-SME(Sch.)-35/2008-SME.—In exercise of the powers conferred by sub-section (4) of Section 7(C) of the Orissa Education Act, 1969 (Orissa Act 15 of 1969), the State Government do hereby make the following order to amend the Orissa Education (Payment of Grant-in-Aid to High Schools, Upper Primary Schools, etc.) , Order, 2004 namely:—

1. (a) This order may be called the Orissa Education (Payment of Grant-in-Aid to High School, Upper Primary Schools, etc.) Amendment Order, 2008.

(b) It shall come into force w.e.f. the 1st April 2008.

2. In the Orissa Education (Payment of Grant-in-Aid to High Schools, Upper Primary Schools, etc.) Order, 2004 (hereinafter referred to as said order) for sub-Para. 3 (b) of Para. 3 and sub-Para. (2) of Para. 4 along with explanation shall be substituted, namely:—

Para. 3.3(b) — Qualified non-teaching employees shall consist of only one Jr. Clerk, 3 Peons, i.e., one Office Peon, one Science Attendant and one Watchman-cum-Sweeper for every eligible High School.

Para. 4(2) — The quantum of Block Grant payable to private education institution which has become eligible to receive Grant-in-Aid after the 1st day of June, 1994 shall be the amount representing sixty per centum (60%) of the emoluments of the teaching and non-teaching employees of such institution in the revised scale of pay.

**Explanation** — For the purpose of this sub-Para. 'emoluments' shall mean the initial pay of the concerned employees in the revised scale of pay as per Orissa Revised Scale of Pay Rules, 1998 *plus* Dearness Pay *plus* Dearness Allowance @ 11% (Pay in Revised scale as per Orissa Revised Scale of Pay Rules, 1998 + Dearness Pay + Dearness Allowance @ 11%).

3. The quantum of Block Grant to 100 Girls' High Schools renotified by Government in School & Mass Education Department Notification No. 19463, dated the 22nd September 2007, shall be the amount representing the Revised Scale of the emoluments of the teaching and non-teaching employees of such Girls' High Schools with Dearness Allowance @ 11%. i.e., pay in the Revised Scale of Pay *plus* Dearness Pay *plus* Dearness Allowance @ 11%

**Explanation** — For the purpose of this sub-Para. 'emoluments' shall mean the initial pay of the concerned employees in the revised scale of pay as per Orissa Revised Scale of Pay Rules, 1998 *plus* Dearness Pay *plus* Dearness Allowance @ 11% (Pay in Revised Scale as per Orissa Revised Scale of Pay Rules, 1998 + Dearness Pay + Dearness Allowance @ 11%).

4. The Orissa Education (Payment of Grant-in-Aid to the High Schools and Upper Primary Schools) Amendment Order, 2008 issued in School & Mass Education Department Order No.5061, dated the 10th March 2008 is hereby superseded.

5. This has been concurred in by Finance Department vide their U.O.R. No. 3186-S.S.F.(I), dated the 26th November 2008.
