Madam/Sir,

With reference to this office letter No. 591 dt. 05.06.2012, I am to say that the central team had visited our State on 11th-12th July, 2012 for orientation of the D.I of Schools (Headquarters), Data Entry Operators attached to the District Project Management Unit on the implementation of web-based monitoring system for Mid-Day Meal Scheme to improve the quality.

However, for effective monitoring, you have to take the following steps, if not already taken:-

- (i) Provision of proper computer facilities and internet connectivity to the district and block level for timely and smooth data entry.
- (ii) The District NICs should be involved in this work to resolve the issues which can be resolved at the district/ Block level.
- (iii) Wherever Data Entry Operators and Programme-cum-Accountants have not been engaged, engagement be given without any delay.

Ministry of Human Resource Development, GoI desire to complete the data entry work positively by 31st August, 2012. Against this backdrop, the S.I of Schools (Headquarters) will feed data to the minimum extent of 25 no. of schools with the support of the Data Entry Operator engaged for the purpose and daily report to this effect will be transmitted to the D.I., Hqrs, as a result D.I. Hqrs. in turn submit weekly report to the SPMU positively on the

succeeding day for kind information of the Principal Secretary. On no account the data feeding process can go beyond 31st August, 2012. The formats for this purpose are enclosed herewith for necessary action at your end.
