## P R E F A C E

The brochure "A Picture of Karnataka Budget, is compiled every year to present the details in the State Budget in an easily understandable form by means of statistical tables. In Part I of the brochure are indicated the salient features of the State Budget for 1987-88 along with the revised estimates for 1986-87 and actuals for previous year. Part II of the brochure aims at presenting the sectoral distribution of the plan expenditure incurred in respect of Annual Plan for the past few years and those anticipated plan expenditure for 1986-87 and the plan that emerges out of the Budget for 1987-88 as now presented. The development outlays for the purpose of this brochure cover the State Plan, Centrally Sponsored Schemes and Central Plan Schemes as also the expenditure on Irrigation Projects under Cauvery having awaiting clearance from Government of India. Part II also indicates the population of Indian State (estimated under mid year population). The actuals for 1985-86 are provisional subject to re-concialiation.

## GENERAL REVIEW OF FINANCES

### Revenue Account

The receipts on Revenue Account during the year 1987-88 are estimated at Rs. 2645.59 crores and the expenditure is estimated at Rs. 2706.55 crores. The estimates for 1987-88 reveals a Deficit of Rs. 60.96 crores. A statement of budgetary position on revenue account is given below :

#### Tax Revenue 1987-88 (Budget Estimates)

The State's share of Central Taxes during 1987-88 is estimated at Rs. 438.52 crores which is Rs. 31.53 crores higher than the share in 1986-87 (Revised Estimates) Receipts from State Taxes and Duties during 1987-88 show an increase of Rs 148.60 crores over the receipts in 1986-87 (Revised Estimates) are listed out in the table given below:

#### The State's Share of Central Taxes 1987-88 (Budget Estimates)

The State's share of Central Taxes during 1987-88 is estimated at Rs. 438.52 crores out of which Rs. 110.82 crores is the share of Central Income Tax and Rs. 322.81 crores, is the share of Union Excise Duties, and the share in Estate Duty and tax on Railway Passengers Fares is Rs. 1.63 crores and Rs. 3.26 crores respectively, & are shown in the table given below: —

**Expenditure met from Revenue 1987-88 (Budget Estimates)**

Estimate of expenditure under the revenue account for 1987-88 comes to Rs. 2706.55 crores which is Rs. 434.63 crores higher than the Revised Estimate of the expenditure anticipated to be incurred under the revenue account during the year 1986-87 (Revised Estimates).

Out of the total expenditure in 1987-88 Rs. 1820.56 crores or 66.34 per cent is earmarked for developmental purposes which is Rs. 259.36 crores higher than the expenditure expected to be incurred in 1985-86 (Revised Estimates) Non-Development expenditure is estimated at Rs. 885.99 crores during 1985-86 which is Rs. 175.27 crores higher than that of 1985-86 (Revised Estimates). They are indicated as detailed below:—
