P R E F A C E

The brochure "A Picture of Karnataka Budget, is compiled every year to present the details in the State Budget in an easily understandable form by means of statistical tables. In Part I of the brochure are indicated the salient features of the state Budget for 1990-91 along with the revised estimates for 1989-90 and actuals for previous year. Part II of the brochure aim at presenting the sectoral distribution of the plan expenditure incurred in respect of Annual plan for the past few years and those anticipated plan expenditure for 1989-90 and the plan that emerges out of Budget for 1990-91 as now presented. The development outlays for purpose of this brochure cover the State Plan, Centrally Sponsored Schemes and Central Plan Scheme as also the expenditure on Irrigation Projects under Cauvery basin awaiting clearance from Government of India. Part II also indicates the population of Indian State (estimated under mid year population). The actuals for 1988-89 are provisional subject to re-conciliation.

PART I—STATE FINANCES

GENERAL REVIEW OF FINANCES

Revenue Account

The receipts on Revenue Account during the year 1990-91 are estimated at Rs. 3815.91 crores and the expenditure is estimated at Rs. 4010.23 crores. The estimates for 1990-91 reveals a Deficit of Rs. 194.32 crores. A statement of budgetary position on revenue account is given below:

Tax Revenue 1990-91 (Budget Estimates)

The State's share of Central Taxes during 1990-91 is estimated at Rs. 659.87 crores which is Rs. 23.85 crores higher than the share in 1989-90 (Revised Estimates). Receipts from State Taxes and Duties during 1990-91 show an increase of Rs 228.42 crores over the receipts in 1989-90 (Revised Estimates) are listed out in the table given below:

The State's share of Central Taxes during 1990-91 is estimated at Rs. 659.87 crores out of which Rs. 208.67 crores is the share of Central Income Tax and Rs. 446.29 crores, is the share of Union Excise Duties, and Tax on Railway Passengers Fares is Rs. 4.91 crores are shown in the table given below:—

Expenditure met from Revenue 1990-91 (Budget Estimates)

Estimate of expenditure under the revenue account for 1990-91 comes to Rs. 4010.23 crores which is Rs. 458.84 crores higher than the Revised Estimate of the expenditure anticipated to be incurred under the revenue account during the year 1989-90 (Revised Estimates).

Out of the total expenditure in 1990-91 Rs. 2662.99 crores or 66.40 per cent is earmarked for developmental purposes which is Rs. 301.84 crores higher than the expenditure expected to be incurred in 1989-90 (Revised Estimates) Non-Developmental expenditure is estimated at Rs. 1347.24 crores during 1990-91 which is Rs. 220.21 crores higher than that of 1989-90 (Revised Estimates). They are indicated as detailed below:—
