
## **FOREWORD**

## **PREFACE**










## **Birth Rate in U.T. Chandigarh (Combined)**




## Ninth Five Year Plan 1997-2002 (Actual Expenditure in %)




## **Annual Plan 2001-2002 (Actual Expenditure in %)**
