It is a great pleasure to release this small brochure containing 'State of Goa - Indicators of Socio-Economic Development, 1998', on the eve of the Thirty Eight Liberation day i.e. 19th December, 1998.

The brochure gives important statistical indicators as at the time of Liberation in 1961, at the time of Statehood in 1987 and those for the year 1998. The State was brought into the main stream of national development through implementation of the five year plans, soon after Liberation from the erstwhile Portuguese Regime. 
