Sub: Formation of 'Skill Development Mission.

In order to oversee and co-ordinate the implementation of the skill development activities carried out by various government/departments/ other related agencies in the state and to have an integrated system in place to ensure the development of all available human resources in the state as per the labour market requirements from time to time, the State Government is pleased to form the 'Jammu & Kashmir Skill Development Mission'.

Objectives of Mission:

- To draw out an integrated strategy for enhancing the employability of the youth in the state.
- To develop a comprehensive strategy for skill development of all the human resources in the state as per the local/national/global job market requirements so that the same are optimally utilized.
- To evolve a complete picture of and to co-ordinate the skill development programmes being/to be carried out by the different departments/agencies in the state.
- To monitor implementation of skill development programmes and to issue directions to remove the hiccups, as and when faced, so that the targets fixed are achieved within their time frame.
- To take necessary policy decisions from time to time.
- To ensure that the skill development programme is proceeding strictly in the direction of imparting demand driven skills to the youth and that the global level standards of training are maintained.
