

### 1. Introduction:

### 1.1 Brief history:

In Assam, National Programme of Nutritional Support to Primary Education (Known as Mid-Day Meal Scheme) was started w.e.f January, 2005 covering school-going children of Class I to VIII in Government, Provincialised & Government aided LP, UP, Composite High & Higher secondary schools, Special Training Centres (RSTC & NRSTC) as well as Madrassa/Maqtab covered under Sarva Shiksha Abhiyan and schools under National Child Labour Project (NCLP), run by the Labour Department. This programme has not only given an opportunity to the children of different strata to have nutritious food in schools together but also enhanced enrolment, retention as well as academic achievement. During the current year, altogether 45,22,806 nos. of children of the state are being covered through this programme.

### **1.3** Process of plan Formulation:

The Annual Work Plan and Budget 2014-15 has been formulated on the basis of data / information reflected in the district level plans submitted by each district with due approval of the District Nodal Officer (DNO), MDMS cum Deputy Commissioner/ Principal Secretary and data available in MDM MIS portal. In this connection, an orientation workshop was organized on 10<sup>th</sup> January, 2014 at state office for field level functionaries (DEEO, DMC, DROs & Officers involved in MDM works) to facilitate the process for formulation of AWP & B 2014-15 in the light of direction given by MHRD in this regard. Pursuant to this districts had organized orientation meeting for key officials (including block level officials) involved in the process for development of the plan.

Special attention has been paid to the process of plan formulation toward incorporating all the action taken points regarding commitment given to MHRD for implementation of the scheme under AWP & B, 2013-14, observations and recommendation of 5<sup>th</sup> JRM, issues/suggestions raised by primary stakeholders and community through different meetings as well as feedback received through Toll Free Contact Centre.



- 2. Description and assessment of the programme implemented in the current year (2013-14) and proposal for next year (2014-15) with reference to:
- **2.1** Regularity and wholesomeness of mid day meals served to children; reasons for programme interruptions, if any and planning to minimise them.

The State Government has taken all needful measures to run Mid-Day Meal programme in the state with utmost care and attention. School Management Committees (SMCs) and Mothers Self Help Group are involved at school level for smooth implementation of the programme. District Administration and District Elementary Education Office/SSA along with Gaon Panchayat Samabai Samittee (GPSS) are also playing a vital role for smooth running of the programme. In fact, steps were taken to ensure service of cooked and hot Mid–Day-Meal in school as per approved number of working days.

Minor interruptions were observed in MDM programme in a few schools in the districts of Karbi Anglong, Goalpara, Dima Hasao, Kokrajhar, Chirang due to local disturbances. However, with the exception of these extraneous factors, the scheme has been running smoothly.

2.2 <u>Coverage of children of NCLP schools as per upper primary norm. NCLP schools are primary schools but eligible for benefit as per upper primary norm.</u>

Altogether, 14380 children of 276 NCLP Schools (55 nos in Kamrup (M), 199 in Nagaon & 22 nos in Lakhimpur district) have been provided with Mid-Day Meal during current year as per upper primary norms.

2.3 <u>Food grains management, including adequacy of allocation, timeliness of lifting, transportation and distribution, and suitability of storage at different levels. Challenges faced and plan to overcome them.</u>

During 2010-11, the Central Govt. had issued new guidelines for making payment of cost of food grains at district level. According to the new system, the district authority of FCI will submit statement of cost of food grains to the DNO, MDM for payment of cost of food grains. The DNOs will submit the requirement of cost of food grains to the State Nodal Officer, MDMS, who will release the amount according to the availability of fund. During the current year, the SNO, MDM has released the cost of food grains up to September, 2013 to DNOs, which is being released to FCI by DNOs concerned.

The Central Government has released the allocation of rice on the basis of average attendance of students in the schools. Accordingly, rice allocation has been made district wise and district-wise break up has been communicated to the DNOs, MDM and FCI authority. In the current year, the Govt. of India has released rice and cost of foodgrains on the basis 4671994 nos of children availing MDM in the state. Rice lifted by School authorities is kept in the store rooms of kitchen-cum—store of respective schools.

District level storage for keeping rice as buffer stock will be beneficial in overcoming problems like shortage of rice and quality maintenance. Besides, transportation cost has been released upto November, 2013 for LP & upto December, 2013 for UP schools under current AWP & B.



2.4 <u>System for payment of cost of food grains to FCI. Status of the pending bills of FCI in the previous year.</u>

FCI Authority submits bills against cost of food grains in the office of the Deputy Commissioner and DNO, MDM and in case of Autonomous Council, in the office of the Principal Secretary, Autonomous Council on monthly basis/quarterly basis. As per guidelines DNO, MDM are to make payment to FCI after receiving the bills for the month/quarter concerned. Though the present status with regard to payment of bills is not encouraging in some districts, but steps are taken to ensure payment of bills at the earliest.

2.5 System for release of funds provided under MDM (Central and State). Please indicate the dates when the fund was released to State Authority / Directorate / District / Block / Gram Panchayat and finally to the Cooking Agency / School.

The State Govt. releases the fund to SNO, MDM cum Director of Elementary Education, Assam after receiving the concurrence and ceiling from State Finance Department. The Director of Elementary Education, Assam presents the bill of the sanctioned amount to the Treasury Office. After receiving the fund from Treasury, SNO releases the fund to the DNOs, MDM. The DNOs, MDM release the fund to the School Management Committee (SMC). The process has been found to be time consumes and hence, the State Govt. has now decided to release the fund against cooking cost & honorarium to cook-cum-helpers directly to the SMCs.

2.7 System and mode of payment of honorarium to cook-cum-helpers and implementing agencies viz. NGOs / SHGs / trust / centralized kitchens etc. This section should also include the details of cook-cum-helpers like eligibility as per norms, approval of cook-cum-helpers, engaged and the strategy to fill the gap (if any)

The State Government Finance Department releases the fund to the Education Department. The SNO, MDMS cum DEE, Assam draws the amount for honorarium to cook-cum-helpers and releases the same to the DNOs. The DNOs release the honorarium of cook-cum-helpers to the SMC which then makes the payment to cook-cum-helpers.



As regards NGO namely The Akhay Patra Foundation receives the fund from Deputy Commissioner & DNO, MDMS Kamrup (M) & Deputy Commissioner & DNO, MDMS Kamrup and the same is released in two ways to the Akhay Patra Foundation. The Akhay Patra Foundation releases the Honorarium to the cook-cum-helper engaged by them and release the fund to the SMC for making payment for honorarium to the cook-cum-helper engaged by SMC at school level.

2.8 <u>System for procuring cooking ingredients (pulses, vegetables including leafy ones, salt, condiments, oil and fuel etc.), Commodities, which are centrally purchased and supplied to schools or locally purchased at school level.</u>

The SNO cum DEE, Assam releases the fund for cooking cost to the DNOs and DNOs release the fund to the SMC for purchase of ingredients locally so that season wise available fresh vegetable can be provided with the meals. 593 schools located in and around Guwahati city are provided with MDM through Akshay Patra Foundation (NGO).

2.9 <u>System for cooking, serving and supervising mid day meals in the school and measures to prevent any untoward happening.</u>

The School Managing Committee (SMC) engages cook-cum-helpers mainly from members of Mother Group/ local female cook. Further, Mother groups of the school help in serving cooked food to the Children. The State Government has already issued notification for engagement of 10 member SHG (formed with mothers of the children studying) to supervise day to day activities in implementation of Mid-Day Meal scheme in the school and an amount of Rs.10,000/- per annum to each will be paid as a token of appreciation for their works. SMC members provide necessary support to implement the scheme smoothly in schools. Besides, steps like providing fire extinguisher, keeping away any toxic and inflammable materials from the class rooms & kitchen sheds, tasting



of food by teacher before serving it to children, ensuring proper hand washing etc are taken to avoid untoward incident. Strict instructions have been given to the field level officers to take precautionary measures for preventing untoward happening in schools in this regard. It is also ensured that Food Security Officer of centralized kitchen regularly monitor the quality of food.

# 2.10 <u>Procedure and status of construction of kitchen-cum-store.</u> This section should also include progress of construction of kitchen-cum-stores during this year and target for the next year.

The State Govt. has engaged two construction agencies namely HOUSEFED and Assam State Housing Board for construction of Kitchen cum Stores under MDM programme. Accordingly SNO, MDM has placed work order for construction Kitchen-cum-store one each in 44729 schools. Besides, fund has also been released for construction of Kitchen-cum-store in 8811 schools through SMCs concerned. Construction is under process.

(Out of 9273 non-started schools, 6019 Nos. of schools were sanctioned during 2008-09 @ Rs. 60,000/- per unit, which were not constructed by the Agencies entrusted for this work (HOUSEFED and ASHB) stating the plea of escalation of price and 3254 No. of schools were sanctioned during 2010-11 @ Rs. 141500/- per unit. Construction of these 3254 kitchen cum stores could not be taken due to low rate against State schedule of rate. It has been planned that fund received against these 9273 Nos of schools will be returned back to the Govt. of India with a request to sanction fund for these schools as per State schedule of rate.

### 2.11 <u>Procedure of procurement of kitchen devices from (i) funds released under the Mid-</u> Day Meal Programme (ii) other sources.

The State Govt. have engaged Assam Govt. Marketing Corporation and Assam Small Industries Development Corporation for procurement of kitchen devices for an amount of Rs. 883.20 lakh. 17666 Schools have been provided with kitchen devices in the year 2006-07. Thereafter, Govt. of India has sanctioned an amount of Rs. 663.85 lakh in the year 2007-08 (drawn in 2008-09) to provide kitchen devices 13277 schools and amount of Rs. 1566.20 lakh in the year 2009-10 (drawn in 2010-11) for 3132 schools. However, the amount could not be utilized due to pendency of High Court cases. The kitchen devices sanctioned during 2006-07, 2007-08 and 2008-09 are required to be replaced by new kitchen devices. Accordingly proposal was submitted for sanctioning of fund in order to replace the kitchen devices provided during 2006-07, 2007-08 and 2008-09, but due to delay in utilizing pending disposal of court case, further fund sanction is pending.

2.12 <u>Capacity building and training conducted for different categories of persons involved in the Mid Day Meal Programme. This section should include details of the training programme conducted for cook-cum-helpers, State level officials, SMC members, school teachers and others stakeholders along with target for the next year.</u>

NUEPA organized a three day orientation programme w.e.f. August, 24-26, 2009 on best practices in implementation of Mid Day Meal at NEHU Campus Shillong for the Officials of North Eastern States involved in implementation of Mid Day Meals Scheme in schools.

SSA, Assam as well as DIETs have also conducted training programmes for teachers to orient them on best practices to be adopted in schools for smooth implementation of Mid Day Meals scheme. Moreover, State Govt. has organized from time to time orientation programme for field level functionaries involved in implementation of MDMs. SMC members are given training on their role and responsibilities for proper implementation of MDMS.

MHRD, GOI has also organized a two-day orientation training programme for the Officers of North Eastern States engaged in Mid Day Meals scheme on 15<sup>th</sup> & 16<sup>th</sup> November, 2013 at Kohima, Nagaland to orient on formulation of AWP & B,2014-15.

Further a National workshop was organized by Central Govt. at Bangalore for preparation of district plan. Besides, day-long training programme was organised for cook-cum-helper by Akshaya Patra Foundation, Bangaluru for 120 cook-cum-helpers. Again, 10 days training programme was organised for 30 cook-cum-helpers by Institute of Hotel Management, Guwahati to train them as Master Trainer.

2.13 <u>Management Information System at School, Village / Gram Panchayat, Block, District and State level and its details.</u>

There is a strong MIS system in SSA, Assam to look after the effective implementation of Mid-Day Meal and SNO, MDM takes the help of MIS of SSA, Assam for collection of school information. Further the State Govt. has decided to set up an implementation mechanism including MIS system under MDMS from Block to State level. Advertisement in this context has been published and engagement will be done shortly.

Meanwhile, the Central Govt. has introduced MDM MIS system for collection of Data through MIS Portal. Annual as well monthly data entries are being done and data feeding in the portal is completed till December, 2013.



2.14 Systems to ensure transparency, accountability and openness in all aspects of programme implementation, including inter alia, foodgrains management, ingredients procurement, cooking and serving, appointment of cooking staff, construction of kitchen-cum-store, and procurement of cooking devices.

Utmost care is taken by the Department to maintain transparency and openness at all levels with regard to implementation of Mid Day Meals Programme. The DNOs, MDM allocate food grains to the Gaon Panchayat Samabai Committees (GPSS) as per allocation of food grains made by the SNO, MDM. Accordingly, the GPSSs lift food grains from FCI godown and deliver the same to the school through FPS. The others ingredients like pulses, vegetables, oil, condiments, fuel etc are purchased locally by the SMC of concerned schools. Mother Self Help Groups also look after day to day maintenance of the meals.

SMCs are assigned responsibility to engage cook-cum- helpers for cooking of meals. Further, State Government has entrusted the HOUSEFED and Assam State Housing Board for construction of Kitchen cum store and AGMC, ASIDC have been engaged for supply of cooking devices. SMCs of 8811 nos of schools are also entrusted for construction of kitchen-cum-store.

Measures taken to rectify the following shortcomings:

### a) Low and uneven utilization of food grains and cooking cost in some district-

Steps are taken to ensure availability of food grains and fund for cooking cost throughout the year through the field functionaries of Education Department. In this regard, instruction has already been issued to the DNOs, MDM and Field level Officers of Education Department. Field functionaries are asked to visit the schools and to take stock at regular interval.

### b) Inter-district mismatch in utilization of food grains and cooking cost.

Review meeting is conducted at regular interval with field functionaries to overcome the issues like inter-district mismatch in utilization of food grains and cooking cost, proper utilization of the fund, interruption due to local disturbances etc.

### c) Delay in delivering cooking cost at school level

In fact, releasing of cooking cost as per present system is found to be time taking. Therefore, State Govt. has recently decided to release cooking cost directly to the school from State through e-bank transfer.

### 2.15 <u>Details of Evaluation studies conducted by State/UTs and summary of its findings.</u>

Assam Mahila Samata Society and ACE Institute were engaged to conduct external evaluation on implementation of MDMS in schools of Assam in 9 & 18 districts respectively. Both the organisations have submitted their evaluation report. A summary finding of ACE Institute is given below.

The external evaluation study on MDMS in schools of Assam, conducted in 2009, provides information on overall functioning of the scheme and its impact on increase



of enrolment, attendance and retention of students in the primary and upper primary schools. The ACE Institute conducted the study in 2009 with the coverage of 4601 primary and upper primary schools in the 18 selected districts of Assam.

### Objectives of the study:

The overall objective of the study is to assess the impact of the MDMS on increase of enrolment, attendance and retention rate of the children- particularly the disadvantaged children in the primary and upper primary schools of Assam. The other objectives are (i) to examine the status and availability of infrastructure of the schools undertaking the Mid-day Meal, (ii) to evaluate overall the functioning of the MDMS in selected schools.

Findings of the study

### Operation and logistic of MDMS:

The study revealed that about 28 % schools served mid-day meals for less than 100 days, 24 % have served for 100- 124 days, 20 % for 125- 149 days, 13 % for 150 - 174 days, about 11 % schools have served MDM for 175-224 days. Only less than 1 % (19 schools) have served mid-day meal for 225- 254 days.

Though clear guidelines were given to the schools to display weekly menu, the study found that only about 24 % schools observed the guidelines.

The investigators of the survey find in about 30 % schools where Dal+vegetable+rice combined meals were prepared and served in 25 % schools prepared khichri. Payas, pulao, biriyani etc. had not been found favourable item in many schools. Moreover, it is to be mentioned that about 34 % schools could not produce their menu on the day of investigators' visit. Variation in menu is comparatively less- it is about 22 % only.

89 % cooks were found to be female. The caste composition of the cooks consists of SC-13%, ST-18%, OBC-27%, Muslim-17%, Tea Tribe-4% and Others -21%. It is observed that the cooks were appointed from the localities of the schools for which the caste of the cooks was mostly the same as that of the local population.

Helpers were mostly females. 58 % female helpers were appointed against only 4 % of male helpers.

About 82 % cooks received payment regularly against about 15 who received partly. On the other hand only 50 % helpers received payment regularly as well as partly. About 38 % schools have no helpers appointed.

About 85 % schools have utensils for cooking MDM and 47 % schools have storage facility in kitchen sheds. However 14 % used teacher's house, 4 % use fair price shops and 23 % use class rooms as store for keeping food grains.

Most of the schools (94 %) use firewood as fuel for cooking MDM against 5 % schools use LPG and 1 % use kerosene and other fuel.

About 71 % schools are found to have source of drinking water in the premises of the school. About 69 % use hand pump water, 4 % tap water, 9 % ring well water, 3 % pond water. Other schools use other source of water. It is also observed that about 57 % schools have water filter.



With regard to involvement of teachers in cooking process, the study finds that 68 % teachers participated in cooking process of MDM.

Regarding nutritional aspects, hygienic and good practices as well as management of hazard and wastage, the study finds some interesting results. Masur dal (48 %) and mixed dal (43 %) are two types of dal which are used mostly in MDM. About 77 % school use leafy vegetable in the MDM served in the schools. For taking meals, about 79 % schools used stainless steel plates, about 8 % used aluminum plates, about 6 % plastic plates and about 6 % used disposable plates. Besides, 60 % schools use aluminum pots and 37 % schools use iron pots for cooking foods.

About 89 % schools maintained proper hygienic practices to have MDM and out of this in about 8 % schools the cooks and helpers used caps, masks and gloves etc. 82 % schools washed vegetables thoroughly before cooking. Also 86 % schools trained children on hygienic and cleanliness issues.

It is found that about 88 % schools maintained cleanliness in dress, dish, hands and mouth. 86 % schools regularly inspect students' nails cutting, about 49 % schools conduct prayer before taking meal.

The study observed that 50 % schools took precautionary measures against fire, 50 % schools took measures against food poisoning, about 54 % schools took measures against food spoilage and about 56 % schools took measures against food wastage.

### Monitoring and transparency of the Scheme:

The success of any programme depends on regular and effective monitoring. This study finds that in the year 2008, only 144 schools were monitored by DEEOs, 81 schools by DIs, 337 schools by BEEOs and 545 schools by SIs in all 18 selected districts. It is observed that the norms like nos of days for monitoring of schools etc, as suggested by the Government is not followed at any levels during the year.

Participation of Mother Groups and School Management Committees (SMC) are significant. These two groups participated in 75 % and 87 % respectively.

The study results observed that about 74 % SMC members were present at the meal serving time; about 64 % schools weigh rice in presence of SMC members, about 69 % schools conduct quality checking through Mothers' Groups members. The villagers of the locality of about 68 % schools were aware of purchasing food grains, quality and quantity of the food served.

### Maintenance of accounts & registers:

With regard to maintenance of accounts and regularity in submission of utilisation certificates, this study finds that about 94 % schools maintained the accounts and registers and about 88 % submitted the utilization certificates regularly.

The schools offering mid-day meals have to send information with regard to lifting of rice and receipt of fund for cooking separately to the District Nodal Officer (DNO) and DEEO. The estimates of the study do not find better correspondence in this regard. Only 58 % schools observed this norm.

About 92 % schools maintained schools inspection registers and 72 % schools recorded the observation of the inspection in proper registers.



### Impact of the MDMS:

The study also investigated to find the impact of the mid-day meal scheme on increase of enrolment, attendance and retention of students at the schools. The results reveal that the respondents of about 68 % schools admitted increase in attendance, of 42 % schools respondents agreed in increase enrolment after introduction of mid-day meal at the schools.

### 2.16 Brief write up on best practices followed in the State.

The best practices adopted in implementation of MDMS are as follows:

- (1) Cleaning of dish, mouth and hands before eating food and washing hand after taking food.
- (2) Awareness about the hygienic and cleanliness practices.
- (3) Discipline and Eco-friendliness.
- (4) Prayer by students before meal.
- (5) Inspection of finger nail at regular interval.
- (6) Inspection of wastage / spillage / spoilage and taking steps by SMCs.
- (7) Precaution against fire & food poisoning.
- (8) Food & Nutrition teaching.
- (9) Development of Kitchen garden in the schools.

## 2.17 <u>Instances of unhygienic food served, children falling ill, sub-standard supplies, diversion/misuse of resources, social discrimination and safety measures adopted to avoid recurrence of such incidents.</u>

No instance/ information for unhygienic food served, children falling ill, sub-standard supplies, diversion/misuse of resource, social discrimination etc are received from field level. However, necessary instruction has been issued to the field level offices for taking safety measures to avoid recurrence of incident.

2.18 System of Tasting of food by teachers and testing of food sample by any reputed labs.

Cooked food is tasted regularly by teachers/SMC members 30 minutes ahead of distribution to the children. It is proposed that, steps will be taken to test the quality of food in labs. Besides teacher's sensitisation programme on MDMS will be taken in convergence with teacher's training programme of SSA, Assam under AWP & B 2014-15.

2.19 Extent of involvement of NGOs and Civic Body Organizations (CBOs)/PRIs in the implementation and monitoring of the Scheme.

Akshay Pattra foundation, a reputed NGO has been taking the responsibility of serving hot cooked Mid Day Meal to 593 LP and UP Schools of Guwahati urban areas with effect from November, 2009.

No. of Schools covered: 593 of Kamrup(M) & Kamrup district.

No. of Children covered: - 51894



#### Mechanism:-

The NGO has one central kitchen where meals are prepared. Hot cooked meal is packed school wise in big Tiffin carriers and delivered to concerned schools before 12 Noon by 30 delivery vans.

PRI (one PRI member is a member of SMC of his/her local school) is involved in monitoring of MDMS in schools. SMCs and Mothers Self Help Groups are fully involved in day-to-day maintenance and implementation of the MDMS.

2.20 <u>Status of School Health Programme with special focus on provision of micronutrients, Vitamin-A, de-worming medicine, Iron and Folic acid, Zinc, distribution of spectacles to children with refractive error and recording of height, weight etc.</u>

NRHM, in coordination with Education Department/SSA has been conducting School Health Programme in all schools of the state under Rastriya Bal Swastha Karyakram programme. Iron-folic acids and Vitamin —A are also supplied to schools under WIFS programme. Provision of micronutrients alongwith MDM food is being considered.

2.21 <u>Present monitoring structure at various levels. Strategy for establishment of monitoring cell at various levels viz. Block, District and State level for effective monitoring of the scheme.</u>

The state Govt. had notified the formation of State, District & Block level Steering cum Monitoring Committee for over all monitoring of the implementation of Mid-day Meal programme. District Level Monitoring Committee headed by senior most MP of the district has been constituted and meeting of the committees is held to review the status of implementation of the programme. All 27 districts have held the meetings. The School Management Committee has already been constituted in schools inducting 75% parents' members of the state. SMC look after day-to-day implementation of the scheme with close co-ordination with teachers and along with Mothers Self Help Group.

Regarding the Development of Management Information System (MIS) with integration of interactive voice response system (IVRS), Deputy Commissioner, Nagaon cum DNO, MDMS has introduced the system in the district w.e.f October, 2013-14.

2.22 <u>Steps taken to strengthen the monitoring mechanism in the Block, District and State level and status of constitution of SMCs at these levels. Status of formation on School Management Committee at village / school / cooking agency level in the light of Right to Education Act, 2009.</u>

In order to monitor the implementation of Mid-Day Meal Schemes in true spirit, the Govt. of India has introduced MIS web Portal through which, all the required information of the schools will be collected.

School Management Committees (SMCs) are constituted in schools of the state in the light of RTE Act, 2009, which is playing an active role in the proper implementation of MDMS. Members of the SMCs are given training on various pertinent issues including MDMS.



Besides, steps have been taken to constitute dedicated cell of MDMS at State, District and Block levels inducting experienced and qualified staff. In this context, advertisement has already been published and process has been initiated

2.23 Frequency of meeting of District Vigilance & Monitoring Committee held under the chairmanship of senior most MP of the District to monitor the scheme. Gist of the issues discussed and action taken thereon.

District level Monitoring Committees meeting is held at district level. All districts have completed one round of meeting during current year. The following issues are mainly raised in the meeting-

- Quality of food and menu
- Construction of cooking shed
- Regular monitoring of schools by grass root level functionaries
- Relieving teacher from day-to-day implementation of MDMS.
- 2.24 <u>Arrangement for official inspections to MDM centres and percentage of schools inspected and summary of findings and remedial measures.</u>

The Director of Elementary Education, Assam and SNO, MDMs have issued instruction to the district level, Sub-divisional level and Block level officers to inspect at least 25% schools/ centres in every quarter. Most of the district level officers have inspected schools regularly. Target for school inspection has been fixed as below for DEEO, D.I. of schools, BEEO, S.I. of schools.

- DEEO will have to visit 15 schools in a month.
- D.I of schools will have to visit 20 schools in a month.
- BEEO will have to visit 25 schools in a month.
- SI of schools will have to 40 schools in a month.

70% of inspections have been completed. Most of the officers have submitted the finding of the inspection report in the review meeting of the MDMs and officers have been asked to take remedial measures in respect of poor performing schools immediately. Further officers from State Offices have also visited the schools time to time and action has been taken as per observation/report.

2.25 <u>Feedback/comments in respect of report of Monitoring Institutions designated for your State/UTs to monitor implementation of MDM and action taken thereon.</u>

Last year, the Monitoring Institute submitted reports in respect of their visit to Golaghat, Jorhat & Lakhimpur districts. The faculties of Monitoring Institute have visited 40 schools in each district. Based on the report of Monitoring Institute, the District officials were asked to take remedial measures on the weak areas for proper implementation of the scheme.

This year, no such report from the Monitoring Institute has been received so far.



### 2.26 Details of the Contingency Plan to avoid any untoward incident.

To prevent untoward incidents the Bihar incident, the DNOs, MDMS cum Deputy Commissioners/Principal Secretaries (Autonomous Council) are instructed by the Govt vide letter no. PMA/MDM-Cell/62/2011/36, dtd 25<sup>th</sup> July,2013 to ensure having of a contingency plan at School, Block, Sub-Division and at the District Level to face any sort of incident that may occur in connection with MDM scheme. The contact numbers of important functionaries are to be displayed in school, visible to all to use at urgent/emergency moment.

### Detail contingency plan to avoid any untoward incident.

Taking lesson from the Bihar incident, the DNOs, MDMS cum Deputy Commissioners/Principal Secretaries (Autonomous Council) are instructed by the Govt vide letter No. PMA/MDM-Cell/62/2011/36, dtd 25<sup>th</sup> July,2013 to ensure having of a contingency plan at School, Block, Sub-Division as well as at the District levels to face any sort of untoward incident that may occur in connection with implementation of MDM scheme. The contact numbers of important functionaries are to be displayed in prominent place of the school to use at urgent/emergency incident.

### i. Contingency Plan for district:

The important phone numbers of Deputy Commissioner, Additional Deputy Commissioner, District Civil Hospital, Ambulance service, DEEO, DMC are to be reflected on the wall of DEEO/ DMC office and Inspector of Schools office.

### ii. Contingency Plan for Block:

The important phone numbers of Deputy Commissioner, Additional Deputy Commissioner, District Civil Hospital, Ambulance service, DEEO, DMC, BEEO, BMC, Public Health Centre are to be reflected on the wall of BEEO/BMC office.

### iii. Contingency Plan for Schools:

- The important phone numbers of Deputy Commissioner, Additional Deputy Commissioner, District Civil Hospital, Ambulance service, DEEO, DMC, BEEO, BMC, Public Health Centre, Headmaster of the school, SMC President are to be reflected on the wall of School.
- Schools should keep First-aid-Box with adequate medicines, bandage, detol, cotton etc.
  - Despite pre-caution, if any untoward incident happens the following steps are to be taken by District authority / school authority.
- ✓ If cooked food is found contaminated that may be buried under ground.
- ✓ Unusable rice may be destroyed in presence district administration.
- ✓ Always used agmarked oil, turmeric etc in cooking food.
- ✓ Cooked food must be tested by the teacher/ SMC member before 30 minutes ahead of distribution among the children.
- ✓ Phone No. of nearest Primary Health Centre, Hospital, DMC, DEEO, BDO, Fire Station, Ambulance Service are to be printed in wall of the veranda.
- ✓ Fast aid training need to be important to the teacher & SMC members.
- ✓ Fire extinguisher shall be installed in the school.

In this regard, advisory from the Govt will be issued to District Administration, district and block officials of Education Department and School authority for strict compliance.



2.27 <u>Grievance Redressal Mechanism if any, used by the States / UTs. Details of complaints received, nature of complaints and time schedule for disposal of complaints.</u>

A Grievance Redressal cell has been formed vide letter No. EPM/14/2011/5 dtd. 8/4/2011 in the Directorate of Elementary Education, Assam in order to dispose off the complained received in respect of implementation of Mid Day Meal scheme. Altogether 12 complaints have been received by the Directorate. The field level officers have been asked for making enquiry into the complaints. A toll free contact centre is set up at SSA State office, through which 47 complaints /grievances are received so far. Complaints are referred to the concerned district officials to enquire into the matter with competent authority and to take actions deemed appropriate.

2.28 Awareness Generation / Media campaign, if any.

Various steps are taken for awareness generation on MDM in the state. Hoardings on MDMS as IEC were installed in prominent places of district headquarters. Arrangement has also been made for fixing / fitting MDM logo in all schools of the state. MDM Calendars having information with regard to the scheme and role and responsibilities of stakeholders are also provided to schools and offices of Education Department. In SMC training, issues related to MDM are also shared. Detail plan of activities may be seen in the plan under MME head.

2.29 Overall assessment of the manner in which implementation of the programme is contributing to the programme objectives and an analysis of strengths and weaknesses of the programme implementation.

Impact of MDM scheme is found to be wide and varied. The impact of the Scheme has been considerably significant with regard to enrolment and retention of children in school. The food provided in school has given physical and mental strength to the children for study and created a joyful atmosphere in class rooms.

So far as the implementation of MDMS in the state is concerned, the areas of strength and weakness may be mentioned as below.

### Strength:-

- 1. Absence of social and caste prejudice
- 2. Awareness of parents/guardians.
- 3. Adequate budget provision.
- 4. Incorporation of hand wash, bathing, regimes in the cultural mores.


#### Weakness:-

Following steps are proposed to be taken to improve the performance:

- (i) Review meeting will be conducted with the Deputy Commissioner / Principal Secretary at State Level in each quarter to resolve the problems/bottlenecks.
- (ii) Meeting will be conducted in the months of April & October with field officials of concerned districts to discuss issues. Strict direction will be given to improve performance.
- (iii) Inspection from State as well as District levels will be strengthened and stern & exemplary action will be taken against erring functionaries/school authority.

### Strategies to ensure timely release of fund:

Smooth implementation of Mid-Day Meal Scheme is fully dependent on timely release of fund to the SMCs. In fact, delay in release of fund at different levels has been observed during the current year, which needs to be addressed.



Following activities are proposed to be carried out in order to ensure timely release of funds:

- Constant effort of follow up from the implementing Department will be made in order to reduce the lag in release of ceiling by Finance Department, Govt. of Assam. If required, meeting with officials concerned will be orgainsed to ensure timely sanction and release of fund by the Finance Department.
- Cooking Cost & Honorarioum to Cook-cum-Helper will be released to the SMCs directly through e-transfer w.e.f 1<sup>st</sup> April, 2014. The SMCs will release the same through a/c payee cheque based on their attendance.
- Specific time frames will be given to respective levels viz, State, District & SMCs to release the fund from date of receipt from the implementing Department/ Finance Department.
- For release of fund (Central & State Share) from state exchequer to SNO, monitoring at the highest level, i.e. by Chief Minister, Minister Education, and Chief Secretary / Additional Chief Secretary will be undertaken regularly.

Receipt and release of fund will be reviewed every month and steps will be taken as per need.

### **Convergence activities with line Departments:**

State has already initiated steps to develop Kitchen Garden in schools in co-ordination with Department of Agriculture and Horticulture, Govt of Assam. It is expected that Kitchen Garden would be developed in all schools availing MDM through active involvement of SMCs and Mothers Groups.

Regarding Rastriya Bal Swastha Karyakram, Department of Education has closely involved in implementation of the programme. Convergence NRHM has already been initiated, The State Programme Officer (IE) and State Programme Officer (CM) of SSA are the Nodal Officer of RBSK. Nodal Teachers from each school have been trained in WIFS to ensure that all children are benefited from the schemes like RBSK, WIFS, Vitamin-A supply etc.

Convergence meeting will also orgainsed with Social Welfare and Labour Department to ensure coverage of all children especially working child and Children with Special Need.

Regular meeting with PHE Department will also be orgainsed to ensure safe drinking water in all schools.

In this connection, a working group with the functionaries of Health/NRHM, Social Welfare, Labour, Agriculture, Horticulture, Food and Civil Supplies and PHE Departments will be formed to monitor and carry forward convergence activities.

Foodgrains (Rice) is provided at the rate of 100 grams per child per day in LP and 150 grams per child per day in UP & NCLP schools. 72041.354 MT of foodgrains are lifted to schools till 3<sup>rd</sup> quarter against 116360.100 MT approved by Govt. of India under AWP & B, 2013-14. For the year 2014-15, an amount of Rs. 6359.18 lakh for 112551.827 MT of foodgrains will be required as cost of foodgrains @ Rs. 5640/- MT to provide MDM in schools ( 210 days for LP & 220 days for UP & NCLP).

### D. Proposal for requirement of cooking cost:

Cooking cost is provided for procurement of pulses, vegetables, oils and fats, salt and condiments and fuel through SMCs. SMCs procure these materials through local shopping. In Assam, mostly fire wood is used as fuel for cooking of the meal. In urban areas, 538 nos of schools are also using LPG to cook the meal.

Cooking cost in presently released through DNOs to SMCs. However, preparations have been made to release Cooking Cost directly to SMCs from SNO through e-transfer with effect from 1<sup>st</sup> April, 2014 to reduce to time at intermediary levels

The members of the State Steering cum Monitoring Committee have suggested that the rate of cooking cost against LP & UP should be same as the cost of fuel, ingredient etc. used for



cooking of Mid-day Meal is almost same for the children of both the levels. Govt. of India may consider to raise the cooking cost of LP level to make it at par with UP level.

Total amount proposed against cooking cost is Rs. 40293.55 Lakh. Details at table below---




### G. Engagement of Mothers Self Help Group:

The Govt. has decided to pay Rs.10,000/- per annum as a token of appreciation to the Self Help Group. The total requirement of fund will be of Rs.5801.70 lakh. The amount is required to be reflected in the State Budget of 2014-15 as State scheme.

### H. Plan under Management, Monitoring and Evaluation (MME) for 2014-15

1. Setting up of Management Structure & Capacity building up of staff. : The State Government has decided to implement MDMS through Sarva Siksha Abhiyan, Assam with dedicated MDMS cells and experienced as well as qualified staff w.e.f 1<sup>st</sup> January,2014. Accordingly, process has been initiated to engage staff (411) in the MDMS cells viz., State, District and Block levels and the process will be completed very soon. This pool of manpower will mainly be utilized for management, monitoring and maintaining and updating of all records related to MDMS. All staffs/functionaries of the cells will be given training with regard to their roles and responsibilities and will also be provided with furniture and computers/laptop to carry out activities in prompt manner.

  - (c) Training module will be developed in consultation with the organization to be involved in the Master Trainers training programme and RPs.

### I. Hand Wash facilities in schools and promoting good habits among children



Hand washing before and after MDM is a prerequisite to maintenance of child health. Meals taken by children with dirty hand undemines the efficacy of the MDM programme. There is consistent evidence that handwashing with soap at critical times – including before eating or preparing food and after using the toilet -- can reduce diarrheal risk by about 45 per cent (Source: Global Hand Washing Fact sheet, UNICEF,2013). Diseases such as diarrhea, intestinal worms and respiratory infections lead to school absenteeism, increased drop-out rates and impact on children's physical and cognitive development as well as education attainment.

Functional WASH (Water and Sanitation Hygiene in schools) infrastructure enables children to internalize related behaviours and influence their families and communities to adopt hygiene practices. In Assam, installation of Mass Hand Washing facilities with soap was piloted in 100 schools of Rani & Rampur Block with the support from UNICEF under Daily Handwashing for an Ailment-free Life (DHaAL) project w.e.f July,2013. In the year 2012, all schools were asked to utilized some amount from SSA, school grant to purchase soap. Preliminary observation of the efforts have shown considerable improvement in attendances, reducing diarrhea related diseases and promoting good hygiene habits among children. This effort was highly appreciated by the members of 5<sup>th</sup> JRM and JRM had suggested to upscale the programme to all other Govt/Provincialised schools of the State.

It is, therefore, planned to upscale the initiative to all elementary schools of the state in phased manner and this year, 10,000 schools preferably in Char, Tea Garden , ST & SC dominated areas is proposed to cover under AWP & B,2013-14 MDMS.

The activity will be carried out through the Civil and WASH wings of SSA, Assam. Design and estimate of the structure is given below. An amount of Rs. 1000.00 lakh (@ Rs. 10,000/- per school) will be required to cover 10,000 schools.

### J. Proposal for Kitchen Devices:

Kitchen devices viz, Aluminum Soucepan (Big Size), Aluminum Bucket, Iron Kerahi, Sterilized Steel Mug, Iron Khanti were provided to 17666 Govt/Provincialised elementary schools in the year 2006-07. As per norms of Govt of India, these devices have to be replaced since it has crossed 5 years duration from the year distribution.

Fund released by Govt of India of Rs. Rs.663.85 lakh in the year 2008-09 and of Rs. 1566.20 lakh in the year 2001-11 for Kitchen Devices could not be procured due to pending High Court Cases. Now, process has been initiated to provide Kitchen devices to 44601 nos of schools @ Rs. 5000/- per school to cover 5917 nos of schools where the Kitchen Devices require to be provided.

It is, therefore, proposed to provide Kitchen Devices to 11749 nos of Schools under AWP & B,2014-15 for replacement of the items provided during 2006-07. An amount of Rs. 587.45 lakh will be required to provide the items @ Rs. 5000/- per school.

538 nos of schools of the state mainly in urban areas have taken LPG connection for cooking of Mid-Day-Meal. These schools are availing of fund against unsubsidized LPG Cylinder of 20 per school per year.

This year, in addition to 538 schools, 2498 nos of Govt/ Provincialised schools (5% of total Govt/ Provincialised) is proposed to cover under this activity. Total Rs. 816.684 lakh amount will be required to implement the activity. Detail is given below:
