



# **Mid Day Meal Scheme Annual Work Plan and Budget 2008-09**

## **1. Introduction**

### **1.1. Brief history, Objectives and Rationale of the Mid - Day Meal Programme.**

#### **Brief History :-**

As a State Govt.'s major initiatives towards its commitment for social welfare and social integration, the Mid Day Meal Scheme was introduced in the state since 1984, wherein the children studying in std. I to VII studying in all Govt. primary schools are served with hot cooked meal. The grant-in aid schools were also subsequently covered under this scheme. At present, about 4839001 children studying in 37134 primary schools [including AIE centre ] (Std. I to V) are taking benefits of this scheme.

Government of India has also introduced a scheme of National Programme of Nutrition Support to Primary Education (NP-NSPE) for the children of Std. I to V under which 100 gms. of food grains and Re.1.50 per child per day cooking cost are provided by Government of India. The State Government bears entire cost of mid day meal provided to the students of Std. VI&VII, Excluding free foodgrains in 85 EBBs blocks of upper primary stage for Std.vi to vii W.e from October-2007.

#### **Objectives :-**

1. To improve the nutritional and health standard of the growing children.
2. To reduce drop-out rate and to increase attendance and to attract poorer children to come to the school.
3. To create supplementary employment opportunities at the village level.
4. To promote social and national integration.
5. To supplement the state efforts towards reduction in poverty.

## Programme Implementation :-

Weekly menus have been prescribed by the District Authorities, based on average daily composition comprising following food components.

#### 1.4. Nutrition status :-

State Govt. is in process of finalising agency to study latest nutrition statuses of children.

#### School Health Check-up Programme :

Gujarat State has the prestige of carrying out school Health Check-up Programme since 8 years. It covers primary school children studying in the Std. I to VII. The details of school health programme as received from health Department are given below :-

- (a) 7,39,755 tables of Vitamin-A were distributed in the year
- (b) 3,22,675 iron/folic acid tablets distributed.
- (c) 3,22,260 de-worming tablets distributed.
- (d) 84,17,655 children were checked/examined and their height/weight were recorded.
- (e) Details regarding special treatment given to children.

Drugs are provided free of cost for skin disease de-worming is carried out and iron folic acid is provided in cases of anemia etc. Every year drugs of more than Rs. 100 lakhs are being provided under the special school health checkup programme.

Education Department has provided first aid box in each primary school.

**2. Description and assessment of the programme implemented in the previous year (2007-08) with reference to :-**

**2.1. Calorific-protein value of the mid-day meal provided**

According to local tastes, likings and available resources, Weekly Menu (Annexure -A) has been in force for every district. As it is based on minimum food composition as mentioned in para-1.1, daily calorific / protein values is as under.

**2.4. Foodgrains management, including adequacy of allocation , timeliness of lifting, transportation and distribution, and suitability of storage at different levels.**

The Gujarat State Civil Supply Corporation has been entrusted the task of procurement and supply of foodgrains and other food commodities. Edible oil, pulses (dal ), as well as foodgrains for children studying in std. I to V are procured by them through a centralised purchase system.

Based upon the prescribed daily food components and probable number of beneficiaries of students, a six monthly indent is sent to the GSCSC for procurement of all food commodities. After procurement, all commodities are supplied up to the level of MDM centre through the Public Distribution System.

**2.5. Central Assistance received and utilized towards (a) cooking costs, (b) kitchen shed construction, (c) procurement of kitchen devices, (d) management, monitoring and evaluation, (e) transport subsidy.**

**(a) Cooking Cost :-**

As narrated in above paragraph, regular payment is made to GSCSC towards the purchase of food commodities. More over Rs. 0.70 ps. per child per day is being paid every month in advance to all the MDM organizers to meet the miscellaneous expenditure on cooking i.e. spices, grinding, fuel , vegetables ( 50gms. per day ) etc. If administrative cost is added to the above two, per child per day cost comes approximately Rs. 3.14 ps., against which the central assistance of Rs. 1.50 for std. I to V and Rs. 2 for std. VI to VII ( Upper primary stage ) is adjusted and utilization certificate is being issued accordingly.

**(b) Kitchen - shed Construction :-**

This year an amount of Rs. 3790.56 lakhs has been released by the GOI for construction of kitchen-sheds to Gujarat State. As per the G.O.I. circular No. F.-1(3)2008-Desk(MDM) Dtd. 23/01/2008. The amount is handed over to Serva Shiksha Abhiyan to construct kitchen sheds @ Rs. 60,000. Clarification was sought from G.O.I. which was received by Govt. of Gujarat on 30.01.08. Now the construction process has started and would be completed soon.

**(c) Procurement of kitchen devices :-**

This year Rs. 1119.95 lakhs have been released by the GOI for procurement of utensils of kitchens in MDM Centres to Gujarat State. The amount was then disbursed to VECs for purchase of kitchen devices in all districts.

**(d) Management, monitoring and evaluation :-**

This year Rs. 125.42 lakhs have been revalidated of year 2006-07. detailed planning ; necessary provision has been made for utilisation of this amount.

(c) Transport subsidy :-

Central Assistance for transport subsidy is paid by the GOI directly to The Gujarat State Civil Supply Corporation according to transportation of foodgrains on the quarterly basis by MOHRD at the rate of Rs. 75/- per quintal.



**2.9. System for cooking, serving and supervising and mid day meals in the school.**

- 1) The MDM centre is run Managed by the Organizers
- 2) Under the supervision of organiser, a cook prepares the food as per the menu.
- 3) To assist the cook and to serve the food, a helper is also appointed at each centre.
- 4) Helper also helps the children to clean their plates and wash their hands.

**2.10. Status of construction of kitchen sheds from (i) funds released under the Mid Day Meal Scheme, and (ii) funds from other development programmes, such as SGRY, BRGF etc.**

- (i) Out of total 30731 MDM centres, 13176 have pucca kitchen sheds and 3369 have kachha kitchen sheds.
- (ii) During the year 2007-08, 7474 kitchen sheds were proposed to be constructed as following.

- (iii) For the next financial year the State Government intends to provide 8815 new kitchen sheds from the fund available from TASP, SSA and MDM.

**2.12. Capacity building and training conducted for different categories of persons involved in the Mid Day Meal Programme under programmes of SSA, DIETs, etc.**

We have organised a comprehensive training programme for about 60,000 organiser and cooks, working in MDM based on the availability of fund under MME. The training programme will be completed during the current year by Food and Nutrition Department M. S. University, Vadodara.

**2.13. Management Information System at School, Village / Gram Panchayat, Block, District and State level.**

Office up to taluka level have been covered under LAN/GS-WAN by State Govt. All offices from taluka level, district level to commissionerate have to be fully computerised and a software to be prepared to get on line information of static data, operational data from MDM centre to State level.

**2.14. Systems to ensure transparency and openness in all aspects of programme implementation, including inter alia, foodgrain management, ingredients procurement, cooking and serving, appointment of cooking staff, construction of kitchen sheds, procurement of cooking devices.**

- (i) Daily food composition ( inputs ) is prescribed.
- (ii) Weekly menu are fixed and displayed at every school / centre.
- (iii) Centralised procurement system adopted by the GSCSC for purchase of edible oil ; pulses etc.
- (iv) The foodgrains and other commodities are regularly tested in laboratories.
- (v) Procurement and supply of all commodities is based on numbers of beneficiaries.

vi) All accounts of MDM are maintained at centre, taluka, district and state level.

(vii) Cooking staff is appointed as per this office circular No. MDM/AML/4568-4636 Dt. 17.05.2006. At District level Dy. Collector invites applications from local persons and the staff is appointed by the committee headed by Dy. Collector.

The grant for construction of kitchen sheds is allotted to S.S.A.

Cooking devices are purchased by VEC's locally.

### **2.15 Measures taken to rectify**

- (a) Inter-district low and uneven utilization of food grains and cooking cost.**
- (b) Intra-district mismatch in utilization of food grains and cooking cost.**
- (c) Delay in delivering cooking cost at school level.**

#### 2.15

(A) Cooking cost is given to the districts at the rate of Rs.O. 70 per child per day for purchase of vegetables, spices, fuel etc. Rest of cooking cost is given to the Gujarat State Civil Supplies Corporation for purchase of pulses and oil. It is done at the Head Office level and in the format of Govt. of India, which covers details of district wise expenditure. We show districtwise expenditure by just estimation hence it cannot be precise and accurate that way.

Due to the above procedure it is obvious that some variations in utilization of cooking cost & foodgrains may be found.

2.15 (B) For the requirement of foodgrains for std. I to V, the number of anticipated beneficiaries was 33.21 lakh where as actual number of beneficiaries 32.63 lakhs as on September-07. The basis for the allocation of foodgrains is anticipated beneficiaries whereas cooking cost is given on basis of actual beneficiaries. Hence this has become the main reason for slight variation and that's why the percentage of cooking cost and foodgrain did not tally with each other..

## 2.15 - ( C )

Necessary fund required at school level is released in advance every month from the state budget and it is adjusted with the fund released by the Central Government. Thus question of delay in delivering cooking cost at school level does not arise.

## 2.16. Overall assessment of the manner in which implementation of the programme is contributing to the programme objectives and an analysis of strengths and weaknesses of the programme implementation.

1. During the year 2006-07 the dropout rate has decreased up to 3.24 % in Std. I to V and 10.29 in std. I to VII.
2. The enrollment has increased.
3. The people's participation is promoted through " Tithi Bhojan " concept.
4. Teachers / Mothers and parents take active part in implementation.
5. On experimental basis the implementation is handed over to NGOs.

## Norms for appointment of Honorary Staff

### Conditions :-

1. Age :- The minimum age limit 20 yrs. and maximum age limit 55 yrs for general candidates. In case of SC/ST/ OBC candidates the maximum age limit is 58 yrs.

10. A person running floor mill will not be eligible.
11. A person engaged in the trading of vegetable, condiments on firewood will not be eligible.
12. A person already working or any post and getting honorarium will not be eligible.
13. A person engaged in Home Guards will be eligible.
14. A person retired/suspended or dismissed from any job of State/Central Govt. will not be eligible.
15. A person running Govt. Fair Price shop will not be eligible.
16. A person engaged in occupation like advocate will not be eligible.
17. The application received after the prescribed date will be fill without any procedure or intimation.
18. The attested copies of the testimonials regarding proof of educational qualification, age, residence etc. should be attached with the application form. The incomplete application will be rejected.
19. A candidate will have to remain present at a place & time prescribed for personal interview at his own expenditure.
20. The right to file or reject any application due to administrative reasons is reserved.



	The programme has been extended to reach out to geographically remote and difficult areas poor and backward sections of the society EGS and AIE centres etc. in the State of Gujarat.

	As per enclosed statement-I inspections are conducted in more than 25% schools in every quarter.

	As per enclosed statement - II we have appointed dedicated staff to implement the scheme and monitor its progress.
2(iv)	What efforts are being made for convergence with respect to infrastructural gaps especially girls toilets in upper primary stage and the School Health Programme of the Ministry of Human and Family Welfare.
	The matter is related to Sarva Siksha Abhiyan and the same is monitored by the State Director, S.S.A. The school Health Programme in the State is run by the Health Department.
3(i)	The low and uneven utilization of Central Assistance in terms of foodgrain and cooking cost. Intra district mismatch in utilization of foodgrain and cooking cost is another area of concern. Many of these problems could be sorted out by suitable addressing logistical and systemic issues to ensure smooth and timely flow of fund resources at various levels. Hence establishing a robust and fool proof monitoring system at all levels is of paramount importance.
	Proper care is being taken in reporting from taluka and district level for utilization of food grains and cooking cost. In the State of Gujarat foodgrain utilization is 28.09 % and utilization of cooking cost is 29.02 % during the month of August-07. So there is no problem of low and uneven utilization of C.A. in terms of foodgrains and cooking cost. We have a set system for monitoring the scheme at taluka, district and H.O. level.

Payment to cooks, in many States, is at a level below the minimum wages and the payment is also irregular. Many States have left the issue of payments of cooks to the school level implementing authorities, which causes adhocism and severe hardships. Some States for example Karnataka, Himachal Pradesh and Tamil Nadu have evolved State level norms for appointment as well as payment of salaries to cooks and helpers. Other States should study these systems and evolve suitable State norms.

A proposal to raise the honorarium to organisers, cooks and helpers is under consideration of State Govt.

Complaints are received about the quality and quantity of the food served to the children under the MDM. There is need to address these issues by taking suitable remedial measures in such a way that they do not recur.

We have taken suitable remedial measures by instructing the district, taluka to inspect the M.D.M. centres as per norms and to take care of quality and quantity of food. Moreover V.E.C. MTA & mothers are also encouraged for their involvement in the scheme.

It is also necessary to track the expenditure incurred by the States / UTs against funds released during 2006-07 & 2007-08 under various components of MDM to facilitate the release of second installment of Central Assistance for 2007-08

Proposal for second installment of Central Assistance for 2007-08 has been sent to the G.O.I.

6	<p>Shri. B. B. Swain, Education Secretary, Government of Gujarat, stated that the MDM Programme is being implemented in the State since 1984. Centralized kitchens are functioning in Gandhinagar and Ahmedabad, while in other districts there are school-based kitchens. At the primary stage, enrollment has increased by 1.25 lakhs. Shri. Swain stated that in Gujarat the primary and upper primary stage covers classes I to VII. Class VIII falls in the secondary stage of education, along with classes IX-X. Given this system of primary, upper primary and secondary education in Gujarat, the MDM for the upper primary stage can be provided upto Class VII (not VIII) only. He also stated that at present, fortified food is given under the ICDS Programme, wherein micronutrient and iron is mixed with cooked food. The State Government is taking steps to provide iron fortified Atta under the Mid Day Meal programme through the State Civil Supplies Corporation. In response, State representative assured that necessary corrective remedial measures would be taken. 	After getting enquiry reports on complaints, VIP references and press reports etc., necessary action is taken at the earliest and action taken report is submitted to the Govt. from time to time.
6.8	<p>Govt. of India has designated 41 leading social sciences institutions to periodically monitor the implementation of SSA and SSA and MDM. Sardar Patel Institute of Economic and Social Research ( SPIESR), Ahmedabad is the monitoring institute for the State of Gujarat. The report received from the SPIESR, Ahmedabad for the period 1<sup>st</sup> April, 2006 to 30<sup>th</sup> September, 2006 was forwarded to the State Government on 4<sup>th</sup> April, 2007. Following gist of the findings of the MI is summarized and the same was also brought to the notice of the State Representative.</p> <p><i>“ It was observed that MDM was separated from school activities. 
