Section-I **Introduction**

An Appraisal Mission comprising Dr. Swarna Gupta of NCERT, Dr. Neeru Snehi of NIEPA, Mr. K. Gopalan, Shri A.K. Prasad and Ms. Anupriya Chadha all from TSG (Ed.CIL) appraised the Perspective Plans for 2003-07 and Annual Work Plan & Budget for 2003-04 prepared for 19 districts (11 non-DPEP & 8 DPEP) of Haryana from 12th – 16th May, 2003. The Mission members also interacted with State representative, Shri. Rajneesh Sachdeva, at Delhi. Shri Amit Kaushik, Director (EE&L), MHRD, Govt. of India has been providing the overall guidance in the appraisal of the perspective plans.

The present desk appraisal note is based on the appraisal of the perspective plans and AWP&B for this year as provided in the district elementary education plans. It may be mentioned that a Central Appraisal Team visited Chandigarh in October 2002 to discuss the perspective plans to be prepared by the districts for the period 2003 – 2010. The appraisal team held discussion with the district and State personnel and expressed their joint opinion to the State to revise the perspective plans of the district in the light of the discussions held.

Known as a cradle of ancient Indian civilization, Haryana is one of the dynamic and most progressive states of the Indian Union. This tiny state with total area of 44,212 sq. km and a population of around 21 million was created on November 1, 1966.

The main source of income of the people in the State is agriculture. Haryana recorded all time low sex ratio of 861. This is the lowest sex ratio since independence and lowest among the major states of India.

Haryana recorded 68.59% literacy rate in 2001 census against the national literacy rate of 65.38%. The female literacy in Haryana has increased to 56.31% during 2001 census as against 40.47% in 1991 census with the corresponding figures of 54.16% and 39.42% at the national level. Density of population in Haryana has increased to 477 in 2001 from 372 persons per sq. kms. in 1991 census. Corresponding density population figures at the national level were 324 & 267 in 2001 and 1991 respectively. **Details provided in Table 1.**

The present Appraisal Team, while appraising the plans observed the major problems identified by the districts. These are listed below:

- Large network of private institutions
- Unfavourable ratio between teachers and students
- Teacher do not work with planning
- Lack of interest towards teaching method of the teacher
- No interaction between teacher and parent
- Poverty
- Lack of teaching aids
- Less accessibility of UP school
- No programme for drop out and non-starters
- Weak ECCE system

Besides, the Team also noted a trend that there were more out of school children and non-starters at the primary level but drop out population was more at the upper primary level. At the same time, nearly all the districts reported low enrolment of girls, especially at the upper primary level. Another feature of the plans was that the districts had also mentioned some incentives provided by the State government. A few of these include free distribution of textbooks, stationery, free uniform and attendance prize.

Section-II **Planning Process**

As per information given in the plans, it is evident that participatory approach of planning has been followed in the districts for preparing the district perspective plans. The process of plan preparation started with the formation of the District Core Teams. The District Core Teams include District Primary Education Officers, as In-charges of their respective districts and members, as Lecturers working in DIETs/ Senior Sec. Schools, BEOs, head masters and teachers. Five days orientation programme of the Core Team was conducted.

Members of the core teams were acquainted with the need of a perspective plan and various stages in the planning process. They were also briefed about the various components to be included in the draft proposal of SSA.

The members of the District Planning Team organised meetings with the government schools teachers, community, members of VECs & PTA, members of local bodies, union leaders and Chairperson Zila Parishad. The main issues raised during these meetings were recorded. A format was given to the CRCs to fill it up in each & every school to help find out the retention rate, dropout rate, requirement regarding infra-structure, teachers, TLM, etc. for the schools.

The planning teams carried out the house hold survey in their respective districts. District Planning Team organised a meeting with DEO, DPEO, Principal DIET, SDEOs and BEOs to chalk out a programme for doing the micro planning exercise. After the completion of household survey the planning team compiled the habitation level sheets at the district level and got the required data. Members of district planning team attended the meetings organised at the State level to discuss and to review the perspective plans from time to time.

Other features of the planning process in the State during the year were:

- Formulation and development of budget proposals in the districts started from the village level.
- VECs have been meaningfully involved in the planning process with a view to enable them to participate actively in monitoring and execution of the SSA. The CRCs in consultation with the teachers and head teachers of primary and elementary schools reviewed the proposals before sending them to the blocks.
- At the block level, Block Advisory Committee considered the plans. Before the finalisation of the plans by district level committees, a planning team scrutinized these extensively and intensively.

Section-III Major Strategies

Quality Improvement:

Sarva Shiksha Abhiyan lays special emphasis on making education at the elementary level qualitative, useful, relevant and need based for children by improving curriculum, developing child-centred activities and effective teaching learning strategies. Haryana in its State Education Policy has focussed on improving quality of education being imparted in the schools. Improved and child friendly textbooks, teaching learning materials and improving the teaching learning process within the classrooms will form the thrust areas in the field of pedagogical improvement. Quality improvement interventions, which happen to be the central focus of the SSA programme, are the most difficult ones to plan. Though districts have mentioned the issue of quality improvement in elementary education, concrete implementable strategies have not been detailed out.

The Mission is of the view that interventions for pedagogical improvement should have included the following:

- Curriculum review and reform
- Development of textbooks
- Teacher training

However, on scrutiny of the plans, the Mission members felt that very general statements have been made about quality related issues. There is no focus on specific aspects of quality and methodology required for curriculum development, renewal and delivery.

Teacher training:

Teacher training is a very important component for quality improvement. This is because teacher training enhances the capacity of teachers and professional and introduces them to new methods of teaching, which in the long run stimulates gradual social change. All the district plans have included teacher training as an important component for quality improvement for Elementary Education.

In the year 2002-03, out of a total of 58,000 teaches in position, 56956 teachers were trained. The training details were as follows:

- 7 day training to primary teachers in DPEP districts
- 5 day training to primary and upper primary teachers for 19 DPEP districts
- 7 day training to upper primary teachers of all the 19 districts and primary teachers of DPEP districts

All the districts have only proposed to impart regular 20-day in-service teacher training. No details of this training have been provided in the plan. However, the State has provided the following information regarding this training:

- 6 day residential training for all teachers (40, 000 primary and 18,000 upper primary)
- 6 day summer course for all 58000 teachers
- 8 day extended teacher training programme at the cluster level

The following suggestions are provided:

- All newly recruited teachers should be provided induction training on child-centred pedagogy, TLM development and understanding the diverse needs of the learners in the classroom
- At the upper primary level, some kind of plan should be drawn up to give subject specific training to the teachers
- The districts should give more emphasis to strengthening its teacher training efforts, as this is one of the main pillars of quality improvement.

However, the State representative informed that the State is planning to conduct a workshop soon to develop a strategy on teacher training.

Curriculum:

One of the most important determinants of the quality of education is the curriculum followed in the school. It was informed by the State representative that the State has renewed its curriculum on the basis of National Curriculum Framework, 2000 developed by NCERT and the books are in the process of being printed. The State has provided details of the books of Class I- IV that have been revised. Ideally, plans should include the activities related to curriculum development should include:

- Details on Curriculum review and renewal
- Making curriculum more local specific and child friendly at the local level
- Adaptation of the TLM based on the actual feedback from the classroom
- Planning/ visioning workshops.

Some of the suggestions are:

- The districts should re-look their plans in relation to curriculum and provide a detailed write up
- Every district, keeping in view its problems, issues and local specific needs should devise strategies that will be effective for all children, including those from special focus groups
- The district should review the pedagogical practices being followed and suggest suitable modifications, corrections and improvements in various stages of school education
- To assess how far the curriculum is able to address the needs of children, who have special needs and thus, exhibiting some problems in learning

It is hoped that the necessary speedy action will be taken by the State to focus on the above suggestions.

Development of Teaching Learning Material:

Development of appropriate TLM is not only an important part of pedagogical experimentation, but also makes learning joyful and interesting, besides improving the learning achievement of the children. The Mission recommends the following:

- The plans should mention as to what kind of TLM would be developed
- The teachers involved in the preparation of TLM should be given some kind of training. A concrete strategy should be chalked out for this
- TLM may be developed for educationally backward children and children with special educational needs for enriching their learning process.

School Grant:

Every district has proposed school grant for all its schools to provide basic facilities. Since, this item is very important keeping in view its contribution to the enhancement of quality of teaching learning process, hence this item is recommended for all the prima y/upper primary schools in each district of the state. **However, the Mission members felt that the plans did not make it clear as to how effectively the school grant of Rs.2000/- would be utilised.**

Teacher Grant:

All the districts have proposed teachers grant for teachers. This outlay is recommended keeping in view its importance for the development of teaching learning materials by the teachers such as charts, models & other teaching aids to be used in the classrooms. **Although the district plans mentions that the TLE grant of Rs.500/- would be used for the preparation of TLM, the Mission recommends that constant monitoring is done from the SPO/DPO level by visiting the schools regularly and assessing the kind of TLM being developed and used.**

To sum up, some basic issues related to quality need to be addressed in the plan. Hence, the Mission suggests:

- A workshop with the teachers to discuss classroom processes and effective teaching strategies
- Adaptation of TLM based on actual feedback from the classroom
- To develop a learning environment conducive to the needs of all children
- A research study should be undertaken on the training needs and then plan accordingly.

Section-IV **Out of School Children**

There are 3.47 lakhs out of school children in the State (details provided in Table -4 & 5) They include adolescent and sibling care girls, working children, etc. The State has provided branch schools to cater the need of unserved habitations. Thus, access has been provided all over the State. Hence, no EGS has been proposed in the plan. To cater to the need of adolescent girls, working children, etc. and their mainstreaming, alternative schooling has been proposed in the plan. In each centre nearly 25 children will be covered. There is a proposal for conducting bridge course in some of the districts. As per strategies proposed, nearly 44,525 out of school children will be provided educational facilities during the current year.

Section-V Special Focus Group

Education of Special Focus Group (IED):

Education of Children with Special Needs:

In the previous year, the State has conducted assessment camps and the process of providing aids and appliances has begun. Teacher training has also been conducted on IED. The State is in the process of mainstreaming these children in schools.

All the districts have provided data for children with special needs (**details provided in Table-7**). SSA provides Rs.1200/- per disabled child. Districts like Panchkula have identified only 242 children whereas, Hissar has identified 3750 children with special needs. The districts proposed the following activities to reach out to children with special needs:

- Identification of disabled children
- Assessment camps
- Development of community awareness material
- Teacher training
- Development of a resource centre
- Recruitment of resource teacher at the block level
- Sports tournaments at the block level
- Provision of aids and appliances.

The following suggestions are made

- Wherever recruitment of resource teachers is not possible, the state should focus on conducting the 45-day or the 90-day course developed by M.P. Bhoj Open University
- To promote access of CWSN, some disabled friendly designs in the schools should be designed with the Civil Works Unit
- Aids and appliances for children with special needs should first be sought through convergence. SSA funds should be used as the last resort
- As far as possible, the districts should provide category wise break up of children with special needs
- Convergence with IDEC has already been achieved for reader allowance, escort allowance, hostel expenditure and transport allowance. It is thereby suggested that the states contact the IDEC cell for this purpose
- Mainstreaming of disabled children into regular formal schools should be undertaken with the help of NGOs, community and other institutions working for the disabled
- Strategies should be developed to sensitize the community and parents towards the proper care of children with special needs

Section-VI Innovations

ECCJ:

Details on the number of ECCE centres and enrollment in these is given in Table -6
Some districts like Gurgaon and Bhiwani have not mentioned any concrete plan on ECCE, whereas others like Panipat and Jind have proposed certain activities. These include:

- Providing ECCE kits to Aanganwadi centres
- Training of AWW
- Refresher course for AWW
- Orientation of CDPOs and AWW
- Supply of material to each centre
- Providing furniture/daris to ECCE centres.

It seems from the plans that the State has adopted the strategy of converging and coordinating with the ICDS to sustain ECCE activities, but no mention has been made as to how this would be merged or linked with the formal system. Therefore, the Mission recommends the following:

- The State/district undertake a study, which can provide some insight on the best strategy that can be used for ECCE
- A need assessment should be done to analyse as to whether support from ICDS would be more fruitful or opening new centres
- If the State decides to converge with the ICDS, it should be done without impinging upon the other objectives of the scheme
- Depending on the local specific needs, districts can also try new models to enhance early childhood education
- Strategy for ECCE in remote areas not provided
- Details of training should be provided, especially related to the content of the training
- Pre-school education component should also be included in the AWW training.

The Mission recommends the strengthening of ECCE component of AWCs and introduction of school readiness programmes for smooth transition from ECCE to primary education.

Girls' education:

From the district plans, it appears that girls' education is not a major problem in the State. Some of the activities proposed for girls' education are:

- Vocational training for girls
- Awareness programmes
- Transport facilities
- Bridge courses for out of school girls

- Use of print and electronic media.

The Mission suggests the following:

- Providing incentives and transport facilities to girls seems to be a good idea to increase their enrolment
- More planning should be done on increasing awareness in the community on the need and importance of girls' education
- Appropriate models/ modules should be developed in those areas where girls' education seems to be a serious issue. Incentive scheme may be introduced in these areas
- Construction of toilets, where not available, may also help in ensuring better enrolment of girls.

SC/ST:

The State has a sizable number of SC children in schools thereby necessitating focussed strategies for the upliftment of this category of children. The district plans have given the necessary data regarding the SC population in schools, such as enrolment.

The plans have not reflected the problems and issues pertaining to the education of SC children. Suitable interventions for teaching learning have also not been proposed in order to improve their educational status except for distribution of free textbooks and some incentive schemes. Some suggestions are:

- New strategies have to be thought of for the upliftment of educational status of SC children
- Modules for remedial teaching should be developed
- Special enrolment drives in SC dominated areas need to be worked out
- Planning workshops should be conducted to chalk out a long-term concrete strategy to impart meaningful education to this target group.

Computer Education:

The Mission feels that this aspect certainly needs more planning on the part of the State/district functionaries. Major activities proposed by the districts are:

- Computer lab in schools selected for computer education
- Recruitment of computer operators
- Training of teachers

The Mission recommends the following:

- Orienting general teachers on the operation of computers and the importance of computer assisted instruction
- Development/purchase of software, which is related to the subject matter being taught in the classroom to enhance learning skills in children

-
- Equipping district level functionaries.

A concrete strategy should be chalked out and it should be monitored that the children get ample opportunities to use the computers to improve their cognitive skills.

Section-VII

Research

The component of Research needs further strengthening as no mention has been made on how the amount sanctioned for this component would be utilised. Some districts have proposed the following:

- Research studies
- Action research.

It is recommended that the existing material on research be first reviewed. If a manual for action research already exists, the same could be used by all the districts. Work done in the area of research by DPEP could also be looked at. Some of the district specific activities could be training programmes, teacher training on action research, research projects and studies more relevant in the context of local needs.

Recommendations & Suggestions

The final recommendations of the Mission are:

- The Mission is of the view that most of the plans have focussed on projected data and costing/budget according to SSA norms. No specific strategies have been spelt out for quality related issues. The districts need to have specific strategies for quality improvement
- The training needs of the teachers at the primary and upper primary stages have not been identified for planning training programmes
- The curriculum and the TLM should be adapted/developed, keeping in view the need of children from special focus groups, as all of them will be mainstreamed in the same school/classrooms. Hence, a need assessment study is very important
- Linkage strategies of ECCE with the formal schooling need to be developed
- The plans have no mention of the progress achieved in the previous financial year
- Identification of children with special needs is a rigorous exercise and orientation should be given to those who are undertaking house-to-house survey.

(v) Free Textbooks to girls and SC/ST students of upper primary level.

All districts have proposed the free issue of textbooks to general girls and SC boys students with a unit cost of Rs. 150/- per child per annum. In addition, some districts have also proposed free textbooks for the SC girls. In Haryana text books to SC girls is being provided under the state scheme and as such the free issue of textbooks for general girls and SC boys is only recommended.

(vi) Civil Works

- The details of the construction of new primary schools, new upper primary schools, new building for building less primary and upper primary schools, additional classrooms, BRC, CRC, toilets, drinking water facilities, proposed and recommended, are given in **Table10**
- The districts of Gurgaon, Jind and Mahendergarh have not furnished data on existing infrastructure and requirement and as such civil works proposed in these districts have not been recommended. However, taking into account the basic necessity for providing toilets and drinking water to the students, the proposal for these two items has been recommended.
- The outlay proposed and recommended is within 33% of the outlay for each year and wherever, the ceiling of 33% has exceeded the same has been restricted.

(vii) Repairs and maintenance of schools

All districts have proposed outlay for repairs and maintenance in the plan and the same has been recommended for government schools having its own buildings. In some districts aided schools have been included which have not been recommended.

(viii) Quality Improvement

Quality assurance in general emerged a significant issue. Plans have components like TLE, school grant, Teacher's grant and training of teachers, the details of which are given below: -

(a) TLE for primary and upper primary

TLE for primary and upper primary schools proposed by the districts has been recommended on the basis of recommendation of opening of new schools in the districts. TLE for existing primary and upper primary schools proposed by some districts has not been recommended as the existing primary schools are not covered and for all the existing UPS the grant was sanctioned during 2002-03.

(b) School Grant

School grant proposed by all districts is recommended on the basis of data furnished by the districts.

(c) Teacher Grant

Teacher Grant proposed by all districts is recommended on the basis data furnished by the districts.

(d) Teacher Training

All districts have proposed for 20 days in-service training to all teachers and 20 days induction training for newly recruited teachers. This has been recommended based on the data furnished by the districts.

(e) BRC/CRC

- Salary of BRPs, contingency grant, TLM, workshop/meeting TA, furniture grant proposed for 119 BRCs and 1181 CRCs have been recommended to 113 BRCs and 1181 CRCs. In respect of Ambala, Faridabad and Gurgaon, the districts have proposed more BRCs, which have been restricted as per the BRCs sanctioned last year.
- Most of the districts have proposed furniture grant for this year without taking into account the outlay on this account sanctioned during 2002-03. Since, the furniture grant is a one time grant the same has not been recommended again for the same BRCs and CRCs.

(ix) Research, Evaluation, Supervision and Monitoring

The districts have proposed outlay for Research, Evaluation, Supervision and Monitoring at various rate ranging from Rs. 800/- per school to Rs. 1500/- per school. It has been proposed by the state that the district will be given Rs. 800/- per school and the balance amount of Rs. 600/- per school will be taken at the state level and accordingly the same has been recommended.

(x) Training of Community Leaders

All districts have proposed two day's training of VECs @ of 8 persons per VECs @ Rs. 30 per day. Since SSA norm envisages training of 8 community leaders per village, this has been restricted as per village.

(xi) Special Focus Group

(a) Provision for disabled children

All the districts have proposed outlays for education of disabled children for special needs which has been recommended as per data furnished district plans keeping in mind the ceiling of Rs. 1200/- per child as per norms.

(b) Innovative Activities

Under innovative activities all the districts have proposed outlays for Girls Education, ECCE, Education of SC/ST and Computer Education for Upper Primary level, which have been recommended.

(xii) Management Cost

- Management cost including MIS & Media has been proposed by all the districts and state. This has been recommended within the ceiling of 6% of the annual outlay for each year.
- The overall management cost for the current year works out to 5.68% and for the perspective period 5.92%.

(xiii) EGS / AIE Centres

- All the districts have proposed outlay for out of school children @ Rs. 845/- p.a. for primary and Rs. 1200/- p.a. for upper primary level, which has been recommended.

(xiv) Spill over of year 2002-03

During the year 2002-03 the annual plans of all the districts were approved by the PAB. The district wise outlay approved and the expenditure incurred up to 31.3.03 is given below: -

(xii) Summary of SSA Outlay for 2003-04 and Perspective Plan 2003-04 to 2006-07

- The district wise and intervention wise outlay proposed and recommended for 2003-2004 and perspective plan for 2003-07 are given in Table-11.
- Detailed district wise plans along with summary are in Table-12.
- The outlay proposed for the current year is Rs. 19636.87 lakhs against which an outlay of Rs. 12119.71 lakhs as detailed below is recommended for the current year. Taking into account the spill over of Rs. 2858.57 lakhs, a total outlay of Rs. 14978.28 lakhs is recommended for the approval of Project Approval Board.
- The outlay proposed for the perspective plan for 2003-07 is Rs. 82721.00 lakhs against which an outlay of Rs. 50214.57 lakhs excluding the spill over for 2002-03 as detailed below is also recommended for the approval of Project Approval Board.
