Mid Day Meal Scheme Annual Work Plan and Budget 2008-09

1. INTRODUCTION:-

1.1 Brief history, objectives and rationale of the Mid Day Meal Programme.

(I) Brief History:

- ↓ The National Programme of Nutritional Support to Primary Education {NPNSPE}, popularly called Mid-Day-Meal Scheme was launched on 15th August, 1995.
- → This scheme was implemented initially in 13 CD Blocks, then, it was extended to 33 CD Blocks and finally, in all the 72 CD Blocks of the state.
- ↓ Under this scheme, due to financial constraints, Un-cooked Food Grains (RICE) @ 3kg per month per student, were being distributed to the children of classes I to V, with 80 % attendance for 10 academic months of the year, in all the Govt. / Govt. Aided Primary Schools and EGS centers under SSA of the entire state, till May, 2003.
- Thereafter, in compliance to the orders passed by Hon'ble Supreme Court of India in Civil Writ Petition 196 of 2001, titled as People's Union for Civil Liberties versus Union of India and Others, Government of Himachal Pradesh decided to provide a Hot Cooked Nutritious, Protein rich Mid Day Meal, supplemented with micro nutrients & iodized salt etc. to all the students of primary classes, in all the Govt. / Govt. Aided Primary Schools as well as EGS centers, of the state, on all the school days of the year, in a phased manner, so as to enhance the child's learning ability in order to achieve the targeted objectives, as envisaged in the NP-NSPE programme (MDM scheme).
- The schools of the Scheduled (Tribal) Areas of the state were covered in the first phase, w. e. f 22nd May, 2003 and in the second phase, all the remaining Government and Government Aided primary schools as well as EGS centers of the Non Tribal Areas of the state were covered w.e.f. 01-09-2004.
- Govt. of India vide its letter No.F-1/2007-desk (MDM) of dated 27.9.2007 allowed the extension of Mid Day Meal Scheme to Upper Primary Stage (Classes VI VIII) in Govt. (including local body) Govt. aided Primary Schools and EGS / AIE centres in 5 (Five) Educationally Backward Blocks of the State viz.: Pangi, Tissa, Salooni and Mehla of Chamba District and Shillai Block of Sirmour district w.e.f the year 2007-08. It was also mentioned that the said programme will be extended to all the areas across the country from the year 2008-09.

It was also decided by GOI that the said extension (in 5 EBBS) of MDM Scheme in Upper Primary Stage will be effective w.e.f 01.10.2007, but due to the Assembly Elections in the state and closure of schools for winter vacation w.e.f 01.01.2008, the MDM Scheme could not be extended to Upper primary stage w.e.f. the stipulated date i.e. 01.10.2007. The State proposes to extend the MDM Scheme to Upper primary stage w.e.f the year 2008-09 all over the state.

(II) Objectives:

- ↓ The National Programme of Nutritional Support to Primary Education {NPNSPE}, popularly called Mid-Day-Meal Scheme was launched on 15th August, 1995, with the twin objectives of;
- **★** Boosting Universalisation of Primary /upper primary education by increasing enrolment, retention and attendance and
- **↓** Simultaneously impacting on Nutritional status of children studying in I-V and VI VIII classes.

(III) Rationale:-

A. Primary Schools

- Under this scheme, Un-cooked (RICE) @ 3kg per month per student, was being distributed to the children of classes I to V, with 80 % attendance for 10 academic months of the year, in all the Govt. / Govt. Aided Primary Schools and EGS centres under SSA of the entire state, till May, 2003.
- Thereafter, in compliance to the orders passed by Hon'ble Supreme Court of India, Government of Himachal Pradesh decided to provide a Hot Cooked Nutritious, Protein rich Mid Day Meal, supplemented with micro nutrients & iodized salt etc. to all the students of primary classes, in all the Govt. / Govt. Aided Primary Schools as well as EGS centers, of the state, on all the school days of the year, in a phased manner.
- Accordingly, in the first phase, schools of the Scheduled (Tribal) Areas of the state w. e. f 22NDMay, 2003 and in the second phase all the targeted students of all the remaining Government and Government Aided primary schools of the Non- Tribal Areas of the state, were covered w.e.f. 01-09-2004 by providing rice based hot cooked meal @ 100 gms of rice per child per school day.
- → Under this programme, rice provided free of cost by GOI, is lifted from the identified FCI distribution Centers by the identified Nodal Transport Agency of the state i.e. Himachal Pradesh State Civil Supplies Corporation (HPSCSC), and transported to the ultimate distribution points i.e. the preparation centers, on the authorization from the respective Deputy Commissioners of different districts. The GOI reimburses the transportation Subsidy cost @ Rs. 100/- per quintal as transportation subsidy to the Nodal Transportation Agency of the State which has been enhanced to Rs.125/- per quintal, vide its letter of dated 27.09.2007.
- Rice is made available free of cost to the identified implementing agency engaged to serve the hot cooked meal to the targeted children. Other provisions shall be procured locally from the local PDS /Fair Price Shops on the rates fixed for such Fair price Shop. However, if the location of the school is outside the village, where Fair price Shop is located more than 2 kms away from such village extra transportation cost is also allowed per rates fixed by Local Administration.
- → The school committees have also been authorized to decide the weekly menu to be served in the school keeping in view of the choice and liking of the children of the area, in order to make the meal more acceptable.
- ↓ Under this Cooked Mid Day Meal programme up to 31.08.2006, the average conversion / cooking cost allowed by the State was @ Rs. 1.76 per child per school day. But, w.e.f 1.09.2006, due to cost escalation and to make the meal more wholesome, more nutritious and more varied to the liking of the children, the conversion / cooking cost has been increased to Rs 2.50 per child per school day. Out of which, Rs. 1.50 is shared by GOI and Rs. 1.00 is being borne by the State.
- → The school committees have been advised to use fresh seasonal vegetables and include fruits & eggs within the approved cost ceiling of Rs. 2.50 per child per school day.
- In order to make the school environment, healthy and pollution free and in the interest of environmental protection, less polluting fuels have been encouraged by the state. With this objective, gas based cooking has been preferred in schools, wherever possible and each school has been asked to procure gas

connection / gas stove along with cylinder out of the grants \widehat{a} Rs. 2000/- released to each school under SSA.

However, at places where Gas supply is not easily available use of Kerosene stoves has been allowed and in the last alternative where both Gas & Kerosene are a problem use of firewood has been allowed.

- The scale of fuel charges has been fixed at par with that of ICDS centers i.e. Rs.0.40 per child per day.
- The Anganwari workers / Part Time Water Carriers /the cooks and helpers have been engaged for cooking and serving the meals under this MDM scheme.
- The number of Cooks & helpers engaged per school is ONE OR more than ONE depending upon the enrolment of the school as well as the quantum of work involved. However, the maximum Honorarium allowed ranges from Rs. 200 to Rs. 1600 per school depending upon the quantum of work e.g. up to an enrolment slab of 5 children the honorarium allowed is @ Rs. 200/-, for 6-15 children @ Rs.400/-, for 16-30 children @ Rs. 600, for 31 to 120 children @ 800/-, for 121 to 270 children @ 1200/-and for schools having enrolment above 270 the scale at which honorarium allowed is @ Rs. 1600/-per school.
- The GOI has released Rs.2059.80 lakhs for the construction of 3433 kitchen sheds which are being constructed in convergence with SSA.
- Also SSA is constructing 88 Kitchen sheds from its own resources for the new primary schools, out of which the construction in 50 schools has been completed ,30 schools is in progress, while the construction in 8 schools is yet to be started.
- Further, in order to ensure the monitoring of the MDM Scheme, the Steering-Cum-Monitoring Committees at State Level, District and Block level have been constituted. Besides this, School Committees at School Level have also been constituted.
- In Himachal Pradesh, the Mid Day Meal Scheme is being implemented in all the 11020 Govt./ Govt. Aided Primary Schools / EGS Centers of the state covering 500983 children by involving different agencies.

B. Upper primary Schools

- The state of H.P was allowed by Govt. of India vide its letter No.F-1/2007-desk (MDM) of dated 27.9.2007, the extension of Mid day Meal Scheme to Upper primary Stage (Classes VI VIII) in Govt. (including local body) Govt. aided Primary Schools and EGS / AIE centres in 5 (Five) Educationally Backward Blocks of the State viz.: Pangi, Tissa, Salooni and Mehla of Chamba District and Shillai Block of Sirmour district w.e.f 01-10-2007. It was also been mentioned in the above referred letter that the said programme will be extended to all areas across the country from the year 2008-09.
- But, due to the Assembly Elections in the state and closure of schools for winter vacation w.e.f 01.01.2008 the MDM Scheme could not be extended to Upper primary stage w.e.f. the stipulated date i.e. 01.10.2007.
- But, in compliance to the Joint Secretary (EE-I), Govt. of India, Ministry of Human Resource & Development, department of School Education & Literacy D.O letter No. 9-1/2008-EE-2(MDM) of dated 14-01-2008, requiring the submission of the project proposals for Mid Day Meal programme separately for the Lower Primary and Upper Primary stages (classes I to VIII) for the entire state, in place of the above said 5 (Five) Educationally Backward Blocks, w.e.f. the year 2008-09, the draft project proposal to extend the existing MDM programme to the Upper Primary classes i.e. (VI-VIII) of all the 4262 Middle Units of the Govt./Govt. Aided Sr. Sec. / High / Middle Schools as detailed at Table –1.5B, to benefit around 350874 Students of the entire state w.e.f. year 2008-09, submitted to the Govt. of Himachal Pradesh vide Department of Elementary Education letter No. EDN-H (FE) (4) 4 31/2007-MDM (EBBS) VI-VIII dated 10.3.2008, is under consideration of the State Govt.

1.2 Demographic profile of the State

- Himachal, meaning the land of snow, located 450 km north of Delhi is one of the most beautiful states of Indian union. Enchanting hills, deep and green valleys, popular pilgrim centers, unexplored regions bathed in pristine beauty, culturally unique and rich tribal areas, gurgling streams and alpine flora all beckon the travelers.
- Himachal has everything for everyone for all seasons. From casual visitor to a devout pilgrim; from those seeking a break from the busy city life to the solitude lover; from easy holiday makers to those who want to rough it out everyone can take their fill. Adventure seekers can choose from trekking, mountaineering, rock climbing, white water rafting, para gliding, angling and skiing including heliskiing. Idyllic landscape, serene environment, cool pollution free refreshing air and pure natural bliss-Himachal waits to be felt, explored, enjoyed and cherished. Small hill villages located across high rising mountain passes that remain blocked for nearly six months in a year, ancient temples dating back to the seventh century; pre-Aryan rituals, customs and traditions; high altitude glacial lakes; national parks and wild life sanctuaries- all join together to create a magic spell.
- From fertile plains to lush green meadows and from thick forests to barren mountains the landscape is rich and varied. Elevation ranges from 350m in the plains of Kangra and Una to 7000m in the high hills of Lahaul and Spiti. Dharamsala receives second highest rainfall in the country whereas Lahaul and Spiti valleys go without rains.
- ← Culture is as diverse as the landscape. More than 2000 deities, local gods and goddesses are worshipped in the state and almost every village has its own deity. These gods speak through the chosen ones called chelas and gurus who regulate the lives of hill people. The dialect changes after every few kilometers and customs and traditions also vary. Numerous fairs and festivals are held around the year celebrating the spirit of life in the most taxing circumstances. People are god fearing and hospitable. There is a wondrous mix of tradition and modernity.

A. The land

- Himachal extends from the plains of Punjab and Haryana to the permanent snow covered Himalayan mountain ranges. The Shivaliks take off from the plains and gentle hills roll one by one and rise in altitude as one approaches Himachal from the plains. The Shivalik, Dhauladhar, Pir Panjal and Great Himalayan ranges run almost parallel to each other and shape the deep valleys irrigated by numerous perennial streams and rivers. The valleys of Kullu and Kangra receive plenty of monsoon rains but the valleys of Lahaul, Pangi, Spiti and Kinnaur that lie beyond Pir Panjal receive very little rains.
- ♣ Several perennial rivers originate in the state. Main rivers that rise in Himachal are Beas, Ravi, Chandrabhaga, Pabbar, Giri, Baira and Siul. The Satluj enters in Kinnaur district from Tibet and flows through many districts before entering Punjab. The Yamuna flows on the western border of Himachal in Sirmour district.

B. The origins

- It is believed that the Kolorian people of Gangatic plains were the original inhabitants of the Himalayan hills who were pushed north by the people of Indus Valley (2250-1750 B.C). The earliest texts of Aryans composed around 1000 BC referred to the hill people as Dasas, Dasyus and Nishadas. In later works these people living in the Himalaya have been called Kinnars, Nagas and Yakshas.
- → The Khashas, a group of Aryans coming from Khashgar, Gilgit and Kashmir spread throughout Himalayan region of Kangra, Kullu, Mahasu, Chamba, Gharwal, Kumaun and Nepal. They established small principalities in the hills.
- The Mahabharata refers to four Janpadas in the Himalaya- Audumbara, Trigarta, Kuluta and Kulind founded by Khasas. Of these Trigarta and Kuluta are identified with present day Kangra and Kullu. Trigarta finds mention in the Mahabharata, the Vedas and the work of Panini. Rivers of Himachal Chenab (Chandrabhaga), Ravi, Beas and Satluj are mentioned in the Vedic literature as Asikim, Panushni, Vipasha and Shatudri respectively.

C. Post independence

- → On 15th April 1948 Himachal came into existence as the Chief Commissioner's province and became a Part C State of Indian Union on 26th January 1950. Bilaspur State was merged with Himachal Pradesh on 1st July 1954. Himachal Pradesh got the status of Union Territory on 1st November 1956. Kangra and most of the other hill areas of Punjab were merged with H.P. on 1st November 1966.
- → On 18th December 1970 the State of Himachal Pradesh Act was passed by Parliament and the new state came into being on 25th January 1971 as the eighteenth state of Indian Union.

D. Language and dialects

- → Hindi is spoken and understood throughout the state. English is also understood and spoken by a large number of people in all towns and most of the villages. Generally both Hindi and English are used in milestones, signposts and signboards.
- ▶ Western Pahari, which is commonly known as Pahari, is spoken by over 90% of the population. It is a Hindi dialect derived from Sanskrit and Prakrit. The main dialects of Pahari have been enumerated as Mandiali (Mandi district), Chambiali (Chamba district), Sirmouri (Sirmour district), Kulvi (Kullu district), Kangri (Kangra, Hamirpur, Una), Mahasuvi (Shimla and Solan), Pangwali (Pangi), Gadi (Bharmour). Formerly Pahari was written in Tankri script but at present, it is written in Devnagri script. People of Kinnaur and Lahaul and Spiti speak the dialects that match the Tibetan and Bhoti languages.

E. Economy

Agriculture, horticulture and animal husbandry are main occupations of the people. While upper Himachal is famous for apple, apricot and walnut the lower part of the state has its niche in citrus fruit. As landholdings are small and hill farming is incapable of mass production people are shifting to cash crops. Seed potato, off-season green peas and vegetables, floriculture, exotic vegetables and fruit are emerging as new money earners. Tourism is another income generating activity.

F. Demography

Himachal Pradesh with 60,77,900 people (50.8 percent males and 49.2 percent females) has 0.59 percent of the country's population. Kangra district has the highest population (13,39,030) which is 22.03 percent of the total population of the state. Lahaul and Spiti district has the lowest population (33,224 persons) which comes out to be 0.55 percent of the total population of the state.

G. Proportion of rural-urban population

→ Himachal is the least urbanized state in the country with 90.2 percent of the total population living in rural areas. Lahaul and Spiti and Kinnaur districts have no urban areas. The higher proportion of urban population is recorded in Shimla district (23.2 percent) followed by Solan district (18.2 percent). Sirmour district has 10.4 percent urban population whereas Una comes fourth in the State with 8.8 percent urban population. This proportion is low in the districts of Kangra (5.4%), Bilaspur (6.4%) and Mandi (6.8%).

H. Village and household size

→ Out of the total 17,495 inhabited villages 83.2 percent (14,558) have less than 500 people. Another 2,094 villages (12.0 percent) fall in the population range of 500 to 999 persons. Only 660 villages (3.8 percent) have the population between 1,000 to 1,999 persons. 174 villages (1.0 percent) have population range of 2,000 to 4,999 persons and 8 villages have population between 5,000 to 9,999 persons. There is only one village in Himachal having a population of more than 10,000 persons. The average size of a household in the state is 5.0 (5.1 in rural area and 4.2 in urban area).

I. Sex ratio

→ The sex ratio of Himachal Pradesh is 968 females per 1,000 males as per 2001 census. In rural areas, it is 989 females while in urban areas it is 795 females for every 1000 males.

- Hamirpur has highest sex ratio of 1,099 females per 1,000 males followed by Kangra (1,025), Mandi (1,013), Una (997) and Bilaspur (990). In remaining seven districts sex ratio is below the state average. Lahaul and Spiti district has the lowest sex ratio of 802 females with Solan (852), Kinnaur (852) and Shimla (896) occupying other lowest positions.
- Rural sex ratio in five districts is above the state average while in remaining seven districts this ratio is below the state average of 989 females. In urban areas, the highest sex ratio is recorded in the urban areas of Kangra (902) followed by Una (895), Mandi (894), Chamba (866), Una (864) and Hamirpur (861). The lowest sex ratio is urban areas is in Solan (624) followed by Shimla (748) and Kullu (782).

J. Sex ratio in the age group of 0-6 years

- → Sex ratio in the age group 0-6 is 896 females per 1,000 males. In rural areas this ratio is 900 females while in urban areas of the state it is 844 females.
- The total sex ratio in age group 0-6 in eight districts is above the state average of 896 females. Among these districts, tribal district of Kinnaur has highest sex ratio is 979 females per 1,000 males and is followed by again tribal district of Lahaul and Spiti (961), Kullu (960), Chamba (955), Sirmour (934) and Shimla (929). Solan district in this group has lowest child sex ratio of 900 which is followed by Mandi with sex ratio of 918.
- → In remaining four districts sex ratio among child population is below the state average. Kangra district has the lowest sex ratio of 836 females in child population. The next lowest position in child sex ratio is occupied by Una (837) and is followed by Hamirpur (850) and Bilaspur (882).

K. Scheduled Castes

- → The total scheduled caste population of Himachal Pradesh in 2001 Census is 15,02,170 persons which constitutes 24.7 percent of the total population of the state. The rural and urban break up of scheduled castes population of the state is 14,03,050 (25.6 percent) and 99,120 (16.6 percent) respectively.
- → Sirmour district has the highest proportion of scheduled castes population (29.6 percent) followed by Mandi (29.0 percent), Kullu (28.3 percent) Solan (28.1 percent), Shimla (26.1 percent) and Bilaspur (25.4 percent). The districts of Lahaul and Spiti (7.8 percent) and Kinnaur (9.7 percent) have low proportion of scheduled caste population as these are dominated by the tribal population. This percentage is below the state average (24.7) in Hamirpur (23.9) Una (22.4), Kangra (20.9) and Chamba (20.0 percent) district.

L. Schedule Tribes

The total scheduled tribes population is 2,44,587 persons which constitutes 4.0 percent. Scheduled Tribes live in rural areas while only 7,527 persons or 1.3. percent of the total urban population of the state live in urban areas. The tribal districts of Lahaul & Spiti and Kinnaur has returned 73.0 and 71.8 percent scheduled tribes population while in Chamba district where entire Pangi and Bharmaur blocks are tribal areas, has also returned higher percentage of 25.5 percent tribal population in the district. In other districts, the proportion of tribal population is very low. The percentage of tribal population in Kullu is 3.0 percent, Bilaspur (2.7 percent), Sirmour (1.3 percent) and Mandi (1.2 percent). The negligible tribal population is returned by Solan (0.7 percent) Shimla (0.6 percent) and Kangra (0.1 percent) to the total population of the district.

1.3 Social and Economic Indicators in the State including Literacy Rates, Health Indicators (IMR, MMR), Sex Ratio, Poverty Ratios etc.

According to Surveyor General of India, the total area of Himachal Pradesh is 55,673 square Kilometers. Out of this total area 45,318 square Kilometers is the measured area according to the revenue papers. The total population of Himachal Pradesh, according to 2001 census was 60,77,900, which gives a density of population of 109 persons. The per capita income at current prices of Himachal Pradesh for the year 2005-06 is Rs 30,140 per annum. The other Developmental Indicators of the State are detailed as under:-

1.4 <u>Nutrition status, including Data on Malnutrition, Anemia, Vitamin-A and other Micro-nutrient deficiencies</u>, etc.

- The mainstay of the population of Himachal Pradesh is Agriculture on which 66.71% population depends for their livelihood. The topography being mostly hilly, the type of cultivation is terraced. Close to 80% of fall in the category in the small and marginal farmers. Due to ideal climate for fruit cultivation, horticulture and vegetable growing (seasonal as well as off season) well—diversified s farm economy has developed rapidly during the past three decades. The main food crops of the State are Rice, Maize, Wheat, Barley, Gram, Mash, Ground nut, Potato, Ginger and Tea etc. Beside this, the State of Himachal Pradesh is also considered as apple State the main fruits which are produced in HP are Plum, Peach, Apricot, Kiwi, Almond Walnut, Orange, Malta Mango and Litchi etc.
- → On some health and nutrition indicators, Himachal scores quite well. Coverage of Vitamin A is high as are levels of immunization (see Table A.9).
- However, much remains to be done for health and nutrition of very young children as well as women in the reproductive age group. NFHS-3 figures indicate that there are serious problems with stunting, wasting, and being underweight among young children.
 - a) Proportion of under-threes suffering from stunted growth is quite high at 27%.
 - b) Proportion of infants with low birth weight had fallen only slightly between 2001 (27%) and 2005 (25%) but has registered a further decrease to 21% in 2006.
- → Deficiencies in iron -- as much as 7 out of every 10 children (6-35 months) in Himachal are anaemic, 2.2% of them are severely anemic. Anaemia in a child leads to "impaired cognitive performance, behavioral and motor development, and ultimately affects academic performance".
- Infant Mortality Rates have dropped but they are still unacceptably high (60 per thousand births). The bulk of infant deaths are neonatal² deaths (50 per thousand births). This can be reduced by improving nutrition levels of young adolescent girls as well as pregnant women and nursing mothers. Over two-fifths of adult women in Himachal suffer from anaemia, and this heightens the possibility of maternal mortality and the birth of low-weight babies. This in turn increases the vulnerability of the newborn to infections, some of which could be fatal. Iodine deficiencies which lead to goitre are still found in 2.5% of the rural population, considerably higher than the Indian average.
- Himachal is also facing the problem of declining Female Male Ratios. Between 1991 and 2001, the female male ratio in the 0-6 year age group has declined from 951 to 897. Clearly this is a situation which requires urgent action. The Himachal government has begun 2 new schemes to support the girl-child.
- → The Department of Health has started many programmes to improve the Health / Nutritious Status through ICDS programmes, Regular Heath Checkups in Schools, Anganwari Schools etc.
- ♣ Under Mukhya Mantri Kanya Dan Yojna, Rs. 11,001/- is provided as marriage grant to those girls whose fathers were no more or are critically ill and the family income does not exceed Rs. 7,500/-. And under Indira Gandhi Baliksha Suraksha Yojna an incentive of Rs. 25,000/- is being provided to parents who adopt terminal family planning methods after the birth of the first girl child.
- → The Govt. of Himachal Pradesh has introduced Hot Cooked Mid Day Meal Programme in all the Govt./
 Govt. Aided primary schools and EGS Centres in the State to improve the status of malnutrition further.

2. Description and Assessment of the Programme Implemented in the previous Year (2007-08) with reference to:

2.1 Calorific / Protein Value of the Mid Day Meal Provided along with menu prescribed

- The meal served under the MDM programme for both at Primary & Upper primary stage will be rice based depending upon the choice of the students of the area. It will be as far as possible Rice Dal for three days, Vegetable Pulao for two days and Sweet rice for one day.
- The SDMC of the school will decide the weekly menu to be served in the school keeping in view the choice and liking of the children of the area, in order to make the meal more acceptable and have been advised to use fresh seasonal vegetables.
- The scale of different ingredients with Standard Protein & Calorie Content included in the Menu, in r/o each student per day and the item wise Average Calorie & Protein Content as per Standard Chart, for Primary & Upper primary stage is given as under:-

• Since most of the areas are located far from the roads and also expected to be land locked during winter months, fresh vegetables may not be available nor it is advisable to use vegetables purchased from market outside the area because the vegetables will be very expensive nor they will be fresh and supply chain will not be regular. Hence only locally available fresh vegetables during the season should be used and the upper ceiling of cost should be pegged at Rs. 12/- per Kg. depending upon location and competitive rates.

2.2 Regularity and wholesomeness of mid day meals served to children; reasons for programme interruptions, if any

A. Primary Schools :-

- ↓ Under the MDM scheme, Hot Cooked Meal of high calorific value and protein content, is regularly being distributed to all the students of classes I to V on all the school days of the year w.e.f. 01.09.2004.
- → The Govt. of HP is making every effort to make the meal served more wholesome, more nutritious, more varied.
- → The Government has also authorized the School Management Committees to decide the weekly menu to be served in the school keeping in view the choice and liking of the children of the area, in order to make the meal more acceptable.
- → The school committees have been advised to use fresh seasonal vegetables.
- The School Management Committees have been advised to include any Dal or seasonal vegetable in the menu, ensuring that the same Dal or vegetable is not repeated frequently. And, on one day of the week, Sweet Rice with dry fruits may be served within the approved cost.
- The School Management Committees have been further authorized to include eggs or fruits in the Mid Day Meal, in case available and within the permissible cost ceiling. However, the dietary preference of the children shall be kept in view in case eggs are to be served.
- The schools have also been directed to ensure that the menu as approved by the School committee is displayed on the Notice Board of the school and to see that the cooking / distribution of meal is strictly as per the displayed menu.

B. Upper Primary Schools:-

♣ After obtaining the necessary approval form the state Govt., on an analogy of Primary Schools , the upper primary schools will also be given instructions separately for the implementation of the MDM Scheme.

Number of children (class, category and gender wise) who participated in the Programme separately for Primary and Upper Primary Schools.

A. Primary Schools

The Number of children (classes I to V), category and gender wise, of Primary Schools who participated in the Programme in the year 2007-08 (as on 30-09-2007) is detailed at Table- 1.5 A.

B. Upper Primary Schools

The MDMS to upper primary stage is likely to be extended in the state in the year 2008-09.

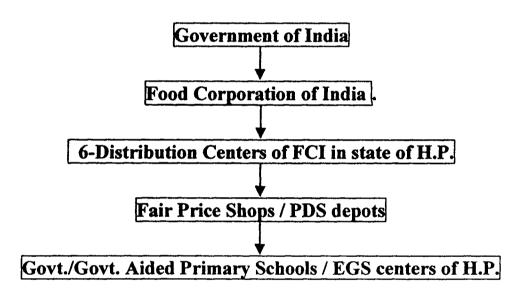
2.4 <u>Food-grains management, including adequacy of allocation, timeliness of lifting, transportation and distribution and suitability of storage at different levels.</u>

A. Primary Schools

For the annual allocation of food-grains, the Deputy Directors of Elementary Education

supply the enrolment figures in r/o the targeted Govt./ Govt. Aided Primary Schools, as well as functional EGS centers, as on 30th September of previous year, on the basis of which, the consolidated demand of rice allocation of the state is projected, on the respective prescribed formats to GOI. And, Government of India accordingly, makes the necessary allocations for the whole year free of cost to the state, @ 100 gram per child per school day for classes I-V, on the basis of the Average attendance rate of the state.

- → The allocations of food-grains made by GOI to the State, are lifted by the designated State Nodal Agency for transporting food-grains, which is Himachal Pradesh State Civil Supplies Corporation. The HPSCSC lifts the rice from the identified distribution centers (FCI godowns) for the state and transport it to the PDS depots/Fair Price shops and then to the ultimate distribution points i.e. the schools on the authorization from the respective Deputy Commissioners regularly on monthly basis.
- → For the smooth and uninterrupted implementation of the MDM Scheme, the state has issued directions for the months advance supply of food-grains to the school.
- → The State Govt. has released funds to the schools for procuring adequate storage containers / Utensils out of the replacement grant (Central Assistance) provided by the GOI for cooking equipments / kitchen devices @Rs.5000/- per school.
- ♣ Food-grain flow chart in r/o the state of H.P. is as under :-



B. Upper Primary Schools

- The procedure for the Food-grains management, including adequacy of allocation, timeliness of lifting, transportation and distribution and suitability of storage at different levels will remain the same for upper primary schools. However 150 gms of foodgrains (rice) per child per school day will be provided free of cost by GOI at Upper primary stage i.e classes VI-VIII.
- → The minimum mandatory cooking cost of Mid-Day Meal for Upper-Primary Stage as fixed by GOI is @ Rs.2.50/- per child per school day with:
 - (a) Central assistance of Rs.2.00 /- per child per school day, while
 - (b) The minimum mandatory States contribution expected is @ Rs. 0.50 per child per school day.

2.5 Central Assistance received and utilized towards (a) cooking Costs, (b) Kitchen shed construction, (c) procurement of Kitchen Devices (d) Management, Monitoring & Evaluation (e) Transport Subsidy

a) <u>Cooking Costs</u>

A. Primary Schools

As per the AWP&B of the year 2007-08, the Govt. of India allocated an amount of Rs. 1923.96 lakh as Central Assistance towards Cooking Cost under Mid Day Meal Scheme out of which 1st installment of Central Assistance amounting to Rs. 961.98 lakh has been utilized and the for 2nd installment of Central Assistance of Rs. 961.98 lakh has been distributed & is expected to be utilized by the end of the current financial year.

B. <u>Upper Primary Schools</u>

The GOI released Central assistance to tune of Rs.113.96 lakh for the implementation of MDM Scheme in upper primary classes of the 5 educationally backward blocks of the state, which could not be utilized as the state could not extend the MDM Scheme w.e.f the stipulated date i.e. 1.10.2007, for reasons of scheduled assembly Elections in the State and enforcement of Model code of conduct.

b) <u>Kitchen shed construction:</u>-

A. Primary Schools

- The GOI had released funds to the tune of Rs.2059.80 lakh to the State for the year 2007-08 for the construction of Kitchen sheds in 3433 identified Primary schools @ Rs. 60,000/- per kitchen shed in 1st phase which are under the process of utilization in convergence with SSA for construction purposes. The work of construction of these above said kitchen sheds has been assigned to the engineering wing of SSA. (Status attached at Table-8).
- Also SSA is already constructing 88 kitchen sheds-cum-stores in the newly constructed primary schools, out of which 50 kitchen sheds-cum-stores have been completed, 30 are under progress and 8 are yet to be constructed (Status attached at Table-8A).

B. Upper Primary Schools

→ The state has received Rs.28.20 lakhs for the construction of 47 kitchen sheds in 47 upper primary schools of the 5 EBB of the state, for which case has been moved to seek expenditure sanction of the state along with matching budget provision to facilitate its drawl. The sanctioned amount will be spent for the purpose also in convergence with SSA.

c) Procurement of Kitchen Devices:-

A. Primary Schools

→ In r/o primary schools, GOI has released Rs.377.85 lakh to 7557 primary schools as replacement grant for the replacement of cooking equipment / kitchen devices @ Rs.5000/ per school for the years 2006-07 and 2007-08 which has been utilized.

B. Upper Primary Schools

In this regard it is further proposed that practically the above said extension of MDM Programme to the upper primary stage in the in the targeted Middle Units could be possible only in the next financial year after the schools are provided with the required budget provision for the procurement / purchase of gas connection / gas stove / utensils and storage containers etc. well

before the targeted date decided for starting the programme in the targeted Middle Units / schools.

- a) In r/o Upper primary schools / Middle units proposed to be added under the Mid day meal programme in the state, required utensils and kitchen devices could be purchased initially to the bare minimum requirement to start the programme, out of the school grant released to each school under the SSA.
- b) However these schools will also be provided with the replacement grant for the replacement of cooking equipment / kitchen devices @ Rs.5000/ per school as per the GOI norms for procurement of all the required utensils, gas connection/ gas cylinder, storage containers and the serving devices as per the requirement of the concerned schools, immediately after the grant is released by GOI and received by the state.
- c) The state has received Rs.11.00 lakhs grant from GOI, for the procurement of cooking equipment / kitchen devices @ Rs.5000/ per school for 220 upper primary schools of the 5 EBB of the state, for which case has been moved to seek expenditure sanction of the state along with matching budget provision to facilitate its drawl.
- d) The state will be requiring Rs.202.10 lakhs grant from GOI, for the procurement of cooking equipment / kitchen devices @ Rs.5000/ per school in respect of the remaining 4262 220 = 4042 schools of the state, meet the required liability under this component. Therefore, funds amounting to Rs.202.10 lakhs for 4042 Schools, may have to be provided in the next financial year 2008-09.

d) Management, Monitoring & Evaluation:

A. Primary Schools

- The state of H.P has utilized the amount of Rs.33.33 lakh allotted during the year 2006-07 for the purpose.
- For the year 2007-08, Rs.14.35 lakhs have been released by GOI under MM&E component ,the administrative and financial sanction for the utilization of these funds is awaited from the State Govt.

B. Upper Primary Schools

• No grant under this component has been received by the state in the year 2007-08, as the MDM Scheme has not yet been started in the Upper Primary Classes.

e) Transport Subsidy:

• The State Nodal Transport Agency, the Himachal Pradesh State Civil Supplies Corporation (HPSCSC), lifts the food-grains (rice) allocated by GOI to the State, and transports them from the identified distribution centers (FCI godowns) for the state to the ultimate distribution points i.e. the schools on the authorization from the respective Deputy Commissioners regularly on monthly basis. In turn the GOI is allowing reimbursements @ Rs. 100/- quintal which has been enhance to Rs. 125/- per quintal w.e.f 1.10.2007 to the Nodal agency, as HP is identified as a special hill state. The reimbursements are being received by the HPSCSC regularly.

2.6 <u>State Budget Provisions and expenditure in 2007-08 towards</u>:

(a) Re-imbursement of Central Assistance:

The re-imbursements made by the GOI as Central Assistance to the state towards Cooking Cost under the CMDM programme are detailed as under:-

Note: With effect from the year 2008-09, the State has shifted the MDM liability under OTA (PLAN) towards NON-PLAN. And, for the year 2008-09, only provision of Rs.360.40 Lakh, under SCSP and Rs.91.10 Lakh under TASP (Total Rs. 451.50 lakh) has been made for the year. However, the state is committed to provide the state liability under different components of the MDM scheme.

2.7 <u>System for release of funds provided under cooking costs (Central and State)</u>

A. Primary Classes

- The conversion cost as approved by the state of Himachal Pradesh is @ Rs.2.50 per child per Primary school day, out of which the GOI shares @ Rs.1.50 per child per day and the remaining @ Rs.1.00 is borne by the state.
- The GOI releases its share directly to the State. For which, the required Financial /Administrative Expenditure Sanction is accorded by the State. Only after that the State Nodal Agency i.e Department of Elementary Education, releases the budget to its drawing disbursing officers i.e Block Elementary Education Officers (BEEOs) for further distribution to the schools through the Centre Head Teachers. The Department has given full powers to the Drawing and Disbursing for the purposes of Mid Day Meal Scheme. At the school level the expenditure is incurred by the school Management Committee.

B. Upper-Primary Classes

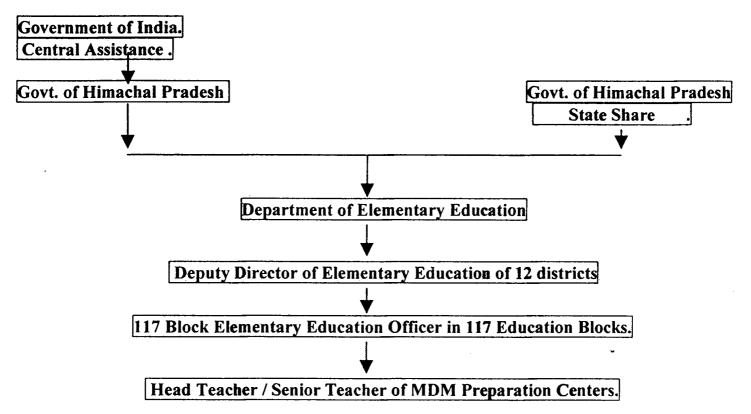
The minimum mandatory cooking cost of Mid-Day Meal for Upper-Primary Stage as fixed by GOI is @ Rs.2.50/- per child per school day with:

- (a) Central assistance of Rs.2.00 /- per child per school day, while
- (b) The minimum mandatory States contribution expected is @ Rs. 0.50 per child per school day.

But, as per the estimated per child per school day conversion cost has been worked out approximately as Rs.3.50 with Central Contribution being Rs.2.00 and State contribution Rs.1.50 per child per day for the Mid day Programme in upper primary schools. The detailed calculations elaborated at Table-2.1.2

C. FUND FLOW CHART:-

• However, the fund flow chart to outline the process for the flow of funds (Central or the State funds) from Govt. to the ultimate implementing agencies at the school level is as under:-



D. MDM BANK ACCOUNTS:-

As per the directions of GOI to streamline the fund flow under MDM scheme, instructions have been issued to the field offices that a separate—saving—bank account be opened at the Block and the School level, at Block level in the name of Block Elementary Education Officer and at school level, jointly in the name of school head teacher and the president of the school committee(SDMC). The Bank Account could be opened in any of the Nationalized Banks preferably H.P. Co-operative Bank functioning at or nearby the Block or School.

2.8 System for procuring cooking ingredients (fuel, condiments, oil, etc.),

Commodities, which are centrally purchased and supplied to schools or

locally purchased at school level and rate of cooking cost per child per day
provided at school level.

2.8.1 System for procuring cooking ingredients (fuel, condiments, oil, etc.)

A. Primary Classes

- a) Rice is made available free of cost to the State by GOI (FCI) to the identified Transport Nodal Agency i.e. Himachal Pradesh State Civil Supplies Corporation which lifts the rice from the FCI godowns to the FPS/PDS depots from where it is lifted to the ultimate distribution points i.e. Primary Schools.
- b) No commodity in the state is proposed to be centrally purchased and supplied to schools.
- → The state has authorized the School Committees to procure locally from the local PDS / Fair Price Shops all the other provisions / ingredients required for cooking the meals as per the menu approved by it, on the rates fixed for such Fair price Shops by the district administration.
- The School Committee has been constituted for each school with the following configuration;
 - 1. President of the VEC OR any active member -- (MEMBER) nominated for the purpose by him.
 - 2. President of the MTA/PTA OR any active member -- (MEMBER) nominated for the purpose by him.
 - 3. C.H.T / H.T / Senior Teacher of the School -- (CO -ORDINATOR / MEMBER SECRETARY)

The School committees have made responsible to perform the following functions:

- **★** To execute all type of purchases of FOODGRAINS and other ingredients.
- **★** To make arrangements for proper/safe storage of articles purchased / hired.
- **↓** To make arrangements for hiring / procuring UTENSILS on reasonable RENT.
- → To make arrangements for hiring the services of COOK / HELPERS / PTWC's at rates as per GUIDELINES of the programme.

B. Upper Primary Classes

- → For providing mid meal to the upper primary schools, on analogy of MDM programme already being implemented in the state in primary schools, the School Development Management Committee (SDMC) will be constituted in each Upper primary school where the Primary and the Upper primary school is at a distance of more than 300 metres. And, where the distance between the Primary and the Upper primary school is 0-299 metres the existing School committee (SDMC) will be reconstituted for the implementation of MDM Scheme.
- → The configuration of School Development Management Committee (SDMC) for both (1) and (2) above will be as follows:-

★ The constitution of the School Development Management Committee (SDMC)

1. President of the VEC or : Member

any active member nominated by the president

2. President of the MTA /PTA or : Member

any active member nominated by the president
3. Senior teacher of the Upper Primary School
: Member Secretary

Note:-

President of the VEC or MTA/PTA of the school shall either offer his or her services voluntary for the successful implementation of the cooked meal program in the school either in person or He / She shall nominate any of the other active suitable and resourceful member who can participate actively and give time for the purpose.

4 FUNCTIONS OF THE SCHOOL DEVELOPMENT MANAGEMENT COMMITTEE:-

The committee constituted for the implementation of the cooked Meal programme in the upper primary units / schools will be responsible to perform the following functions:-

- 1. To make arrangements for procuring / purchasing utensils / Kitchen devices after following all the required codal formalities.
- 2. To execute all type of purchases of required ingredients.
- 3. To make arrangements for proper / safe storage of all the articles purchased.
- 4. The Committee will also see that the quantity of commodities purchased, are exactly as per norms given in the guidelines in view of the enrolment of the school.
- 5. To check the quantity and quality of the food grains (rice) and other ingredients before preparing the meals.
- 6. To ensure maximum effort to maintain cleanliness at the time of cooking / preparation of the meal, avoid wastage and maintain quality.
- 7. To make arrangements for hiring the services of cooks / helpers at rates as per guidelines of the project.
- 8. To decide about the weekly MENU under the programme and ensure that the decided menu is also adhered and implemented in letter & spirit.
- 9. It will also ensure that the weekly menu is also displayed in the school notice board.
- 10. To test and taste the meals before serving to the children.

Note:-

The Committee will also ensure that stock registers and accounts are maintained properly. It will also see that the statement of accounts and the quarterly progress reports are submitted to the Deputy Director Elementary Education of the concerned district as per prescribed schedule.

2.8.2 Deployment of Cooks / Helpers

A. Primary

→ The number of Cooks & helpers engaged per school is ONE OR more than ONE depending upon the enrolment of the school as well as the quantum of work involved. However, the Honorarium allowed ranges from Rs. 200 to Rs. 1600 per school depending upon the quantum of work i.e on the basis of enrolment slabs as per details given hereunder:-

- Role of Cooks & Helpers is to obtain the strength of students present on the day, within one hour of the starting of the school, obtain the required quantity of rice and other ingredients in view of the strength of the children for whom the meal is to be cooked and served on the day.
- ♣ Thereafter, they had to remove pebbles etc from the rice and pulses and wash them and cook the meals properly as per the menu and start serving the meals as soon as the recess/lunch break starts in the school.
- They had to ensure that this entire process is over within the lunch break, so that the teaching of the school may not suffer.
- ♣ After this, the helper has to clean the utensils and place them in the store for use on the next day.
- The cook has also to ensure that the gas stove/cylinder has been properly switched off and the cylinder has been placed in the store taking all precautions.

B. Upper Primary

In respect of engaging the cooks / Helpers under the programme and the rates at which the honorarium etc. will be paid to them, it has been proposed that:

- All such middle units which, either exist in the same campus or are within a distance of 300 meters (i.e. 0-299 metres) from the nearest primary school, already implementing the MDM programme for primary classes, the preparation center will be clubbed and will be common for both primary and middle units. And, the honorarium payable to the workers already engaged in such preparation center will continue to be paid at the following rates already approved for the purpose.
- ▶ In such schools, where the enrolment is up to 30, and where Anganwari centres is functional, within the same campus, the MDM programme is implemented in convergence with Anganwari centres, and the preparation center could be common. In r/o such schools, the honorarium payable will be equal in case of both Anganwari supervisor and the Anganwari Helper and will be payable at rates as per Table 2.8B.

→ In respect of all other schools, where the programme is implemented by the school itself, Only ONE worker / Helper will be allowed to be engaged up to an enrolment level of 30 students and more than ONE worker could be engaged in view of the enrolment slab of the school. The honorarium payable will be at rates as indicated at Table-2.8C, given below:-

- → However, for all those middle units i.e. Govt./Govt. aided Middle / High / Sr. Sec. Schools, located beyond 300 meters, from the nearest primary school serving the mid day meal, separate preparation center / kitchen, will be allowed. For the preparation of mid day meal, the workers such as Anganwaris / Mahila mandals / Water carriers of the respective school and additional Cooks/ Helpers will be employed by the SMDC/MTA/PTA / Gram Panchayat / NGO of the respective school / village and paid honorarium at rate in view of the enrolment slab, as per Tables 2.8 B & 2.8 C, given above.
- However, the SDMC will take every care that the expenditure incurred towards honorarium remains within the prescribed upper ceiling of @ Rs.0.795 per student per day.
- In respect of the schools / units with low enrollment, where the expenditure on Honorarium etc. exceeds the prescribed ceiling i.e. Rs. 0.795 per child per day, each worker so engaged will be allowed Honorarium at the minimum rate between Rs.200/- to Rs. 400/- p.m., the difference, so involved will be met at the Block level by the concerned BEEO, out of the savings accrued from other schools, with heavier enrollment.

2.9 System for Cooking Serving and Supervising Mid Day Meals in School:

- ↓ Under cooked Mid Day Meal Programme in the state of Himachal Pradesh, the meal is being cooked & served either through Anganwari Centres of ICDS / Mahila Mandals OR through concerned primary schools at places where ICDS Centres and Mahila Mandals are unable to implement, by using the services of water carriers, if so, available in coordination with the local community, MTA / PTA / NGO's / VECs / Gram Panchyat/women's Self-Help-Group etc.
- ★ The meal will be cooked & served by the Cooks & helpers engaged under the programme.
- → The cooked meal is served in every school under the supervision of teachers.
- ♣ Apart from above, mothers have also been asked to supervise the preparation and serving of mid day meal.

↓ The assigned Role of Mothers is ;

- (i) To supervise and see that the food is being cooked properly.
- (ii) To see that the food is cooked hygienically.
- (iii) To see the scale of ingredients is as per the approved norms of the state.
- (iv) To form rosters, so that on each day one of the mother is present in the school to supervise the cooking and distribution of meal. They have been asked to check the quality as well as quantity of meal served.
- (v) To see that the serving, eating process is over within the period of RECESS BREAK and teaching time of children is not wasted.
- (vi) To help the school committees in choosing the Cooks and Helpers engaged under the MDM scheme.
- (vii) To test and taste the meals before serving to the children.

2.10 Status of construction of kitchen sheds from (i) funds released under the Mid Day Meal Scheme, and (ii) funds from other development programmes, such as SGRY, BRGF, etc. Details of activities through convergence with other developmental programmes in provision of drinking water, toilets etc.,

i) Funds released under Mid Day Meal Scheme:-

A. Primary

- In the year 2006-07, the GOI released funds to tune of Rs.2059.80 Lakh for the construction of 3433 Kitchen sheds in Primary schools @Rs.60,000/- per kitchen shed in 1st phase. But the state could release these funds to the Department in year 2007-08 due to financial constraints of the state Govt. which has been granted to SSA for carrying out the work of construction of these kitchen sheds. Out of 3433 sanctioned kitchen sheds. The work of construction of these said kitchen sheds has been assigned to the engineering wing of SSA.

 (Status attached at Table-8).
- Also SSA is already constructing 88 kitchen sheds-cum-stores in the newly constructed primary schools, out of which 50 kitchen sheds-cum-stores have been completed, 30 are under progress and 8 are yet to be constructed (Status attached at Table-8A).

B. Upper Primary

→ The state has submitted project proposal to the state Govt. for consideration and necessary approval against which the Government of India has released Rs.28.20 lakhs for 47 kitchen sheds for EBB under MDM.

(ii) funds from other development programmes, such as SGRY, BRGF, etc.

↓ In the state of Himachal Pradesh, no kitchen shed could be constructed through funds received under other development programmes, such as SGRY, BRGF, etc.

2.11 <u>Status of procurement of Kitchen devices from (i) funds released under the Mid Day Meal Programme(ii) other sources:-</u>

→ In the state of Himachal Pradesh the School Committees have been authorized to purchase the kitchen devices as per requirement of the school.

(i) Funds released under the Mid Day Meal Programme:-

- → In the beginning in the year 2004, when the cooked Mid Day Meal programme was started, the State of Himachal Pradesh allowed the purchase of utensils out of the school grant of Rs. 2,000/per annum per school released under under Sarva Shiksha Abhiyan (SSA).
- → In year 2006-07, Govt. of India has released under Mid Day Meal Scheme funds amounting to Rs. 177.30 lakh as replacement grant for the Replacement of cooking equipments/ Kitchen devices in r/o 3546 schools @ 5000 per school.
- ♣ And in year 2007-08, Govt. of India has released under Mid Day Meal Scheme funds amounting to Rs. 200.55 lakh as replacement grant for the Replacement of cooking equipments/ Kitchen devices in r/o 4011 schools @ 5000 per school.
- The State has also received Rs.11.00 lakhs grant from GOI, for the procurement of cooking equipment / kitchen devices @ Rs.5000/ per school for 220 upper primary schools of the 5 EBB of the state, for which case has been moved to seek expenditure sanction of the state along with matching budget provision to facilitate its drawl.
- → The state will be requiring Rs.202.10 lakhs grant from GOI, for the procurement of cooking equipment / kitchen devices @ Rs.5000/ per school in respect of the remaining 4262 220 = 4042 schools of the state, meet the required liability the under this component. Therefore, funds amounting to Rs.202.10 lakhs for 4042 Schools, may have to be provided in the next financial year 2008-09.
- As far as the procurement of kitchen devices to the 7557 (3546+4011) primary schools in the past two years is concerned, the state has distributed these funds to the targeted number of schools through its block level offices in order of decreasing enrolment with the directions to utilize for the purpose of procuring cooking devices/ utensils such as 2nd Gas cylinder storage container and utensils specifically as per the requirement of the school as decided/ worked out by the school committee constituted for the purpose. The expenditure is in progress.

(ii) Other Sources :-

- ♣ Some of the private societies such as Ambuja or other community/NGOs have donated utensils for the purpose.
- → The Ambuja Cement Foundation, Darlaghat of District Solan had adopted 29 Primary schools, SOLAN district and has provided compressed plates, spoons and glasses for every child under Mid Day Meal Scheme.

2.12 <u>Capacity building and training conducted for different categories of persons</u> involved in the Mid Day Meal Programme under programmes of SSA, DIETs, etc.

(i) Capacity building :-

- → The Department of Elementary Education has imparted training to teachers, Organizers, Cooks and Helpers for ensuring the effective implementation of the Mid day meal scheme in the state.
- **★** Instructions are circulated to take necessary precautions in respect of cleanliness, hygiene.
- Beside this the Deputy Directors of Elementary Education, the Block Elementary Education Officers, The Centre Head Teachers, the Head Teachers and the other teachers have been instructed for encouraging the community participation through the effective involvement of Gram Panchayat/VECS, SMCs, and MTAs in the selection of cooks / helpers and for the supervision of the programme.
- Apart from above, under Sarva Shiksha Abhiyan in consultation with DIETs in service teachers are being provided 20 days training, in which at least ONE day training slot is kept for discussing issues regarding the implementation of Mid Day Meal scheme in the state. Further, in service teachers are also guided about maintenance of record such as stock registers, cash books in r/o Mid Day Meal Scheme at school level and also to use this programme for the inculcation of good habits and to educate children about hygiene discipline, communal harmony, social equity, conservation of water etc.

2.13 <u>Management, Information System at School, Village/ Gram Panchayat, Block, District and State level</u>:-

Presently, no MIS system exists at the school / village/ Gram Panchayat/ Block level in the State. However, the MIS units have been established at the district level in all the DIETs institutes of respective districts under SSA. The MIS data received from the districts i.e. DIETs is consolidated at the state level in MIS unit of the State Project office of SSA and thereafter consolidated at the National level by NIEPA.

However in order to streamline the flow of information in the state at different levels the state has take the following steps:-

- The Head Teacher OR the Senior Teacher of the school is responsible for the proper maintenance of Accounts as well as Stock Register of Rice and other ingredients used for the implementation of the programme.
- He is required to submit the Quarterly Feedback Reports / Accounts Statements to the Block Elementary Education Officers, who further compiles and submits the consolidated Report for his Block to the Deputy Director Elementary Education, who further consolidate these for his entire district and submits the consolidated reports for his District to the Director Elementary Education. The Director further consolidates, the information for the entire state and submit reports to the State as well as Govt. of India.
- → Apart from above the community organizations such as the VEC, the Gram Panchayat, the Mother Teacher Association also play supervisory role for effective implementation of the Scheme.
- → Management Information System at School, Block and District level is maintained manually. Which as such is a quite time consuming process and cause delay in submission of consolidated information at different levels.
- → Out of the MM&E funds released to the state till date, the State of HP through EE Deptt., has provided 2 computers to state level cell, 12 at district level and 28 at block level. The remaining blocks are likely to be covered in a phased manner depending upon the future releases under MM&E by GOI to the state.
- → The state has planned to launch its own web site and also likely to develop web based monitoring system at least up to the district level, to facilitate the faster flow of MIS data.

- 2.14 Systems to ensure transparency and openness in all aspects of programme implementation, including inter alia, food grains management, ingredients procurement, cooking and serving appointment of cooking staff, construction of Kitchen sheds, procurement of cooking devices.
 - → The Steering-cum Monitoring Committees at different levels i.e. at STATE, DISTRICT, AND BLOCK level have been constituted in the state of Himachal Pradesh.
 - → The State level Committee has been empowered to oversee the management and monitoring of programme implementation.
 - → The District level committee has bee authorized to conduct surprise visits at random in at least 10% MDM Centres, in each quarter and submit reports to Principal Secretary Elementary Education and Director of Elementary Education.
 - The Block level committee has been given targets to conduct surprise visits at random, in at least 25% MDM Centres in each quarter and submit report to Deputy Commissioner/Deputy Director Elementary Education of the concerned district.
 - → In the state of H.P also as per the instructions of GOI, joint inspections are carried out for ensuring that the quality of RICE supplied under the MDM scheme, is of desired quality, are being carried out by the area managers of the State lifting Agency i.e. H.P State Civil Supplies Corporation and the officers of the Food corporation of India.
 - For ensuring the Transparency and Accountability at School Level, especially w.r.t food-grains and cash, the school development management committees have been constituted for every school. The Member secretary of the said school Committee who is either the head teacher OR the Senior Teacher of the school has been made responsible for the proper maintenance of Accounts as well as Stock Register of Rice and other ingredients used for the implementation of the programme. He has also been made responsible for submission of Quarterly Feedback Reports / Accounts Statements to the Block Elementary Education Officers, who further submits the consolidated Reports for his Block to the Deputy Director Elementary Education Officers, who submits these Reports consolidated for his District to the Director Elementary Education.
 - → The State of H.P. with a view to ensure transparency and openness in all aspects of programme is encouraging the participation of mothers in the programme.
 - The mothers are being asked to form roster so that one of the mothers could be present in the school on every working day and supervise the preparation and serving of meal process. They are also assigned to keep a check on the quantity as well as the quality of meal severed to enhance their level of satisfaction.
 - → All the DIET Principals have been given targets to conduct assessment studies in respect of one third of the schools in their Districts with the involvement of their staff, in every quarter of the year. They have been asked to include both rural as well as urban schools in the selected sample size of 25%.
 - → The State of H.P. identified the Dr. Y.S. Parmar University of Horticulture & Forestry Nauni, District Solan, for the conduct of External Evaluation Study of MDM programme in primary schools of the state and the study is under process with the said agency which has sought three months extension for the completion/submission of report.

2.15 Measures taken to rectify

- a) Inter-district low and uneven utilization of food grains and cooking cost
- b) Intra-district mismatch in utilization of food grains and cooking cost.
- c) Delay in delivering cooking cost at school level.
- Agency i.e. HPSCSC and the districts covered by these centre are also not in the form of the single unit. Some of the districts such as Kullu, Lahaul-Spiti due to the geographic locations are covered from the two different distribution centres causing thereby the mixing of reported figures in the respective districts. In view of this specific geographic problem is requested that the state of HP may kindly be looked as one unit at state level in place of comparing figures at district level. And when the state is looked as one unit the problem of no mismatch between the allocation, lifting and utilisation is found.
- In order to reduce the delay in delivering the cooking cost at school level the state of HP has decided to distribute the funds from state to directly at the Block level. The Blocks and the school have been asked to open Bank accounts and the BEEOs have been directed to release funds directly to the schools on quarterly basis through cheques after working out the requirement for each school as per the approved norms for the purpose.

2.16 Overall assessment of the manner in which implementation of the programme is contributing to the programme objectives and an analysis of strength and weaknesses of the programme implementation:-

The over all assessment of the programme implementation in the state of H.P. is as under:-

- → The programme is being implemented smoothly and regularly in the state without involving any complaint or interruption and this scheme is helping the state in achieving the targeted objectives.
- ➡ Under this scheme, rice based nutrious Hot cooked meal prepared fresh daily on all the working days of the school, is being served to all the students of the targeted schools. The menu of the meal is allowed to be varied at the school level, as decided by the school committees keeping in view the choice of the children of the area as per the liking of the students. This scheme has also helped the malnourished students of poor families in improving their nutritional status and has also helped in inculcating good habits among them.
- → In the state of Himachal Pradesh 100% of children are found to be present on all the school days of the year.
- The only constraint of the implementation of the programme noticed is that adequate dedicated manpower and the required infrastructure such as computer hardware, internet connection could not be provided to the offices at different levels made responsible to implement and monitor the MDM scheme.
- → Presently in the existing fund releases mechanism inordinate delay has been noticed in the state. The ACA released by GOI to the state takes around three months time in reaching the ultimate implementing agencies i.e. school committees causing thereby many hardships to them in ensuring the continuance of the programme.

2.17 Impact of Mid Day Meal Scheme such as increase in enrollment, attendance, retention, learning level etc., reduction in drop-out, increase in nutritional status etc.,

- → The MDM programme implemented in the State has very successfully helped in motivating the students of Govt./Govt. Aided Schools/EGS centres in enhancing the attendance rate and retention of students. The attendance of children has gone up to nearly 100% in the state.
- → But due to ongoing tendency in the society to put their wards more and more in the so called Public Schools which have mushroomed up even in rural areas of the state, the trend of enrolment in the Govt. Schools is decreasing, though the overall enrollment of the eligible children in formal schools including Public Schools has been increasing as is clear from the following data of the past three years:-

2.18 Details of Evaluation studies conducted and summary of its findings.

The study reports submitted by the districts Mandi reveal that the Programme is being implemented quite regularly and successfully without any interruption. The Programme is liked by the children / the parents as well as the community.
- 2) Another, study of MDM programme was conducted in the state by HP University in the districts of Chamba, Kullu, Mandi and Hamirpur. The study report submitted by the University revealed that:-
 - All 100% sampled primary schools and comprehensive schools with primary section serve hot cooked food to children daily.
 - Variety of food is maintained.
 - Children were happy and satisfied and none of them brings tiffin from home.
- 3) As per the instruction of GOI external evaluation study of ongoing MDM Programme in Primary schools of the State was allotted to Dr. Y.S. Parmar University of Horticulture and Forest, Nauni H.P. Solan, to study the impact of Programme on the following suggested indicators:
 - a) Infrastructural facilities available at school level.
 - b) The hygienic aspects of raw ingredients and food preparation.
 - c) The overall quality of food served.
 - d) Availability of Budget.
 - e) Attention paid to issues of serving and eating of food
 - f) Perception of Parents about the Programme.
 - g) Perception of Children about the Programme.

- h) Perception of Teachers about the Programme.
- i) Impact of the Programme on :Attendance, Retention, Drop out Rate and Enrolment.
- j) Monitoring of the Programme by :Teachers at School level and others.
- k) Number of Inspections conducted in the schools by different Education officials:
- 1) Checking of food by :School Committee, Teachers, Members of PTA/MTA and Mothers of children.
- m) The School level Evaluation regarding School cleanliness, availability of Drinking water & sanitation , hygiene of children, Maintenance of daily record of MDM and timeliness in managing the whole process of MDM.

The study report on the above indicators is still awaited for which the concerned agency has sought more time for completion of report.

2.19 Brief write up on best practices followed in the State

- The State of HP has adopted the rice based hot cooked Mid Day Meal to be prepared a fresh every day in the school to keep the 100% attendance of children on working day even in the remote location of the schools.
- To manage the preparation of MDM, schools committees have been constituted in all the schools and have been given right to decide menu keeping in view the liking and choice of children of the area within the approved norms decided for the purpose.
- For preparing of meal, state has given preference to the widows and destitute women among the worker engaged under the Programme.
- The MDM Programme has helped the students in inculcating the good habits among the students.

2.20 Instances of unhygienic food served, children falling ill, sub-standard supplies, diversion/misuse of resources, social discrimination and safety measures adopted to avoid recurrence of such incidents.

- No instance of children falling has been reported in the state of HP.
- Instructions regarding safety measures have been issued to the field offices.

2.21 Extent of involvement of NGOs and Civic Body Organizations (CBOs) / PRIs.

The state has not involved any NGO or Civic Body as the mid day meal scheme is being implemented by making use of the services of Anganwari workers/ Mahila mandals/ water carriers or the cooks/helpers engaged by the SDMC/PTA/MTA/VEC/Gram Panchayat of the respective school as they are actively involved in such activities.

2.22 Status of School Health Programme with special focus on provision of micro-nutrients, Vitamin-A, de-worming medicine, Iron and Folic acid, Zinc and recording of height, weight etc,.

The School Health programme is being implemented through the Health and family Welfare Department .

2.23 Steps taken to strengthen the monitoring mechanism in the Village, Block, District and State level and status of constitution of SMCs at these levels. Details of such meetings.

Instructions regarding conducting of meetings have been issued at Village, Block, District and State level. Meetings are held monthly at these levels where other issues including Mid day meal are also discussed.

2.24 Arrangement for departmental inspections to MDM centres and percentage of schools inspected and summary of findings and remedial measures.

In the state of Himachal Pradesh, following inspection targets have been assigned to the officers at different levels:-

2.25 Note on Action Taken on the findings of national level review meeting held at New Delhi on 9-10th Oct. 2007.

→ In respect of the critical issues as pointed out by Joint Secy. (EE-I) to MHRD the Govt. of India, the comments of the State are as under:-

a) **Item No.3 (i)**

As far as the pointed out low and uneven utilization of Central Assistance in terms of foodgrains and cooking cost is concerned, the detail of utilizations by the State in the year 2007-08 are as under:-

b) Further, as far as the inter district miss match in utilization of foodgrains is concerned, it is submitted that the estimates of project proposals regarding food-grains, are made on the basis of the enrolment of the previous year as on 30th September. But, due to the decreasing trend of enrolment during previous years in the state, for reasons of the tendency of parents to send their children to Private schools and due to adoption of counter contraceptive measures by the parents of the targeted population, the enrollment is found to decrease by approximately 20,000 in a year, than the level projected as on 30th September of the previous year. However, in the state, the schools have been instructed to lift the foodgrains as per the actual requirement, in view of the actual enrollment of the previous month, so that the food grains may not be wasted or misutilized.

Apart from above, due to the hilly terrain of the state, the PDS Depots / Fair Price Shops have been allowed liftings from the distribution centre of the other districts more convenient and nearer to the center of the other adjacent district. So, the state is of the view that in case the lifting position of foodgrains is viewed in a state specific manner, in place of district specific view, then the mismatch may not figure as problematic. The consolidated lifting percentage of foodgrains in the state of H.P as on 31.12.2007 is around 73%.

- c) Further, in r/o the irregular payment to Cooks and at level below the minimum wages, it is stated that in the state of Himachal Pradesh, the cooks and helpers engaged under the programme are in different numbers depending upon the enrolment slab of the school and they are allowed honorarium ranging Rs. 200/- to Rs. 1600/- keeping in view the quantum of works involved.
- d) In r/o the redressal of complaints concerning the quality and quantity of food served under MDMS, it is stated that the State is having a set mechanism to look at the complaints.

The complaints are redressed at grass root level (i.e. Block / District) by the respective Block Elementary Education Officer/ Dy. Director of Elementary Education and thereafter, if need arises at the state level by the Director Elementary Education and then at the Govt. level depending upon the nature of complaint involved. At every level immediate follow up action is taken to avoid any further recurrence of the problem giving rise to the complaint..

Apart from above, the Steering cum Monitoring Committees have also been constituted in the state at Block, District and State level to over see the implementation of the scheme. The different functionaries of the SMCs have also been authorized to inspect preparation Centers under MDMS programme and help the state to ensure that the programme of Mid Day Meal is implemented smoothly.

- e) The state of Himachal Pradesh has also decided to ensure the fund flow under the MDM scheme i.e. from Block Offices to the schools through Banks. The Bank Accounts, specifically for MDM have been instructed to be opened both at the Block and the School level by the concerned Block Elementary Education Officers and in the joint names of Pradhan & Member secretary (Sr. Teacher of the school) of the School Committee of each school.
 - Further directions have been issued to all the Block offices to make quarterly drawls of the estimated required amount and distribute to the concerned schools through cheques to avoid any risk involved in transacting Cash. The school have been instructed to withdraw from their Bank Accounts, the required amount fortnightly. This has been done to avoid spending by teacher from their own pocket on the implementation of the programme and to ensure the smooth and continued implementation of the MDM scheme in the state.
 - f) In view of financial constraints the state as yet could not appoint dedicated staff at different levels purely for the implementation of MDM Programme in the state. However efforts are being made to not to assign other works to the existing staff so as to implement the MDM Programme at State/ District level and Block level effectively.
