The schemes did not however include the cost of continuance of 6th plan schemes because of one of the guidelines of the Planning Commission was " the current year i.e. 1984-85 being the terminal year of the Sixth plan the level of maintenance expenditure in the plan would become a committed liability and would require to be transferred to the non-plan side in accordance with the past practice you may follow the past practice of isolating this expenditure and indicating this as part of non-plan expenditure."

The total outlay proposed in the draft 7th plan was Rs.38889.05 lakhs. The draft plan was scrutinised by the working group of the Planning Commission in December, 1984 and it recommended an outlay ~~xxxxxx~~ of Rs.38026.00 lakhs. As stated earlier this outlay did not include the cost of plan maintenance. The total outlay that has now been finalised is Rs.14975.00 lakhs. The outlay that has been finalised involved a substantial reduction in the outlay recommended by the Working Group of the Planning Commission. Moreover, the expected transfer of the plan maintenance expenditure to non-plan has not been materialised leading to further reduction in the resources available for new schemes. As a consequence of drastic curtailment of the total plan outlay, physical targets even in the national priority areas, have had to be drastically reduced. As would be explained later it is no longer possible to aim at universalisation of elementary education for the children in the age group of 6-11 and enrolment at 65% for

children of the age group 11-14. It is also not possible to achieve 100% coverage of adult illiterates. Most of the schemes aimed at qualitative improvement of vocationalisation of education and removal of critical deficiencies have had to be dropped. Major part of the plan resources would have to be devoted to committed expenditure such as payment of grant-in-aid to schools and colleges which would mature for payment of such grant-in-aid in accordance with present policy.

A statement showing outlay proposed by the Department in the draft plan outlay recommended by the Working Group of the Planning Commission and outlay finalised in each sector for the Seventh Plan as well as the Annual plan for 1985-86, is given below.

ELEMENTARY EDUCATION:

At the National level overriding priority has been accorded to the universalisation of Elementary Education for the children in the age group 6-14 by 1990. As regards enrolment of children in the age group 6-11, progress made during the sixth plan period was satisfactory. The sixth Plan target of enrolling 32.06 lakhs of children in this age group has been exceeded and 32.09 lakhs of children have been enrolled. The enrolment achieved till the end of the 6th Plan represents 90.5% of the child population in the age group 6-11 on the basis of 1981 census and 94.5% on the basis of 1971 census figures. In 11-14 age group, as against a target of 7.78 lakhs, 7.83 lakhs of children were enrolled till the end of the 6th Plan which is 39.96% of the age specific child population according to the 1981 Census. Universalisation of enrolment of children belonging to the age group 11-14 would involve raising the level of enrolment by nearly 60 per cent during one plan period. Apart from the fact that such a target may not be feasible it should also be noted that since universalisation in the age-group 6-11 is likely to be achieved by the year 1989-90, universalisation in the age-group 11-14 can only be achieved three years thereafter.

As such, in the draft seventh Plan which was submitted earlier it was proposed to aim at a coverage of 65 percent of children within the age-group 11-14. This proposal was accepted during discussion in the Working Group of the Planning Commission in December, 1981.

The projected child population belonging to the age group 6-11 in the year 1990 is 38.85 lakhs. On the basis of a conservative estimate at least 10% overaged and underaged children are likely to seek admission in classes I-V. Thus the total number of children who would need to be enrolled of the Plan would be about 43 lakhs. The projected child population of the age-group 11-14 for the year 1990 is 21.47 lakhs. On a modest estimate at least 10% overaged children are expected to seek admission in classes VI-VIII. The target of covering 65% of children in this age-group would require provision of schooling facility for atleast 13.4 lakh of children. The funds required for covering 43 lakhs of children in age group 6-11 and 15.4 lakhs of children in 11-14 age group by the formal stream alone would be very high.

Keeping in view the emphasis on low cost alternatives, it was proposed in the Draft Plan document to adopt a mixed instructional pattern comprising of both the formal and non-formal methods of education for covering all these children. Keeping the requirement of diverse villages and habitations in view, it was proposed in the draft plan to provide 21,575 formal school teachers and 43,150 non-formal teachers during the Seventh Plan to achieve the objective of universalisation for the age group 6-11.^{and} for achieving the target of 65% enrolment for the age group 11-14. Of these, 4305 formal teachers and 7940 non-formal teachers were required during 1985-86. This proposal was endorsed by

the Working Group of the Planning Commission. After finalisation of plan allocation, it has been possible to make provision for creation of only 2000 posts of primary school teachers and opening of 2000 non-formal education centres during the entire 7th five year plan period out of which posts of 1000 primary teacher will be created in 1985-86. There is no provision for opening of Non-formal centres during 1985-86 in the plan budget.

In the draft plan it was proposed to construct 4200 new primary school building, upgrade 3300 primary schools to U.P. Schools and 3900 U.P. Schools to M.E. School and to construct additional class rooms for all the upgraded schools during the plan period. These proposals have had to be dropped because of reduced plan size.

To encourage attendance of children in primary schools and reduce the rate of dropouts, the draft plan envisaged introduction of incentive schemes in low literacy areas such as free Midday meals to primary school children, supply of free text books, free uniform to girls and attendance scholarship to the children of E.R.R.P. beneficiaries. Even though programmes aiming at reduction in drop outs are of considerable importance in the final plan programmes none of these incentive schemes could be retained owing to inadequacy of plan resources. Proposals for strengthening the supervisory and administrative network for improvements

J supervision of primary schools have also had to be dropped for the same reason although strengthening of the arrangements for supervision an essential for ensuring proper utilisation of higher investment proposed to

Adult Education:

At National level, the target is to make all the illiterates in the age group 15-35 literate by 1990. It is estimated that by 1990 there would be 51.58 lakhs of illiterates in the State belonging to this age group. The working group of the Planning Commission endorsed an adult education programme involving an outlay of Rs.300.00 lakhs for 1985-86 and Rs.3362.00 lakhs for the 7th Plan. The outlays mentioned above represents the State share for the Adult Education Programme. The size of the annual plan of this deptt. did not permit opening of any new Adult Education Centre during 1985-86. One thousand Adult Education Centres under state sector were functioning during 1984-85 and the same number of Centres will continue in 1985-86. A provision is being made for opening of 500 new Centres during 1986-87. As such it would not be possible to achieve the natural target of covering all adult illiterate by 1990.

PHYSICAL TARGETS OF M.N.P.

The physical targets envisaged in the draft Seventh Plan have had to be substantially reduced owing to substantial reduction in plan ceiling. Eventhough funds available after making provisions for the continuing schemes and some of the spill over schemes are substantially proposed to be allocated for schemes for enrolment at the elementary level, ~~and for opening of Adult education Centres, for opening of Adult education Centres, the target of 100% enrolment of children in the age group 6-11, 65% enrolment of children in the age group 11-14 and coverage of all adult illiterate in the age group 15-35 during the 7th Plan period cannot be achieved by the end of Seventh Plan period.~~

It has to be ensured that the level of enrolment at the end of the 7th Plan does not fall below the level achieved by the end of the 6th Plan. Having regard to the total outlay proposed for 7th Plan it would subject to marginal increase in outlay be atleast possible to aim at one to two per cent increase in enrolment in at the elementary level by the end of the 7th Plan. This does not however take into account funds which may be available under the Centrally sponsored schemes as no clear indication of the amount likely to be available under these scheme is yet available. In the year 1984-85, 95.03% of children in the age group 6-11 were enrolled (both by formal and non-formal streams). Provision is being made for appointing 2000 formal and 2000 non-formal teachers for the children of this age group during the seventh plan period. Besides 3871 teachers will be appointed in single teacher Primary Schools neither funds available under the upgradation grant (non-plan) during the Plan Period.

On the basis of teacher-pupil ration of 1:40 in formal schools and 1:25 in non-formal schools, additional enrolment of 2.35 Lakhs in formal schools 0.5 Lakhs in non-formal schools can be targetted. With additional enrolment of the above order, by the end of Seventh Plan 96.24% of children of the age group 6-11 can be enrolled. This is marginally higher than the enrolment percentage achieved at the end of sixth Plan.

But the position is different for the age group 11-14. In this age group 40.42% of children have been enrolled under both formal and non-formal streams by

the end of 1984-85. The teacher pupil ratio at M.E. stage in 1984-85 was 1:31 in formal schools. The teacher popil ratio in non-formal schools fixed by Govt. of India is 1:10. For the M.E. stage, i.e. for children in 11-14 age group, the proposed outlay for the Plan does not allow scope for appointment of additional formal & non-formal teacher during the 7th Plan period. Therefore even if the teacher pupil ratio is improved to the level of 1:33 as a result of enrolment drive, the percentage of enrolment at the end of 7th Plan will fall below the sixth plan level of achievement i.e. from 40.42% to 38.84%. This unsatisfactory position can only be changed by expanding facilities for enrolment at M.E. stage during the Plan Period. If a sum of Rs.4.50 crores in addition to Seventh Plan ceiling of Rs.149.75 crores will be available during the 7th Plan period then it will be possible to achieve 41.5% of enrolment of children in the age group 11-14 which is about 1% more than the sixth Plan level of achievement. To provide additional facilities at the M.E. stage, it is proposed to upgrade 600 U.P.Schools to M.E. schools by appointing 1200 teachers (600 trained Matric and 600 trained Graduates). The cost of appointing 1200 teachers in a phased manner at the rate of 300 teachers from 1986-87 is Rs.3.00 crores and the cost of construction of additional class rooms in the upgraded schools is Rs.1.50 crores.

The gap between the targets fixed now and the targets envisaged at the time of drafting the Seventh Plan namely enrolment of 100% children in the age group 6-11,

65% children in the age group 11-14 and all illiteration in the age group 15-35 in Adult Education Centres during the Seventh Plan period can be bridged only if central assistance is available in a big way and in case the Central Scheme is a sharing scheme, the State Govt. is able to provide for the State share for which additional provision has to be made.

SECONDARY EDUCATION

In this sector grant to Non-Govt. High Schools will be the major item of expenditure during the Seventh Plan period. 184 High Schools will be eligible for full grants from 1985-86. 156 High Schools in 1985-86 and 866 High Schools between 1985-86 will qualify for receiving grants. Having regard to the Plan ceiling indicated there is no scope for expansion in this sector and very limited scope for taking up any scheme for qualitative improvement. With a view to reducing the disparity in access to Secondary Education existing between different districts in the state, it was proposed in the Draft Plan to establish 80 Govt. High Schools in the seven backward districts of the state. This proposal has had to be dropped. Also, schemes proposed in the Draft Plan aiming to reduce existing deficiencies in the High Schools, construction of additional class rooms in schools having poor class room facilities, construction of hostels and teachers' quarters in backward areas, supply of library books to non-Govt. High Schools and opening and strengthening of Book Banks could not be accommodated.

Few new schemes such as grant to Secondary Board for in-service training of High school Teachers, supply of science equipments and supply of library books to Government High Schools and organisation of community singing in high schools have been provided in Seventh Plan and Annual Plan for 85-86. One English Teachers' Training Institute will be opened in 1985-86. For retirement benefits to the employees of Non-Government Institutions 15 posts of U.D.Clerks are to be created during the year, 1985-86.

UNIVERSITY EDUCATION

In this sector, as in the secondary sector, grant to Non-Government Colleges will be the major item of expenditure. 41 Non-Government Colleges will receive grants for the first time from 1985-86 and 111 Non-Government Colleges will mature for grant during 1985-86. Though vocationalisation of Education is given priority at the national level, due to constraint of resources, it has not been possible to introduce vocational stream at the +2 stage during the Plan period. Three years degree course has been introduced in Colleges from 1985-86 and Rs.8.53 lakhs has been provided during 1985-86 for appointment of teaching and non-teaching staff in Government Colleges. To remove imbalance in teaching facilities as between science, Commerce and Arts streams, it was proposed to open Science Courses at +2 stage in seven Govt. Colleges and increase science seats in other Colleges. This proposal has had to be dropped. Draft proposals aiming at qualitative improvement of Higher Education such as construction of laboratories, construction of additional class rooms, hostels and quarters for teaching and

non-teaching staff could not be accommodated. As a measure of qualitative improvement, it was also proposed to develop two Degree College (one being a Women's College) as Model Colleges in each district during the Seventh Plan period. The purpose was to provide opportunity for the students of each district to prosecute their studies in good educational institutions. The Plan ceiling did not permit inclusion of this proposal.

An Institute of Social Science is proposed to be established from the current year. Both for the secondary and Higher Education sectors, Rs.600.00 lakhs has been provided for construction work during the entire plan period out of which Rs.205 lakhs has been provided in 1985-86 for completion of some of the on-going building projects. The total requirement for completing all on-going building projects is Rs.372 lakhs. Besides, this construction programme, Rs.63.76 lakhs has been provided during the current year for special repairs of buildings in the three Universities and construction of boundary wall of Utkal University. In addition to this Rs.20 lakhs has been provided for construction of the campus of Jagannath Sanskrit University.

PHYSICAL EDUCATION

The programme for development of Physical education and promotion of games and sports in the educational institutions were neglected during the previous plan periods.

With the limited resources available, some new schemes such as conduct of Mini Games in the State for participation at the National level for the primary school children , conduct of Junior and Sub-junior Nehru Hockey tournaments and grant for participation of high school students in sports competition at the State and National level have been provided for in the Seventh Plan. Provision has been made in the current year for creating posts of lecturers for B.P.Ed and M.P.Ed. Courses in the Govt. College of Physical Education,Cuttack.
