AMENDMENTS TO ORDINANCES AND APPENDICES TO ORDINANCES

1. Amendments to Ordinance XXII-D vide Appendix VIII relating to Terms and Conditions of Service and Conduct Rules of nonacademic employees of the University, (E.C. 4-9-1977).

(i) Original Rule 35(a):

"35. (a) Right to leave:

Leave cannot be claimed as a right, and when the exigencies of service so demand, leave of any description may be refused or revoked by the authority empowered to sanction leave."

Amendment approved:

Add the following as Para 2 to the Rule 35(a) :

"In case an employee is recalled to duty before the expiry of his leave, such recall to duty shall be treated as compulsory in all cases."

(ii) Original Rule 35(d)

"35. (d) Grant of leave beyond the date of retirement and in the resignation :


"No leave shall be granted beyond the date on which an employee must compulsorily retire : provided that the authority empowered to grant leave may allow any employee who had been denied earned leave in whole or in part on account of exigencies of service, the whole or any portion of the earned leave so denied even though it extends to a date beyond the date on which such an employee must compulsorily retire.

Amendment approved:

Substitute the following for the above :

"No leave shall be granted beyond the date on which an employee must retire : provided that the authority empowered to grant leave may allow any employee who had been denied earned leave in whole or in part on account of exigencies of service, the whole or any portion of the earned leave so denied subject to a maximum of 120 days even though it extends to a date beyond the date on which such an employee must retire.



(iii) Original Rule 35(f):

"35. (f) Joining the duty on return from leave on medical grounds:

An employee who has been granted leave on medical grounds shall be required to produce a medical certificate of fitness before resuming duty."

Amendment approved :

Add the following as Para 1 to the Rule 35(f) :

"35. (f) Leave on medical grounds and resumption of duty.

The authority competent to grant leave may in its discretion, waive the production of a medical certificate in case of an application for leave for a period not exceeding 3 days at a time on medical grounds. Such leave shall not, however, be treated as leave on medical certificate and shall be debited against leave other than leave on medical grounds."

(iv) Original Rule 35(1):

"35. (1) A leave account will be maintained for each employee in the prescribed form."

Amendment approved:

Add the following as Para 2 to the Rule 35(1):

"The order sanctioning earned leave/half pay leave to an employee shall hereafter indicate the balance of such leave at his credit."

(v) Original Rule 37(i)(a):

"37. Earned Leave:

- (i) Earned leave admissible to employees:
 - (a) Each employee's account of leave should be credited with 30 days and 31 days earned leave in alternate leave years. This should be done in two instalments, 15 days on the 16th of July and 15 days on 16th of January of the following year except that on the 16th July of an even year (ending with 2, 4, 6, 8 or 0) the credit shall be 16 days e.g. the credit on the 16th July, 1976 will be 16 days and on 16th January, 1977, 15 days while on 16th July, 1977 and on 16th January, 1978, 15 days and so on."

Amendment approved :

Substitute the following for the above :

- "37, Earned Leave :
- (i) Earned leave admissible to employees :
 - (a) Each employee's account of leave should be credited 15 days earned leave on the 16th of July and 15 days earned leave on 16th of January of the following half year."
- (vi) Original Rule 37(i)(e):
- "37. Earned Leave :
- (i) Earned leave admissible to employees :
 - (e) If a University employee has taken any leave other than earned leave in a half-year, the credit to be afforded to his leave account at the commencement of the next half-year shall be reduced by 1/11th of such leave e.g. if a University employee has taken 11 days' half pay leave or 11 days commuted leave or 11 day's extra ordinary leave, the credit to his leave account will be reduced by 1 day, i.e. 1/11th of the 11 days half-pay leave or commuted leave or extra ordinary leave."

Amendment approved :

Substitute the following for the above :

"37. Earned Leave :

- (i) Earned leave admissible to employees :
 - (e) The credit afforded under Clause (i)(a) above, shall be reduced by 1/10th of the period of extra-ordinary leave only availed of during the previous half year, subject to a maximum of 15 days."
- (vii) Original Rule 37 (ii) :
- "37. Earned Leave :
 - (ii) Limits of accumulation and grant :
 - (a) A University employee shall cease to earn the earned leave under (i) (a) when the earned leave due amounts to 180 days.
 - (b) The maximum amount of earned leave that can be granted to an employee at a time shall be 120 days. Earned Leave may be granted for a period not exceeding 180 days, if the entire leave so granted or any portion thereof is spent outside India, Bangla Desh, Bhutan, Burma, Sri Lanka, Nepal and Pakistan. Provided that where earned

leave exceeding 120 days is so granted, the period of such leave spent in India shall not in the aggregate exceed 120 days."

Amendments approved :

- (1) Substitute the following for the above :
 - "(ii) Limits of accumulation and grant :
 - (a) A University employee shall cease to earn the earned leave under (i) (a) when the earned leave due amounts to 180 days.
 - (b) The maximum amount of earned leave that can be granted to an employee at a time shall be 120 days.

Provided Earned Leave taken as Leave preparatory to Retirement can be availed of up to a maximum of 180 days.

Earned Leave may be granted for a period not exceeding 180 days, if the entire leave so granted or any portion thereof is spent outside India, Bangla Desh, Bhutan, Burma, Sri Lanka, Nepal and Pakistan.

Provided that where earned leave exceeding 120 days is so granted, the period of such leave spent in India shall not in the aggregate exceed 120 days."

- (2) Add the following as (c) after sub-Clause (ii) (b) :
 - "(c) Prefixing | suffixing of holidays to leave:

Prefixing and suffixing holidays to leave, other than leave on medical certificate, shall be allowed automatically except in cases where for administrative reasons permission for prefixing/suffixing holidays to leave is specifically withheld. In the case of leave on medical certificate, if the day on which an employee is certified medically fit for rejoining duty happens to be a holiday, he shall be automatically allowed to suffix such holiday(s) to his medical leave and such day(s) shall not be counted as leave."

(viii) Original Rule 39:

"39. Commuted Leave :

Commuted leave not exceeding half the amount of halfpay leave may be granted on medical certificate to a permanent employee subject to the following conditions :

(a) When commuted leave is granted, twice the amount

of such leave shall be debited against the half-pay leave due.

(b) The total duration of earned leave and commuted leave taken in conjunction shall not exceed 240 days provided that no commuted leave may be granted under the provision unless the authority competent to sanction leave has reasons to believe that the officer will return to duty on its expiry."

Almendment approved :

Substitute the following for the above :

"39. Commuted leave:

Commuted leave not exceeding half the amount of halfpay leave may be granted on medical certificate to a permanent employee subject to the following conditions:

- (a) When commuted leave is granted, twice the amount of such leave shall be debited against the half-pay leave due.
- (b) No commuted leave may be granted under the provision unless the authority competent to sanction leave has reasons to believe that the officer will return to duty on its expiry.
- (c) Where a University employee who has been granted commuted leave resigns from service or at his request is permitted to retire voluntarily without returning to duty, the commuted leave shall be treated as halfpay leave and the difference between the leave salary in respect of commuted leave and half pay leave shall be recovered.

Provided that no such recovery shall be made if the retirement is by reason of ill-health incapacitating the University employee for further service or in the event of his death.

Note : Commuted leave may be granted at the request of the University employee even when earned leave is due to him."

(iix) Original Rule 40 :

"40. Leave 'not due' :

- 1. Save in the case of leave preparatory to retirement, leave not due may be granted to a University employee in permanent employ subject to the following conditions :
 - (a) The authority competent to grant leave is satisfied that there is reasonable prospect of University employee returning to duty on its expiry;

- (b) Leave not due shall be limited to the half pay leave he is likely to earn thereafter ;
- (c) Leave not due during the entire service, shall be limited to a maximum of 360 days, out of which nct more than 90 days at a time and 180 days in all may be otherwise than on medical certificate;
- (d) Leave not due shall be debited against the half pay leave the University employee may earn subsequently:
- (e) The authority competent to grant leave obtains an undertaking from the University employee that in the event of his resigning or retiring voluntarily from service, he shall refund the leave salary paid to him.
- 2. * * * * *''.

Amendment approved ;

Add the following as proviso under sub-Clause 1 of Rule 40 :

"Provided, however, in order to mitigate the hardship of the temporary employees who are suffering from T. B., Leprosy, Cancer, or mental illness, leave not due may be granted to such employees for a period not exceeding 360 days during entire service subject to the fulfilment of conditions in clauses (a), (b) and (d) above and also subject to the following further conditions :

- (i) that the employee has put in a minimum of one year's service ;
- (ii) that the post from which the employee proceeds on leave is likely to last till his return to duty; and
- (iii) that the request for grant of such leave is supported by a medical certificate."
- (x) Original Rule 43:
 - "43. Maternity Leave:
 - (i) Maternity leave may be granted to a woman employee on full pay for a period which may extent up to the end of 3 months from the date of the commencement or to the end of 6 weeks from the date of confinement whichever is earlier. Maternity leave may also be granted in cases of miscarriage, including abortion, subject to the condition that the leave applied or does not exceed 6 weeks and the application for leave is supported by medical certificate.
 - (ii) Maternity leave may be combined with leave anyof other kind, except casual leave, but the leave appled

for in continuation of maternity leave may be granted only if the application is supported by a medical certificate."

Amendment approved:

Substitute the following for the above :

"43. Maternity Leave:

- (i) Maternity leave may be granted to a woman employee on full pay for a period of 90 days from the date of its commencement.
- (ii) Maternity leave may also be granted in case of miscarriage, including abortion, subject to the conditions that the leave applied for does not exceed six weeks and the application for leave is supported by a medical certificate.
- (iii) Maternity leave may be combined with leave any of other kind, except casual leave, but the leave applied for in continuation of maternity leave may be granted only if the application is supported by a medical certificate.
- (iv) Leave in continuation of maternity leave may also be granted in case of illness of a newly born baby, subject to production of medical certificate to the effect that the condition of the ailing baby warrants mother's personal attention and that her presence by the baby's side is absolutely necessary."
- (xi) Original Rule 45 (iii):
- "(iii) Except in case of a permanent employee the duration of extra-ordinary leave on any one occasion shall not exceed the following limits :---
 - (a) Three months.
 - (b) Six months in the case of an employee who has completed three years of continuous service on the date of expiry of the leave admissible to him under the rules, and his application for such leave is supported by a medical certificate.
 - (c) Eighteen months when the employee is suffering from tuberculosis or leprosy and undergoing treatment in a recongnised clinic or under a specialist.
 - (d) The authority empowered to grant leave may commute retrospectively the period of absence without leave into extra-ordinary leave.
 - Note :- The power of commuting retrospectively the period of absence without leave into extraordinary leave is absolute and not subject to any conditions."

Amendment approved :

Substitute the following for the above :

- "(iii) Except in case of a permanent employee the duration of extra-ordinary leave on any one occasion shall not exceed the following limits :
 - (a) 3 months without medical certificates ;
 - (b) 6 months with medical certificate for common ailments; and
 - (c) 18 months on medical certificate for Cancer, mental illness, pulmenary tuberculosis or pleurisy of tubercular origin, tuberculosis of any part of the body and leprosy.

Provided that for grant of extra-ordininary-leave as at (b) or (c) above, the employee should have put in a minimum of one year's continuous service.

- (iv) The authority empowered to grant leave may commute retrospectively the period of absence without leave into extra-ordinary leave.
 - Note: The power of commuting retrospectively the periods of absence without leave into extraordinary leave is absolute and not subject to any conditions."
- (xii) Original Rule 47 (A) (5):
 - "(5) A University employee who is permitted during leave preparatory to retirement, to take up any other service or employment under an employer other than the University, his leave salary shall be restricted to the amount of leave salary admissible while on half pay leave."

Amendment Approved :

Substitute the following for the above :

"(5) No permission for private employment during leave preparatory to retirement shall be granted hereafter. If, however, an employee on leave preparatory to retirement is permitted to take up an employment with public sector undertakings, the leave salary shall no longer be restricted to that admissible during half pay leave."

(c) If during such re-employment he is granted leave earned by him during the period of re-employment, the leave salaryshall be based on the pay drawn by him exclusive of the pension and pension equivalent of other retirement benefits."

Amendment approved :

- (1) Add the following as sub-Clause (6) (d) after sub-Clause (6)
 (c) of Rule 47 (A) :
- "(d) Leave salary for terminal refuse leave, L.P.R. and reduction on account of employment during leave.
 - (i) An employee who is granted terminal/refuse leave under the provisions of rules shall be paid in lump-sum the amount equivalent to leave salary and allowances, if any admissible during such leave, for the entire period of such leave, as one time settlement instead of monthly payments as at present.
 - (ii) If any employee while on terminal/refuse leave is permitted to take up employment, the leave salary for the leave shall no longer be restricted to that admissible during half pay leave as at present. However, the leave salary shall continue to be subject to reduction on account of pension/pension equivalent of other retirement benefits."
- (2) Add the following as sub-Clause (7) after sub-Clause (6) of Rule 47 (A) :
 - "(7) Advance of leave salary :

The advance in lieu of leave salary admissible to an employee proceeding on leave of not less than 30 days shall include allowances as well, subject to deduction on account of income-tax, provident fund, house rent, recovery of advances etc."

- (xiv) Original Rule 47 (B) :
 - "47. (B). In case a University employee dies in harness, the cash equivalent of the leave salary that the deceased employee would have got, had he gone on earned leave, but for the death, due and admissible, on the date immediately following the date of death, subject to a maximum of leave salary for 120 days, shall be paid to his family subject to reduction envisaged in rule 47 (A)(6)(a) *ibid.*"

Amendment approved :

Substitute the following for the above :

- "47. (B) In case a University employee dies in harness the cash equivalent of the leave salary that the deceased employee would have got, had he gone on earned leave, but for the death, due and admissible on the date immediately following the date of death, subject to a maximum of leave salary for 180 days, shall be paid to his family. Further such cash equivalent shall not be subject to reduction on account of pension equivalent of deathcum-retirement gratuity."
- 2. Amendment to Ordinance V—University Degrees and Diplomas (Pages 186-187 of the University Calendar—Vol. I—1976)—(E.C. 18-10-1977).

Delete the following Clause 2-B to Ordinance V:

Clause 2-B:

"From July, 1963, in addition to the courses of study prescribed under Clause 2 and 2-A above, every male student of the University admitted to and undergoing a course of study for the B.A. (Pass)/B. Com. (Pass), B. A. (Honours), B.Com. (Honours), B.Sc. (General), B.Sc. (Honours) and B.E., B.Ch.E., B.Text, B.Arch. (up to III Year) or B.Sc. (Civil, Mechanical, Electrical, Chemical Engineering) and B.Sc. (Textile Technology) (up to II Year) and M.B.,B.S. (for a period of $10\frac{1}{2}$ months during first two years of the course with no N.C.C. Training during the three months preceding the first Examination) courses shall be required to enrol himself as a Cadet in the N.C.C. and undergo Training as required under the N.C.C. Rules:

Provided that exemption from the foregoing provisions may be granted by the Principal of the College concerned to a student who is medically unfit to undergo such a training, if he obtained a certificate to the effect from the University Medical Officer, College Medical Officer or a Medical Officer not below the rank of a Civil Surgeon:

Provided further that every student exempted from joining the N.C.C. under the above provision shall be required to undergo physical training, unless exempted on account of medical fitness duly certified by the competent medical authority as specified in the foregoing Clause.

(2) From July, 1963, in addition to the course of study prescribed under Clause 2 and 2-A above, every woman student of the University admitted to and undergoing a course of study for the B.A. Pass), B.Com., (Pass), B.A. (Honours), B.Sc. (General), B.Sc. (Honours), B.Sc. (Home Science) and B.Com. (Honours) and M.B., B.S. (for a period of $10\frac{1}{2}$ months during the first two years of the course with no N.C.C. Training during the three months preceding the first Examination) courses, shall be required to errol herself either as a Cadet for the N.C.C. Women's Wing or undergo physical training in the University/College, according to her choice:

Irovided that the exemption from the foregoing provisions may le granted by the Principal of the College concerned to a student vho is medically unfit to undergo such a training, if she obtains a certificate to that effect from the University Medical Officer, College Medical Officer or a Medical Officer not below the rank of a Civil Surgeon:

Irovided further that every woman student exempted from joining the N.C.C. or undergoing physical training under the above provision shall have to undergo training in other courses, viz., First-Aid or Home Nursing, unless exempted on account of medicul fitness duly certified by the Competent Authority.

- Note:— (i) The following categories of students shall, however, be exempted from the N.C.C./Physical Education Training :
 - (a) Women students enrolled with the Advisory Board of Women (Non-Collegiate) Education,
 - (b) Students studying in the Evening Classes;
 - (c) Persons enrolled as Teacher Candidates;
 - (d) Persons enrolled with the School of Correspondence Courses and Continuing Education;
 - (e) Students who have completed their training Senior Division, N.C.C.;
 - (f) Students of the Pre-Medical Courses;
 - (g) Students of the B.Sc. (Nursing) (Honours) Course;
 - (h) Students of the Final Year of the B.Sc. (Honours) Courses;
 - (ii) Students of the Final Year of the B.Sc. (Genl.) Courses;
 - (iii) Matters pertaining to the procedure of enrolment and leave of absence etc. shall be laid down by regulations as prescribed by the Academic Council."

3. Amendment to Ordinance VII—'Conditions for Admission to Examinations' (Page 206 of the University Calendar-Volume I-1976) (E. C. 18-10-1977).

Delete the following Clause 2-B to Ordinance VII:

"2-B. No student who is required to be enrolled in the N.C.C. or undergo Physical Training or other similar training, shall be deemed to have satisfied the required conditions in respect of his/her instruction unless in addition to the requirement of attendance at lectures, he/she has attended not less than three-fourths of N.C.C. parades or physical training classes in each academic year:

> Provided that the Principal may on the recommendations of the Officer Commanding, N.C.C. Parades/Officer-in-Charge, Physical Training Classes condone the shortage in attendance to the extent of 10% for promotion from I Year to II Year and II Year to III Year, on condition that they attend for a further period in the following year to make up the shortage".

4. Amendments to Ordinance XXVIII'-Scholarships, Fellowships, Medals and Prizes'. (E. C. 18-10-1977).

(i) Add the following at Serial No. 51 under 'Medals' (Page 393 of the University Calendar-Volume I-1976):

"DR. KRISHNA RAO GOLD MEDAL

- 51. (1) There shall be a medal known as 'Dr. K. Krishna Rao Gold Medal' to be awarded each year out of the annual income accruing from the endowment of Rs. 5,000/made by the Secretary, Indian Society of International Law, 7-8, Scindia House, Kasturba Gandhi Marg, New Delhi-110001.
 - (2) The medal shall be awarded each year to a candidate who obtains the highest marks amongst the successful candidates at the Diploma in International Law Examination, obtaining not less than 60% marks.
 - (3) In the event of no candidate being found eligible for the award [as definedⁱin Clause (2)], the income accruing from the endowment shall be added to the endowment fund."
- (ii) Amendment to Serial No. 10 under 'Scholarships and Fellowships' relating to 'Research Scholarships in Sociology' (Page 354 of the University Calendar—Volume I—1976):

Original provisions regarding 'Research Scholarships in Sociology'.

"IESEARCH SCHOLARSHIPS IN SOCIOLOGY

10. There shall be two Research Scholarships in Sociology each of the value of Rs. 300/- per mensem for two years for the encouragement of research and original work under the following conditions:

> Provided that on the recommendations of the Head of the Department concerned the Vice-Chancellor may extend the scholarship for one year more.

- (1) The Scholarships shall be open to persons below the age of 27 (on July 1st of the year of award) and who have passed M.A. with Sociology or Social/ Cultural Anthropology of any recognised Indian University in the First Class or in the second class with an aptitude for sociological Research.
- (2) The scholarships shall be awarded on the recommendation of a Selection Committee comprising the Head of the Department of Sociology, as senior teacher (Professor or Reader) in the Department Sociology, and an external expert.
- (3) The recipient of the scholarship shall get himself enrolled at the Department of Sociology as a regular whole time research student for the Degree of Ph.D. under the approved guidance in a subject selected by him, and approved by the Head of the Department of Sociology.
- (4) If a scholar accepts any post or undertakes any work, which in the opinion of the Head of the Department is inconsistent with the obligations attached to the holding of the scholarship, he shall thereupon forfeit his scholarship and his emoluments shall cease.
- (5) Payment of the scholarship shall be subject to the recipient producing a certificate of progress an satisfactory work of each term. Payment shall be made monthly after deducting such dues as may be outstanding in his name in the books of the University and the Department of Sociology.
- (6) During the first six months of award, the scholar will be on probation. Confirmation of the award will depend upon the satisfactory completion of the period of probation.

(7) The scholar shall complete the full period of research work. In the event of a scholar discontinuing before the completion of the period for no valid reason, he shall be liable to refund to the University the entire amount received by him."

Amendments approved:

- (i) Delete the above provisions from the Ordinance:
- (ii) Add the following as serial No. 10 under 'Scholarships and Fellowships':

"JUNIOR RESEARCH FELLOWSHIPS (Departmental)

 (1) There shall be 21 Junior Research Fellowships at a given point of time for award to the deserving candidates for undertaking studies leading to an M.Phil. and/or a Ph.D. Degree in the University on the following subjects:

- (2) (a) Value and Duration: The value of each Junior Research Fellowship shall be Rs. 400/-p.m. for the first two years. At the end of two years, the work done by the fellow will be assessed and after his/her work is judged to have been good, he/she may be awarded the fellowships of Rs. 500/- p.m. for anothor two years. Each fellowship will carry contingency grant of Rs. 1500/- per annum. The fellowship and contingency grant are exempted from Income Tax.
 - (b) Junior Research Fellowship will be tenable for a period of four years, extendable by six months, in special cases. However, after two year of the tenure, the performance of the Junior Research Fellows will be assessed by the University Grants Commission and if on assessment, it is found that the fellow lacks research potentiality, the fellowship may be terminated. In case of the research fellow who has displayed research ability, but has not achieved significant progress he/she may be given an extension for a period of one year and at the end of

the third year his/her extension of fellowship would be subjected to a further assessment and if report is found to be satisfactory he/she may be given further extension for one year.

- (c) The award of the fellowships to the M.Phil. students will be made for a period of one year (for the duration of the course) and thereafter the fellowship may be continued for another period of three years provided the candidates after passing M.Phil. Degree Course get themselves registered for the Ph.D. degree course.
- (3) Eligibility: The Junior Research Fellowships are open to persons preferably below the age of 30 years who have obtained a Master's Degree in the subject concerned or an allied subjects from a recognised Indian University in the First or Second Division with at least 55% marks or an equivalent qualification as laid down in the Ordinance relating to the M.Phil. Degree.
- (4) Researvation: Other things being equal, the candidates belonging to Scheduled Castes/Tribes would be given preference for the award of the fellowships.
- (5) (a) Conditions of Award: In case the awardee is a Ph.D. student, the award shall be effective from the date of the issue of award letter or from the date he/she reports for research work in the Department of University, whichever is later. In case, the awardee is a M.Phil. Degree Course student the award shall be effective from the date of his/her admission to the said course.
 - (b) The fellow shall do whole-time research work and shall not accept or hold any appointment paid or otherwise or receive any emoluments; stipend etc. from any other source during the tenure of the award. The research fellows may be required to undertake up to four hours a week teaching assignment i.e. assisting in tutorials, evaluation of test papers, laboratory demonstration work, etc. which would help them in future as teachers.
 - (c) The fellow shall present to the University through his/her Supervisor(s) half-yearly reports of his/her work for the period ending

- (d) If a fellow wishes to leave the fellowship before the expiry of the normal tenure it shall be done with the prior approval of the University. No fellow shall join any other course leading to a degree or appear in any competitive examination after commencing his work under the fellowship.
- (e) If it should appear at any time to the University that the progress or conduct of the fellow has not been satisfactory his/her fellowship may be suspended or withdrawn by the Academic Council.

I.F.C.I. DOCTORAL FELLOWSHIP

Conditions of Award:

- (5) (a) The award shall be effective from the date on which the fellow reports for research work in the Faculty of Management Studies. University of Delhi, Delhi-7, or from the date of issue of award letter to the fellow, whicherver is later.
 - (b) The fellow shall not accept or hold any appointment paid or otherwise or receive any emoluments, salary, stipend etc., from any other source during the tenure of the award. The Doctoral Fellow will also be required to undertake up to four hours a week teaching assignment e.g. assisting in tutorials, evaluation of test papers, etc., assigned to him(/her by the Dean, Faculty of Management Studies from time to time.
 - (c) The fellow shall not join any other course leading to a degree or appear at any competitive examination after commencing his/her research work under the fellowship.
 - (d) The fellow shall present to the University through his/her Supervisor half yearly reports of his/her work done for the period ending June and December each year. He/she shall before the expiry of the

fellowship present to the University a comprehensive report of the work done under the award and an abstract of the thesis.

(e) If it should appear at any time to the University that the progress or conduct of the fellow has not been satisfactory his/her fellowship may be suspended or withdrawn by the Academic Council on the report of the Dean, Faculty of Management Studies.

Leave:

Note :- A student being admitted to a course is required to pay the fees, as above, at the time of his admission. The examination fee is to be paid by the middle of October. Original Clause :

"35(d) Grant of leave beyond the date of retirement and on resignation:

No leave shall be granted beyond the date on which an employee must retire; provided that the authority empowered to grant leave may allow any emplopee who had been denied earned leave in whole or in part on account of exigencies of service, the whole or any portion of the earned leave so denied subject to a maximum of 120 days even though it extends to a date beyond the date on which such an employee must retire.

Provided further that an employee, who is re-employed in the interests of the University service, beyond the date of his retirement may be granted earned leave as under :---

- (i) During the period of re-employment any leave due in respect of the period of such re-employment and to the extend necessary earned leave which would have been granted to him under the preceeding proviso, had he retired on the date of retirement;
- (ii) After the expiry of the period of re-employment :
 - (a) The earned leave which could have been granted on him under the preceeding proviso had he retired on the date of retirement, diminished by the amount of such leave as availed of during the period of re-employment ; and
 - (b) Any leave earned during the period of re-employment as has been formally applied for as leave preparatory to retirement prior to final cessation of his duties in sufficient time during the period of

re-employment and refused to him on account of exigencies of University service ; and

- (iii) In determining the amount of the earned leave due during the periods of re-employment, the earned leave, if any admissible under the preceeding proviso shall be taken into account.
- Note: 1 For the purpose of this paragraph an employee may be deemed to have been denied leave only if in sufficient time before the date on which he must retire or the date on which his duty finally ceases, he had either formally applied for leave and heen refused on the ground of exigencies of service or has ascertained in writing from the sanctioning authority that leave applied for would not be granted on the aforesaid ground.
 - 2. If any employee resigns he shall not be granted either prior or subsequent to his resignation any leave due to his credit provided that the University may, in any case, grant terminal leave to an employee prior to his resignation which may extend beyond the date in which the resignation becomes effective, if in the opinion of the University the circumstances justify such grant of leave."

Amendment approved :

The portions *underlined* above be *deleted* and the amended Clause to read as follows:—

"35. (d) Grant of leave beyond the date of retirement and on resignation:

No leave shall be granted beyond the date on which an employee must retire; provided that an employee may be paid cash equivalent of leave salary in respect of the period of earned leave at his credit at the time of retirement on superannuation subject to the following conditions:

- (i) The benefit under this rule shall be admissible to an employee who attains the age of superannuation on or after 30.9.1977.
- (ii) The payment of cash equivalent of leave salary shall be limited to a maximum of 180 days earned leave.

- (iii) The cash equivalent of leave salary thus admissible will become payable on retirement and will be paid in one *lump-sum* as a one-time settlement.
- (iv) The cash payment will be, subject to (v) below, equal to leave salary as admissible for earned leave and dearness allowance admissible on that leave salary at the rates in force on the date of retirement. No City Compensatory Allowance and/or house rent allowance shall be payable.
- (v) The cash amount worked out in accordance with (iv) above will be reduced by the amount of pension and pensionary equivalent of other retirement benifits for the period for which cash equivalent is payable.
- (vi) The authority competent to grant leave shall, suo-motu, issue order granting cash equivalent of earned leave at credit on the date of retirement.
- (vii) An employee can also avail of, as leave preparatory to retirement, a part of earned leave at his credit. In that case, he will be allowed benifits of this rule for the earned leave that remains at credit on the date of retirement in accordance with the terms and conditions stipulated in this rule.
- (viii) The benifit of this rule shall also be admissible to the employees who attains the age of retirement on or after 30.9.1977 and are granted extension of service after that date. In such cases, the benifit shall be granted on the date of final retirement on expiry of extension, to the extent of earned leaved at credit on the date of superannuation plus the earned leave earned during the period of extension reduced by earned leave availed of during such period, subject to a maximum of 180 days.
 - (ix) An employee already on leave preparatory to retirement who has been allowed to return to duty shall also be entitled to benefit under this rule on the date of retirement.
 - (x) The above benefits will not, however, be available to those who attained the age of retirement before 30.9.1977 and were on extension of service thereafter.
 - (xi) The above benefits will also not be available in the cases of premature/voluntary retirement.

Persons who are compulsorily retired as a meansure of punishment under the disciplinary rules will also not be covered by this rule.

In the case of an employee retiring prematurely/ voluntarily, he may be granted leave due and admissible to him which may extend beyond the date on which he retires or is retired from service, but not extending beyond the date on which he attains the age of retirement;

Provided that an University employee, who is retired by the University by giving him Pay and allowances in lieu of notice may apply for leave within the period for which such pay and allowances were given, and where he is granted leave, the leave salary shall be allowed only for the period of leave excluding that period for which pay and allowances in lieu of notice have been allowed.

Provided further that an employee, who is reemployed in the interest of University service, beyond the date of his retirement may be granted earned leave as under:

- (i) During the period of re-employment any leave due in respect of the period of such re-employment and to the extent necessary earned leaved which would have been granted to him under the preceeding proviso, had he retired on the date of retirement.
- (ii) After the expiry of the period of re-employment, the earned leave which could have been granted to him under the preceeding proviso had he retired on the date of retirement, diminished by the amount of such leave as availed of during the period of re-employment.
- (iii) In determining the amount of earned leave due during the periods of re-employment, the earned leave, if any admissible under the preceeding proviso shall be taken into account.

If any employee resigns he shall not be granted either prior or subsequent to his resignation any leave due to his credit provided that the University may, in any case, grant terminal leave to an employee prior to his resignation which may extend beyond the date on which the resignation becomes effective, if in the opinion of the University the circumstances justify such grant of leave." Amendment approved :

SENIOR SCHOLARSHIP IN ECONOMICS

6. (1) The University Scholarship in Economic slall be awarded on the recommendation of ϵ Sdecction

- (2) The Scholarship shall ordinarily be open to a first class M.A.'s in Economics of this University who are not more than 30 years of age at the time of award.
- (3) The Senior Scholar shall be required to do whole-time research work under approved guidance and the topic selected by him for research shall be subject to the previous approval of the Head of the Department concerned.
- (4) The Senior shall be expected to devote the whole of his time to the work undertaken, and if he accepts any post or undertakes any work, he shall immediately inform the Head of the Department and, if, in the opinion of the Vice-Chancellor, the post accepted or the work undertaken is inconsistent with the obligation attached for the holding of the Scholarship, the scholar shall thereupon forfeit the scholarship and shall not receive any further emoluments beyond that he has been actually paid.
- (5) The Scholarship shall ordinarily be tenable for one year, but may be renewed for a second year on the recommendation of the Head of the Department and the Dean of Faculty concerned.
- (6) Payment of the Scholarship shall be subject to the scholar producing a certificate of progress and satisfactory work from the Head of the Department concerned at the end of the each Term, but subject as aforesaid, shall be made monthly.
- (7) Applications for the scholarship shall be sent to the Registrar so as to reach him within two months after the date on which the M.A. results in Economics are declared and shall state the subject chosen by the applicant for his original investigation or study.

Amendments approved :

- (i) The above provisions be *deleted* from the Ordinance.
- (ii) The following provisions be added as serial No. 6 under Scholarships, Fellowships :

JUNIOR RESEARCH FELLOWSHIPS IN ECONOMICS

6. (1) There shall be two junior Research Fellowships, at a given time, for encouragement to the deserving

candidates for undertaking studies leading to an M.Phil. and/or a Ph.D. degree in the department of Economics in the University.

- (2) Value and duration
 - (a) The fellowships, each, shall be of the value of Rs. 400/ p.m., with a contingency grant of Rs. 1,000/- p.a. In the first instance the fellowships will be awarded for a period of two years and thereafter, if the progress of the fellows are found satisfactory, the fellowships may be extended for another period of two years. The fellowships after a period of four years may be extended by six months, as a special case. The fellowships and the contingency grants are exempt from the income tax.
 - (b) The award of fellowships to M.Phil. students will be made for a period of one year (for the duration of the course) and thereafter their fellowships may be continued for another period of one year provided the candidates after passing M.Phil. Degree Course get themselves registered for the Ph.D. Degree Course. Extension of fellowships after two years of tenure will be made as per provision contained in Clause 2 (a).
- (3) The fellowships are open to persons preferably below the age of 30 years who have obtained Masters degree in Economics from a recognised Indian University in the first or second division (with at least 55% marks or at least B+ in grade system).
- (4) Conditions of Award :
 - (a) In case the awardee is a Ph.D. student, the award will be effective from the date of issue of award letter or from the date he/she reports for research work in the Department of Economics in the University, whichever is later. In case the awardee is a M.Phil. Degree Course student, the award will be effective from the date of his/her admission to the said course.
 - (b) The scholars shall do full time research work and shall not accept or hold any appointment paid or otherwise or receive any emoluments, stipend etc. from any other source during the tenure of their award. The scholars may be required to under-

- (c) The scholars shall present to the University through their supervisor(s) half yearly reports of their work done for the periods ending June and December each year. They shall before the expiry of their fellowships, present to the University a comprehensive report of the work done under the award and the extract of thesis.
- (d) If the fellow wishes to leave the fellowship before the expiry of normal tenure, it should be done with the prior approval of the University. The fellow shall not join any other course leading to degree or appear in any competitive examination after commencing his/her work under the fellowship.
- (e) If it should appear at any time to the University that the progress or conduct of the fellow has not been satisfactory, his/her fellowship may be suspended or withdrawn by the Academic Council.
- (5) Leave
 - (a) Leave for a maximum period of 30 days in a year in addition to general holidays may be taken by a fellow with the approval of the supervisor(s). The general holidays, however, do not include the vacation periods viz. Summer, Winter and Autumn Vacations. No other leave with fellowships will be admissible to the fellows. The women awardees would be eligible for maternity leave at full rates for a period not exceeding three months once during the tenure of their award.
 - (b) The fellow may, in special case, be allowed by the University leave without fellowship up to one academic year during the entire tenure of the fellowship for accepting teaching assignment on temporary basis, provided the post accepted by the fellow is in the Department of the University or in any of its Colleges; in other cases not exceeding three months during the tenure of the award on the recommendations of the supervisor(s) and the Head of the Department. The period of leave without fellowship will be counted towards the fellowship.

- (6) **Procedure of Selection**
 - (a) The fellowships shall be awarded on All-India basis.
 - (b) The awards will be made by the Academic Council, whose decision shall be final, on the recommendations of a Selection Committee consisting of the following members :
 - 1. The Head of the Department of Economics
 - 2. One or more Senior member(s) of the Department. To be appoint-
 - 3. On outside expert in the subject (a person not connected with the University)
- (7) Payment of fellowship will be made to the fellows by the University in the first week of each month.
- (ii) Amendment to Sl. No 7 under 'Scholarships and Fellowships' relating to 'Kikabhai Premchand Senior Scholarship in Economics' (Page 351 of the University Calendar-Volume I-1976):

Original provisions regarding 'Kikabhai Premchand Senior Scholarship in Economics':

"KIKABHI PREMCHAND SENIOR SCHOLARSHIP IN ECONOMICS"

- 7. There shall be a Kikabhai Premchand Senior Scholarship in Economics of the value of Rs. 100/- per mensem for two years for the encouragement of research or original work under the following canditions :
 - (1) The scholarship shall be open to First Class M.A.'s in Economics of any statutory University in India, who are not more than 24 years of age at the time of award.
 - (2) The recipient of the scholarship shall get himself enrolled at the Delhi School of Economics as a regular, whole time research student of the University and shall study for the degree of Doctor of Philosophy at the Delhi School of Economics.
 - (3) The recipient of the scholarship shall not be permitted to undertake any work which in the opinion of the Director, Delhi School of Economics, is in consistent

- (4) Payment of the scholarship shall be subject to the recipient producing a certificate of progress and satisfactory work from the Director of the Delhi School of Economics, at the end of each term, but subject as aforesaid, shall be made monthly after deducting such dues as may be outstanding in his name in the books of the University and the Delhi School of Economics.
- (5) Application with documentary evidence of qualifications shall be sent to the Director, Delhi School of Economics, so as to reach him on or before the 1st July every second year, beginning with 1949.
- (6) The Scholarship shall be awarded on the recommendations of a Selection Committee comprising the Vice-Chancellor or his nominee, the Director of the Delhi School of Economics and a person nominated by the Vice-Chancellor from outside the University."

Amendment approved :

The following be *substituted* for the above :

"KIKABHAI PREMCHAND SENIOR SCHOLARSHIP IN ECONOMICS"

- (7) (1) There shall be a research scholarship called "Kikabhai Premchand Senior Scholarship in Economics" for encouragement of research or original work leading to M.Phil. and/or Ph.D. degree at the Delhi School of Economics, Department of Economics in the University.
- (2) Value and Duration:
- (a) The Scholarship shall be of the value af Rs.409/- p.m. with a cantingency grant of Rs. 500/- p.a. In the First instance the scholarship will be awarded for a period of two years and thereafter, if the progress of the scholar is found satisfactory, it may be extended for another two years. Beyond four years period the scholarship may also be extended by six months, as a special case. The scholarship and contingency grants are exempt from Income Tax.
- (b) The award of scholarship to a M.Phil. student will be made for a period of one year (for the duration of the course) and thereafter the scholarship may be continued for another period of one year provided the caddidate after passing

M.Phil. degree Examination ges himself/herfelf registered for the Ph.D., degree course. Extension of scholarship after two years of tenure will be made as per provision contained in clause 2(a).

(3) *Fligibility*:

The scholarship is open to persons presons preferably below the age of 30 years who have obtained Master's Degree in Economics from a recognised Indian University in the First or Second division (with atleast 55% marks or at least B+ in grade system).

- (4) Conditions of Award:
- (a) In case the awardee is a Ph.D. student, the award will be effective from the date of the issue of award letter or from the date he/she reports for research work in the Department of the University, whichever is latter. In case, the awardee is a M.Phil. Degree course student, the award will be effective from the date of his/her admission to the said course.
- (b) The scholar shall do whole time research work and shall not accept or hold any appointment paid or otherwise or receive any emoluments, stipend, etc. from any other source during the tenure of the award. The scholar may be required to undertake up to four hours a week teaching assignment i.e. assisting in tutotrials, evaluation of test papers, laboratory demonstrotion work, etc. which would help him/her in future as a teacher.
- (c) The scholar shall present to the University through his/ her Supervisor(s) half-yearly reports of his/her work for the period ending June and December each year. He/she shall befor the expiry of the scholarship, present to the University a comprehensive report of the work done under the award and an abstract of thesis.
- (d) If the scholar wishes to leave the scholarship before the expiry of the normal tenure he may do so with the prior approval of the University. The scholar shall not Join any other course leading to a degree or appear in any competitive examination after commencing his/her work under the scholarship.
- (e) If it should appear at any time to the University that the progress or conduct of the scholar has not been satisfactory his/her scholarship may be suspended or witndrawn by the Academic Council.

(5) *Leave*:

- (a) Leave for a maximum period of thiry days in ε year in addition to general holidays, may be taken by the scholar with the approval of the Supervisor(s). The general holidays, however, do not include the vacation period i.e. summer, winter and autnmn vacations. No other leave with scholarship will be admissible to the scholar. The women awardee would be eligible for maternity leave at full rates for a period not exceeding three months, once during the tenure of her award.
- (b) The scholar may, in special case, be allowed by the University leave without scholarship up to one scademic year during the entire tenure of the scholarship for purpose of accepting teaching assignment on a temporary basis, provided the post accepted by the scholar is in the department of the University or in any of its colleges; in other cases, not exceeding three months during the tenure of the award on the recommendations of the Supervisor(s) and Head of the Department of Economics The period of leave without scholarship will be counted towards the tenure of the scholarship,
- (6) Procedure of Selection:
- (a) The scholarship shall be awarded on All-India basis:
- (b) The award shall be made by the Academic Council, whose decision shall be final, on the recommendations of a Selection Committee, consisting of the following members:
 - 1. The Head of the Department of Economics

2.	One or more Senior Member(s) of the Department)
3.	One outside expert in the subject who shall not be connected with the University.	To be appointed by the Head of the Department of Economics.

- (7) Payment of the scholarship will be made to the Scholar by the University in the first week of every month.
- (iii) The following provisions be added as Sl.No. 34 under 'Scholarships and Fallowships' (page 375 of the University Calender-Volume I-1976)

"POST-GRADUATE SCHOLARSHIPS (COMMERCE & ECONOMICS)

34. (1) There shall be twelve Post-Graduate Scholarships each of the value of Rs. 100/- p.m. (for non-resident students) and Rs. 125/- p.m. (for resident students) tenable for a period of one year to be awarded from May each year to the meritorious students of M.A. Economics and M.Com. registered in the Delhi School of Economics. Out of the twelve Scholarships, eight shall be awarded equally to the students of M.A. Economics Part I and Part II and four equally to the students of M.Com. Part I and Part II.

 - (i) The Head of the Department concerned.
 - (ii) Two or more Senior Members of the Department concerned (to be nominated by the Head of the Department)
- (4) Each selected scholar shall be informed by the Head of the Department concerned of his/her having been awarded a scholarship A scholar not notifying his/ her acceptance of the award within a fortnight from receipt of a communication from the department shall be liable to forfeit his/her scholarship, which, then, will be offered to the next candidate on the waiting list.
- (5) No student who is in receipt of this scholarship shall be permitted to hold any other scholarship/financial assistance from any source, except freeship. In case he/she accepts any other scholarship/financial assistance from any other source, he/she shall be required to surrender this scholarship and to refund the total amount received by him/her on this account from the date he/she accepts the other scholarships/financial assistance.
- (6) If it should appear to the University at any time during the tenure of the award that the scholar is unable to show satisfactory progress or is found guilty of gross misconduct or is irregular in attendance, he/ she shall, after due warning in writing, will be reported by the Head of the Department concerned to the

Academic Council who may suspend or withdraw his/her scholarship.

- (7) The Scholarship will be notified by the Head of the Department concernd to all the concerned students for receiving the applications on the prescribed form.
- (8) The payment of scholarship amount will be made to the scholars through the Head of the Department concerned on presentation of monthly bills together with a certificate to the effect that during the period covered in the bill(s), the scholar was not in receipt of any other scholarship/financial assistance from any other source."

- (b) A student of the First Year will be promoted to the Second Year only if he has passed in at least five papers out of total number of the papers offered by him for the first and second Term Examinations taken together.
- (c) A student of the Second Year will be permitted to proceed to the Third Year only if he has passed in at least 15 papers out of the total number offered by him for the First, Second, Third and Fourth Term Examinations taken together.

Amendment approved :

The following be substituted for the above :

"7. Promotion Rule :

A student of the First, Third and Fifth Term will be promoted to the Second, Fourth and Sixth Term respectively, irrespective of the number of courses in which he has failed to pass or failed to appear in the First, Third or Fifth Term Examinations as the case may be; provided, however, that no such student shall be admitted to the Third or the Fifth Term unless he has passed in atleast eight courses offered by him for the First and Second Term examinations taken together in case of promotion from I Year to II Year and in at least eighteen courses offered by him for the First, Second, Third and Fourth Term Examinations taken together in case of promotion from II Year to III Year of the LL.B. Course.

Transitory Provision

Notwithstanding anything contained in the above rule, the students admitted to First Year LL.B. Course for the academic years 1976-77, 1977-78 will be provided option either to have the benefit of supplementary examinations alongwith the above mentioned promotion rule or to continued to be governed by the promotion rules in force at the time of their admission.
