2. The Committee may Co-opt other Members for assisting the Committee on any special scheme under the Plan Programme including 20-Point Programme coming under the purview of the Voluntary Organisations

3. The Committee shall review the activities of Voluntary Agencies involved in implementation of the Plan Programmes in the State and recommend measures necessary to enlist full co-operation of such agencies and the people in the implementation of Plan Programme including 20-point Programmes. It shall also provide necessary feed-back on implementation of plan schemes and help in sorting out problems affecting the works of the Voluntary Agencies.

4. The Committee may meet at least once every six months

5. The non-official members of the Committee shall draw T.A. and D.A. at the rate as admissible to Grade-1 Officers of State Government for attending the meetings of the Committee in accordance with the rules in force from time to time. The Development Commissioner will be countersigning authority for the purpose of countersigning T.A. Bills.

6. The Under Secretary to Government, Planning & Coordination Department will be the Drawing and Disbursing Officer in respect of expenditure relating to the Committee.
7. The expenditure on these accounts will be debitible to Demand No.16-3451-Secretariat-Economic Services-090-Secretariat -0009370-P & C Department-0300000-T.E-Non-plan-Voted.
8. This will be given effect to from the date of issue of the order.
