Convention held in collaboration with the CAPART on 28.7.94, Government have been			
pleased to constitute a State Level Cell for effecting collaborative relationship between			
Voluntary Organisations and Government in the following manner:			
1. The State Level Cell shall be constituted with the following official members			
and 17(seventeen) non-official members from Voluntary Organisations and			
N.G.Os known for their commitment to social development, as follows:

Provided that the State Level Cell may be reconstituted or dissolved as and when felt necessary by Government.

The functions of the said Cell shall be as follows:

- a) The Cell shall act as a joint machinery which may advise Government in laying down all policy frame-works for effective collaboration between Government and Voluntary Organisations/Non-Government Organisations and may suggest for evolving participatory development models resting on social mobilization and organization of the people at grass-roots level.
- b) The Cell shall play an advisory role to the Government for ensuring involvement of the people as well as Voluntary Organisations/Non-Government Organisations in wider developmental areas such as; generation of self-employment potential for the unemployed and economically backward youths, protection of ecology and environment, protection of the rights of the tribals and harijans, community health, alternative rural technology, social/community forestry, social campaign for peace and harmony amongst the classes and

castes, spread of education and literacy and participation of Women in development works and strengthening the Panchayati Raj system.

c) The Cell may advise on appropriate policies for project appraisal and work out the criteria of eligibility of the Voluntary Organisations/Non-Government Organisations to avail funds from Government either jointly or wholly. It shall also recommend/approve all such projects which can be taken up by the Voluntary Organisations/Non-Government Organisations with the assistance of Government.

Provided that Departments of Government may recommend/approve projects to be implemented through Voluntary Organisations/N.G.Os up to Rs 5.00 lakh and the cases of such projects costing more that Rs. 5.00 lakh should be referred to Planning & Coordination Department for recommendation and approval of the Cell.

- d) The Cell may review the procedure adopted relating to the grant-in-aid provisions to the Voluntary Organisation/NGOs by the Departments of Government and recommend measures to remove procedural anomalies in order to ensure uniformity to streamline the grant-in-aid to the genuine and deserving Voluntary Organisations/NGOs
- e) The Cell may recommend/frame policy measures in dealing with conflicts so as to mitigate harassment and victimization meted out of the Voluntary Organisations/NGOs engaged in sensitive task of social mobilization in the State.
- f) The cell may review existing policies and frame suitable policies to deal with cases of fraud, mis-appropriation, forgery, mis-utilisation of public funds by Voluntary Organisations /NGOs and may advise Government for suitable action thereof.
- g) The Cell may devise suitable mechanism for collaboration and coordination with the Voluntary Organisations/NGOs at the district as well as block level.
- h) The Cell may have various Task Forces/ Sub-Committees for reviewing, appraisal and identification of innovative programmes and activities entrusted or to be entrusted to the Voluntary Organisations /NGOs of the State.
- i) The Cell may devise/recommend appropriate policy measures for sensitization of officials as well as non-officials dealing with Voluntary Organisations/NGOs through the training institutes of the State.
- j) The Cell may deal with any other matter/subject arising from time to time with regard to the functioning of Voluntary Organisations/NGOs and its collaborative relationship with Government.
- 3. All expenses in relation to the meeting of the Cell and operation incidental thereto would be met by the Planning and Coordination Department.

4. The cell should meet as often as necessary and the Chairman of the cell may invite any officer of the State Government or any eminent persons who can contribute the deliberations of the Cell.

5. The representatives of the Voluntary Organisations shall be entitled to T.A and D.A. as admissible at par with Grade-1 officers of the State Government.
