P R E F A C E

The estimates of Gross Fixed Capital Formation (G.F.C.F.) indicate the growth potential of the economy of Nation or a State. Higher the growth rate of Capital Formation, higher would be productive capacity of the economy. At the State level the estimates of Gross Fixed Capital Formation are not yet available for the economy as a whole due to huge requirements of data from State Departmental Commercial Undertakings (SDCUs) & State Non -Departmental Commercial Undertakings (SNDCUs), Urban & Rural Local bodies, State & Central Govt. Administrative Departments, Supra regional sectors, Central Govt. Departmental Commercial Undertakings (CDCUs) & Central Government Non-Departmental Commercial Undertakings (CNDCUs), Private Corporate Sector and House hold Sector. It was felt necessary for a long time to release estimates of Gross Fixed Capital Formation at State level, hence Directorate of Economics & Statistics (DES) has taken up the work of preparing the estimates of GFCF in phased manner.

The publication which concluded the GFCF estimates of State Govt. Administrative Departments for the period 2000-01 to 2008-09 & Central Govt. Administrative Department including Supra Regional Sector from 2000-2001 to 2006-07 has been published by this Directorate. Now the publication regarding the GFCF estimates of State Govt. Departmental Commercial Undertakings (DCUs) and Non-Departmental Commercial Undertakings (NDCUs) from 2001-02 to 2008-09 is prepared for publication

It is hoped that the estimates of GFCF by state DCUs & NDCUs would be useful to planners, administrators and research workers.

Suggestions towards improvement of this publication will be appreciated .

CAPITAL FORMATION

INTRODUCTION:-

The capital formation serves as a very important indicator to measure the magnitude of the growth of productive potential of the economy. As capital being one of the four factors (viz. Land, Labour, Capital & Entrepreneurship) of production, plays an important role in the production process. These estimates are among the important statistics required for determining policy decision in resource mobilization, allocation of resources and assessing the growth potential of the economy.

SCOPE AND COVERAGE:-

These two publication have been published earlier.

1. Estimates of GFCF of State Govt. Administrative Departments for the period 2000-01 to 2008-09
2. Central Govt. Administrative Department including Supra-Regional Sector from 2000-2001 to 2006-07 has been published by DES.

Now "this publication" is included with estimates of GFCF of State Govt. Departmental Commercial Undertakings (DCUs) and Non-Departmental Commercial Undertakings (NDCUs) for the year 2001-02 to 2008-09.

For the purpose of estimation of Gross Fixed Capital Formation, the economy of the State has been classified in to 9 industrial groups of use.

1. **Agriculture (including Animal Husbandry, Forestry & Logging and Fishing)**
2. **Mining and Quarrying**
3. **Manufacturing**
4. **Electricity, Gas and Water Supply**
5. **Construction**
6. **Trade, Hotels & Restaurants**
7. **Transport, Storage and Communications**
8. **Financing, Insurance, Real Estate & Business Services**
9. **Community, Social & Personal Services**

Each Sector has been further classified in to

A . Public Sector

B . Private Sector

The Public Sector consists of :-

1. Administrative Departments
2. Departmental Commercial Undertakings (DCUs)
3. Non-Departmental Commercial Undertakings (NDCUs)
4. Local Bodies
5. Central Non-Departmental Commercial Undertakings (CNDCUs)
6. Supra-Regional Sectors

And this publication is based on state government DCUs & NDCs.

Departmental Commercial Undertakings (DCUs):-

Undertakings, which are owned and controlled by the Government, producing Goods and Services and selling at prices like any other commercial establishments come under this segment. For example Govt. Printing Press etc. In the present publication the estimates of GFCF of DCUs functioning within the State have been obtained by analyzing the budget document. Each year the State Govt. made provision for expenditure to every DCU in it's Annual Budget for different purpose of uses. The data provided in the accounted budget is taken in to consideration during estimating GFCF.

Non- Departmental Commercial Undertakings (NDCUs):-

Non-Departmental Commercial Undertaking comprises of 1. Govt. companies registered under Companies Act and wherein not less than 51% share is owned by State Govt. and 2. Public corporations setup under the State Govt. Act wholly or mainly owned and/or controlled by public authorities. These NDCUs are also engaged in producing goods and services for general sale. In this publication the estimates of GFCF for the State NDCUs are being prepared by analyzing the annual account of these companies.

Presentation of estimates

The estimate of GFCF in the present publication covers only State Govt. Departmental Commercial Undertakings (DCUs) and Non Departmental Commercial Undertakings (NDCU'S) functioning within the geographical boundaries of Chhattisgarh State.

The following features are being covered under the present estimates of GFCF.

1. It covers the State economy as a whole for the **Primary Sector** i.e. Agriculture (including Animal Husbandry), Forestry & Logging, Fishing and Mining located within the State, **Secondary Sector** including Manufacturing, Construction, Electricity, Gas and Water Supply and **Tertiary Sector**.
2. GFCF estimates are prepared for industry of use and by type of assets.
3. Estimates are compiled for the year 2001-02 to 2008-09.
4. The estimates are prepared at current price only.
5. Estimates are made by expenditure approach i.e. the commodities which are taken in to account in estimation of GFCF are valued at purchasers price or actual expenditure incurred.

GROSS FIXED CAPITAL FORMATION BY DEPARTMENTAL COMMERCIAL UNDERTAKINGS (DCUS) AND NON DEPARTMENTAL COMMERCIAL UNDERTAKINGS (NDCUS) IN PUBLIC SECTOR OF CHHATTISGARH YEAR 2001-02 TO 2008-09

Capital Formation is a basic macro economic aggregate often used as an indicator for the growth potential of the economy of Nation or a State. The estimates of G.F.C.F. were prepared in phased manner.

The estimates of G.F.C.F. of DCUs, NDCUs and together by type of assets i.e. Buildings, Road & Bridges, Other Construction, Machinery & Equipment, Transport Equipment of different years are presented in Table No 2 to 4. Similarly the G.F.C.F. of DCUs, NDCUs and together by type of industry of use and by type of assets for each of the years 2001-02 to 2008-09 are presented in Table No. 5 to Table No 31 respectively.

Analysis Of Estimates Of G.F.C.F.

A brief analysis of estimates of G.F.C.F. by State Govt. DCUs and NDCUs are given in following paragraphs.

G.F.C.F. at Aggregate Level

The estimates of Gross Fixed Capital Formation and annual change over previous year are given in Table 1

It is seen in the table that the Gross Fixed Capital Formation by DCUs during the year 2008-09 was accounted to Rs 922.46 crores as against Rs 186.47 crores in 2001-02. The average rate of increase during the year 2001-02 to 2008-09 works out to be 31.88 percent. Similarly the GFCF estimates of NDCUs during the year 2008-09 was accounted to Rs. 806.52 crores as against Rs 333.25 crores in the year 2001-02. The average rate of increase of GFCF during the year 2001-02 to 2008-09 is worked out to be 46.46 percent. Taken in to consideration both DCUs and NDCUs together the annual growth is working out to be 33.48 percent.

By the analysis of the table some more facts have seen.

.No any fixed tendency has found in annual changing of GFCF of DCUs & NDCUs.

. Annual change in GFCF of DCUs & NDCUs got variation in during period.

. Annual change in GFCF of NDCUs in year 2008-09 made a huge decline.

. Some NDCUs yet to be added in calculation of GFCF So here is a possibility of increasing the value of GFCF of NDCUs.

G.F.C.F. by Industry of Use

The estimates of G.F.C.F. of DCUs, NDCUs and together by industry of use i.e. by different sectors of the economy to which DCUs and NDCUs belong along with their share for the year 2001-02 to 2008-09 are given in Table No. 29 to Table No. 31.

It is observed that in case of DCUs, amongst all the industry groups "Agriculture" represents the highest share in the G.F.C.F. followed by Manufacturing. In the year 2002-03 and 2007-08 Transport is another sector where major part of the Govt. Budgetary Fund is used for capital formation in DCUs. Similarly in case of NDCUs Electricity is a major sector where capital is created every year. During the period of 2001-02 to 2007-08 Real Estate and Storage sector generated some capital but in 2008-09 no any capital generated in these sectors. In trade sector some capital generated in almost every year except 2006-07. Taking in to consideration both DCUs and NDCUs together, Electricity occupies a major component to total GFCF followed by Agriculture sector during the period of 2001-02 to 2008-09. In the year 2008-09 Trade and Manufacturing (regd.) are the another sectors where capital generated.

G.F.C.F. by type of Assets

The estimates of G.F.C.F. of DCUs, NDCUs and together, by broad categories of assets i.e. Buildings, Road and Bridges, Other Construction, Machinery Equipments, Transport Equipments of different years are given in Table No 2 to 4

In case of DCUs it is seen in the table 2 the " Other Construction Works " occupies major share in total GFCF by type of assets. Other Construction Works here includes expenditure on Electricity Transmission, Water Supply works etc. The average percentage of these assets to the total GFCF for 2001-02 to 2008-09 is worked out to be 85.98%. During the period of 2001-02 to 2007-08 Machinery and Equipment is another assets created capital. Now 2008-09 Buildings, Roads & Bridges holds the second major share in total GFCF by type of assets.

It is seen in the table 3 For NDCUs the major share of GFCF during the period of 2001-02 to 2008-09 is "Machinery and Equipment". The average percentage contribution of this category of assets to total GFCF during the same period is worked out to be 72.3%. In the year of 2008-09 Other Construction Works " occupies second major share in total GFCF by type of assets. Whereas Buildings & Transport Equipment contribute few shares.

Taking in to consideration both DCUs and NDCUs together, "Machinery and Equipment" occupies a major component to total GFCF during the period of 2001-02 to 2008-09. The average percentage contribution of this asset to total GFCF during the same period is worked out to be 59.59% followed by "Other Construction" which is having 28.6% of total GFCF. Now in the year 2008-09 Other Construction holds more share in GFCF than Machinery & Equipment.

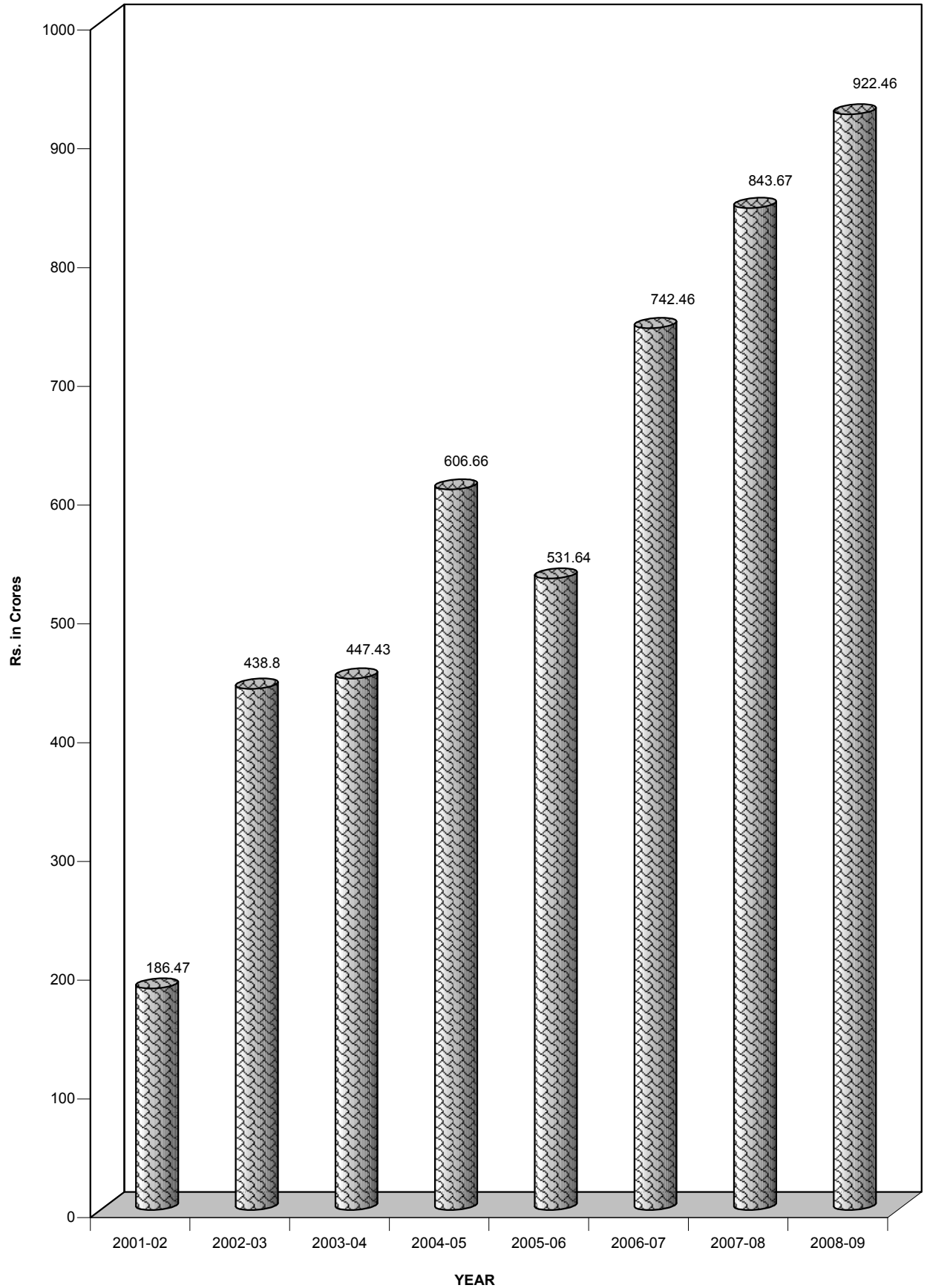

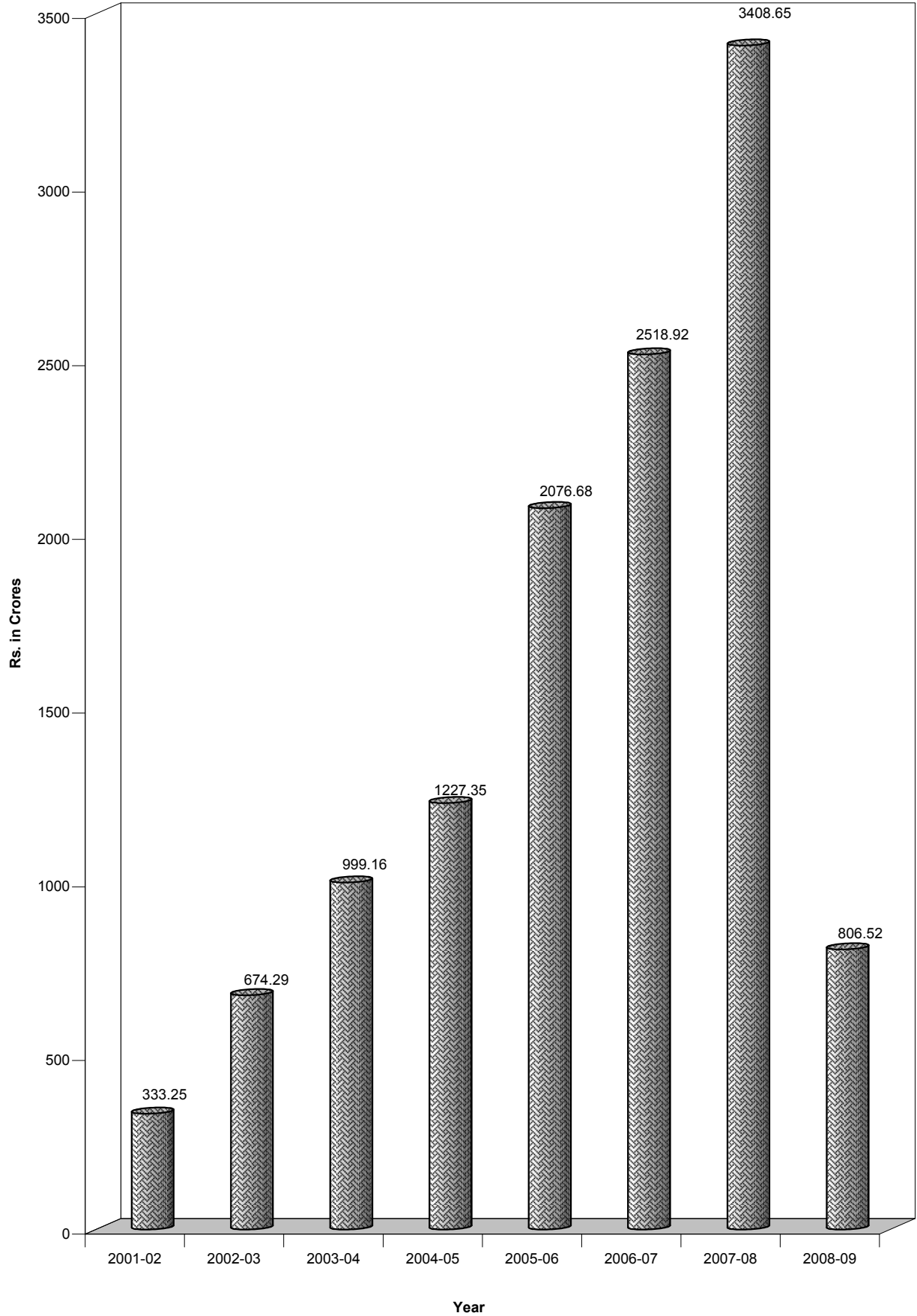

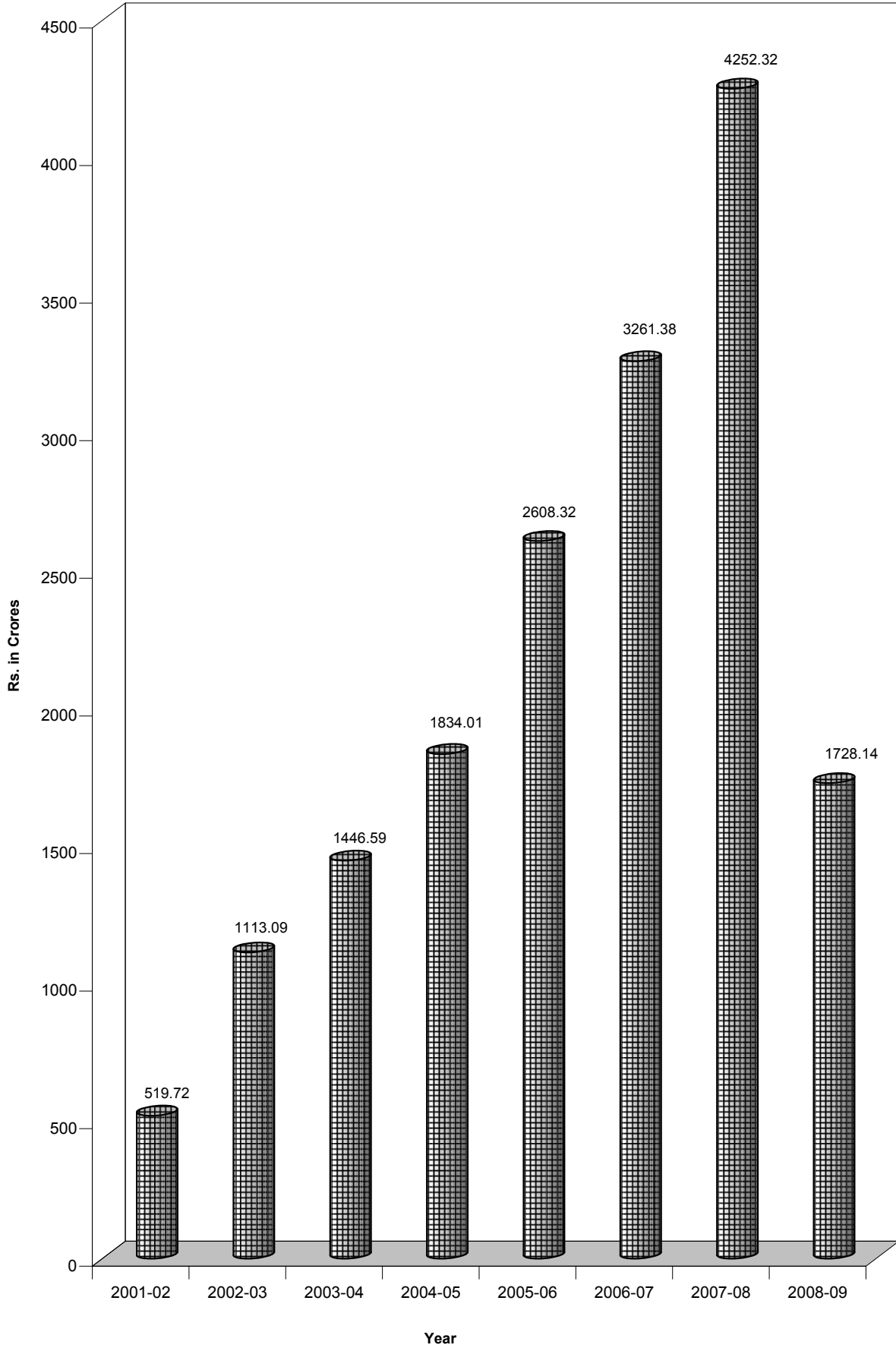
YearWise GFCF(Departmental Commercial Undertakings)

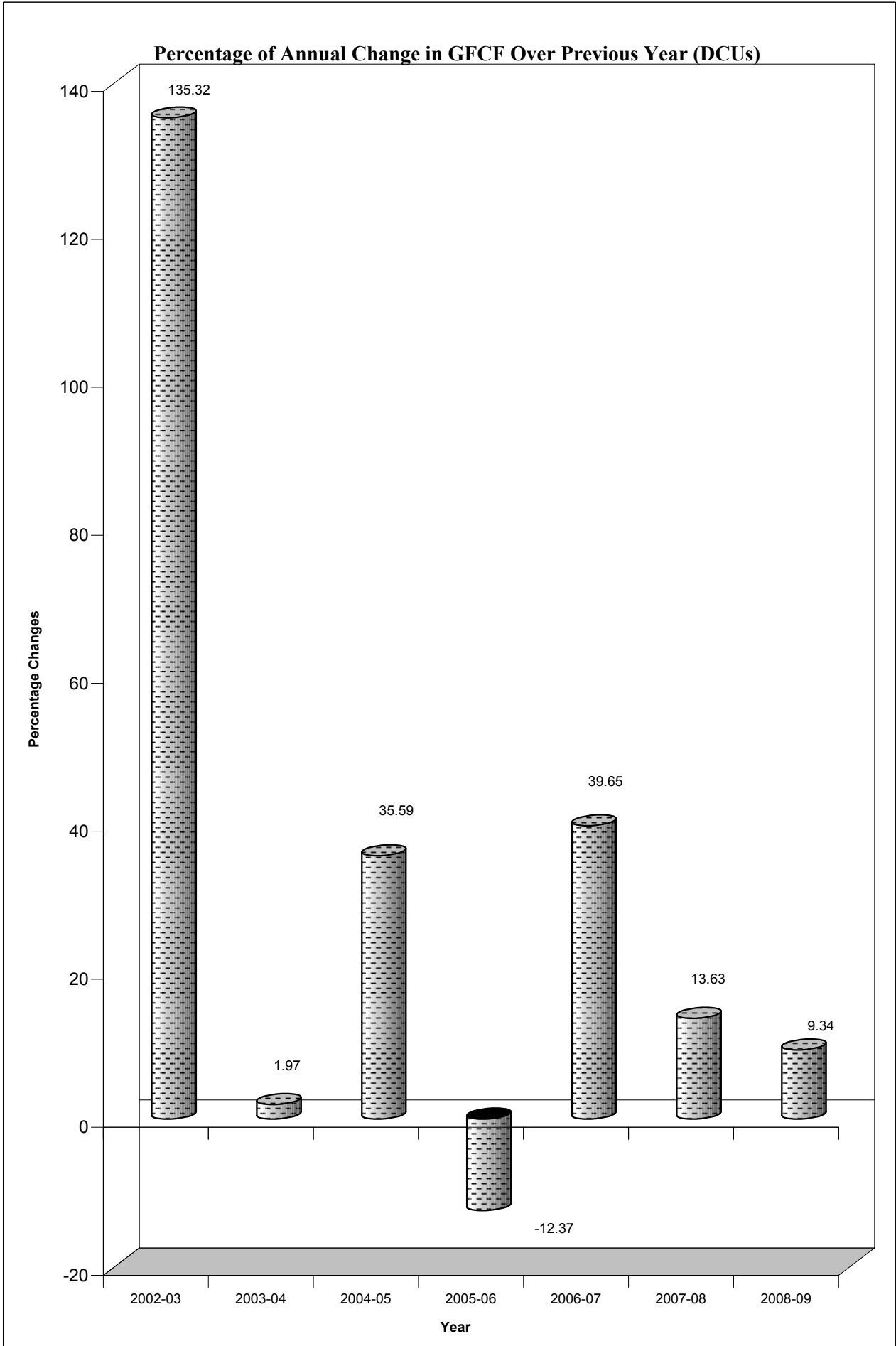


Year Wise Gross Fixed Capital Formation(Non-Departmental Commercial Undertakings)

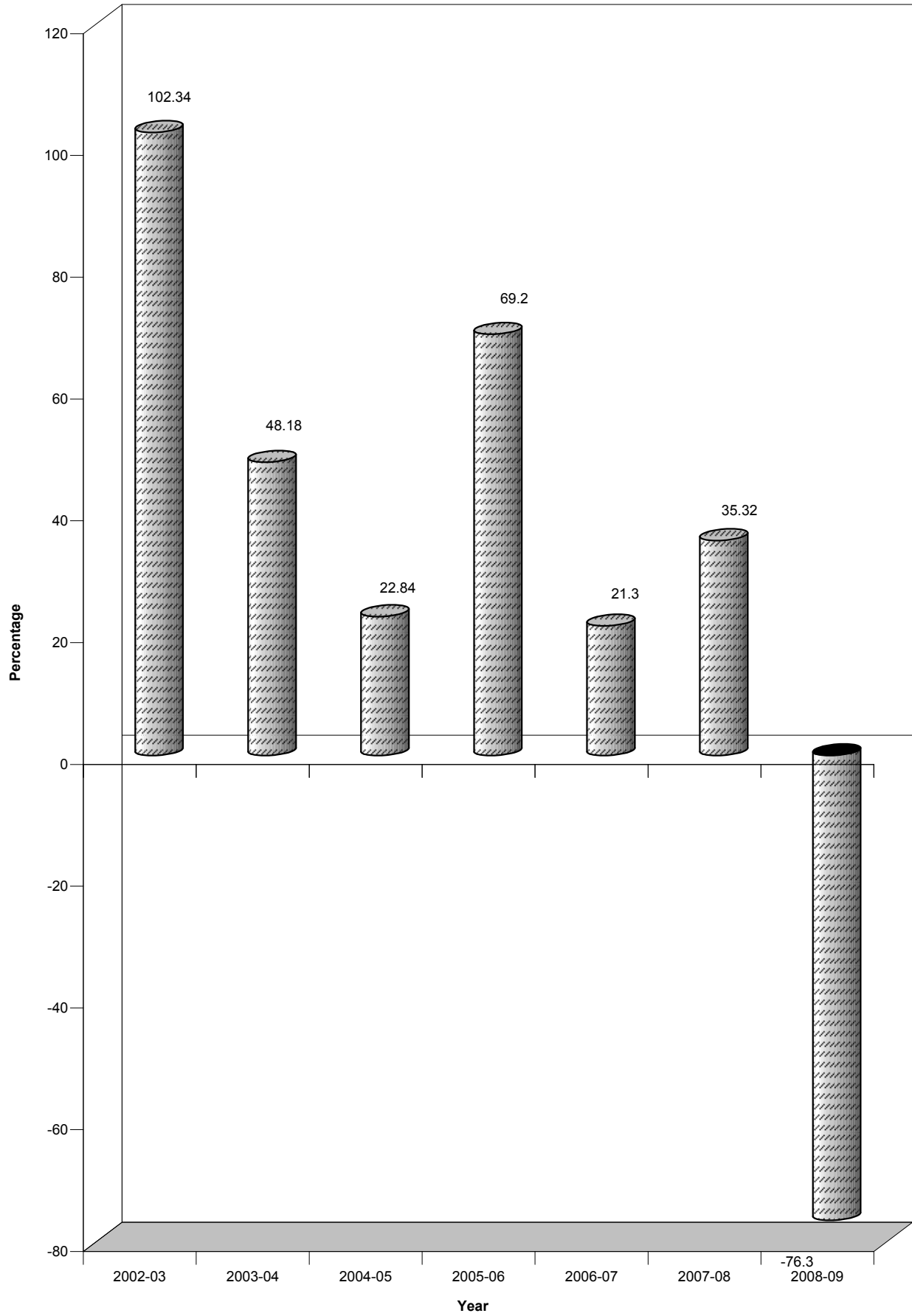


Growth of GFCF of DCUs & NDCUs Together

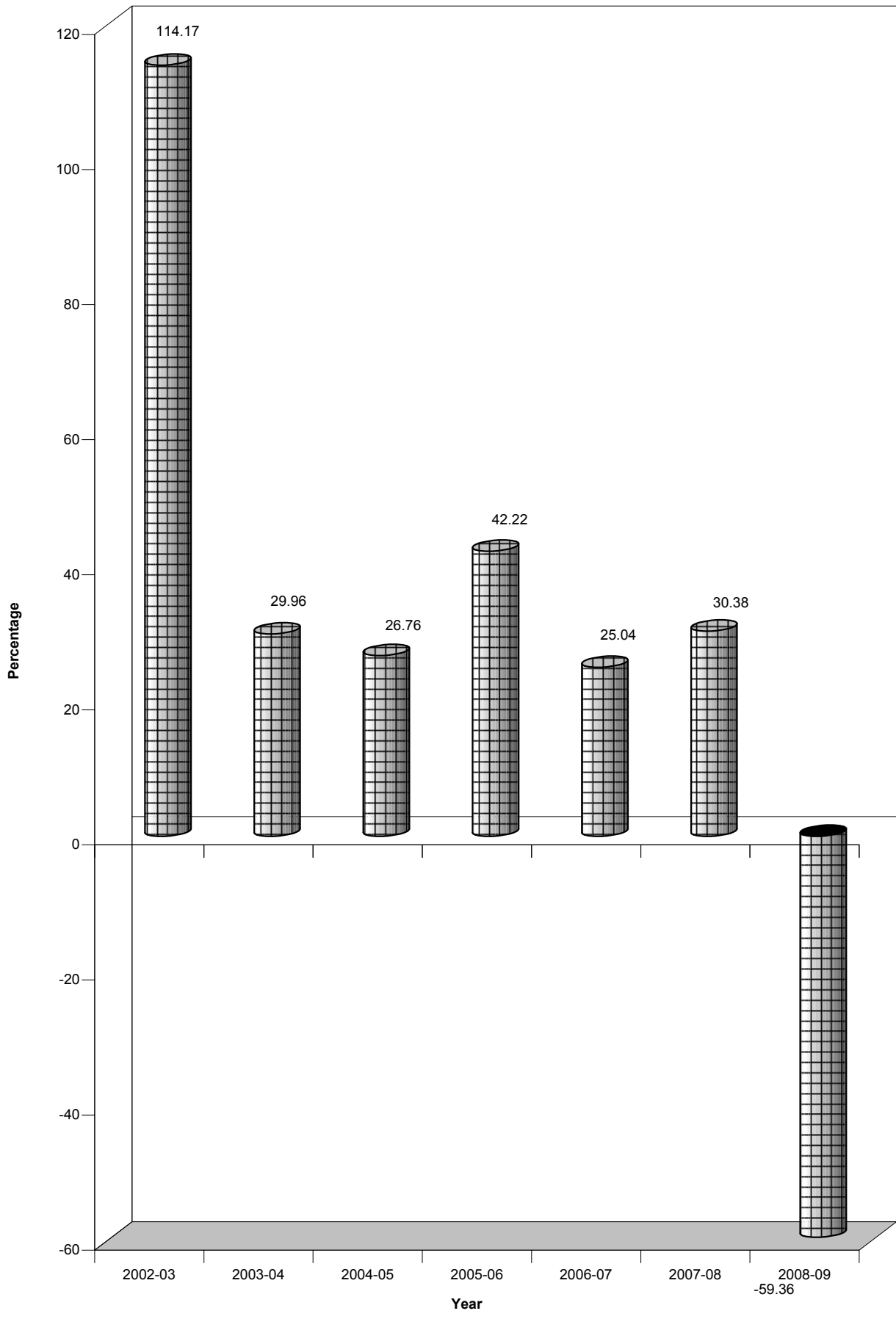




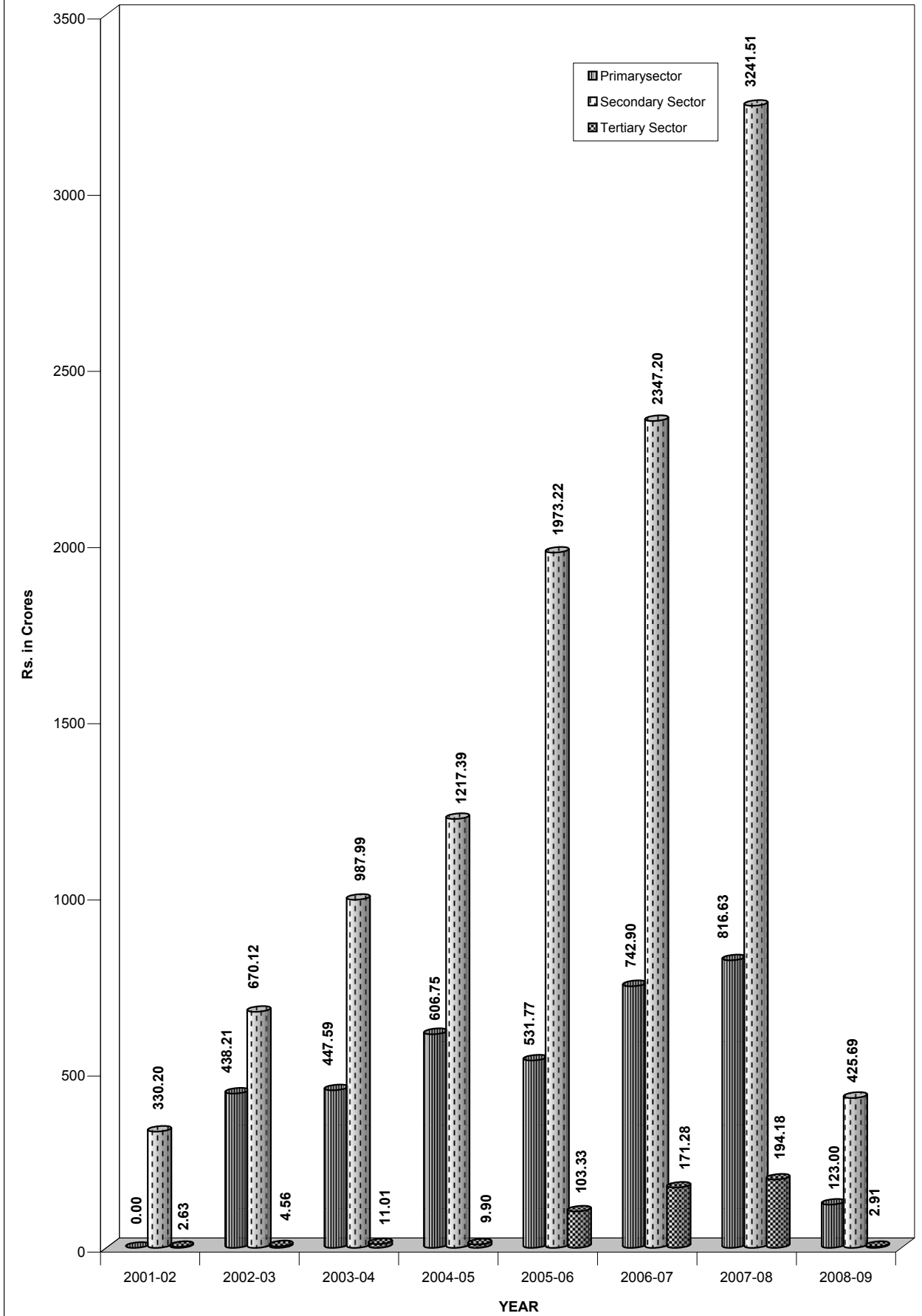
Annual Changes in % in GFCF Over Previous Year (NDCUs)



Annual Changes in % in GFCF Over Previous Year (DCUs&NDCUs)

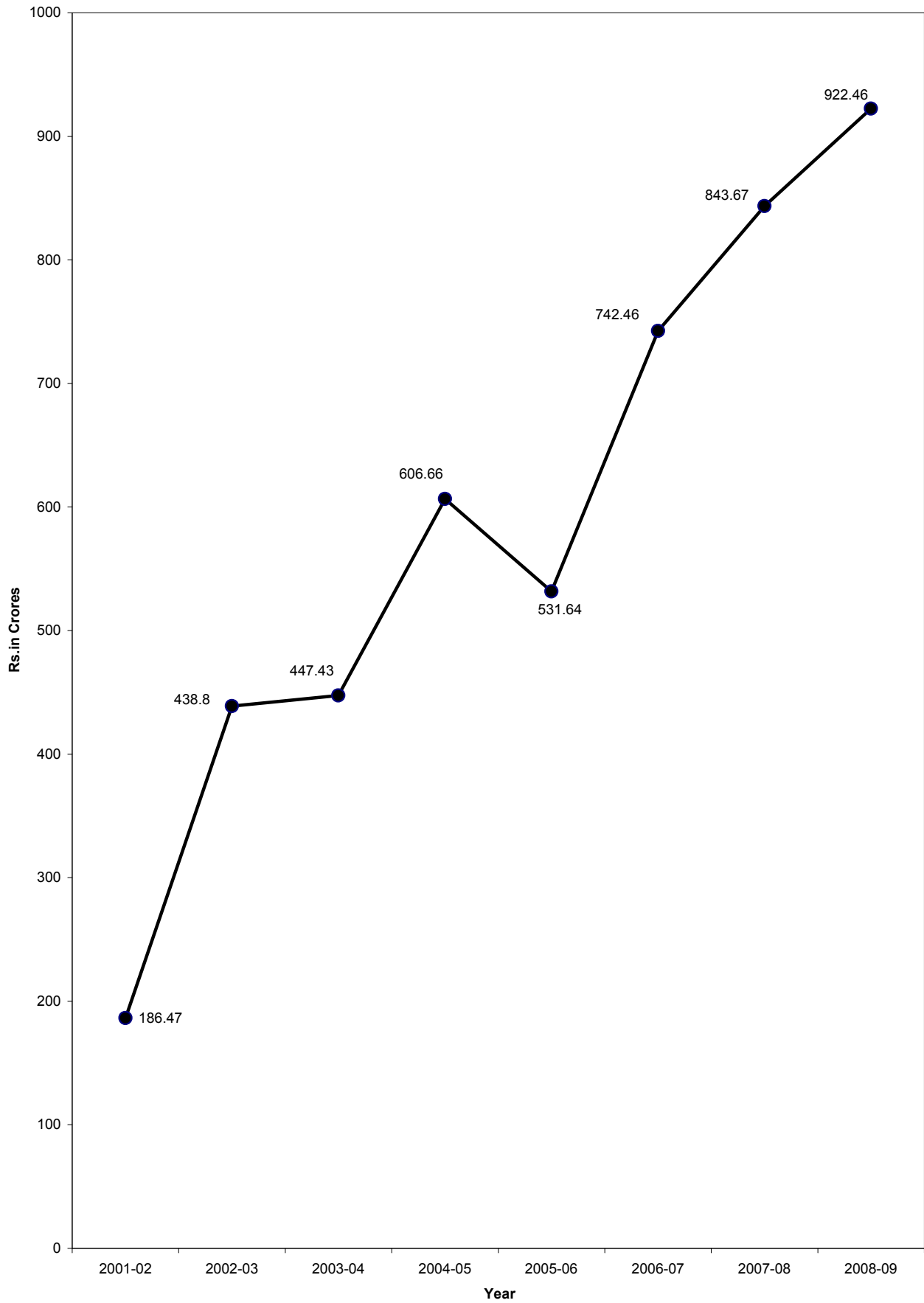


Year and Sector Wise GFCF DCUs&NDCUs

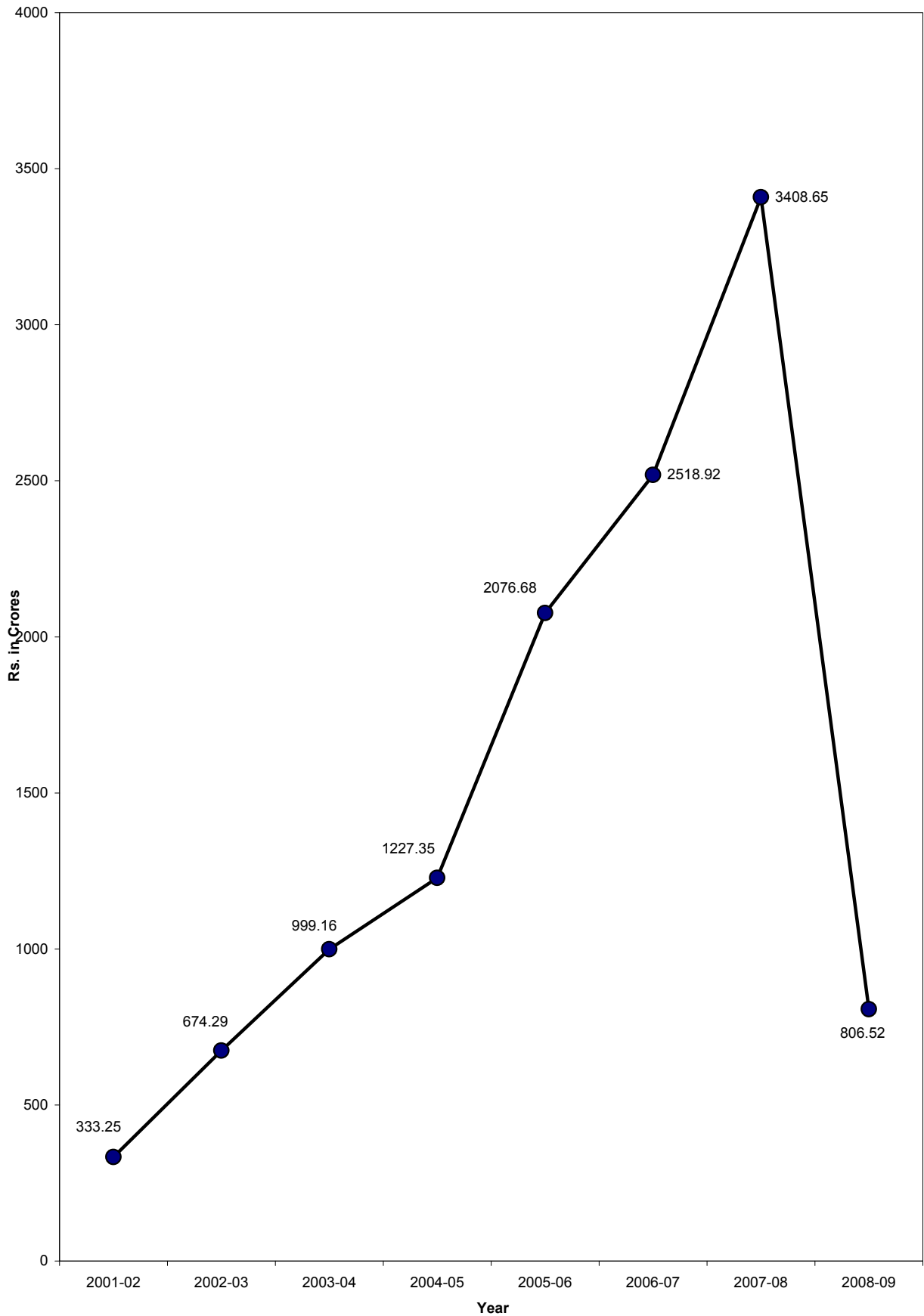

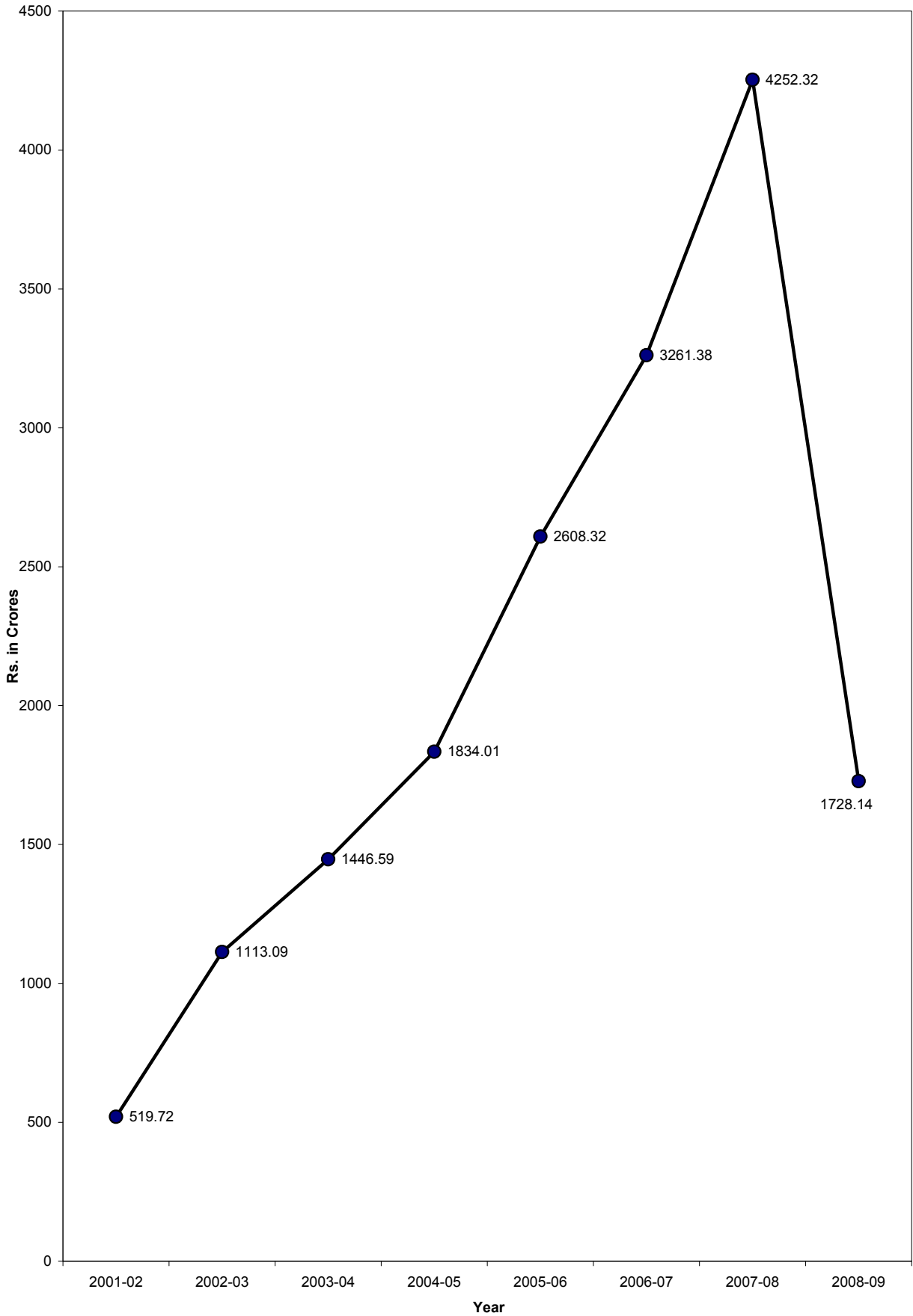
Growth of GFCF of DCUs



Growth of GFCF of NDUS

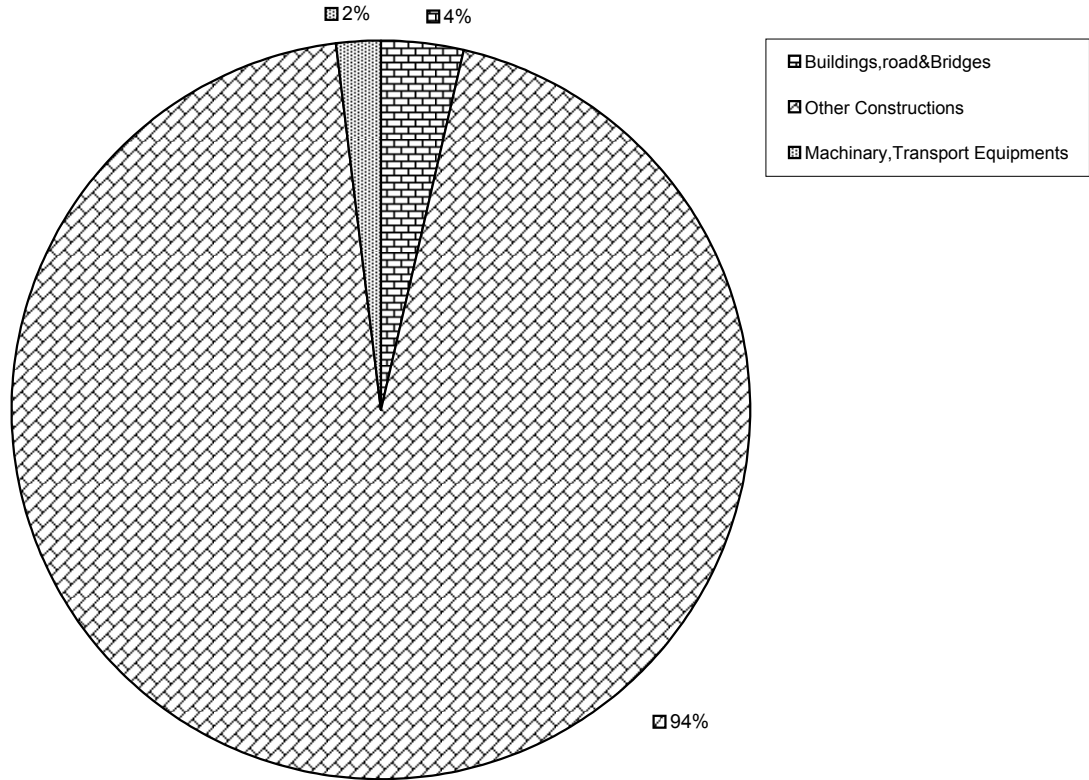


Groth of GFCF of DCUs& NDCUsTogether

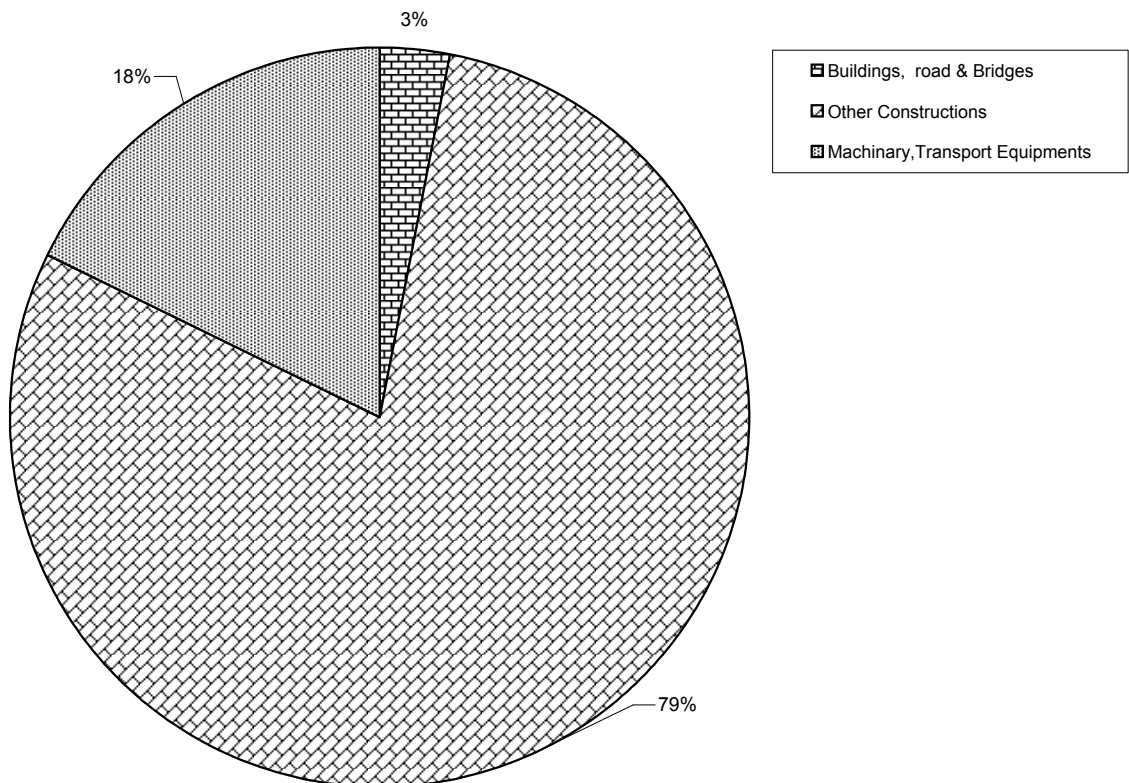

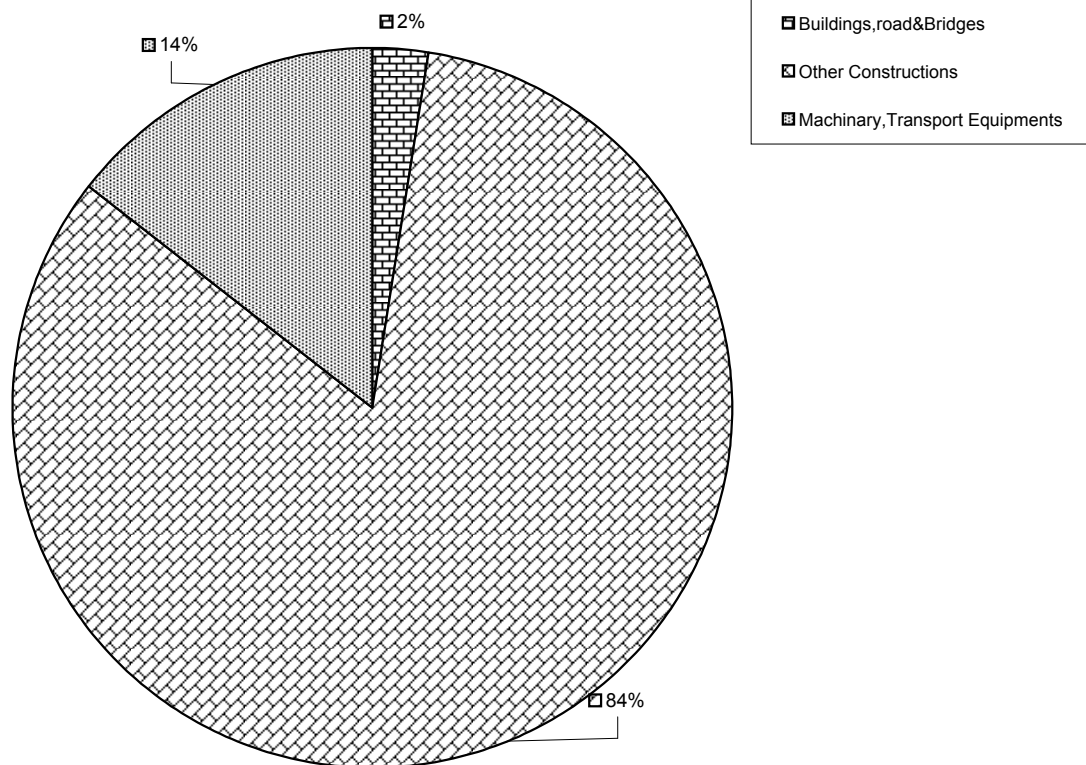
**Percentage Distribution of GFCF By Type of Assets (DCUs),
Year 2001-02**



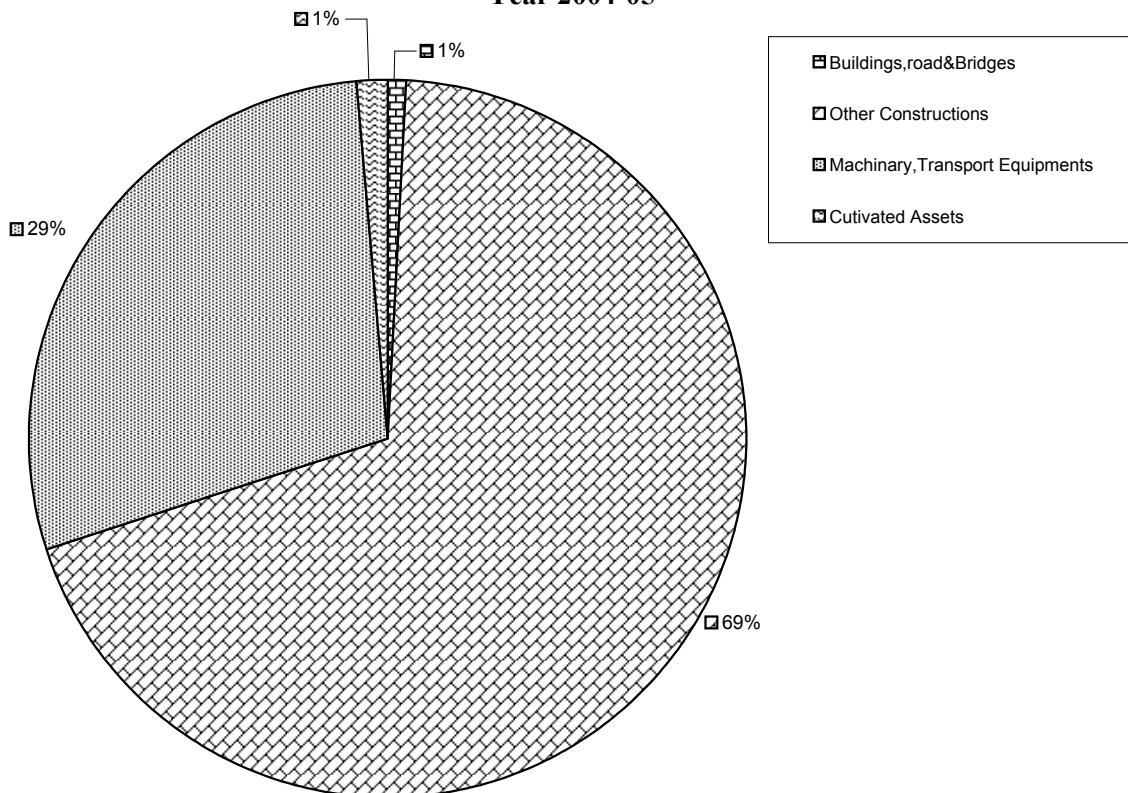
**Percentage Distribution of GFCF By Type of Assets(DCUs),
Year 2002-03**



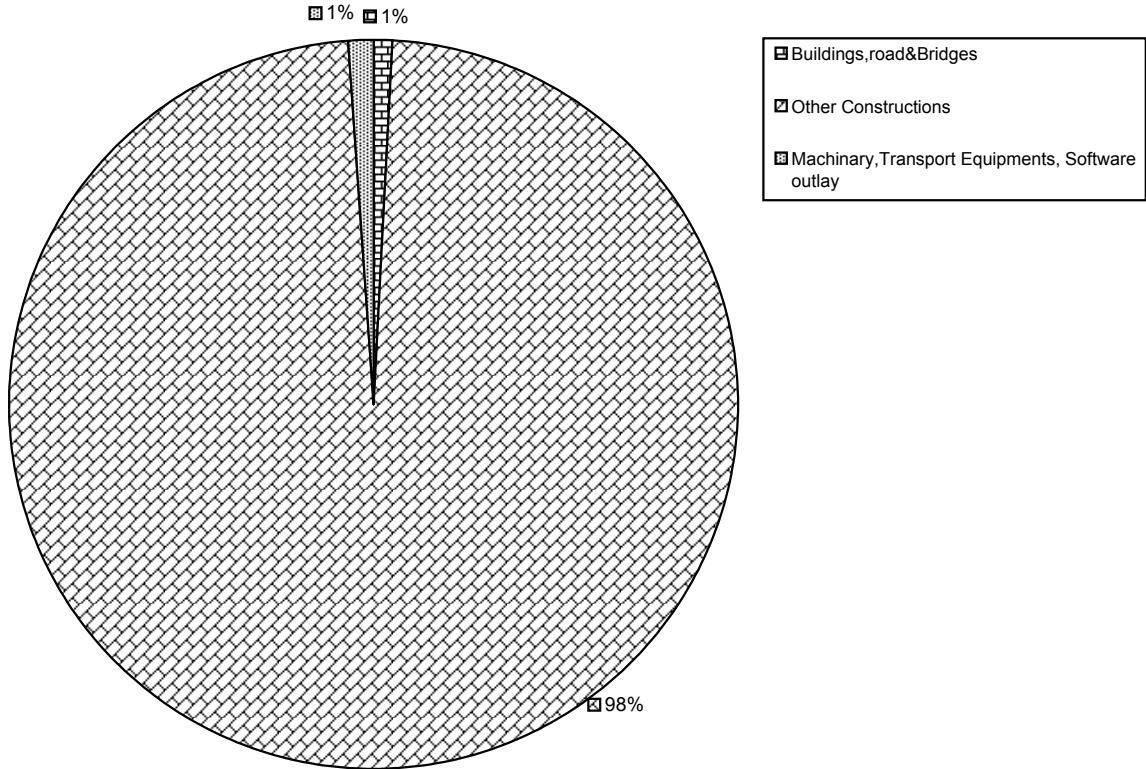
**Percentage Distribution of GFCF By Type of Assets(DCUs),
Year 2003-04**



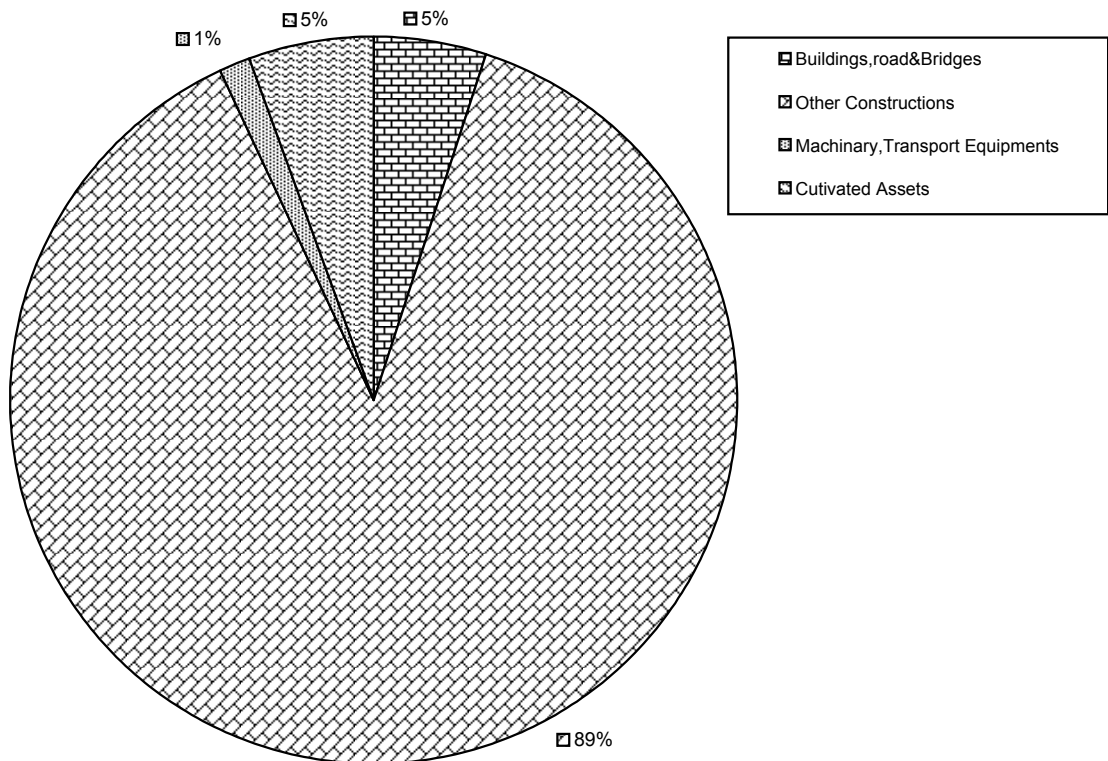
**Percentage Distribution of GFCF By Type of Assets(DCUs),
Year 2004-05**



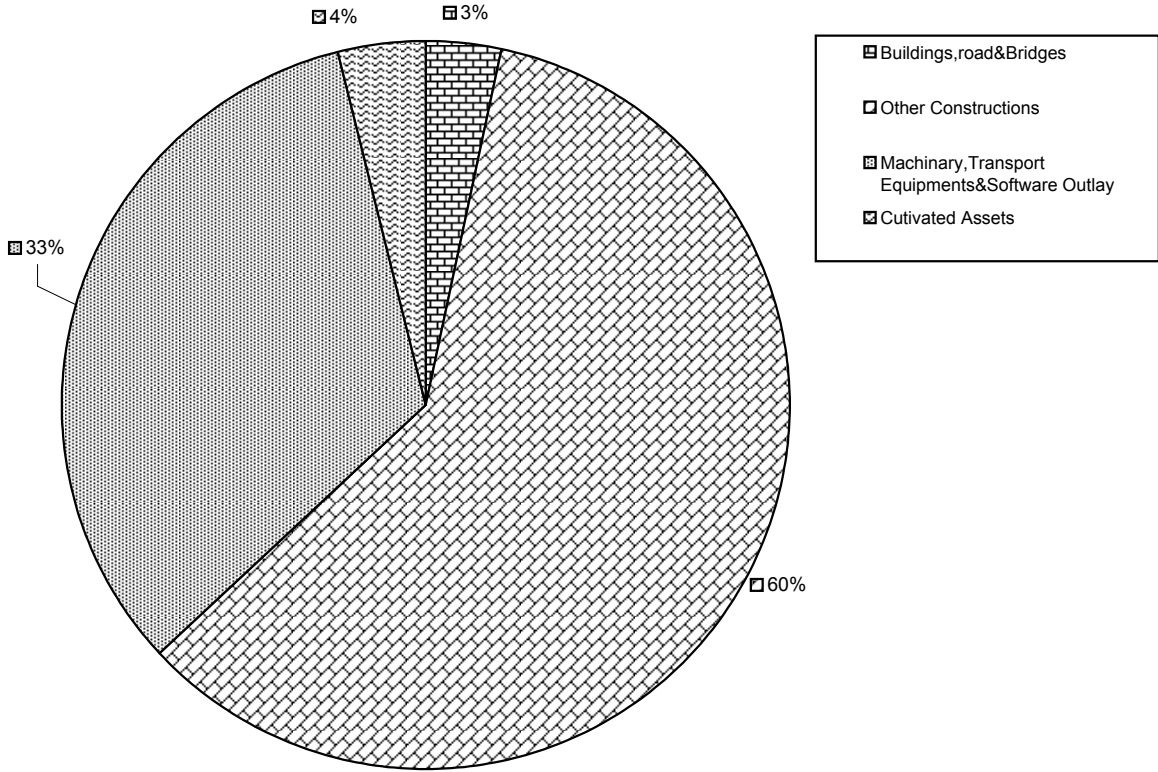
**Percentage Distribution of GFCF By Type of Assets(DCUs),
Year-2005-06**



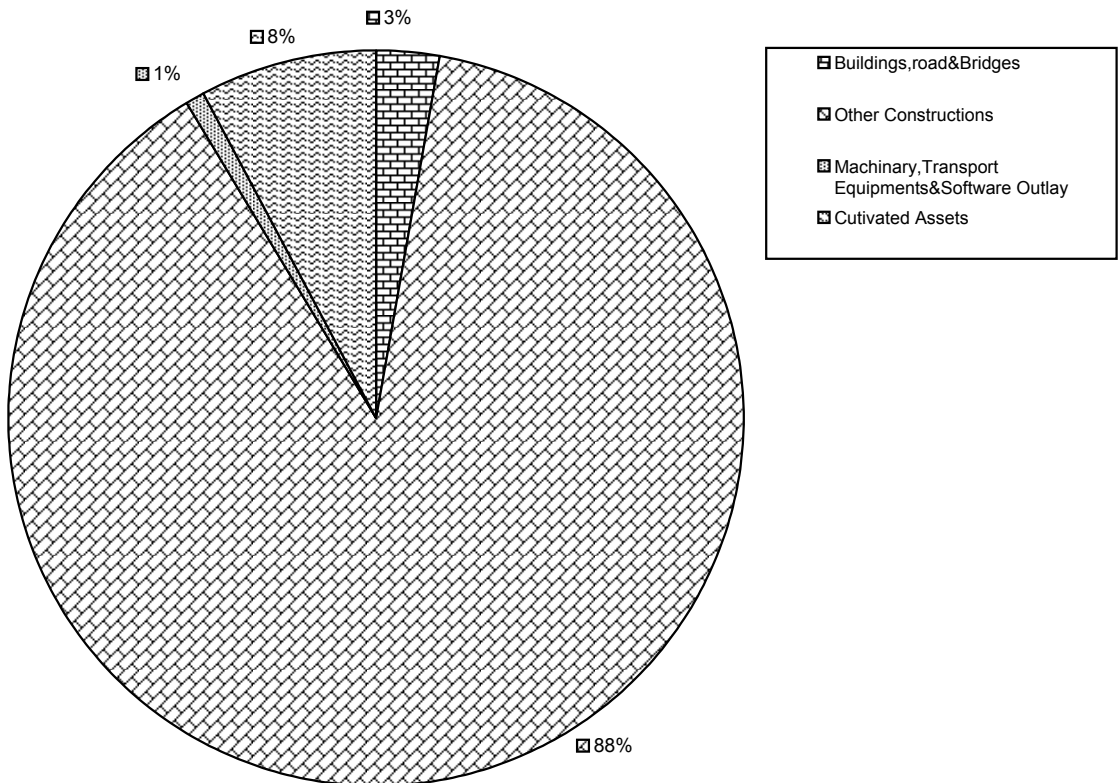
**Percentage Distribution of GFCF By Type of Assets(DCUs),
Year-2006-07**



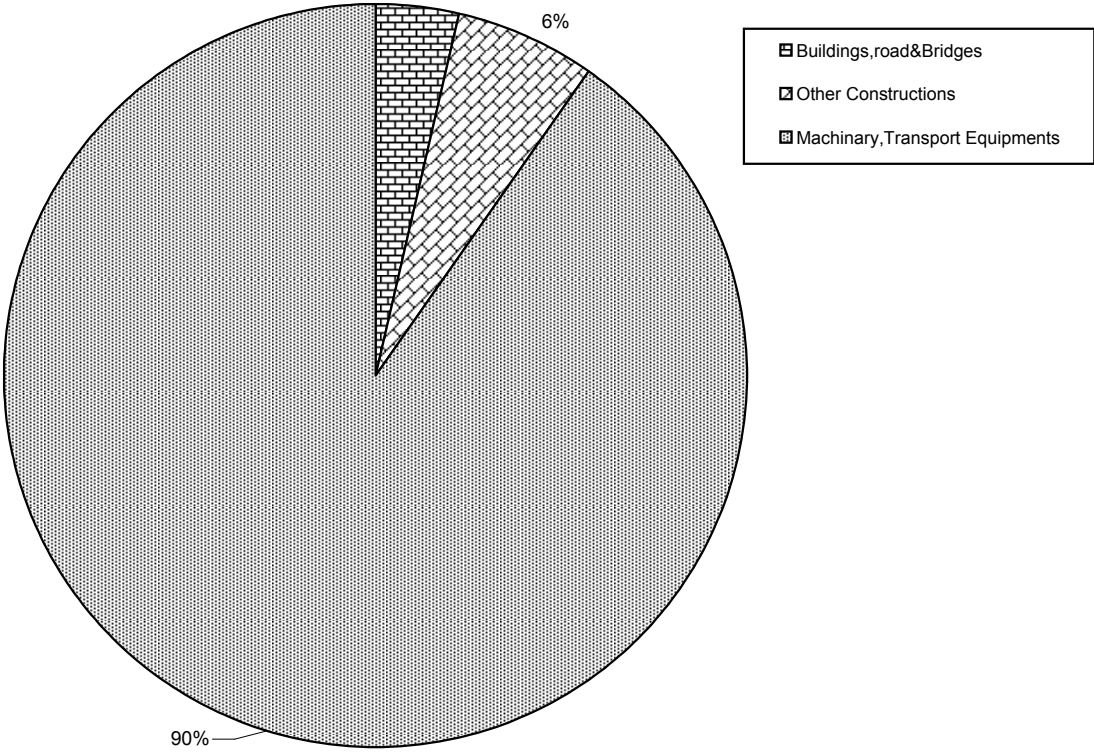
**Percentage Distribution of GFCF By Type of Assets(DCUs),
Year 2007-08**



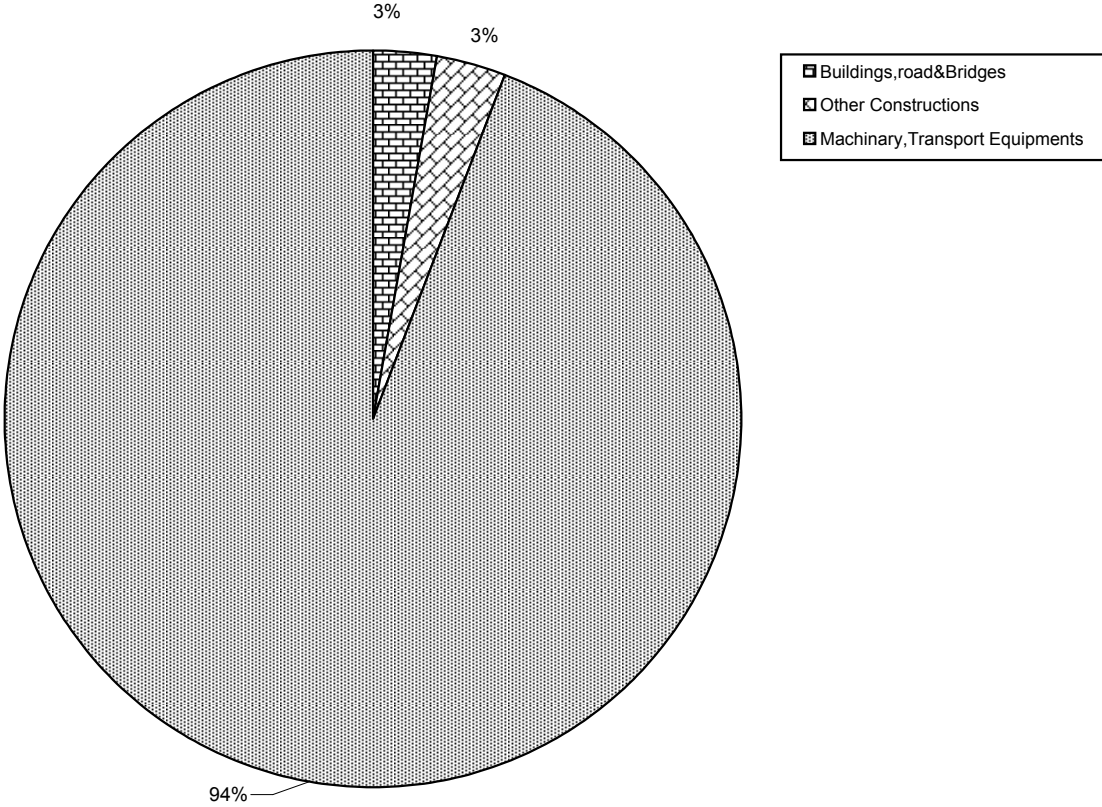
**Percentage Distribution of GFCF By Type of Assets(DCUs),
Year 2008-09**



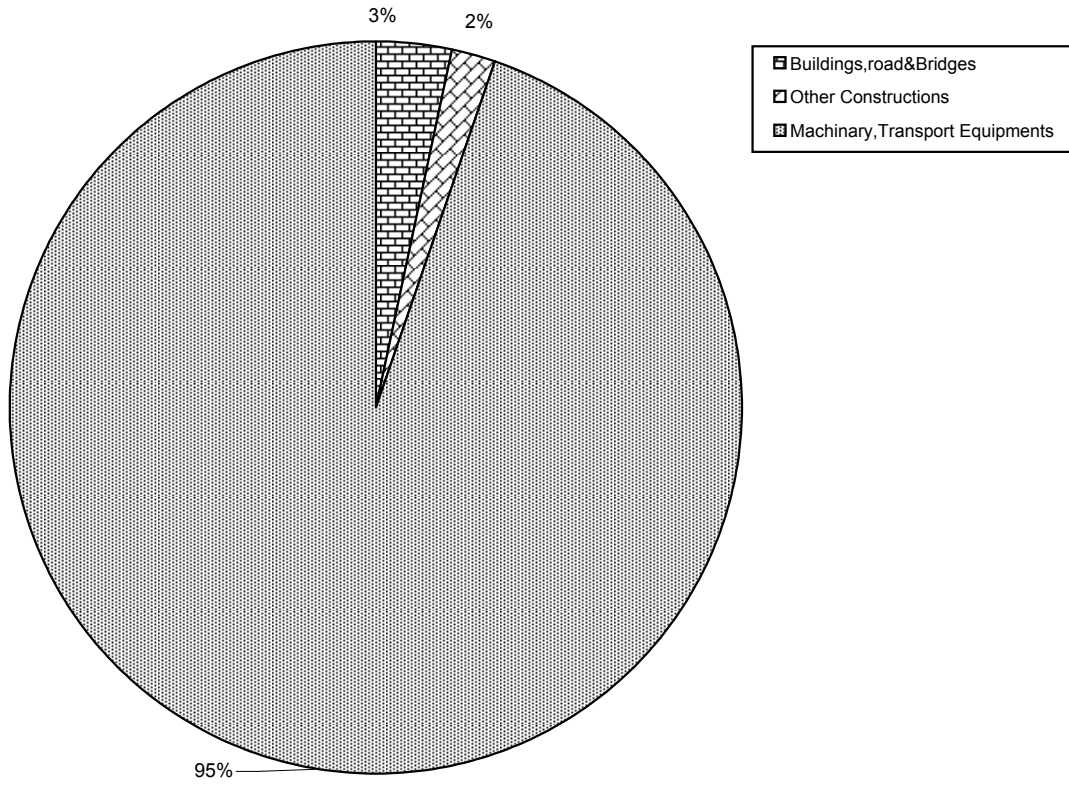
Percentage Distribution of GFCF By Type of Assets(NDCUs),
Year 2001-02



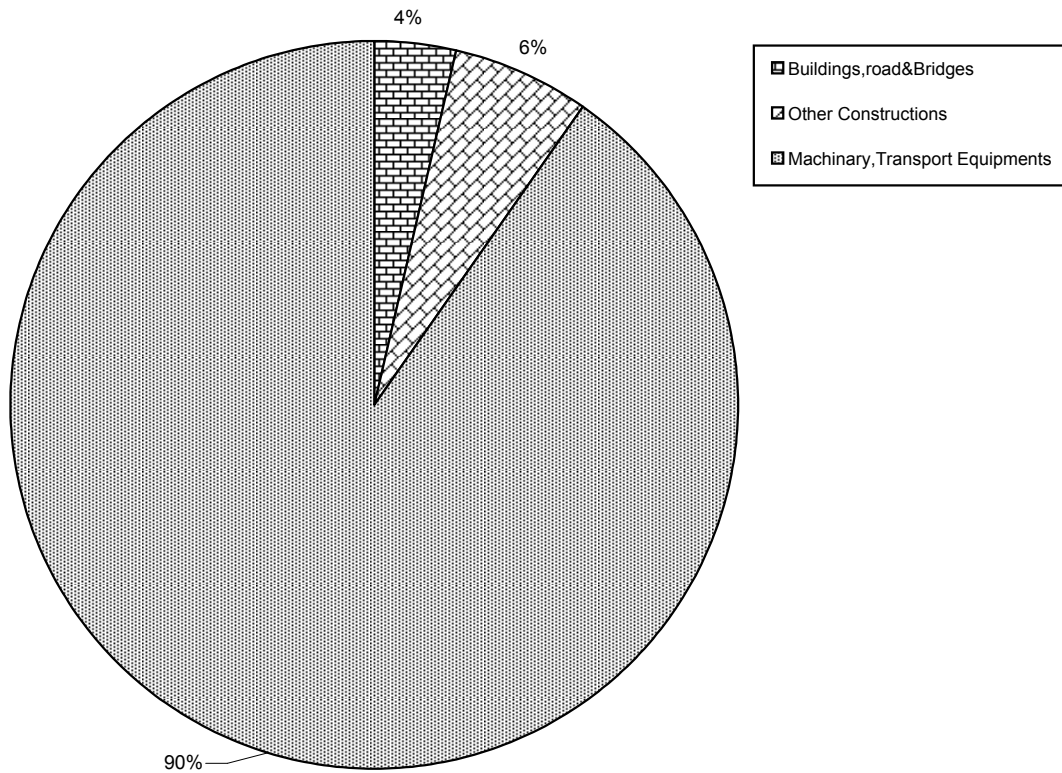
Percentage Distribution of GFCF By Type of Assets(NDCUs),
Year 2002-03



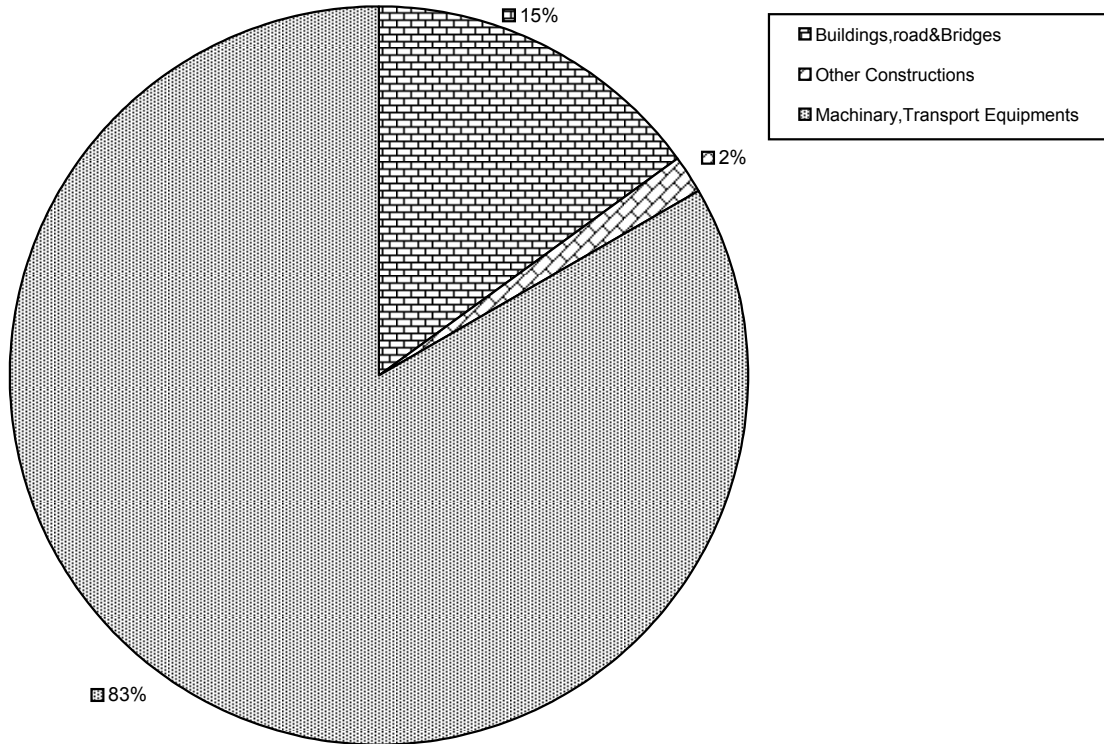
Percentage Distribution of GFCF By Type of Assets (NDCUs),
Year 2003-04



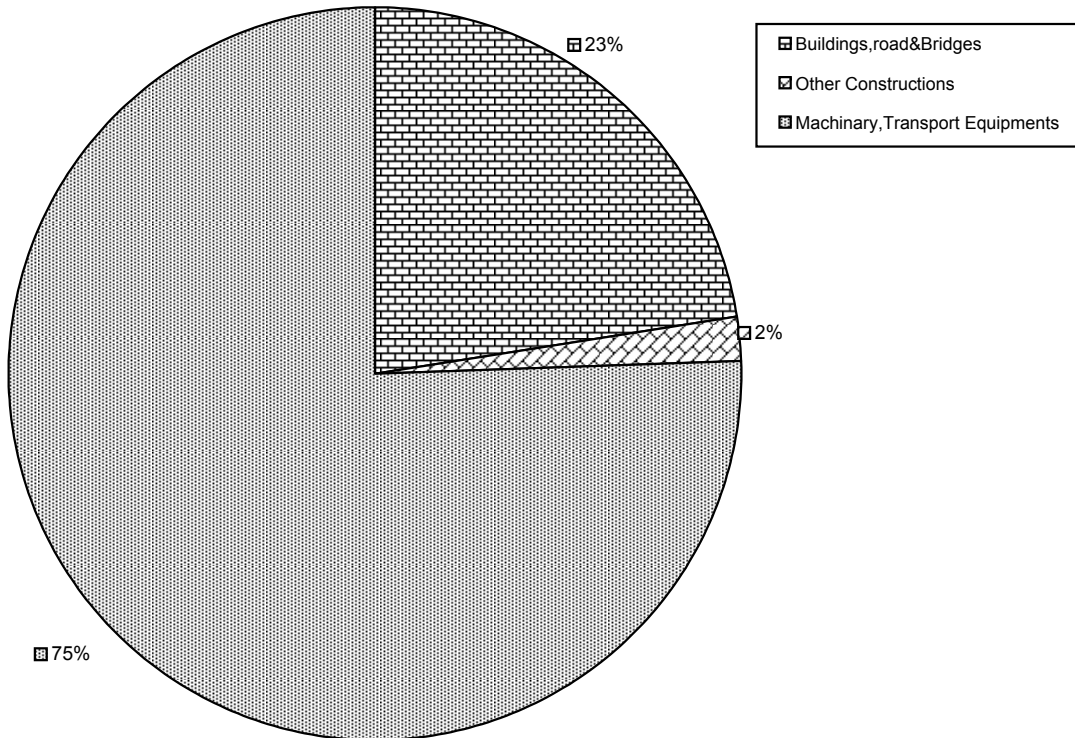
Percentage Distribution of CFCF (NDCUD),
Year 2004-05



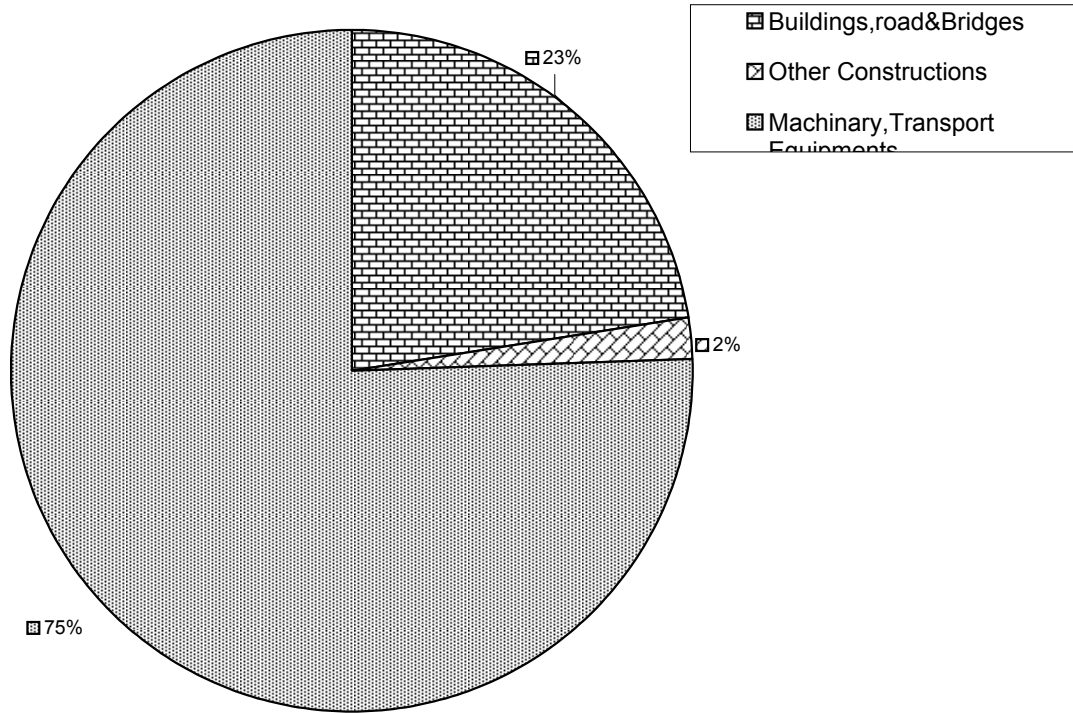
Percentage Distribution of GFCF(NDCUS)Year-2005-06



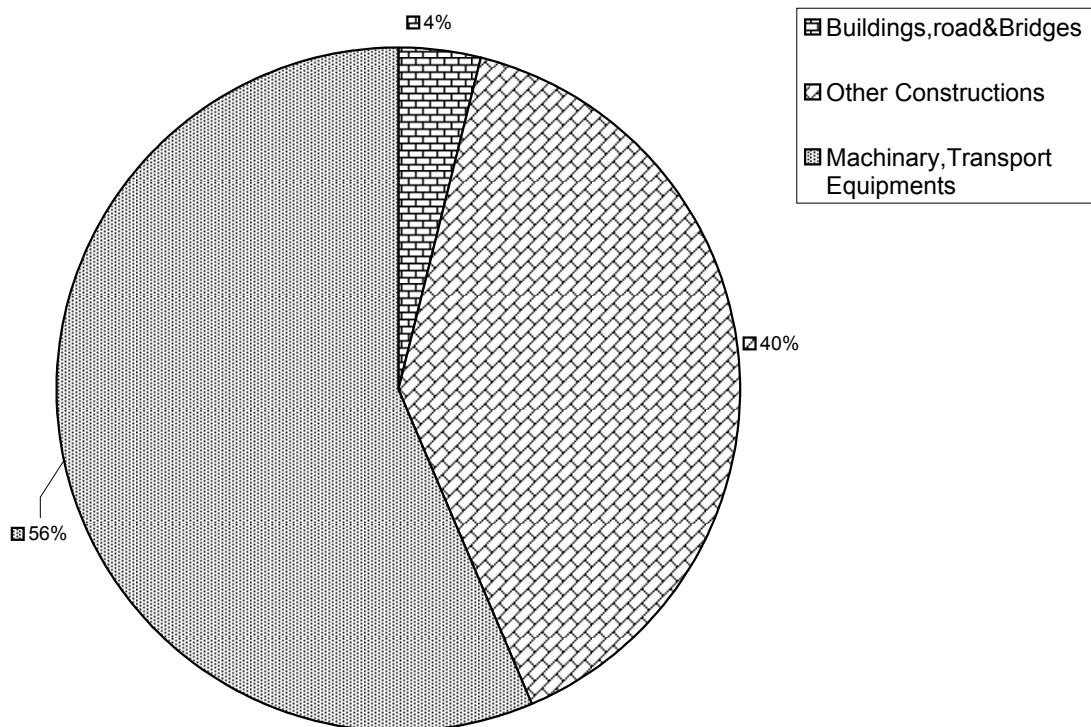
Percentage Distribution of GFCF By Type of Assets(NDCUs),

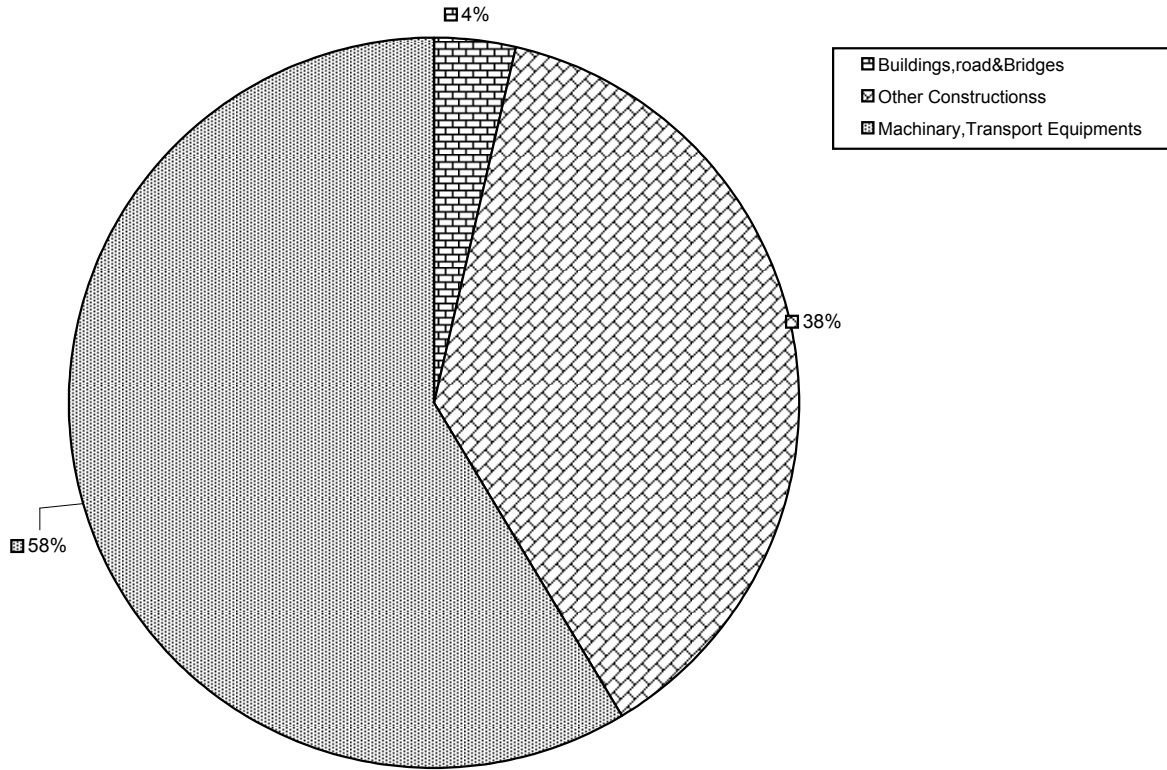
Percentage Distribution of GFCF By Type of Assets(NDCUs),
Year 2007-08



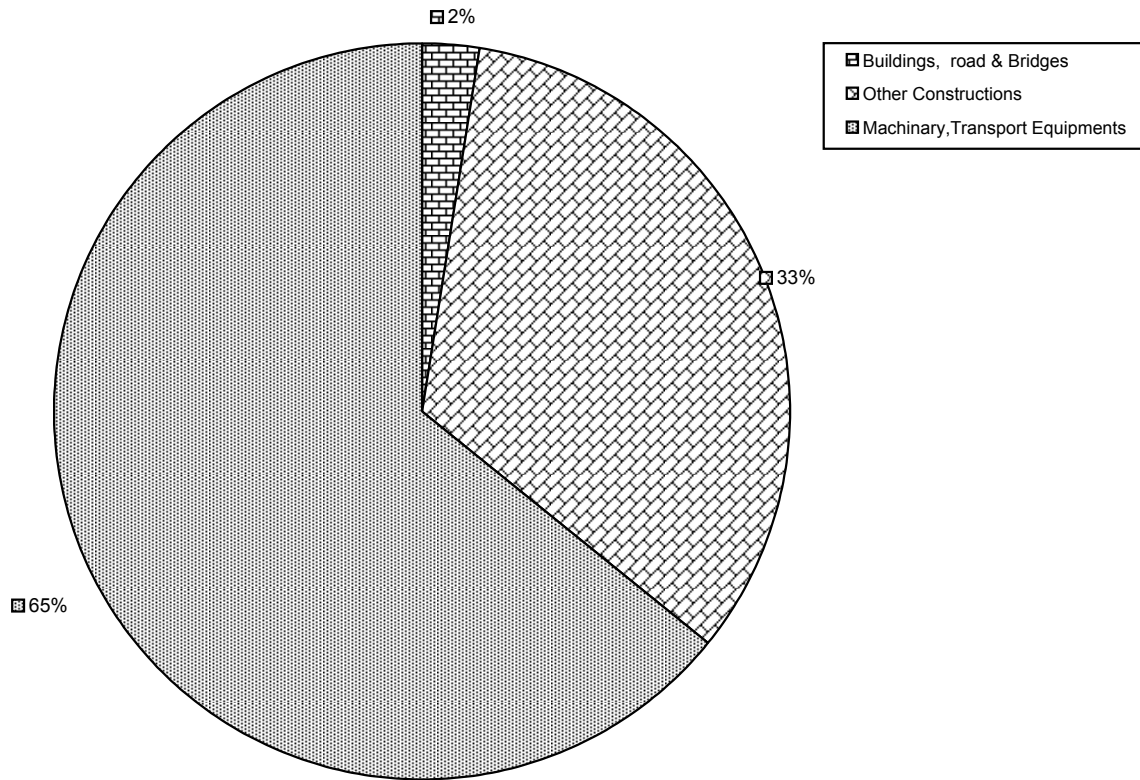
Percentage Distribution of GFCF By Type of Assets (NDCUs),
Year 2008-09



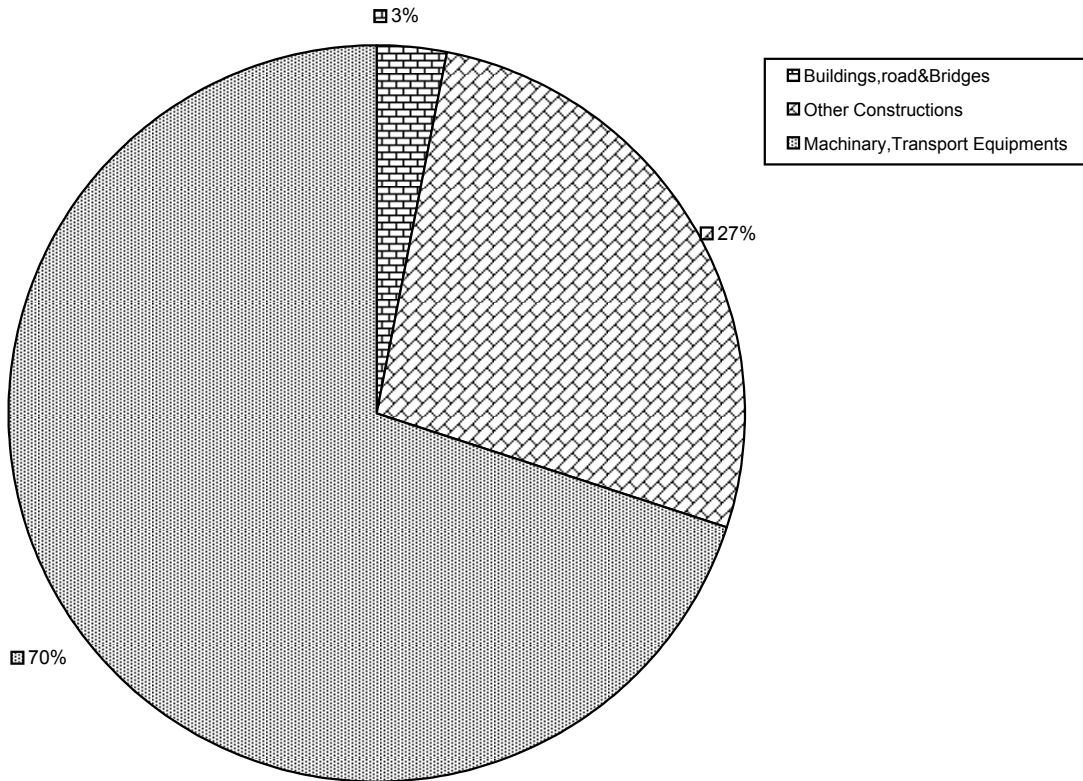
**Percentage Distribution of GFCF By Type of Assets (DCUs&NDCUs),
Year 2001-02**



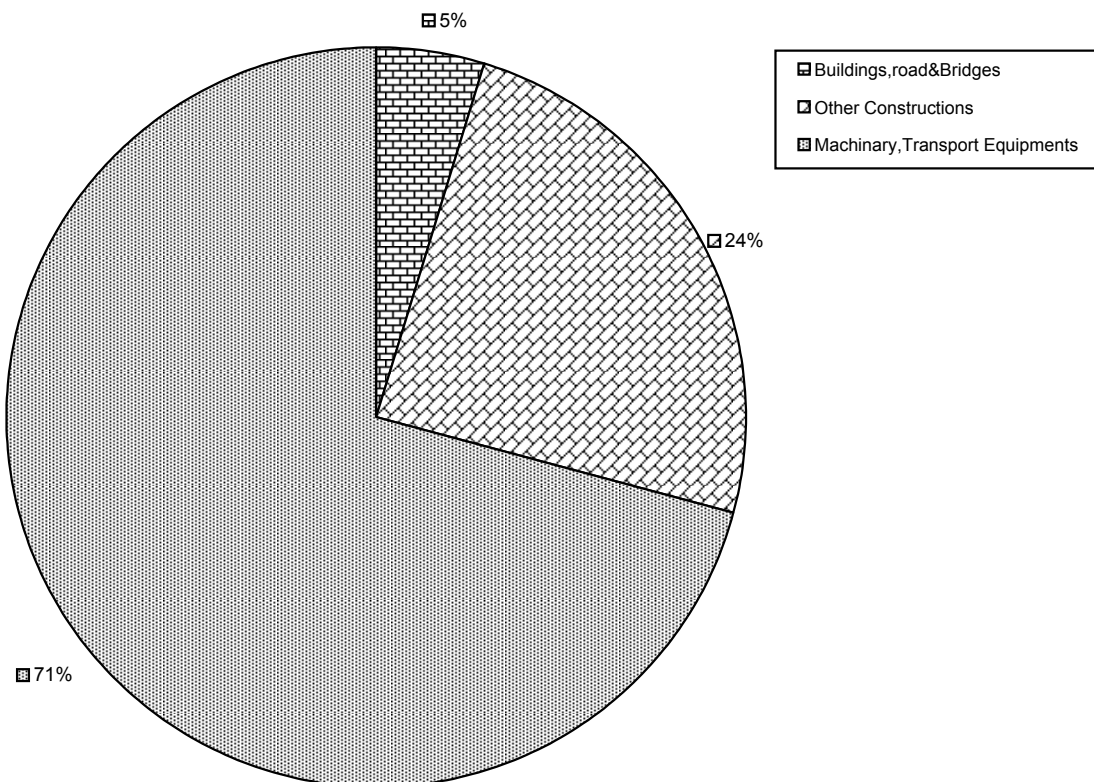
**Percentage Distribution of GFCF By Type of Assets (DCUs&NDCUs),
Year 2002-03**



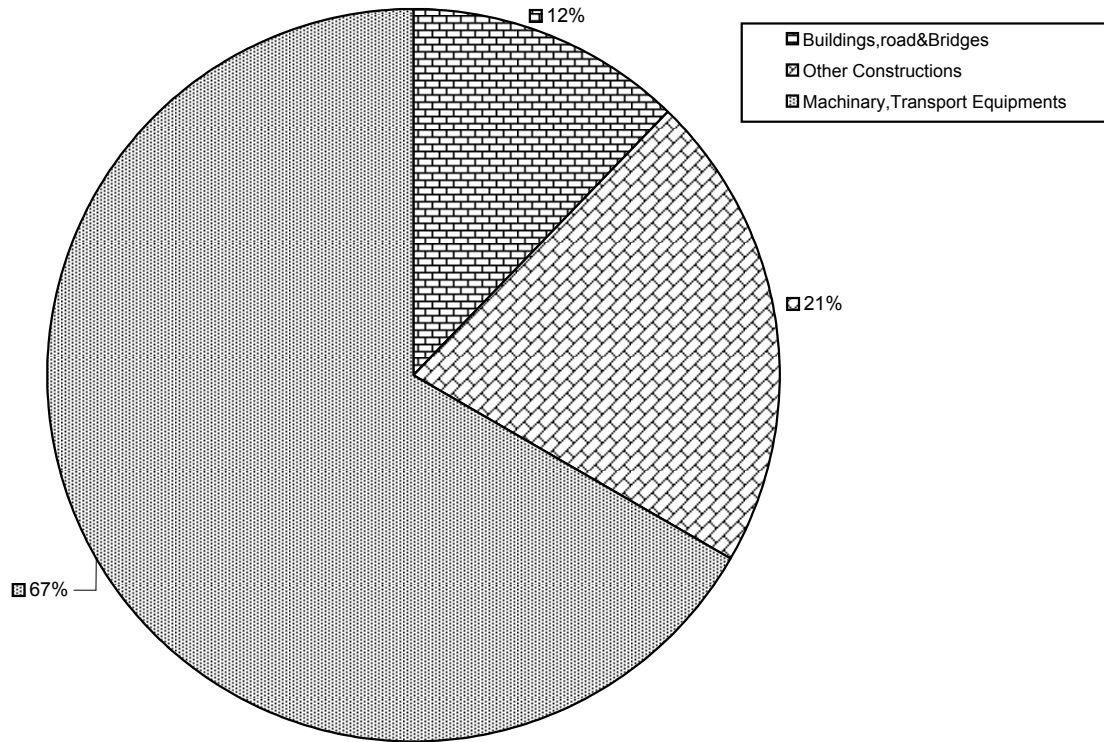
**Percentage Distribution of GFCF By Type of Assets (DCUs&NDCUs),
Year 2003-04**



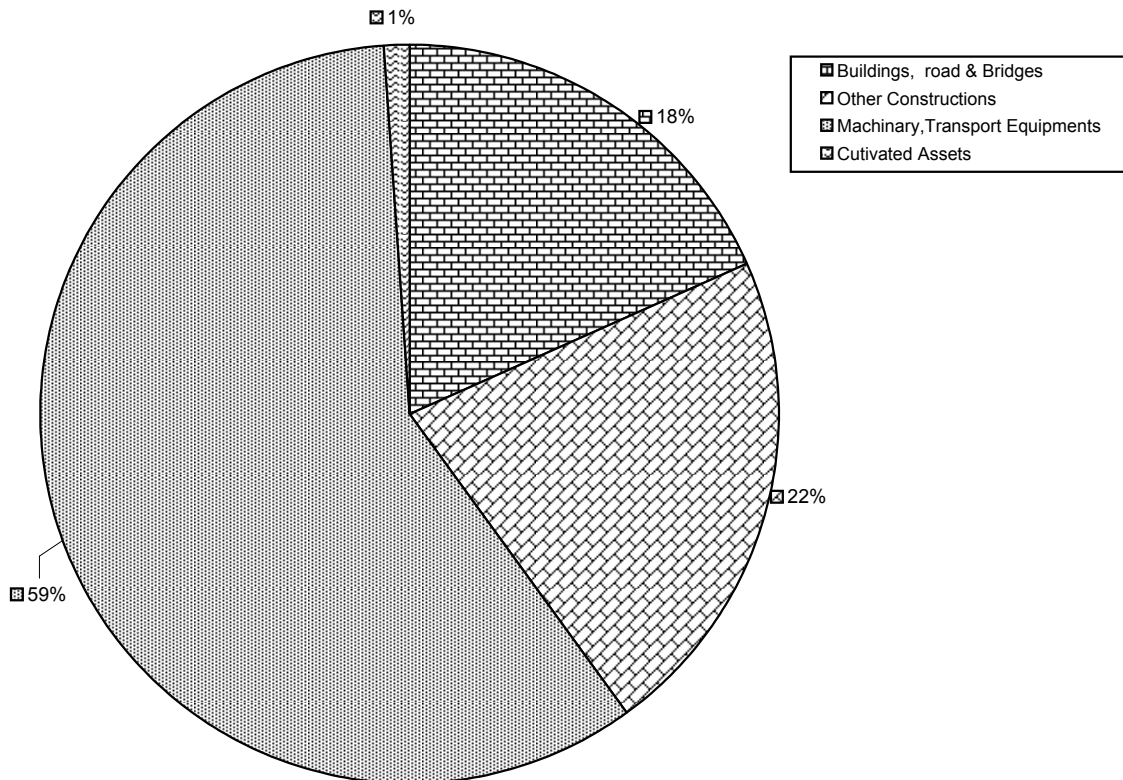
**Percentage Distribution of GFCF By Type Of Assets (DCUs&NDCUs),

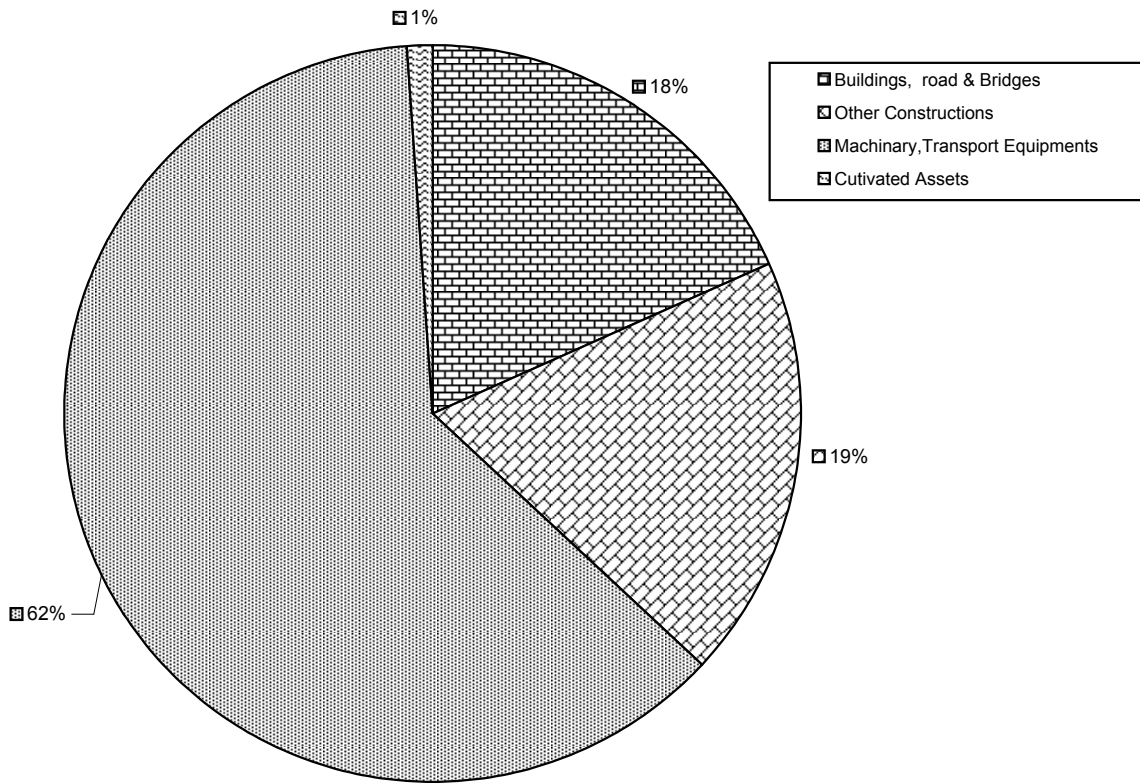
**Percentage Distribution of GFCF By Type of Assets (DCUs&NDUs),

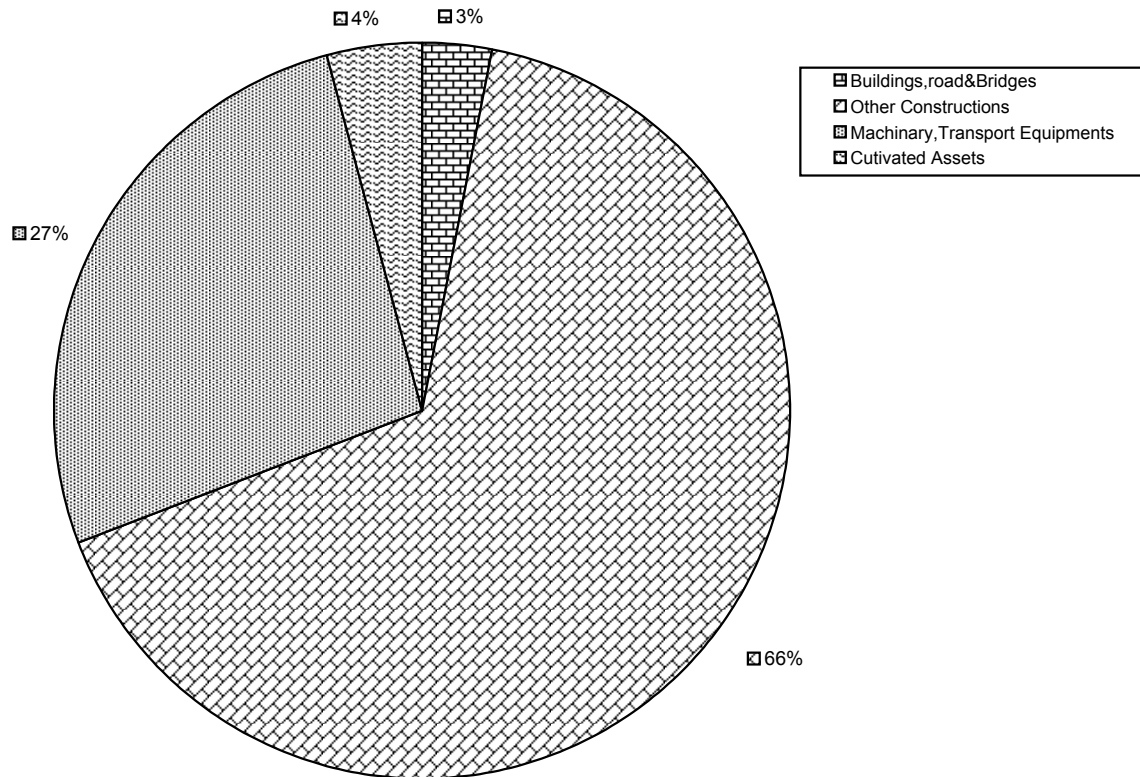
**Percentage Distribution of GFCF By Type of Assets (DCUs&NDCus),
