PREFACE

The estimates of Gross Fixed Capital Formation (G.F.C.F.) indicate the growth potential of the economy of Nation or a State. Higher the growth rate of Capital Formation, higher would be productive capacity of the economy. At the State level the estimate of Gross fixed Capital Formation are yet not available for the economy as a whole due to huge requirements of data from State Non -Departmental Commercial Undertakings (NDCUs) , Urban & Rural Local bodies, Central Govt. Administrative Departments, Supra regional sectors, Central Govt. Departmental Commercial Undertakings(DCUs) & NDCUs, Private Corporate Sector and House hold Sector.

DES Chhattisgarh has taken up the work of preparing the estimate of GFCF in a phased manner.

The present publication provides the G.F.C.F. estimates only of State Govt. Administrative Departments for the period 2000-01 to 2008-09 and Central Govt. Administrative Department including Supra Regional Sector from 2000-2001 to 2006-07.

I hope this publication will help Planners and Administrators in understanding the process of Capital Formation.

We welcome suggestions for improvement in the contents of this publication .

CAPITAL FORMATION

INTRODUCTION:-

The growth of the productive capacity of the economy of a state depends on its rate of capital accumulation and it is measured by estimating the capital formation. Higher the rate of capital accumulation the higher would be growth of the productive capacity of the economy. whereas the low growth indicates the low level of production. Thus the capital formation serves as a very important indicator to measure the magnitude of the growth of productive potential of the economy. The estimates of capital formation are important in context of planning and economic development as these highlights the addition to capital base of the economy and consequent change in the modes and capacity of production. These estimates are among the important statistics required for determining policy decision in resource mobilization, allocation of resources and assessing the growth potential of the economy.

The estimates of Gross Capital Formation consists of Gross Fixed Capital formation (GFCF) and changes in stock of raw materials, semi-finished and finished goods. As it is difficult to capture changes in stock at state level the present estimates are confined to Gross Fixed Capital Formation rather than Gross Capital Formation.

SCOPE AND COVERAGE:-

The estimates of GFCF are prepared for the entire economy of Chhattisgarh State. Chhattisgarh is a new State formed after the reorganization of old Madhya Pradesh. It come in to existence on 1st November 2000. In the earlier first and second edition the estimates of GFCF of Public Sector (State Government Administrative Departments) of Chhattisgarh State for the year 2000-01 to 2007-08 were published. The third edition of same publication, incorporating the year 2008-09, is now prepared.

Gross Fixed Capital Formation refers to the aggregate of gross addition to fixed assets and less disposal in a particular year. The assets comprising of Construction (including construction of Building, Road and Bridges), Machinery and equipment (including transport equipment), Software-outlay, cultivated assets and Animal assets, excluding stock during the accounting period.

For the purpose of estimation of Gross Fixed Capital Formation, the capital originated within the geographical boundaries of the state has been taken in to account.

For the purpose of estimation of Gross Fixed Capital Formation, the economy of the State has been classified in to below 9 industry groups of use :-

1. **Agriculture (including Animal Husbandry, Forestry & Logging and Fishing)**
2. **Mining and Quarrying**
3. **Manufacturing**
4. **Electricity, Gas and Water Supply**
5. **Construction**
6. **Trade, Hotels & Restaurants**
7. **Transport, Storage and Communications**
8. **Financing, Insurance, Real Estate & Business Services**
9. **Community, Social & Personal Services**

Each Sector has been further classified in to

- A . Public Sector &**
- B . Private Sector**

The Public Sector consists of :-

1. Administrative Departments
2. Departmental Commercial Undertakings (DCUs)
3. Non-Departmental Commercial Undertakings (NDCUs)
4. Local Bodies
5. Central Non-Departmental Commercial Undertakings (CNDCUs)
6. Supra-Regional Sectors

Administrative Department:-

All Central Govt. Departments established in the State and State Govt. Departments/offices engaged in administration and regulation of public order comes under this segment . The present G.F.C.F. estimates are being confined with the State Govt. Administrative Departments, central government Administrative department and supra regional sectors.

Departmental Commercial Undertakings (DCUs):-

Undertakings, which are owned and controlled by the Government, producing Goods and Services and selling at prices like any other commercial establishments comes under this segment. For example Govt. Printing Press etc.

Non- Departmental Commercial Undertakings (NDCUs):-

Non-Departmental Commercial Undertaking comprises of 1. Govt. companies registered under Companies Act and wherein not less than 51% share is owned by State Govt. and 2. Public corporations setup under the State Govt. Act wholly or mainly owned and/or controlled by public authorities. These NDCUs are also engaged in producing goods and services for general sale.

Local Bodies:-

The Local Bodies consist of Zila Panchayat, Janpad Panchayat, Gram Panchayat, Municipal Corporations , Municipalities and Nagar Panchyat .

Central Govt. Non-Departmental Commercial Undertakings:-

Central Govt. Non-Departmental Commercial Undertakings comprises of 1. Govt. Companies registered under Companies Act and wherein not less than 51% share is owned by Central Govt. and 2. Public Corporations setup under the Central Govt. Act wholly or mainly owned and/or controlled by public authority established in the State.

Supra-Regional Sectors:-

All such sectors the boundaries of which are not co-terminus with state geographical boundaries are known as Supra-Regional Sectors. For ex. Railways, Banking, Insurance & Communications etc.

GROSS FIXED CAPITAL FORMATION BY STATE GOVERNMENT ADMINISTRATIVE DEPARTMENTS (PUBLIC SECTOR) OF GOVERNMENT OF CHHATTISGARH YEAR 2000-01 TO 2008-09

Capital Formation is a basic macro economic aggregate often used as an indicator for the growth potential of the economy of Nation or a State. The G.F.C.F. estimates at the State level was not attempted earlier due the absence of system for collection of huge data from various organizations viz. Central Government, Local bodies (Panchayat & Municipalities), Private corporate Sector and household sector. Therefore, attempts are being made to prepare the estimates of G.F.C.F. by State Govt. Administrative Departments (Public Sector) by industry of use and by type of assets for the year 2000-01 to 2008- 09 at current prices.

The estimates of G.F.C.F. by type of assets i.e. Buildings, Road & Bridges , Other Construction, Machinery & Equipment, Transport Equipment of different years are presented in Table No 2 A& B and G.F.C.F. by type of industry of use and by type of assets for each of the years 2000-01 to 2008-09 are presented in Table No. 3 to Table No 11 .

The estimates of Gross Fixed Capital Formation (G.F.C.F.) presented here pertain to State Govt. Administrative Departments. Each year State Govt. makes provision for

expenditure of every govt. departments in its Annual Budget for different purpose of uses . The data provided in the accounted budget is taken into consideration during estimating G.F.C.F. Chhattisgarh State has come in to existence on 1st. November 2000 hence, the actual data for the year 2000-01 is available for five months (November to March) only. The estimates given in this publication for the entire year of 2000-01 is worked out on average based on available data of five months .

Analysis Of Estimates Of G.F.C.F.

A brief analysis of estimates of G.F.C.F. by State Govt. Administrative Departments are given in following paragraphs.

G.F.C.F. at Aggregate Level

The estimates of Gross Fixed Capital Formation and annual change over previous year are given in Table 1

It is seen in the table that the Gross Fixed Capital Formation by State Govt. Administrative Departments during the year 2008-09 was accounted to Rs. 2702.26 crores as against Rs. 432.94 crores in 2001-02. By the analysis of the table it seems that maximum annual change in G.F.C.F. was occurred in the year 2006-07 where as the latest year got minimum changes. The average rate of increase during the year 2002-03 to 2008-09 works out to be 36.98 percent.

G.F.C.F. by Industry of Use

The estimates of G.F.C.F. by industry of use i.e. by different sectors of the economy to which Administrative Departments belong ,along with there share for the year 2000-01 to 2008-09 are given in Table No. 12

It is observed that amongst all the industry groups "Construction" represents the highest share in the G.F.C.F. of the State followed by Public Administrative Services. Electricity, Gas and Water supply are other sectors where major part of the Govt. Budgetary Fund is used for capital formation.

G.F.C.F. by type of Assets

The estimates of G.F.C.F. by broad categories of assets i.e. Buildings, Road and Bridges, Other Construction, Machinery Equipments, Transport Equipments of different years are given in Table No 2

It is seen that each and every year major share of Govt. budget is being used in Roads and Bridges and other construction works. "Other Construction" includes expenditure on parking facilities, dams, canals, drainage, water supply etc.

Building works is the other major component which has large contribution to total G.F.C.F. for respect year.

Estimates of G.F.C.F. from Central Govt. Administration & Supra-regional sectors

the estimates of Gross Fixed Capital Formation from Supra-regional viz. Railways, Communication, Banking & Insurance and Central Government Administration at current price for the period 2001-01 to 2006-07 in context to Chhattisgarh State data from 2004-05 to 2006-07 supplied by CSO as a base year 2004-05 is given in Table No.2(B). The G.F.C.F. estimates of Banking & Insurance and Communication Sectors are provided for Public as well as private sector separately.

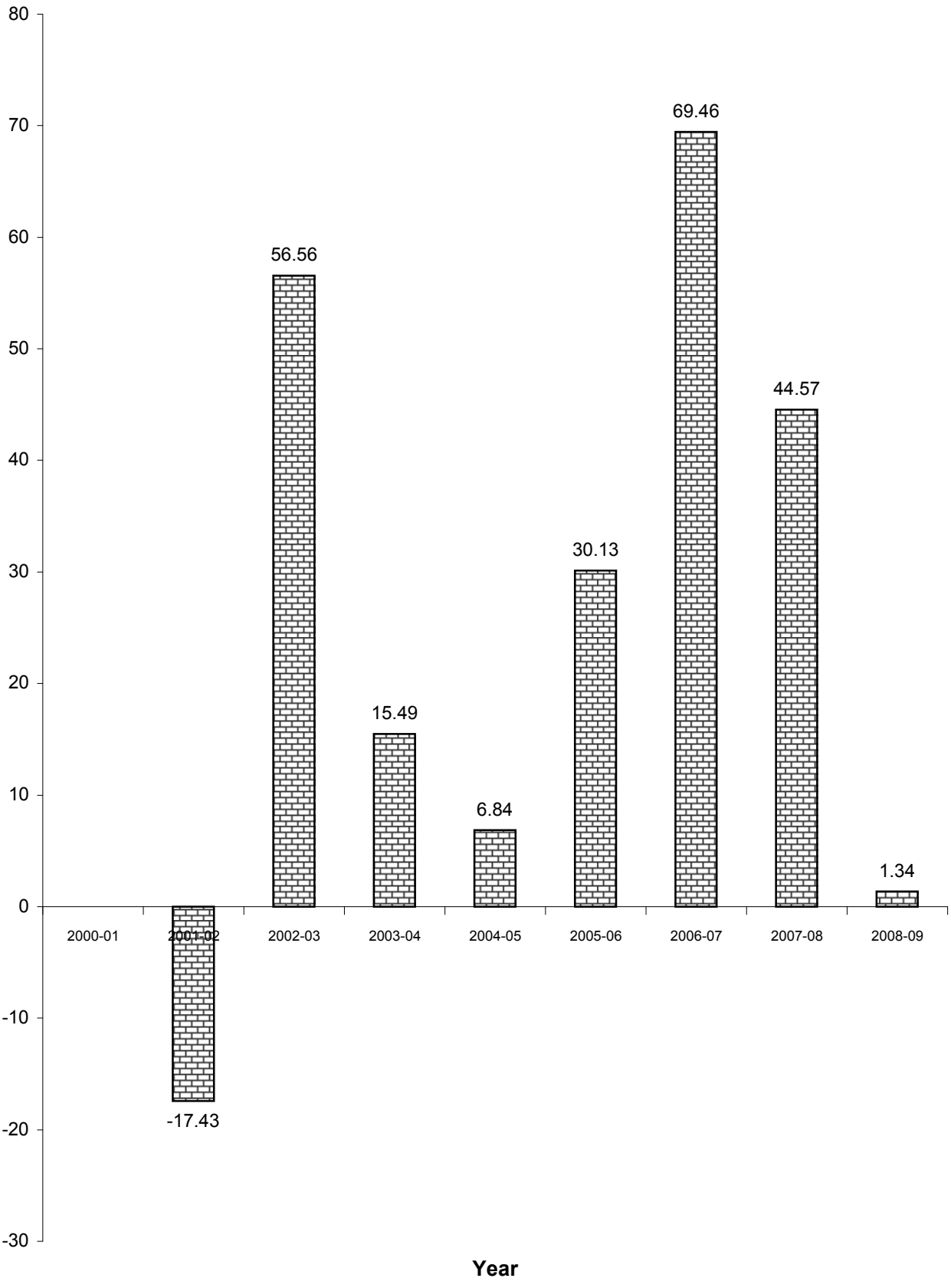

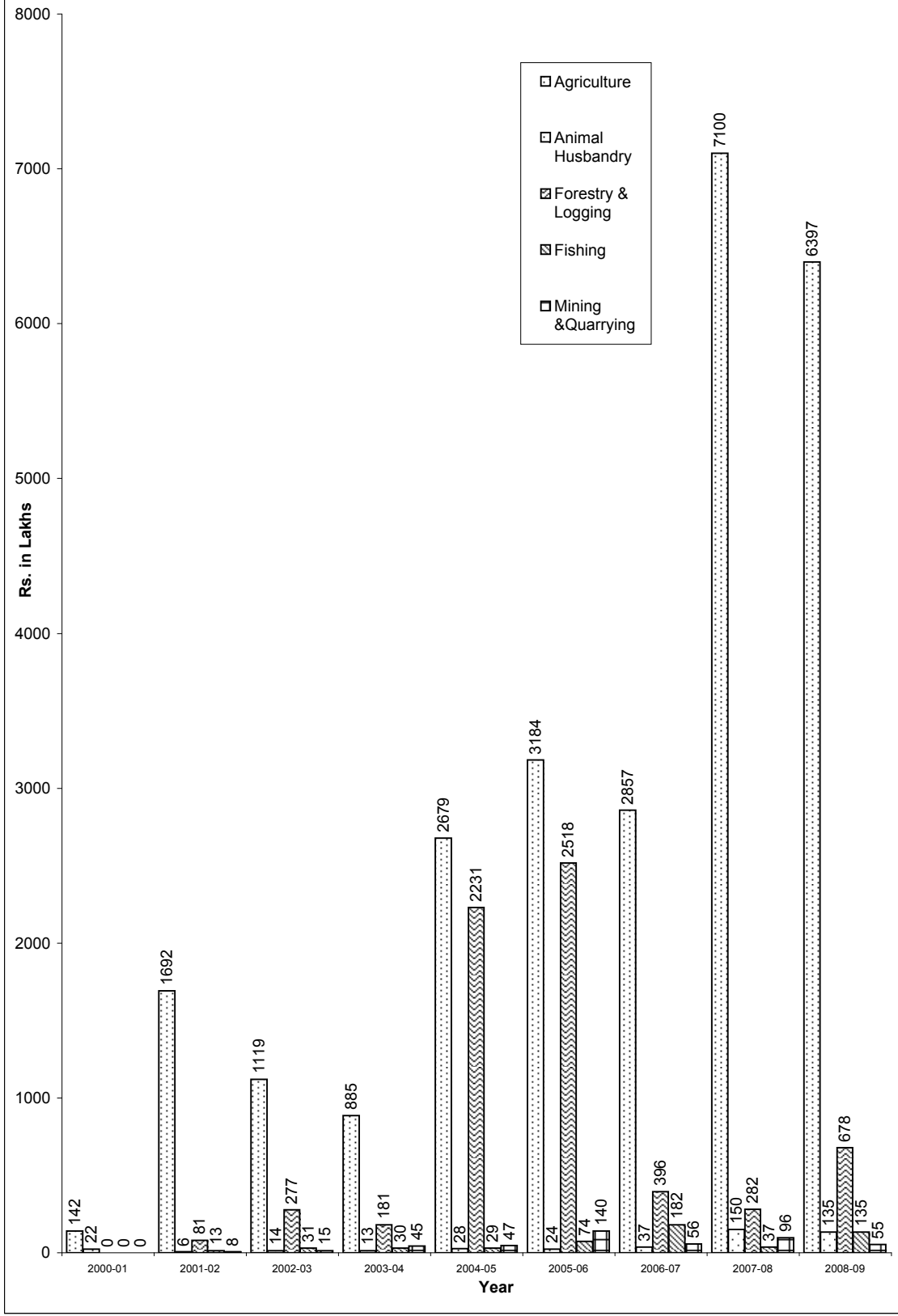

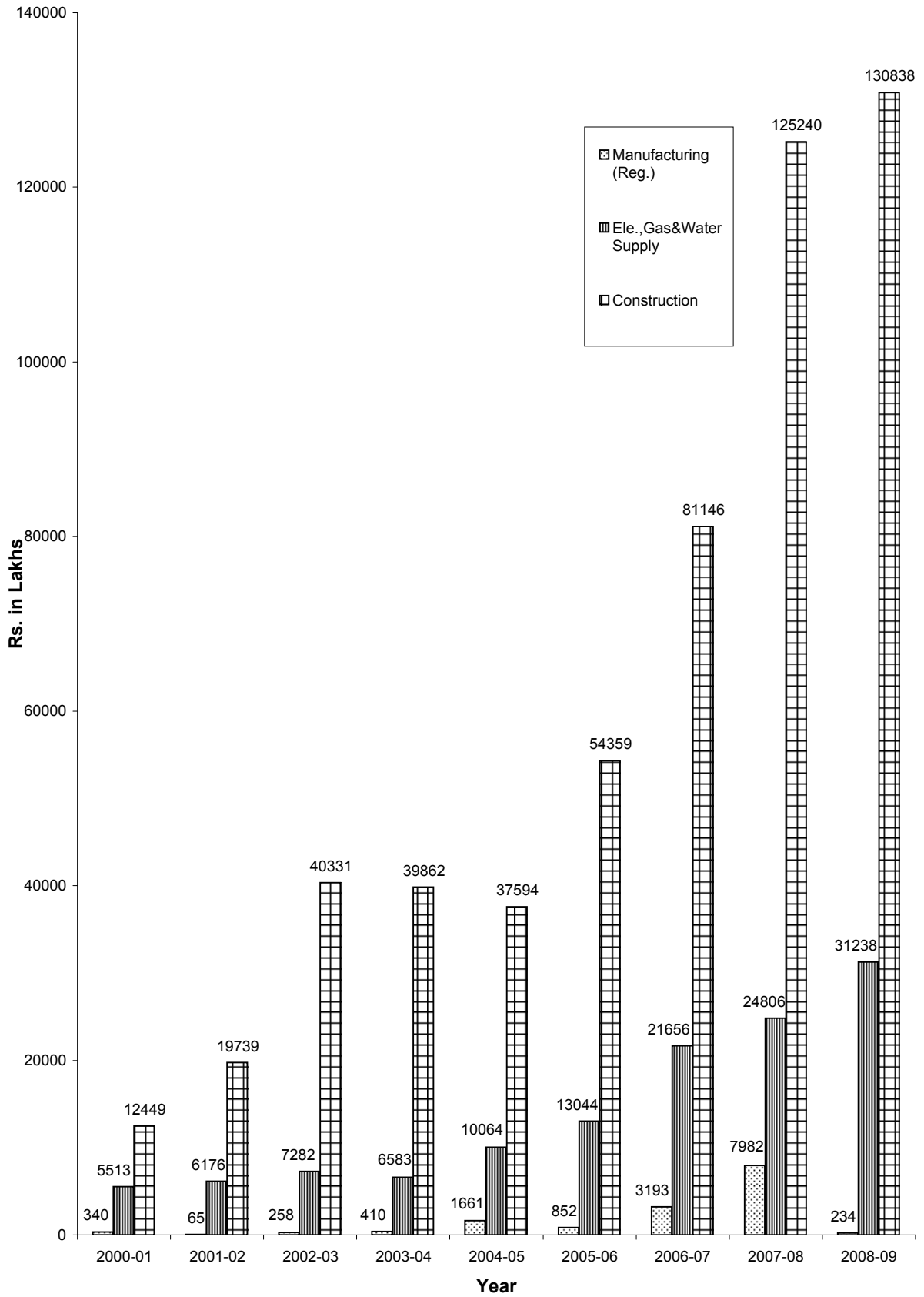
Annual Change in G.F.C.F.(Percentage)



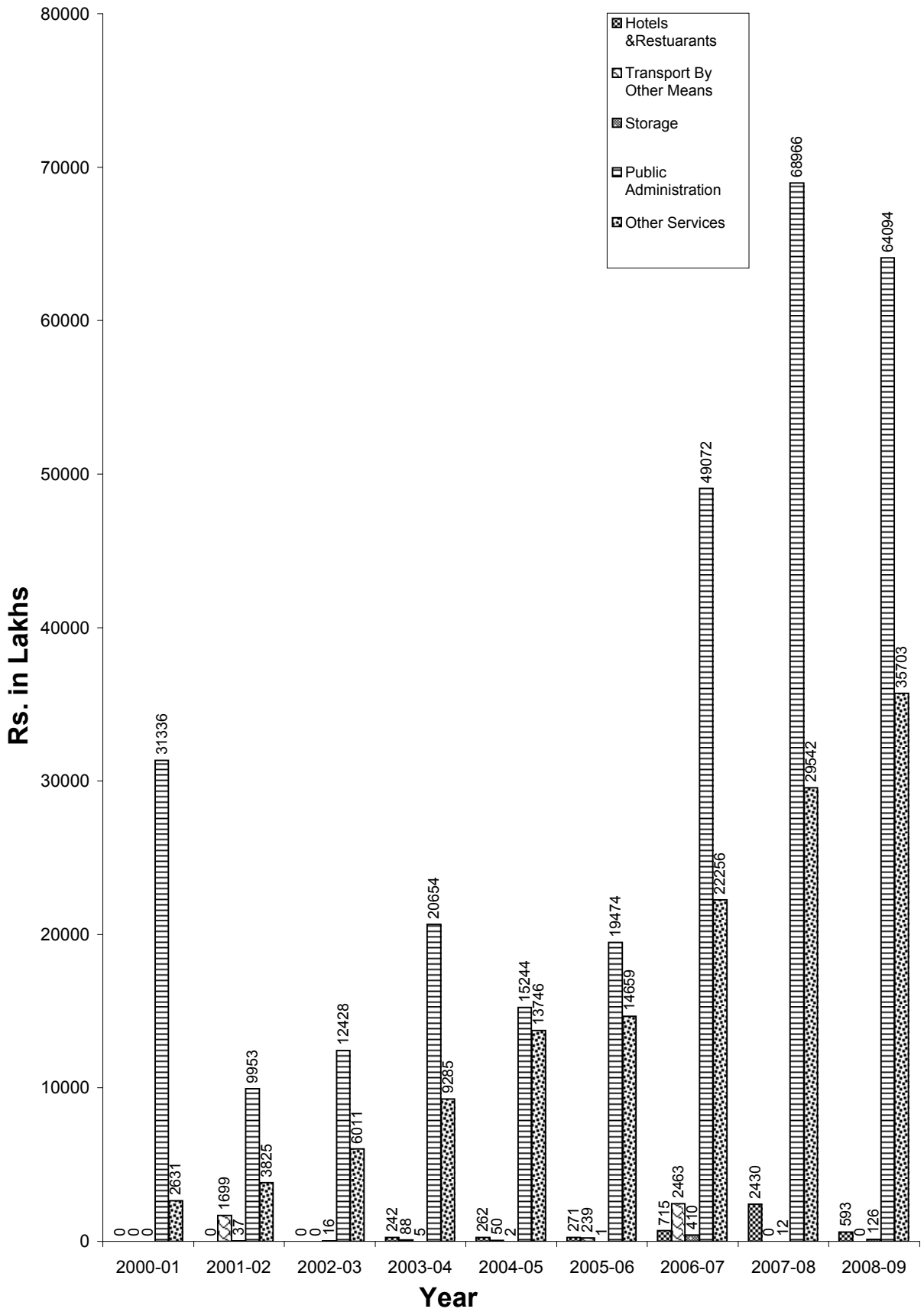
G.F.C.F. by Industry of Use(Primary Sector)



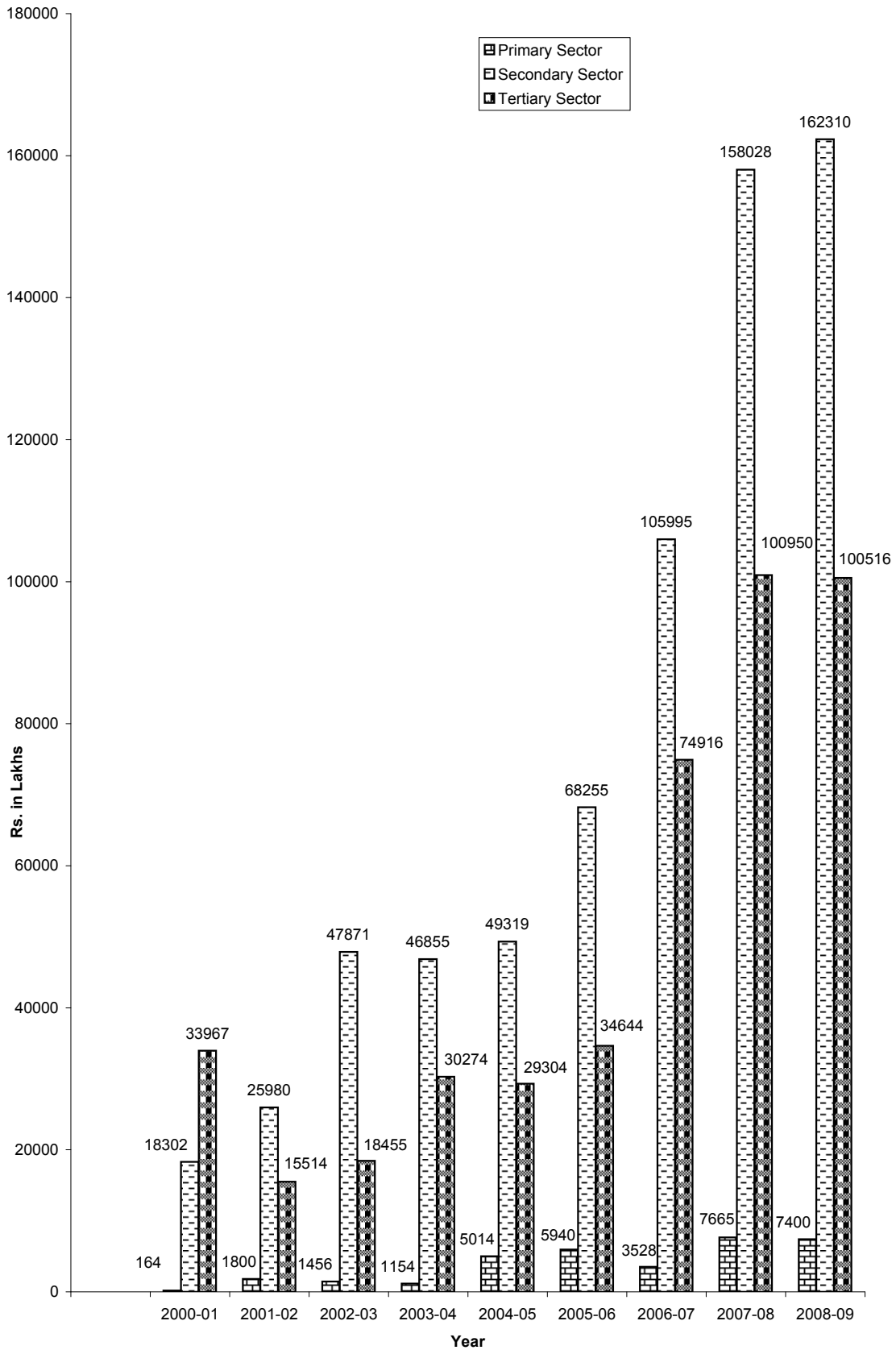
G.F.C.F. by Industry of Use(Secondary Sector)



G.F.C.F. by Industry of Use (Tertiary Sector)

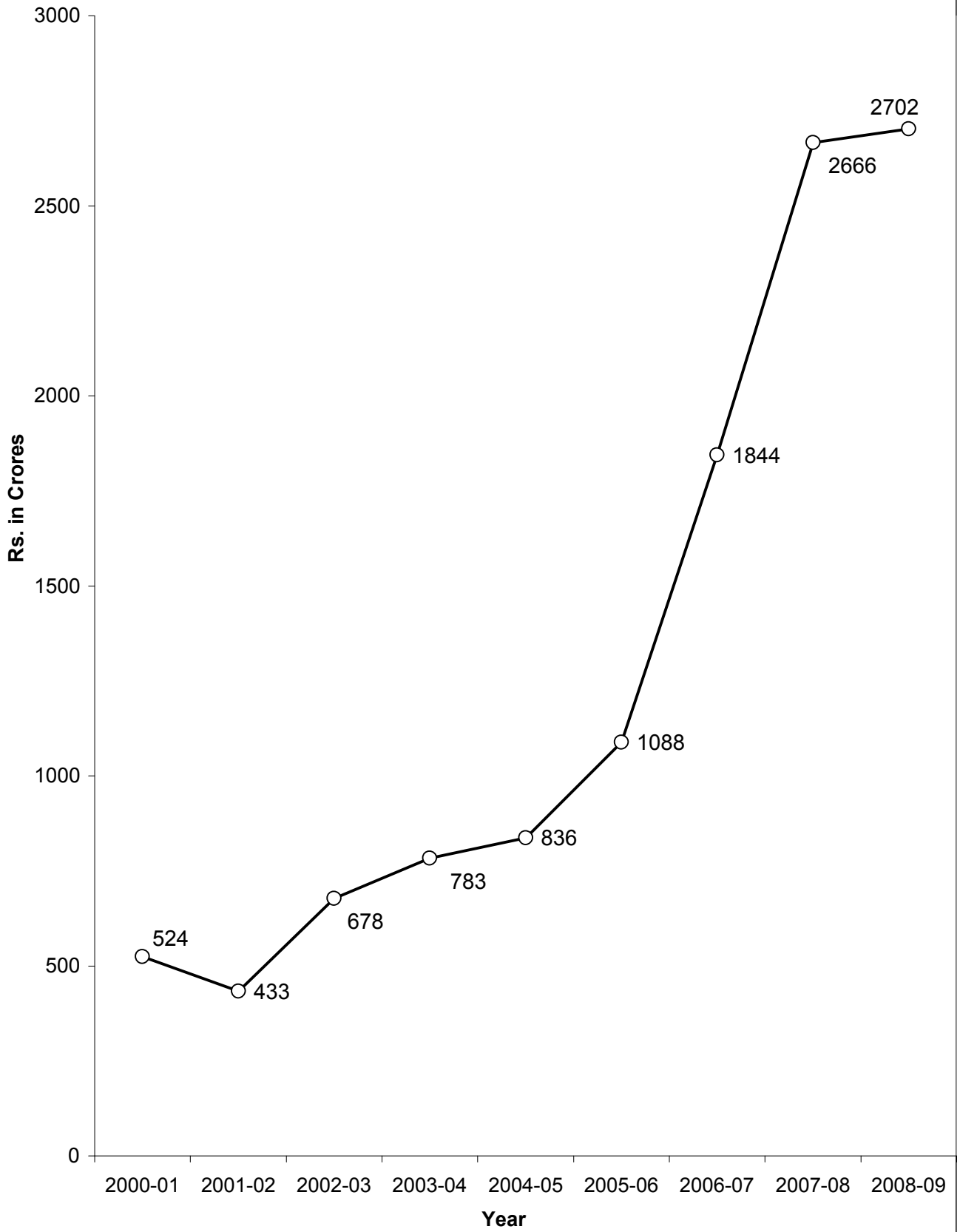


Year And Sector Wise G.F.C.F.



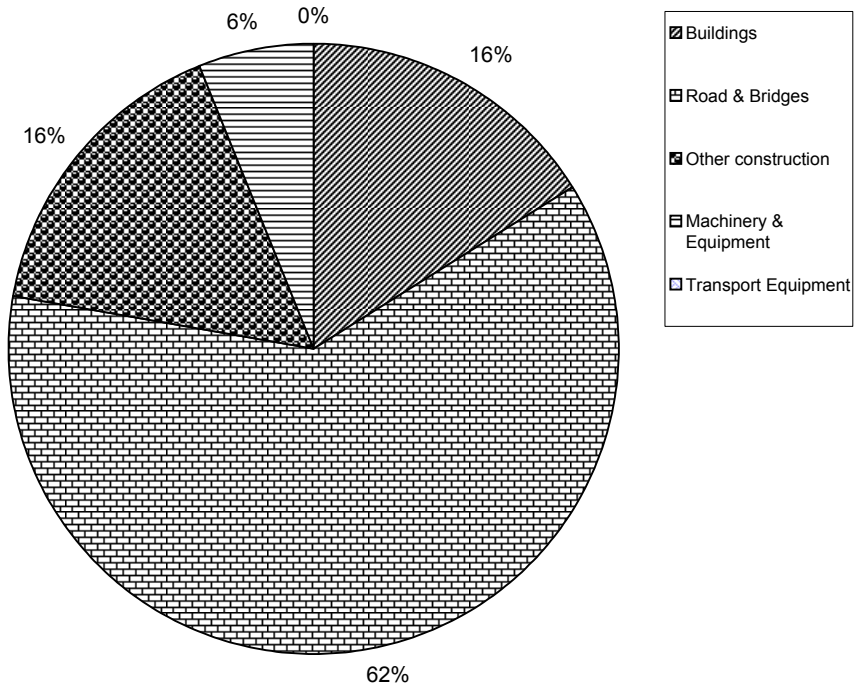

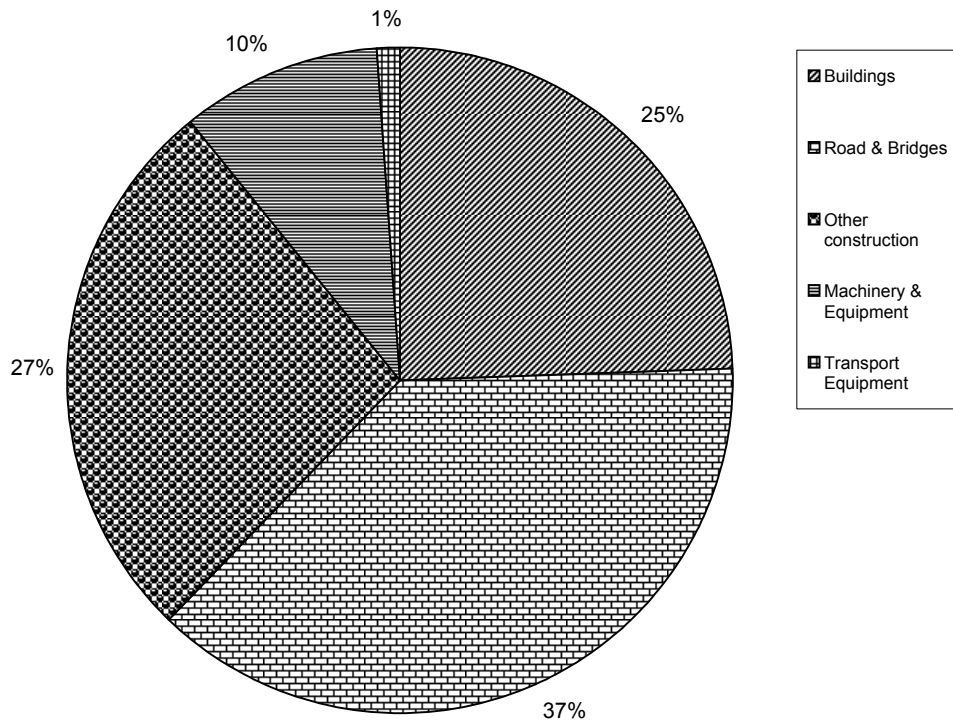

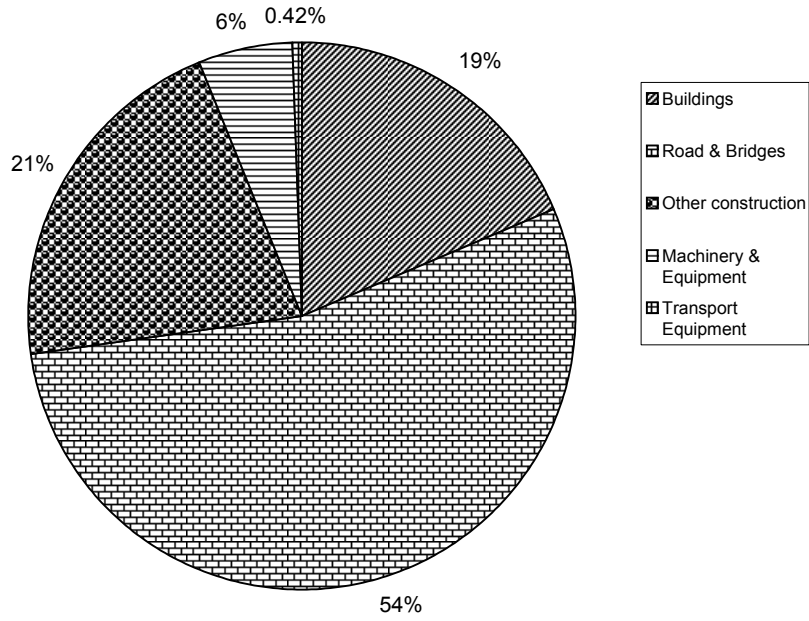
**Percentage Distribution By Type of Assets
Year 2000-01**



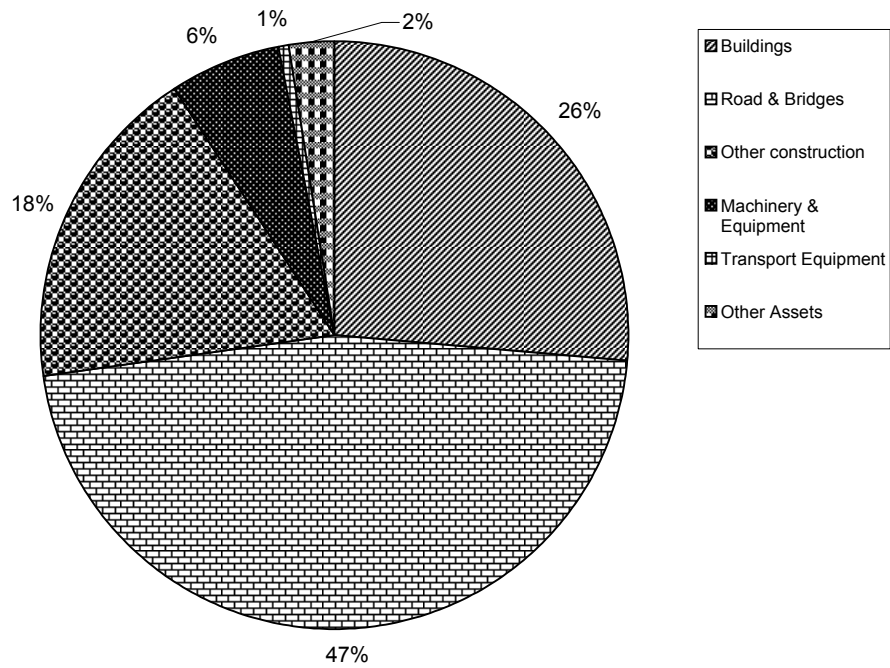
**Percentage Distribution By Type of Assets
Year 2001-02**



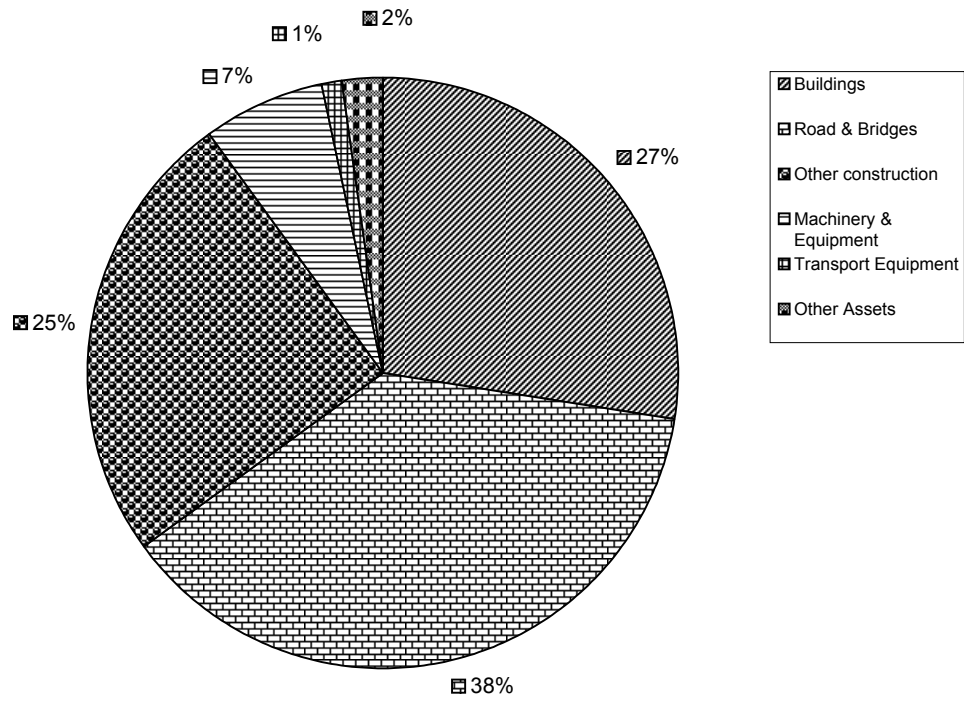
**Percentage Distribution By Type of Assets
Year 2002-03**



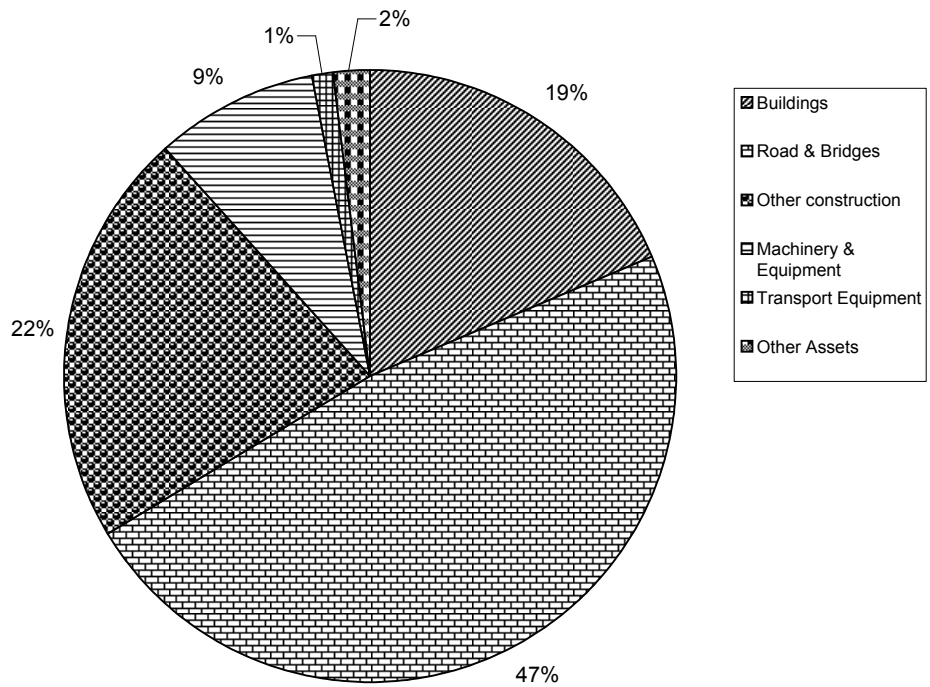
**Percentage Distribution By Type of Assets
Year 2003-04**



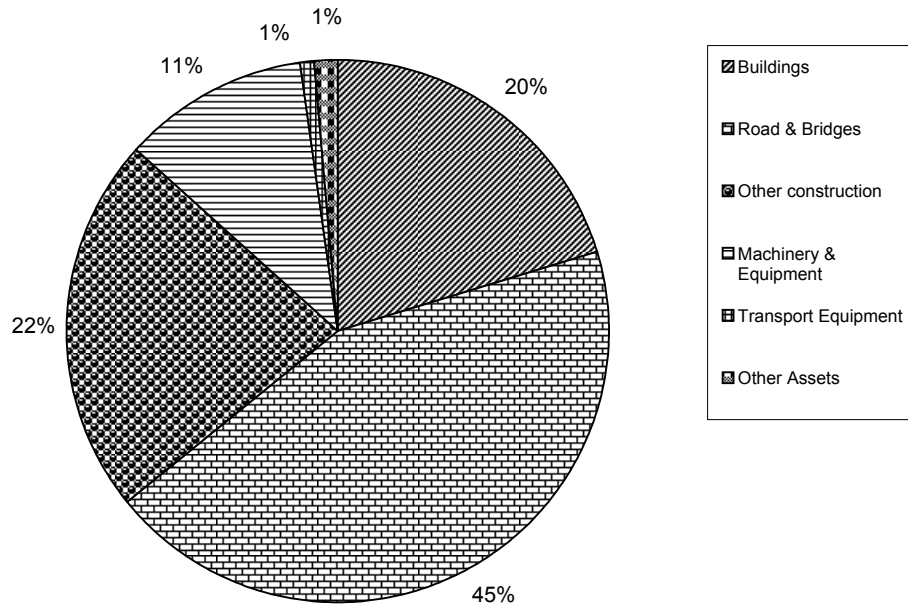
**Percentage Distribution By Type of Assets
Year 2004-05**



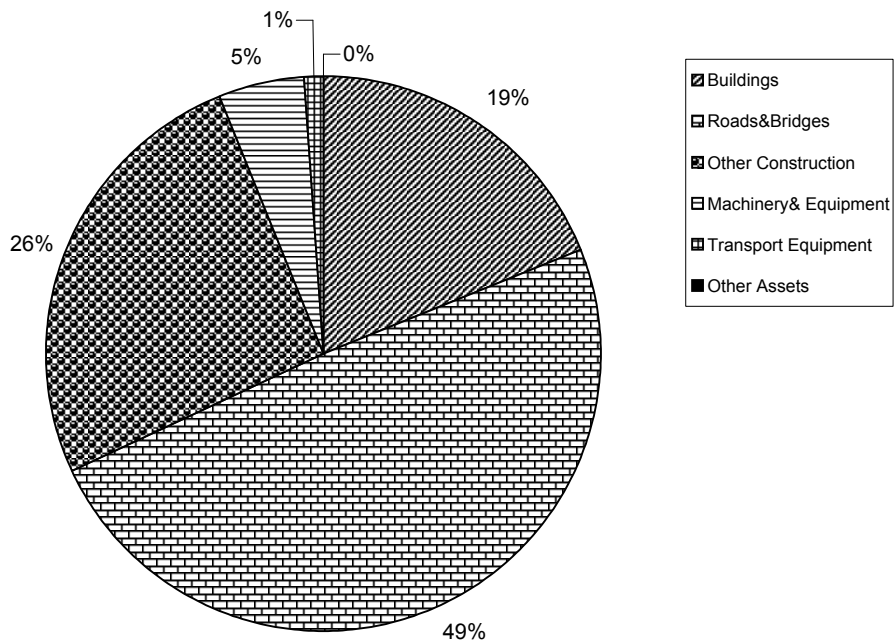
**Percentage Distribution By Type of Assets
Year 2005-06**



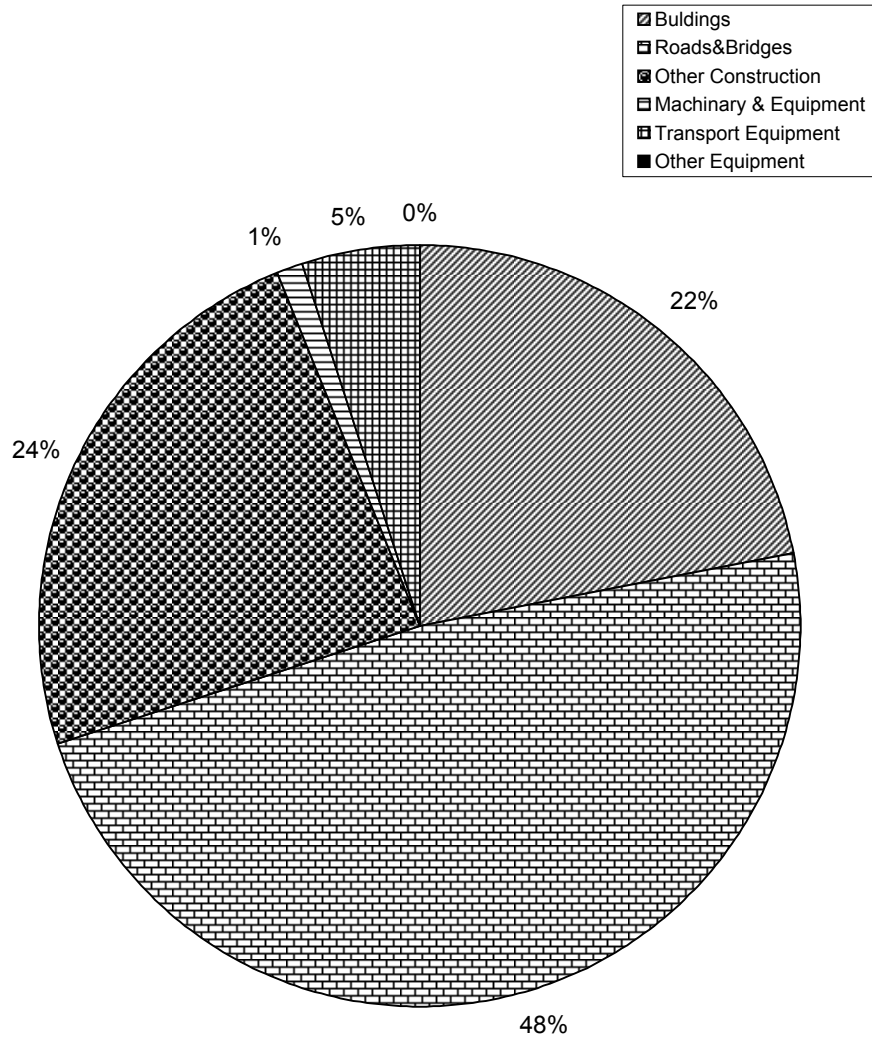
**Percentage Distribution by Type of Assets
