REPORT OF THE UGC EXPERT COMMITTEE WHICH VISITED NITTE EDUCATION TRUST, MANGALORE, KARNATAKA ON 29TH - 30TH DECEMBER, 2007 TO ASSESS ITS PROPOSAL FOR CONFERMENT OF DEEMED TO BE UNIVERSITY STATUS IN THE NAME AND STYLE OF NITTE UNIVERSITY COMPRISING OF A.B.SHETTY MEMORIAL INSTITUTE OF DENTAL SCIENCES, MANGALORE, KARNATAKA UNDER SECTION 3 OF THE UGC ACT, 1956

I BACKGROUND

The Ministry of Human Resource Development, Government of India forwarded the proposal of Nitte Education Trust, Mangalorre, Karnataka for the conferment of Deemed to be University status under Section 3 of the UGC Act, 1956 vide letter No. F.9-13/2007-U.3(A) dated 28th February, 2007 in the name and style of Nitte University, Mangalore, Karnataka.

In 1979, Justice K.S. Hegde, former Judge of the Supreme Court and Speaker of the Sixth Lok Sabha, established Nitte Education Trust with the establishment of a School and Medical Centre at Nitte village, from which the name Nitte Education Trust has been derived.

In 1985, a Dental College was established in memory of late Shri A. B. Shetty, a renowned social reformer and Health Minister in Madras Presidency and Karnataka with intake of 40. Nitte Education Trust is committed to provide primary to tertiary level health-care facilities to the people of Karnataka and neighboring districts of Kerala. In 1988, the DCI accorded permission to enhance intake from 40 to 100. In 1989 Government of Karnataka/DCI granted permission to start post-graduate programs in Oral Surgery, Prosthodontics, Conservative Dentistry and Orthodontics. In 1990, DCI accorded permission to start post-graduate programs in four more specialties – Oral Medicine and Radiology, Pedodontics, Periodontics and Oral Pathology with total intake of 50. In 1991, Mangalore University accorded permission to start Ph.D. programs in Oral Surgery, Prosthodontics, Conservative Dentistry and Orthodontics.

OBSERVATIONS OF THE COMMITTEE INCLUDING DCI NOMINEE

The UGC Expert Committee on examination and verification of the academic, physical and financial viability of the institution, academic and physical infrastructure of the institution, the academic programmes conducted and proposed by the institution and after due interaction with the student community, faculty members and non-teaching staff of the Institution makes the following general observations:-

1. The Committee noted that the Nitte Education Trust was established in the year 1979 under the Chairmanship of Justice K.S. Hegde, former Judge of the Supreme Court and Speaker of the Sixth Lok Sabha. The Trust was registered on 15th July, 1985. The total area of the Campus of Nitte Education Trust at Mangalore comprising of Medical College, Dental College, Pharmacy College and Nursing College is 48.78 acres. The Nitte Education Trust has established A.B.Shetty Memorial Institute of Dental Sciences, Mangalore in the year 1985 after due approval of Dental Council of India and affiliated to Rajiv Gandhi University of Health Sciences for 100 admissions since 1988. It is located in a land area of 5 acres earmarked for the institutions as per the undertaking given by the Institution (Annexure-XXIII). It has a seven storied building.
2. The A.B.Shetty Memorial Institute of Dental Sciences, Mangalore is supported with 650 bedded multi-speciality well equipped Hospital attached to Medical College. Presently, A.B.Shetty Memorial Institute of Dental Sciences is running BDS Course and Postgraduate courses in 8 subjects. The Institution has well earmarked building, with sufficient space and infrastructure for running the said college. It has more than 22 years of existence. The infrastructure in the form of Building and Machinery and equipments is excellent and fulfils the norms laid down by DCI. Each department has UG and PG training programme supported with necessary modern equipments required for the students.
3. Every PG department has separate seminar rooms with LCD and Audio-visual facilities along with departmental library. The institution is having 4 museums i.e. Dental Material, Histology, Anatomy and Oral Pathology. The labs. for UG and Research labs. for PG are well equipped and spacious. One Seminar Hall having a capacity of approx. 250 persons and 4 lecturer hall having a capacity of 110



persons fitted with the audio-visual aids are available. One Auditorium having capacity of 650 persons is being shared by Medial and Dental Colleges.

4. In all departments, full time, regular, well qualified and experienced staff is available. The teaching faculty in pre-clinical medical departments, medicine and surgery departments is also as per DCI norms and shares the workload of Dental as well as Medical College which is recognized by MCI. The faculty members are committed and most of the faculty members have been working in this Institution for more than 10 years. The staff is satisfied with the pay scales and other benefits being given to them by the Management.
5. The institution has provided a good library located in spacious building demarking separate space for Dental students. The Dental Library has 10396 books, 53 journals, 709 e-journals are online subscribed. The library is having digital and indexing facilities. In addition, there are departmental library for each department. There are three Reading Rooms for faculty and students (boys and girls) separately in the Library.
6. The Institute has provided 48 staff quarters for the faculty members in the campus itself common for medical and dental faculty and one guest house for 30 persons meant for the visiting faculty members and others. The institution has one hostel for boys accommodating 100 boys and two hostels for girls accommodating 286 girls at undergraduate level. In addition to this there are one boy's hostels accommodating 110 boys and one girls hostel accommodating 110 girls for Interns and PG students. Besides this, another new hostel building of 4100 sq.mtrs. is near completion. The indoor games and other recreational facilities including the gymnasium are also available in the hostel campus. Good quality and hygienic foods at subsidized rates is being served in all hostels.
7. The faculty and clinical material for the teaching and training of students is adequately available. The faculty takes initiative in research work.. Some of the departments have taken research projects with ICMR also. Three books have been published by the faculty members and some of the faculty members are on the editorial board of reputed journals of Dentistry. The management is pro-active and encourages the faculty to undertake research work, attend and organize




conferences for updating the knowledge of the faculty. The environment is conducive for research and other academic activities. However, it needs to be further strengthened.

8. The institution has taken up the community and extension activities by having two mobile dental vans well equipped for community dental services for rural population around Mangalore and has established 13 Rural Health Centres. Transportation facilities are being provided with a fleet of more than 27 buses and 13 vans including three ambulances. The Institute is organizing Dental check-up and School screening Camps minimum two per month throughout the year in rural areas in the catchment area of approximately 50 kms. Free health services are being provided to the poor and needy patients.
9. The syllabus followed by the college is as per DCI norms and regulations and are approved by the Rajiv Gandhi University of Health Sciences. The pass percentage of the UG and PG students has been more than 90% since 2002-03.
10. The Nitte Education Trust have independent physical infrastructure in terms of buildings, libraries, students facilities and administrative set up satisfying the norms of the Dental Council of India and is affiliated to the Rajive Gandhi University of Health Sciences, Bangalore, Karnataka.
11. The Committee went through in detail to verify the financial viability of the institution and also all the documents relating to the registration as a society, ownership of assets, corpus fund deposits, Memorandum of Association etc. The Committee is satisfied with the financial strength of the institution as evidenced from the physical infrastructure and future programme of their activities. Hence, the Nitte Trust seems to be financial viable and having assets with 740 crores and is managing 24 educational institutions. It has proven track record of quality professional education. The administrative set up is well organized. The Dental College is being managed by Principal and all the departments are being monitored by Head of the Departments. The management participation is through various Committees. The leadership of the College seems to be motivating and inspiring.



12. The institution is having national and international collaboration with the academic institutions of repute.






