INTRODUCTION

Indian Council for International Amity, Jaipur, Rajasthan applied for deemed to be university status to International College for Girls, Jaipur in the name of 'The I.I.S. University' under general category through Ministry of Human Resource Development, Government of India. Accordingly, the Chairman, UGC constituted an Expert Committee, comprising of the following, to make an on the spot assessment of the existing infrastructure and academic facilities and also of its future potential for considering conferment of deemed to be university status under Section 3 of the UGC Act. 1956:

Prior to the actual validation and assessment of the Institute, Prof. Abhai Maurya, Chairman of the Committee and Sh. S.C. Chadha, Coordinator of the visit briefed the members of the Expert Committee in a separate meeting about the proposal of the applicant institute received by the UGC for consideration for deemed university status. It was further informed that the proposal is for deemed university status to International College for Girls, Jaipur, Rajasthan in the name of 'The I.I.S. University' under the general category. Prof. Abhai Maurya then requested the members to visit the institute and to examine the infrastructure and other facilities available and give their observations / suggestions keeping in view the provisions in the UGC guidelines.

Dr. Ashok Gupta, Secretary General of the parent society, received the Committee Members along with other functionaries of the College and faculty members. A power point presentation was made by Dr. Rakhi Gupta, Principal of the College about the College and its activities / programmes. Dr. Rakhi Gupta and other faculty members to the satisfaction of the Members answered various queries raised by the Expert Committee. Thereafter, the Expert Committee visited various departments of the College.

The Committee also visited the common facilities like Administrative Building, Library, Computer Labs, Central Instrumentation Lab, Examination Cell, Placement Cell, Seminar Hall, Auditorium, Play Ground, Swimming Pool, CRS FM Radio, Hostels, Seminar Hall, Auditorium, Canteen, Cafeteria etc...

Background of the Institution

The International College for Girls (ICG) is run by the "Indian Council for International Amity" (ICFIA) (1973), registered under the Rajasthan Societies Registration Act, 1958 which is headed by Justice S.N. Bhargava, Retired Chief Justice of the High Court of Sikkim.

International College for Girls was established in 1995 and became a Post Graduate College in 1999. Today, ICG has 3190 students, 150 faculty members and 51 technical and non-teaching support-staff on roll and around 52 regularly visiting faculty. Affiliated to the University of Rajasthan, it was recognized by the UGC on 15th December 2003 under Sections 2(f) and 12(B) of the UGC Act., 1956. ICG has been accredited and awarded A+ grade for five years by the National Assessment and Accreditation Council (NAAC) in 2005. It has also been identified as a Model College and Centre of Excellence by the State Government. In a survey conducted by A.C. Nielson for 'India Today', the College was not only rated best in the state but also found mention in the list of the top 50 colleges of the country.

The University Grants Commission has recently conferred an Autonomous status on ICG for a period of six years w.e.f. 2007-08.

OBSERVATIONS OF THE COMMITTEE

- International College for Girls, Jaipur was established in the year 1995 for 1. women's education in the state of Rajasthan by Indian Council for International Amity, a society registered under the Rajasthan Societies Registration Act, 1958 which is headed by Justice S.N. Bhargava. Retired Chief Justice of the High Court of Sikkim.
- 2. The College which became a Post Graduate College in the year 1999, has 3190 students, 150 faculty members and 51 technical and non-teaching support staff on rolls and around 52 well qualified regularly visiting faculty.
- 3. The College is presently affiliated to the University of Rajasthan and was recognized by the UGC under Section 2 (f) and 12 (B) of the UGC Act, 1956, in the year 2003.
- 4. The College has been accredited and awarded A+ grade for five years by the National Assessment and Accreditation Council (NAAC) in the year 2005.
- 5. It has been identified as a Model College and Centre of Excellence by the State Government of Rajasthan. The College was ranked the best College of the State by India Today for 2 consecutive years in 2006-07 and 2007-08 and was ranked one of the top 50 Colleges of India. The students of the College have been securing high ranks in the University examinations. It is not only education but their contribution in the extra-curricular and outreach activities has been distinct.
- 6. The University Grants Commission has recently conferred an Autonomous status on the College for a period of six years w.e.f. 2007-08. With the implementation of the autonomy, the Management and its faculty has already acquired the experience of functioning as an independent educational entity. The Statutory Bodies are already functioning, the faculty is already involved in designing new courses and curricula, system of assessment, evaluation and compilation of results is already in existence.

7. The College is presently offering 6 professional UG programmes, 14 professional PG programmes, 16 UG programmes, 17 PG programmes, 3 M.Phil programmes, 6 Ph.D. programmes and 24 innovative programmes

8. The programmes offered are in the field of Environmental & Life Sciences, Physical & Computing Sciences, Chemical Sciences, Home Science, Computer Science & Information Technology, Behavioural & Health Sciences, Fashion & Textile Technology, Languages & Mass Communication, Social Sciences, Fine Arts, Commerce and Management.

- 9. The College is also running various innovative and career oriented programmes awarded by the University Grants Commission.
- 10. The total land area available with the College is 50,331 sq. Mtrs. in its four campuses at Gurukul Marg, Kshipra Path, Mahaveer Marg and Sitapura campus at Jaipur. The infrastructure available with the College is more than sufficient and it fulfills the requirement under UGC guidelines and for future expansion also.
- 11. The College has 41 labs well equipped with latest Computers and other required equipment. It also has 67 class rooms with overhead projectors, Public address system and microphone facility in bigger rooms. Three auditoriums, two conference halls and three meeting halls can accommodate 2375 persons in all. However, Science labs should be developed further.
- 12. The total floor area of the library is about 790 sq. mtrs. The library system of the College is equipped with about 26,258 text books, 5100 reference books, 211 Journals & periodicals, 1835 bound journals and periodicals, 59 magazines and 838 CDs and Cassettes. The College has an arrangement for resource sharing and an access to online books, e-journals and other information by the faculty & students with Questia, DELNET and American Information Resource Centre. The library also has reprographic and bar-coding facilities. However, the Committee felt that the library budget be augmented and e-learning resources should be strengthened further.
- 13. The College has excellent hostel facilities with three hostels with 77 rooms accommodating 240 students. The hostels have central air cooling facility, public address system, RO system, water coolers, recreation room, phone card facility, 24 hrs. water and electricity supply, 100% power back up etc. However, the Committee felt that there was a need for adding more hostel space. The endeavor on the part of the College should be that all out station girl students should be provided with hostel facility.
- 14. The faculty is engaged in research activities and is encouraged to participate in conferences and workshops by the management. The research activities are co-coordinated and streamlined by the Research Promotion Committee. It was a pleasure to learn that in spite of the limited opportunities available in an affiliation system, the faculty has completed 42 funded projects, 5 projects are on-going and 5 projects have been proposed. At present, 45 faculty members are with Ph.D. qualification, 8 have submitted thesis and 33 are pursuing Ph.D. The College has also

been encouraging its faculty members to take up sponsored R & D work from Government agencies and industries. The College also provides financial assistance to the faculty members and students for promotion of research activities. The financial assistance for research promotion may be enhanced. Some of the research projects are funded by UGC and DST. Seven faculty members are approved research supervisors and eleven are awaiting approval by the University. The faculty has also published 296 research papers published. The faculty members have attended 1165 and organized 35 National / International Conferences / Seminars / Workshops including FDPs. In view of the research potentials, the College should strengthen its research component to an optimum level.

- 15. The facilities available with the College are comparable with those that are available at University level. The College has its own publication department, designing and publishing in house magazines and news letters like Maa , Hamari Sanskriti, lCgian etc.
- 16. The College is a self-financing institution with proven administrative. managerial and financial capabilities and it can meet its needs of maintenance and development.
- 17. The College has demonstrated its financial viability satisfactorily and its accounting practices, balance sheets and audited statements seem to be in The financial viability is evident from the income-expenditure order. statement.
- 18. The College has introduced many innovative practices in imparting education, particularly going beyond the syllabi.
- 19. The Institute has been following a transparent faculty / staff recruitment policy as per State Government norms, attracting good faculty / staff. The faculty receives salaries as per UGC norms.
- 20. The management has shown its commitment for promotion of women education and to address issues related to women in general. The management is running a secondary school named 'The IIS Gurukul' for the girls' students coming from the weaker section of the society. The students are being provided with free education, free books and uniform.

21. The faculty, students and non-teaching staff are highly motivated and satisfied with the existing facilities in the College.

 - b. The experience it has gained from autonomous status.
 - c. Its potential for further progress.
 - d. Wide range of extension activities pursued through faculty and student involvement.
 - e. The College has taken innovative initiatives to upgrade its academic and research activities.
 - f. The initiative it has taken for the promotion of higher education among women.
- 3. The College has demonstrated its capabilities for becoming a leading centre in education and research in the State of Rajasthan.

Taking a holistic view of the activities and achievements of the College, the Expert Committee unanimously recommends the conferment of Deemed University status on 'The I.I.S. University', Jaipur, Rajasthan comprising of International College for Girls, Jaipur, Rajasthan. The Committee also recommends a review of its activities and progress after five years.
